Beverwyck marks 20 years

Slingerlands retirement community holds special events for residents, families

Twenty-five years ago, when Adelaide Muhlfelder was sitting on the board of the Beverwyck Retirement Community, she didn't expect to be moving into the facility. But when the

project was completed five years later, plans had changed.

"I already knew everything about the project," said Muhlfelder, 93. "By the time that five years was up my husband wasn't too well and we decided it was time for us to move."

This month, Beverwyck, The Eddy's retirement community located in Slingerlands, celebrated its 20th anniversary. It was the first full-service

retirement community to be built in Albany County.

Muhlfelder is one of four "charter members" still living at Beverwyck. Dorothy Storms, Arthur and Janet Hengerer and Muhlfelder have all been living at the facility since it was built 20 years ago. They were among 80 people who put their names on a waiting list to move to the facility before the building was completed.

Challengers hit the trail

Bethlehem United candidates holding public meetings to kick off campaigns

Bethlehem United candidates are kicking off the local elections season by holding a series of community meetings around town.

The first meeting was held on the night of Thursday, Sept. 19, at Selkirk Firehouse No. 2 in Glenmont, and was hosted by Albany County Legislator Rich Mendick. Supervisor candidate Fred DiMaggio, who is also former chairman of the Bethlehem Republican Committee, spoke with residents and took questions from the audience, as did Town Board candidates Linda Jasinski, a conservative, and Dan Cunningham, a member of the Independence Party.

All three candidates are endorsed by the town's Republican and Independence parties, as well as the Albany County Conservative Party, and are referring to themselves as Bethlehem United because of the mixed political makeup of the ticket. The

group came together this spring to work against a referendum to abolish the elected position of highway superintendent and place those responsibilities under the commissioner of public works. The referendum failed 3,086 to 1,969.

"I don't like the way the town is being run," said DiMaggio about his decision to run for office. "I think there has been a lack of vision and direction on the part of this administration, particularly with Supervisor (John) Clarkson, and I think this assembled team of a non-partisan coalition is a far better approach to government, instead of the one-party partisanship we've seen in Town Hall."

Jasinski and Cunningham echoed those sentiments, with the former stressing how she is more concerned with how the government is run and not the politics behind it. Jasinski also said her goal is to seek equal representation for the "outlying areas of town."

"Right now, the Town Board is very Delmar-centric," Jasinski said. "Everybody is from that area and they don't even realize that down in South

Bethlehem people live a little differently."

Councilwoman Joann Dawson is a resident of Glenmont.

Cunningham said his efforts are focused on maintaining the services that make up the character of the town, while keeping taxes at a livable level for residents.

"If my taxes go up 15 percent last year, that means my kids are going without something," Cunningham said. "And ultimately if they keep going in this direction, my kids won't be living here."

About 40 people attended the meeting. Questions ranged from how the candidates would promote economic development in the town, to preserving open space for agriculture, to open-door policies for constituents.

"We need to work with developers and let them know this isn't a hostile environment for business," DiMaggio said.

Cunningham said Bethlehem should be going after "low-hanging fruit" and promote the waterfront and rail yard instead of seeking technology tenants because of the competition

involved.

"We have assets here we should be focused on developing," he said.

One woman asked how the public could work to get rid of the town's Comprehensive Plan, arguing it does very little for parts of the town other than Delmar and is not working to stop overdevelopment.

Jasinski, who was an advisory member on two Comprehensive Plan committees, said she doesn't think the plan needs to be thrown out, but rather tweaked to take into account the needs of all residents.

The meeting was attended by former Democratic Supervisor Jack Cunningham, who is Dan Cunningham's

brother. Also in support of the Bethlehem United group are two Bethlehem Democratic Committee members, Stephen Vazci and Leo Dorsey, from the town's 28th district. Both spoke at the meeting, and were critical of other parties for not working harder to get out the vote and obtain absentee ballots in the recent Primary Election.

"I'm probably going to make some enemies here tonight, but I don't care," said Dorsey. "The Republican, Independence and Conservative parties failed in the primary because they didn't get off their lazy butts. I'm a Democrat and I got 145 absentee ballots for these candidates."

Vazci said he's

supporting the Bethlehem United candidates in part because he represents the people of Selkirk, and those residents rarely see the Town Board members in their area of town.

"I think you know what the people want and you'll do a good job," Vazci said to the candidates.

At the end of the meeting, those in attendance were encouraged to speak with the candidates one-on-one. They were also asked to take lawn signs.

The next two Bethlehem United public meetings will be held on Thursday, Sept. 26 at Selkirk Firehouse No. 3 in Selkirk and Tuesday, Oct. 15 at the Bethlehem Public Library. Both meetings begin at 7 p.m.

County puts the ABCs in infant sleeping

Albany County highlights National Baby Safety Month, gives task force progress update

Parents of a newborn often stay as close to their child as possible, but area medical experts and county officials are pushing parents to remember their “ABCs.”

The Albany County Safe Sleeping Task Force’s latest initiative isn’t an exercise in remembering the alphabet, but rather another outreach effort cautioning parents and caretakers to not sleep in bed with an infant. The ABC slogan stands for “Alone on their Backs in a Crib,” which is recommend as the safest way for a baby to sleep at night. New signs with the slogan and public service announcements will be added to the county’s ongoing safe sleeping campaign.

Albany County Executive Dan McCoy joined Task Force members on Wednesday, Sept. 18, at Albany Medical Center to recognize National Baby Safety Month and proclaim the day as Safe Sleep Day in the county. The ABC slogan was also unveiled.

“We can try to educate before (parents) leave and have their new babies,” McCoy said. “It is just important that we let people know the safe sleeping habits.”

along with other area hospitals, are including safe sleep information with discharge papers, McCoy said. The hope is parents will be better informed about best practices.

“When you got a brand new baby, you got 50,000 things on your mind, you want to go home and show everyone your bundle of joy,” McCoy said. “Now with the weather changing and the winter months coming, more people are going to be in tune to have their babies sleep in their bed for warmth.”

Kathy Marsch, interim chief nursing officer at St. Peter’s, said while parents always have their baby’s safety in mind, they might not know some “common practices” are dangerous. Marsch said the hospital educates parents on preventing sleeping death in childbirth preparation classes.

“All family members, babysitters, day care staff and anyone caring for infants need to be informed and alert to the risks,” Marsch said.

Gladys Carrión, commissioner of the state Office of Children and Family Services, said “decades of conflicting information” surrounding best practices for babies has led to an “unfortunate number” of infant deaths.

“These tragedies are not inevitable,” Carrión said. “They are preventable.”

County officials announced the formation of the Safe Sleeping Task Force in March, and said 12 infant deaths tied to unsafe sleeping conditions were reported in the county over the past three years. The deaths were primarily attributed to adults rolling onto an infant and smothering them while sharing a bed, according to county officials.

Since then, McCoy has received sporadic pushback through posts on his Facebook page from those who support co-sleeping. One person accused McCoy of running a “smear campaign” and argued the practice of “bed sharing” reduces the chance of sudden infant death syndrome.

The medical journal BMJ Open published a study in May led by London School of Hygiene and Tropical Medicine professor Bob Carpenter that found newborns sharing a bed with a parent are five times more likely to suddenly die when compared to a baby sleeping in a cot.

“The current messages saying that bed sharing is dangerous only if you or your partner are smokers, have been drinking alcohol

or taking drugs that make you drowsy, are very tired or the baby is premature or of low-birth weight are not effective because many of the bed sharing deaths involve these factors,” the study read. “Our findings suggest that professionals and the literature should take a more definite stand against bed sharing, especially for babies (less than) 3 months old.”

The study is the largest ever conducted and involved analyzing individual records of 1,472 SIDS cases and 4,679 controls from five major case-control studies. Approximately 88 percent of bed sharing deaths analyzed in the study could have prevented if the baby wasn’t sharing a bed, according to the authors.

Dr. David Clark, director of the Children’s Hospital at AMC, said bed sharing is “absolutely” dangerous. “In the winter season it

tends to tick up a bit more, because in the summer folks aren’t using the blankets and other sorts of things they are using in colder weather,” Clark said. “Particularly now we want to make sure the message gets out and reinforced.”

Since the county’s safe sleeping program started,

there have not been any infant deaths from unsafe sleeping reported in the county, McCoy said on Wednesday.

“It doesn’t end because we have zero,” McCoy said. “We have to continue with that message out there so people are aware what can happen if you sleep with your baby.”

Drugged driving charges come months after car crash

Police have charged a Greenville woman with drugged driving more than eight months after the alleged violation.

Coeymans police said Cassandra Ray, 41, was under the influence of prescription medication when she was involved in a crash on Route 32 in Coeymans Hollow on Jan. 6, 2013. There were four children aged 16, 15, 11 and 1 in the car with her, police said, and the 16-year-old girl suffered a fractured vertebra in the crash.

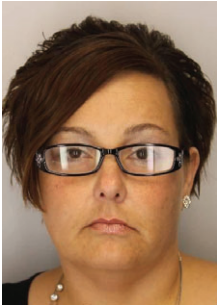
Ray was charged on Thursday, Sept. 19, with misdemeanor driving while ability impaired by drugs, felony vehicular assault in the second degree and a felony Leandra's Law violation because children were in the car, police said.

Police said a lab analysis of Ray's blood took months. She allegedly had alprazolam, an anti-anxiety medication marketed as Xanax, in her system.

Ray turned herself in to police, was

arraigned in Coeymans Town Court and was released under the supervision of probation.

The Albany County Sheriff's Office and other local law enforcement agencies have launched anti-drugged driving campaigns in the wake of a 2011 incident in which three women were killed by LuAnn Burgess, who was found to be under the influence of prescribed medication at the time she ran her car off the road in Voorheesville. Burgess was eventually sentenced to probation and community service.

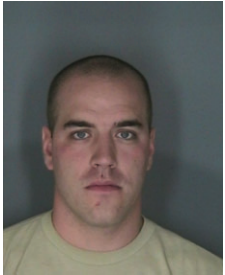

Simpson was charged with DWI, and police said her BAC was 0.12 percent. She was released and scheduled to appear in Town of Guiderland Court on Sept. 26.

The Albany County Sheriff's Office has charged a Cohoes man with possession of child pornography.

Robert V. DuBuc, 26, was charged with four felony counts of possessing a sexual performance of a child and misdemeanor charges of endangering the welfare of a child on Friday, Sept. 20.

Police said DuBuc befriended a

15-year-old girl from Ohio on Facebook and solicited sexually explicit photos from her. He also forwarded nude photos of himself in exchange, police said. The girl's mother found the photos and alerted the local police department, which led to sheriff's investigators being contacted, according to police.

DuBuc was released and scheduled to appear in Cohoes City Court on Oct. 3.

The investigation is continuing and police are looking to see if there may be other victims. Anyone with information is urged to contact the sheriff's office at 765-2352.

Police probe Selkirk burglary

Police are investigating a Selkirk burglary in which a woman returning home allegedly found an unknown man in her house.

Coeymans police and State Police were called to the Route 9W address Monday, Sept. 23. The woman was on her cell phone when she entered the house and the party on the other end called the police. "There was no shopping for us, this was the only place around," said Storms, who originally moved to the facility with her husband. "It's a great place to be if you need this kind of attention. You're probably better off at a place like this than on your own. I would not want to be on my own today."

To mark the anniversary, a week of events was held for the facility's 300 residents and their families. Seniors enjoyed themed dinners,

trivia games, an ice cream social and a celebration gala.

Beverwyck Executive Director Doug Miller said while facility has grown over the years, the mission remains the same: to provide a caring place that feels like home for seniors in their later years.

Miller said the facility was built out in phases. In 1983, 15 cottages and 85 apartments were built. Twelve years later, another 85 apartments were added, along with an auditorium. In 1999, a 41-unit enriched housing complex called Beverwyck Terrace was finished. Larger cottages

were built in 2008, and two years later, a nursing home-style facility with 24 beds was built.

Completion of the Beverwyck meant local residents no longer had to move to retirement communities in Southern states, because there was a place available closer to home. This meant seniors could remain an active part of their community and get the care they needed, Miller said.

He added that besides Beverwyck's physical growth, trends in senior care have changed.

Residents are coming to the retirement community at older ages than what

was once the norm. Miller said many seniors are choosing to, or have to, work later in life. This means many are opting to stay in their homes later. The average age of a Beverwyck resident 20 years ago was 75. Now it's 82. Miller said this, in part, led to the decision to add on the nursing home component.

"Beverwyck is now full-service with all three levels of care for seniors on the same campus," said Miller. "Residents can go from independent living to the terrace and to the nursing home. The beauty is they don't have to move around the Capital Region for their increased needs."

And just one more thing in case

everyone hasn't heard about it.

More than \$776,000 was awarded to the town through a new NYS Local Government and Efficiency Program for shared services and modernization. It is an award given to fiscally responsible leaders who demonstrate significant innovation, savings, efficiency and modernization. It was one of the largest amounts given to any NYS community.

Finally we arrive at John's temperament, perhaps as important as all of the above successes. John is the perfect leader for our town. He welcomes and encourages citizen involvement and is receptive to differing opinions, recognizing that we have a diverse population in the town. In that regard the town's website has become more informative and transparent, again inviting citizen participation and differing opinions. Five new committees composed of citizen volunteers have been formed, two of which are the Ethics and the Comprehensive Land Use Committees, both dealing with important issues for our town. Snappy slogan oversimplifies

There are a lot of good reasons for parents to follow the “safe sleeping” techniques for infants touted by the Albany County Safe Sleeping Task Force and County Executive Dan McCoy. The fact is, of the 12 infant deaths in the county attributed to unsafe sleeping over the past three years, the majority were caused by a parent accidentally smothering a child while co-sleeping – a tragedy that is easily preventable.

While declaring Wednesday, Sept. 18, Safe Sleep Day, the task force also unveiled the newest slogan in its outreach efforts: “ABC,” which stands for “Alone on their Backs in a Crib.” A good slogan is catchy and easy to remember, and this one certainly

fits the bill. However, in reality, very little in parenting can be distilled down to something as simple as “ABC.” Decisions about how to best raise a child are based on far more nuanced details, and it would be wrong to assume that parents aren’t able to come to their own valid conclusions without the help of a snappy slogan.

On his Facebook page, McCoy has caught flak from some bed-sharing proponents who accused him of running a “smear campaign.” While this is hardly the case, parents who do co-sleep with their infants are feeling unnecessarily villainized. Even as they promoted their safe-sleeping recommendations, county officials

acknowledged the reasons some parents choose to co-sleep with their infants. McCoy said the changing weather can prompt some parents to let their “babies sleep in their bed for warmth,” and Kathy Marsch, interim chief nursing officer at St. Peter’s, recognized the conflicting information about infant sleeping practices over the years has some parents confused. But both joined a number of other health professionals in calling bed sharing a dangerous practice.

It is easy to see that the county has the best interests of its very youngest residents in mind, but it does well to remember that their parents have their best interests in mind, too.

Sign law needs new look A few questions about the IDA and Vista

Editor, The Spotlight:

On behalf of Boy Scout Troop 75, I would like to comment on the Bethlehem sign law. We feel it is too restrictive and should be amended to include a short term permitting process for nonprofit groups to place signs in public areas for up to two weeks. Over the past year, there has been debate on Section 128-59 of the town code, which states, “No signs other than an official traffic sign shall be erected in the right-of-way of any public streets or highway.” While the spirit of the law had merit in preventing signs being left on Route 32 and other public roads for months, it had unintended consequences for Troop 75 and other nonprofit groups (Troops 58 & 71, GSA, BCHS sports teams, youth soccer, Little League, etc.) who routinely give back to the community, and/or benefit all our kids.

Last Nov. 17, we held our 40th annual Sports Mart at BCHS. Sports Mart is a community consignment sale, which provides donations to the Regional Food Bank and is our only fundraiser each year. Our primary means of advertising are the signs that we have traditionally placed on Route 32. They go up nine days before the event and come down the day after. We unsuccessfully petitioned the town for a two week exemption to the sign law and had a significant decrease in equipment drop offs and a nearly 20 percent drop in sales. A number of people approached Troop members afterwards and said things like “aren’t you doing Sports Mart this year, I need to get my kids new skis and clean out my basement.” Sports Mart

benefits the community by bringing families considerable savings on sporting goods and a means to pass on outgrown clothing and equipment.

Troop 75 has been a part of our community since 1930, and routinely does service projects to include building park areas and handicapped accessible tables, repairing Little League bleachers, painting school carnival equipment, improving church properties, etc. Over the next month, we will be building signs to clearly mark all the fields at the Town Park and putting mulch in the picnic area at the Brauer Education Area. Other community groups like us do service projects on a regular basis, provide our kids with the kinds of activities that make Bethlehem a great place to live and should be able to responsibly advertise for fundraising activities.

While the bypass is much nicer to drive on than in years past, the one size fits all policy should be amended. We would like the Town Board to take action on this issue now to amend the law and establish a permit policy that would allow us to put signs on Route 32 for a ten day period before our 41st annual Sports Mart this Nov. 23. Groups can be held accountable to this policy and Troop 75 looks forward to discussing the issue at an upcoming board meeting. We understand that other non-profit, community groups would be able to advertise their events as well, and believe it is the right thing for the supervisor and board members to do. Thank you.

5. Do the two Slingerlands I LaSalle Med. Office projects current number of Full Time Employees (FTE) of 73.5 and 109 seem reasonable?

6. Is the YMCA project estimate of 150 jobs to be created a realistic number?

7. IDA Projects involve exemptions of taxes. Do the officials or boards representing NYS, local, county, school and mortgage have the opportunity and right to review and approve or disapprove the proposed reduction in taxes by the IDA Agency officials? If the answer is no, this is actually taxation without representation since the taxpaying public has to make up the difference between the tax exemption and PILOT (Payment in Lieu of Taxes).

8. For information-Comptroller DiNapoli states that Authorities create 94 percent of NYS debt for which citizens have no vote.

On average, three out of every four participants receive academic scholarships to some of the most competitive schools in the country. You don't have to be an "A" student to join or participate in Youth in Government. Rather, a willingness to apply yourself and speak out with confidence are useful skills for the program.

The process begins this October, when students gather to identify a community issue of concern, with the assistance of staff leaders at the YMCA. They research the issue, work on a solution, consult with local attorneys and legislators and take their idea through the legislative process.

Students that sign up for Youth in Government receive training and experience in research, writing and debating legislation; public speaking; the legislative process; parliamentary procedure; working with the news media; lobbying techniques; and learn about our judicial system.

Students will hear from local community leaders with first-hand experience in the law-making process. They will also participate in a district conference and conduct a model legislative session at the state Capitol in March.

The YMCA's Youth in Government program is a hands-on experience that teaches young people how to become active citizens in a democracy, teaches them leadership skills, gets them interested in public services and can help high school students get into the college of their choice, possibly with scholarship assistance.

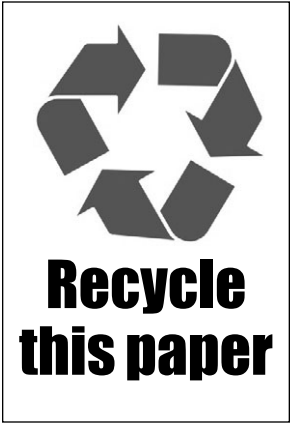

County gets \$600k security grant

Funds will help build countywide communications, terrorism prevention

On the eve of Sept. 11, Albany County Executive Dan McCoy announced the county had been awarded nearly \$600,000 by the state Division of Homeland Security and Emergency Services to help improve crisis communications and prevent terrorist attacks.

"I'd like to say we live in a perfect world and this stuff doesn't happen, but it does unfortunately," McCoy said. "One of the things I've said is we need to be prepared for any type of emergency."

The funds are being awarded through the 2013 State Homeland Security Grant and will be divided up between the Albany County Sheriff's Office and the county Health Department, which will receive \$334,700 and \$262,750, respectively.

The Sheriff's Office's share will go toward building upon the county's Interoperable Communications Systems. The Health Department will use its awarded funds to sustain homeland security personnel and programs and support terrorism prevention activities.

The Health Department grant will allow for the county to continue enhancing public health preparedness, training and recruitment for the county Medical Reserve Corps, and improving emergency medical response capabilities.

The Medical Reserve Corps is a group of volunteers, including many medical professionals, who prepare for various types of major public health emergencies. It consists of more than 500 volunteers, and McCoy said holding training exercises periodically is important to keep members prepared.

Upgrading the communications system will allow more local emergency services providers interact with one another in the event of an emergency. Keeping emergency communications up-to-date is an "extensive" task, McCoy said, but it allows for first responders

and law enforcement to coordinate a joint response across the county. He said Colonie operates on a different radio system than the countywide system, for example, so its police and firefighters can't communicate with surrounding agencies easily.

"It costs so much money to update it," he said. "This will allow for a continuity of communications efforts."

The county recently received \$6 million to upgrade the first half of its 911 infrastructure, but the remaining work will require another \$5 million to complete.

"If something were to have happened here, you would need something where we are all connected," said Mary Rozak, spokeswoman for the county executive. "I think this is one of the lessons we learned on Sept. 11, that our communication structures can be hit."

McCoy said his priority since taking office has been to ensure law enforcement and health officials have the necessary resources to keep the public safe.

"It is crucial that we work together to ensure that the county remain up to date and provide state-of-the-art security programs on all levels," McCoy said in a statement. "We do not know when or if a situation will occur in our area, but with this funding in place, we can be prepared and that is crucial."

McCoy said receiving grant funding for these initiatives is important with the tax levy cap.

"We are all trying to live within the 2 percent cap and we are trying to do things for less, but we still have obligations to protect the public," McCoy

said. "It helps continue this mission without me having to raise funds to continue it, because that is when things get tougher."

McCoy said a cell phone can't be thought of as a stable communication tool during emergencies because cell towers could be disrupted, service could be limited and an influx of calls or texts can overwhelm systems.

"Cell phones are not reliable because it depends on power," he said.

The Medical Reserve Corps is looking for physicians, physician's assistants, nurses, dentists, pharmacists, veterinarians, paramedics, mental health professionals, respiratory therapists, epidemiologists and social workers to volunteer. Residents without any medical training are also encouraged to volunteer for other roles, such as interpreters, management and data entry.

Race for Hope keeps running

Fifth year for 5K that raises money to help patients with cancer

The Capital Region Special Surgery Race for Hope will be held in Slingerlands for the fifth year running.

The race is the idea of a group of local practitioners who are giving back to the community by helping in the fight against cancer. Race for Hope began in 2009 as a way for Capital Region Special Surgeries to aid families in their times of need through fundraising to provide support services.

Each year, hundreds of people participate in a 5K race in the Town of Bethlehem to raise thousands for those seeking treatment for brain, head and neck cancer.

"Every dollar raised goes to those in the Capital Region," said Carla

Sorbero of Capital Region Special Surgery.

Those within the practice felt it was important to aid not just patients, but their families as well. In previous years, all of the money raised was divided between the Ronald McDonald House Charities of the Capital Region and a patient fund at St. Peter's Hospital.

Now, the money will be given to the Community Foundation for the Greater Capital Region, serving as a nonprofit for the race. This new venture will allow any local organizations dealing with head, neck and brain cancers to apply for grants from the money raised at the event.

In previous years, more than 500 people ran the race while several hundred more donated to the cause. Each year, the event has raised about \$50,000. One hundred percent of all registration fees, donations and corporate sponsorship

money is given to those in need because the medical group pays for all expenses associated with the race.

The race will feature digital chip timing, provided by USA Track and Field, and the University at Albany athletics department will once again be providing much of the volunteer labor needed to run the race. Walkers are welcome to participate in the race after the runners step off.

The race starts at 10 a.m. on Saturday, Sept. 28, from the Special Surgery offices at 1220 New Scotland Road. The entry fee for children or teams is \$10 per person, while registration for adults is \$30 the day of the race. Online registration closes at midnight on Friday, Sept. 27. Finish line open to the whole family

In the fall running season, there seems to be a race to fit every skill level and ambition. But few aim to please the whole family.

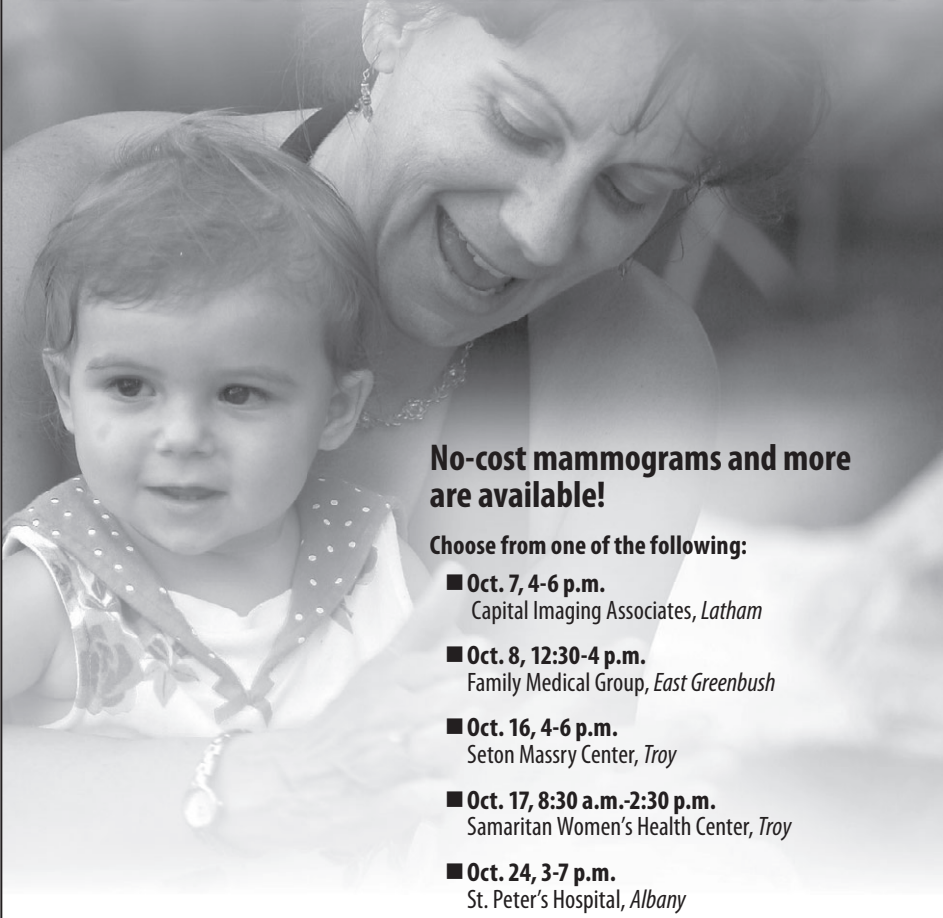

a competitive process to faculty and staff from all levels of Bethlehem schools for projects to be implemented in the next school year.

Some of the ideas that were approved included purchasing a green screen to be used during announcements at the middle school to help students learn graphic design, purchasing iPads for struggling readers at Elmsere Elementary, a recycling project and Eagle Elementary and a community garden at the middle school.

"The fundraising is part of the event, but really what we have found is there isn't a solid alumni foundation, so we are sort of trying to be that for the community," said Jamboree organizer Tina Sheehan. "There's not really a go-to place for alumni. There was one, but it sort of fell apart after

a while."

Sheehan said the BCCF is trying to establish the tradition of the Jamboree so alumni want to come home every year for the Homecoming game and visit with their old friends. The event would hearken back to what homecoming games and dances were once meant to be.

The event will feature pizza made-to-order by Jim Gallagher of Jimmy Makes Pizza, a bake sale, live music from the Hooligans pep band, a virtual art show, face painting, a bounce house and Eagle Spirit giveaways.

Additional activities

will also be planned for returning alumni.

"We didn't make a ton of money last year," said BCCF President and Middle School Principal Mike Klugman. "We were hoping to break even and were surprised when we raised more. We're hoping to beat last year, but it's really about throwing a great event for the community."

Tickets to the game itself are \$3 for adults and \$1 for students. The Homecoming Jamboree will take place on Friday, Sept. 27 from 5 to 7 p.m. The varsity homecoming game will immediately follow.

Burbank said the event started with two board members trying to development a fun fall event. One was interested in cars and another wanted some type of food contest.

"We were thinking about tailgating or burgers ... but then a board member came up with soup," Burbank said. "We tried to think what would be easy for restaurants to come to a different location and be able to serve. Soup is genius because it is very easy."

For several years, Altamont Orchards hosted the car show and the chamber would organize the soup cook-off. Burbank said the new location offers a better layout for the event, which typically attracts more than 400 people.

"We switched it to (Adventure Camp) because it is a more centrally located area and the YMCA had asked us to move there," she said. "It is really level with good drainage and it is nicely laid out. The car show can also be close to the soup tent in the pavilion, so people can wander in and out and see things together."

There is also more parking and a playground area for kids. Other

attractions include a bouncy bounce, hayrides and a DJ playing music.

The inaugural event saw five restaurants making a couple of soups each and "a ton of cars," Burbank said, and around 200 people turned out. Over the years, it has grown to include more restaurants, and chefs often return to defend their culinary titles.

"All the restaurants loved it and we just keep getting more and more," she said.

The awards being given out for soups this year include best soup, best chili, best stew, best vegetarian and most unique. Soup offerings usually aren't the typical choices you might get at restaurants, with chefs exploring new flavors and combinations.

"Grandmas last year did a pumpkin pie soup and the Township Tavern did a turkey dinner soup that had everything ... it was awesome, so you get pretty elaborate things," Burbank said.

Each year before the cook-off, Burbank talks to the different chefs and gets them fired up about the contest.

"Chefs are naturally competitive and I get them going," she said. "Usually, if there are 10 soups, eight of them are outstanding. ... It is above and beyond

what you normally get anywhere."

The car enthusiast turn out is a little harder to control, with the weather playing a big factor. The event will go on rain or shine.

"There can be no puddles or really rain the day before," Burbank said. "If it has been a nice week and is a nice weekend, we get 100 to 140 cars."

She said the "swag bags" filled with donated items from chamber members is part of the attraction, and every car gets a bag. Around 25 awards are also given out during the car show.

"This event is one car show people look for ... because of the goodie bags and the soup," she said.

The event opens at 10 a.m. on Saturday, with soup tasting beginning at 11 a.m., and there is a \$5 admission to enter the soup area. Entering a car in the auto show costs \$10, but that includes one entry ticket to the soup area, too. Children under 12 years of age can enter the soup area for free. Prizes are typically award around a half-hour before the event ends at 2 p.m.

Village to exit County Stormwater Coalition

Voorheesville trustees cite increased fee in plans for departure

There will be one fewer municipal partner in the Stormwater Coalition of Albany County, after the organization doubled its fees for the Village of Voorheesville.

Village Board of Trustees members signaled their intention to leave the county Stormwater Coalition during a workshop meeting on Monday, Sept. 16, after the annual membership fee for the village was more than doubled to around \$7,300, according to Mayor Robert Conway. The independent coalition relies on membership fees to cover administrative expenses. The agency chose to hire a second full-time employee this year.

Conway said the village had joined the Stormwater Coalition for a “strength in numbers”

approach and possibly to offer some sort of “protection” from state and federal regulations.

“I like the idea of being part of the coalition, because we are always talking about partnering with neighboring communities ... and I see the value of it,” Conway said. “I am not worried that we don’t have capable people to handle it.”

Stormwater Coalition Program Coordinator Nancy Heinzen said as of now, Voorheesville is the only member signaling its intent to leave the organization next year. The Town of Guilderland previously left, but rejoined after less than a year. With Voorheesville’s exit, there will be 10 members in the coalition.

“It is always an unknown if the municipalities will come back and recommit again the following year,” Heinzen said. “Every municipality is trying to decide how to get a handle on these regulations.”

The coalition had received a grant from the state Department

of Environmental Conservation to hire someone for two years to complete mapping of stormwater systems.

“I think the group felt the work of the mapping project was really valuable to the municipalities, and being that the green stormwater regulations are asking more of the municipalities ... it would be a benefit to everyone to expand the staffing,” Heinzen said.

She said the agency also wanted to avoid relying on a student intern when work was entering into the legal territory of the Clean Water Act requirements.

Glenn Herbert, code enforcement officer for the

village, said Voorheesville has been a member of the Stormwater Coalition since it was formed in 2008 to assist municipalities and public institutions regulated by the Clean Water Act. The members, along with coalition staff, worked to implement the Municipal Separate Storm Sewer System (MS4) permit requirements.

“We had joined the coalition when the EPA and DEC was first coming out

and really going after municipalities about cleaning up stormwater from construction sites,” Hebert said, “and doing public education to the people ... to try to get them aware of stormwater and the importance of it.”

Herbert said the village’s zoning law covers “everything the coalition does” and he recommended the village leave it as it is. He suggested keeping \$3,500, the coalition fee before the increase, budgeted to cover any outside contractor help.

“We can save some money here and still do just as good of a job as we were doing with the coalition,” Herbert said. “My feeling is we got a very good handle on this ... we should get out of that coalition and save the taxpayers money.”

The village will be able to rejoin the coalition at any time. Conway said the village would reassess its absence from the coalition after one year and determine if it saved money by not being a member.

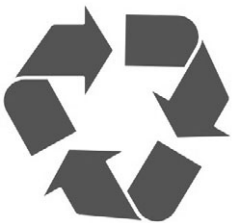
Heinzen said to solve drainage problems more “holistically,” municipalities will need to look at the watershed more broadly.

“We have laid the foundation for the really critical, analytical work

to begin to address the drainage problems,” she said. “We have got the elements of beginning to really solve some serious problems.”

Heinzen said several resources are available the coalition’s website to anyone, but the “full breadth” of services would not be offered to the village once it leaves.

“The reality of the collation is everybody is very aware of the regulations and they have a lot of experience,” she said. “Everybody has something to bring to the table, which ends up very useful when everyone is trying to come up with their own program.”

Guilderland girls post three consecutive shutouts to build big lead in South Division

Halfway through the regular season, the Guilderland girls soccer team is sitting pretty on top of the Suburban Council South Division standings.

Wins over Shaker, Burnt Hills-Ballston Lake and Ballston Spa last week improved the Lady Dutch’s record to 6-1-0 and gave them a three-game lead over second-place Bethlehem (3-3-0) in the win column.

However, head coach Curtis Snyder said he’s not taking a division title for granted.

“There’s still a lot of games left,” said Snyder. “We still have a couple of North Division teams left to play, and then we still have to play the entire South Division again. That will be tough.”

Guilderland’s defense tightened up significantly since the team’s lone loss of the season, a 6-3 setback against Niskayuna (6-1-0) on Sept. 13. The Lady Dutch posted shutouts over Shaker (3-2-1), BH-BL (3-4-0) and Ballston Spa (0-6-0) as they expanded their divisional lead over Bethlehem.

“Even though we had scored more goals than we gave up (through the Niskayuna game), we knew we couldn’t hold up like that,” said Snyder. “So we made some adjustments, and we posted three shutouts in a row.”

Rebecca Golderman started Guilderland’s week in style when she scored the first goal of last Tuesday’s 2-0 win over Shaker. Golderman launched a long shot that bounced off the inside

of the right goal post and into the net midway through the first half.

“It was classic,” said Snyder. “It was probably an inch away from bouncing out, and it hit just right.”

Emma Oliver added an insurance goal in the second half, and the goaltending duo of Carli Weinberg and Taylor Dorado each made three saves to collect the shutout.

Weinberg and Dorado were busier in last Thursday’s 1-0 victory over BH-BL. Weinberg stopped eight shots in the first half, and Dorado made six saves in the second half to preserve the victory.

“We put one in during the first half, and I wasn’t sure it would hold up,” said Snyder.

The Lady Dutch had no such concerns in Saturday’s 6-0 victory over Ballston Spa. Lauren Kogelmann assisted on Abby Marco’s first-half goal and scored two of her own in the second half to lead the offense. Emma Oliver and Alyssa Kogelmann contributed goals, and Weinberg added her first of the season after Dorado replaced her in goal in the second half.

Guilderland has a chance to pad its lead over the rest of the South Division this week. After visiting divisional rival Averill Park (1-5-0) Tuesday, the Lady Dutch meet Mohonasen (1-4-0) Thursday.

Meanwhile, Bethlehem was looking to shake itself out of a two-game losing streak when it hosted Columbia (3-4-0) Tuesday. The Lady Eagles entered the game off a 1-0 setback against Niskayuna last Thursday and a 4-2 loss to Saraoga Springs last Friday.

Goaltender Miranda Manziano stood tall in both games. She made 14 saves against Niskayuna (6-1-0) and stopped 11 shots against Saratoga (2-21).

Winchester wins Super Senior division title at state amateur tourney

Earl Winchester practically grew up on the Normanside Country Club golf course.

"My parents have been members here since 1952," said Winchester. "Except for four years in the service, I've been here every year."

So when Normanside hosted last week's New York State Men's Senior Amateur Golf Championship, Winchester felt right at home.

Ghost tours get underway

Three evenings with paranormal society will be added to this year's program

The Original Albany Ghost Tour isn't just about telling spooky stories. It's about giving people a different look at the history of New York state's capital city.

The 90-minute evening trolley tour of downtown Albany begins Thursday, Oct. 3, and continues through Wednesday, Oct. 30. The tour starts at 7 p.m. at the Ten Broeck Mansion and makes stops at Graceland Cemetery and the state capitol building. Other sites along the tour include the Empire State Plaza, the Cathedral of the Immaculate Conception and the Department of Education building.

As the trip progresses, tour guide and co-organizer Maeve McEneny will tell stories about ghostly encounters in the city, including one her father, Albany historian and former state assemblyman Jack McEneny, told her about a particular picture in the Ten Broeck Mansion – the man with the billy goat beard.

"One day, a psychic came to the mansion and asked to take a tour of the mansion," said Maeve McEneny. "Since it was a slow day, they allowed the

psychic to tour the mansion. When the psychic went into the attic, the psychic found the picture of the man with the billy goat beard in storage. The psychic said, 'This is the angry spirit I've been feeling. This (picture) doesn't belong up here. It belongs downstairs.'"

The tour is run by Harmony House Tours, and there will be some additional support this year from the Tri-City Paranormal Society, a team of professional investigators who examine supernatural activities in the Capital District. The Tri-City Paranormal Society will join the tour for socials on Friday, Oct. 11, Friday, Oct. 18, and Wednesday, Oct. 30, to demonstrate their equipment and talk about some of the paranormal cases they have investigated.

"They (the tour organizers) came to one of our reveals at the Ten Broeck Mansion a few years ago," said Tri-City Paranormal Society founder Gary Robusto. "We were showing evidence to the public for a fundraiser, and they came to see our presentation. We have always wanted to work with them and collaborate ideas with this organization, and now that we have set events for the month

of October we are really excited at this opportunity to work with such great people and a great organization."

McEneny thinks it will add an interesting dimension to the regular tour.

"They have these gadgets that they say can pick up the presence of the ghosts," she said.

McEneny said the presence of older buildings in the city add to the ghost tour's visual experience.

"There's still so much here in the city from its history," said

McEneny. "We can take a walk through the Center Square neighborhood, and people can look around and have an idea what the city looked like back then."

Two historic locations around Albany will highlight the story of Hattie the Hitchhiker. McEneny said the story that starts when a man picked up a young woman walking near Graceland Cemetery on Delaware Avenue one rainy night and took her to her home at the corner of Madison Avenue and Lark Street, which is now Justin's restaurant. When he went back to the house the next day, an older woman answered the door and told him Hattie had died several years ago. So

he went to the cemetery and found his coat draped over her gravestone.

"We can go to Graceland Cemetery, we can go to Justin's and we can follow the path that man took," said McEneny.

Local actors will also be scattered throughout the tour to help tell the stories McEneny learned as a child from her father that put Albany's history in a different light.

"Using these ghost stories were a way to open up the history of these historic sites," said McEneny.

The Original Albany Ghost

Tour runs Thursdays through Sundays in October, and all of the week leading up to Halloween. The cost is \$30 per person, and the three paranormal socials are an additional \$10. Space is limited, but McEneny said she encourages people to call as more 26-seat trolleys can be added to tours.

"We do book up, but we love accommodating as many people as we can. So, don't be shy about calling us," said McEneny.

Festival's secret ingredient is community

Agudat Achim's carrot festival has grown to an annual rite of fall

In Niskayuna, an orange vegetable marks the beginning of the fall season, and it's not the pumpkin.

Thirty-five years ago, the parking lot at Congregation Agudat Achim needed to be paved. Congregation members put their heads together, looking for a way to do something different to raise the funds for the parking lot. They wondered what they had that was unique. The answer was carrots, and lots of them.

Congregation members Paul and Rose Westheimer owned the Carrot Barn at Schoharie Valley Farms where more than 1,400 tons of carrots were produced annually.

"We were able to arrange to get produce from them, and because it was a carrot barn we called it the carrot fest," said Hillary Fink, the chairwoman of the festival.

Fink said the first festival in 1979 was mainly a farmers market. The Westheimers brought their carrots and other vegetables and various farmers from the area brought produce to sell. "The first festival was attended by about 1,000 people, primarily congregants. It was out on the lawn, just like it is now. Produce, cider and carrot juice were sold," Fink said.

The festival was a success, and became one of the community's most anticipated fall events. Over the years, the festival grew and added music and entertainment, vendors, crafters, kids activities and all kinds of foods made with carrots—most notably the festival's signature carrot cake, two layers thick with praline filling and cream cheese frosting.

"People say it's the best carrot cake they ever had," Fink said. "They literally travel for miles and they line up at the carrot tent early in the morning just for a piece of cake."

In July, members of the congregation begin peeling, chopping, baking and stewing hundreds

of carrots to make the different cakes, strudel, breads and even soup.

"They make hundreds and hundreds of the individual cakes, and over 1,000 portions of the signature cakes are sold," Fink said.

Fink said no one really knows where the original recipe came from, but it has been perfected over the years. Festivalgoers often ask where they can get a copy, so a cookbook was compiled titled, "Divine Kosher Cuisine," featuring the congregation's favorite carrot festival recipes.

Besides the famous cake, a variety of other carrot cakes and baked goods are available at the festival, including banana chocolate chip cake, pineapple carrot cake, chunky apple cake, apple carrot strudel, fudge carrot brownies, a number of different types of cookies and carrot bagels.

In addition to hamburgers and hot dogs, the food tent features traditional Jewish favorites such as a brisket sandwich, falafel chicken shawarma, chicken soup with matzoh



ball, tzimmes, knish, potato latkes and Israeli salad. New this year is the addition of a vegetable and beef chili, said Fink.

"The focus is to bring the community together," Fink said. "We have a huge children's area so there are a lot of activities for children to do and give families the opportunity to stay for a long time and enjoy the day."

Also new this year is a



children's Home Depot workshop, running from noon to 2 p.m.

Radio Disney, miSci (The Museum of Innovation and Science), and Reptile Adventure will also be at the festival along with pony rides and a petting zoo for kids.

Entertainment is scheduled all day, including a concert at 12:45 p.m. by Body and Soul, who play a variety of music from the oldies to the top 40.

"We have vendors

The Westheimers sold the Carrot Barn to Richard and Sue Ball in 1993, and they have helped to keep the carrot festival tradition going, although the Westheimers continue to be a part of the festival's committee and are amazed at how much it has grown.

has evolved from a small produce market to a full-fledged fall festival," Rose Westheimer said.

four performances, featuring four different actors. They've all been asked to refrain from even researching the play, and will be handed the script as they step on to the stage.

"I got myself the script and read the script, and that's when I said to myself, 'This just has to be done here.' ... I felt compelled to have it here," said Assistant Director of the UAlbany Performing Arts Center Kim Engel. "I think that it's exciting for the actor and the audience to discover this together."

The never-the-same, off-the-cuff approach to performing the play doesn't mean its creation was thoughtless. Playwright

Nassim Soleimanpour's story is as unlikely as it is unconventional. He put pen to paper in 2010 but never saw the play performed until this year, because Soleimanpour was confined to his native Iran as a conscientious objector to the country's mandatory military service.

Putting a play of this nature onto the stage absent the playwright was a statement in its own right, and the need

to send it abroad was reflective of Iran's cultural censorship. Audiences were encouraged to email the playwright notes during the performances.

The play itself features animal characters that serve as metaphorical devices, and it is heavily influenced by the events and aftermath of the Iran-Iraq War. It also features some audience participation, making it even less likely one performance will mirror another.

"I think that the content, the message, is very important and very timely, especially with what's going on and continuing to go on in that area of the world right now," Engel said. "He is challenging people to think, and to question, and I think that's good."

Soleimanpour was granted his passport earlier this year when, during a physical, it became clear he was actually ineligible for military service. He saw “White Rabbit, Red Rabbit” performed for the first time in Brisbane, Australia.

The play still calls for an empty seat to be left for the playwright at each performance, and evidently Soleimanpour has shown up to performances unannounced this year and sat down to take it in.

In keeping with the play's tradition, four area actors will take the stage for just as many performances. Chad Larabee, a visiting assistant professor in the UAlbany Department of Theatre, will take the stage

Oct. 2; NewsChannel 13 anchor and local actress Benita Zahn will appear on Oct. 3; Yvonne Perry, a freelance actress who has numerous local credits to her name and spent time on the television show "As The World Turns," will perform Oct. 4; and professional actor and Albany High School teacher Ward Dales will round out the experience on Oct. 5.

Doing a cold read in front of a live audience presents a unique challenge, Larabee said, but it's one he's excited about. The actors only know they'll be walking onto a stage with a chair and a bottle of water, and be handed an extensive monologue.

"It is exhilarating and terrifying at the same time, to really not know what you're in store for," Larabee said. "It's also liberating. From the little bit I know the material is quite powerful and engrossing, that it doesn't require more than your presence and your truth."

One might imagine performing under such circumstances and without preparation would be restrictive, but Larabee sees it as potentially liberating.

"It forces you to approach it blindly, to really trust the playwright that he's doing his job. ... Everything's immediate and based on what is happening on the page," he said.
