



# Making connections

**Ricky the Robot** teaches Glenmont first graders about technology

Peter Rawitsch bought his first robot more than 25 years ago from Toys 'R' Us.

The Glenmont Elementary School teacher made the purchase in an effort to introduce technology to his first-grade students. Nearly 30 years later, the technology has improved, but the heart of the lesson where the "turtle" moved. has remained the same.

"This is their future, so it's always better to start them early,' said Rawitsch.

One of Rawitsch's first robots was a Terrapin Turtle, which plugged into an early Apple computer. Rawitsch said the mechanism looked like a motor on wheels with a large bowl on top. Using the sensors installed in the robot, students were able to control

# V'ville ambulance contract talks stabilize

Village and service company near agreement after sheriff intervenes

Voorheesville Area Ambulance Service members and village officials have locked horns for months over contract differences, but in recent talks, the atmosphere has become surprisingly civil as next year's agreement deadline nears.

At the village held contract negotiations with its ambulance service, located next to village offices,

during the Voorheesville Board of Trustees workshop before the Tuesday, Nov. 26, regular meeting. The mood appeared to have shifted, with ambulance service representatives and board members possibly approving next year's contract before the Dec. 31 deadline or soon after.

The current contract was not approved until more than seven months after the deadline, but Voorheesville Mayor Robert Conway said he does not see that happening this time around.

"There are still a few items that we need to resolve, but I am hopeful that they will come to a resolution pretty quickly," Conway said. "I don't know if it is going to be done exactly for January 1st, but the feeling I have right now is that it will be settled much sooner than later. This past contract wasn't settled until well into the summer. I can't envision this one going that long.'

Ambulance service representatives left the meeting feeling positive that progress was being made.

The lines of communication have been opened and improving of recent. There is definitely some

# One for the books

**Colleagues praise** retiring Voorheesville **Library Youth** Services director's passion and creativity

Connecting with young readers of all ages is what attracted Joyce Laoisa to Voorheesville Public Library around 16 years ago. Although a library's role has changed over time, her mission to inspire children remained steadfast.

Laoisa started out at Bethlehem Public Library while studying for her master's degree. A larger library, though, usually assigns a children's librarian to a particular age range, and Laoisa was interested in working with all ages. She didn't have to look far to find the job she wanted.

"At a big library, you have to choose to work with young children or teens, but at Voorheesville, I could do both," Laoisa

Gail Sacco, the director of Voorheesville Public Library who hired Laoisa to be director of Youth and Family Services, said she was perfect for the position.

"Joyce is very creative, and she has that gift of seeing the library through the eyes of the child," Sacco said. "There are people that work with kids that always see themselves as adults and the kids as kids, but it is a gift to be able to see somebody through their eyes. She does that with kids and ... with kids of all ages."

Voorheesville library will hold a retirement party for Laoisa on Sunday, Dec. 8, from 3 to 5 p.m. in its community room. Anyone is welcome to attend, and there will be light refreshments and holiday cookies.

Mary Fellows, regional consultant for Youth Services of Upper Hudson Library System, said she is going to miss Laoisa as a colleague and praised her work with the community.

"She is very innovative in her work at Voorheesville Public Library," Fellows said. "She takes risks and tries new things. She connects very creatively with her community, and in doing all of these things, she is a role model for local librarians."

Fellows said Laoisa has mentored many colleagues in the Upper Hudson Library system

and has reached out to other libraries and "very generously" offered her experience, knowledge and help.

"She has shown them what it is to be an active, creative professional librarian and give wonderful service to your community," Fellows said. "She passionately cares about kids, tweens and teens, and it is her mission to help them really enjoy the best literature and the best experiences that a public library can offer.'

Sacco said Laoisa expanded the breadth of children and family services at the library, including offering more parenting resources and paying more attention to tweens and teens.

Laoisa said libraries are where new parents go to find a network of people to support them and also begin to see the library as a part of the community.

"It gets you in the rhythm that libraries are places to meet, talk and get to know each other," Laoisa said. "I feel that (libraries) are a part of the community and they are a resource for the community."

Reaching out and connecting with an increasingly tech-savvy

community, particularly children, is no easy task,

"The fact that people are so involved with television, videos on YouTube and Netflix, they sometimes fail to realize all of the offerings a library has," Laoisa said.

Fellows said Laoisa was great at finding a book to connect with any reader.

"She is an extraordinary book talker," Fellows said. "If you want to know what to read next, no matter what age you are, she is the Library Association exhibit incorporating math and picture books. Laoisa said she was always be looking for grant opportunities to expand the library's offerings.

Sacco also pointed to a quilting program she brought to the library called Nimble Fingers and worked to develop a Junior Nimble Fingers group to teach children the craft.

Laoisa also worked closely with librarians and teachers at Voorheesville Central School District, Sacco said.

One program at the middle school has students picking out books they wanted to read and then reviewing the book, with the reviews posted on the library's website. Sacco said this helped children learn to evaluate what they read and present their

Laoisa said she has learned to become more understanding of not only children, but parents as


"I think over the years, I really grew to appreciate how hard parents work to get kids to library programs and take them out and help them pick out books," she said. "Parents are really trying so hard to do the best for the kids.'

Laoisa said she is "going to miss a lot," but it's time for her to retire.

"I am going to miss seeing the children," she said. "I am going to miss the collaboration with librarians."

She is looking forward to seeing her grandchildren in Wisconsin whenever she wants and also freeing up her summers, which were consumed by the popular reading program. She has two grandchildren and three sons. She and her husband, David, have spent the majority of their married life in the Town of Bethlehem.

Laoisa will still be connected to young readers in retirement, because she will be serving on the Association for Library Service to Children's Notable Books for Children Selection Committee.

# Lights to aid in emergencies

**Donation allows Selkirk Fire Department to** purchase portable generators

Late-night shifts for the volunteers of one local fire department will no longer be so dark following the purchase of several lighting units.

PSEG Power NY's Bethlehem Energy Center donated the funds to the Selkirk Fire Department just before Thanksgiving for the purchase of three portable generators with lighting units.

"We were happy to support our local firefighters so they can work safely in emergency conditions," said BEC Plant Manager Bill Clancy. "Each year, we invite them to tour our station to get to know the facility in the event of an emergency and to foster a safe work environment."

During emergency situations and nighttime calls, fire officials often found the lighting to be inadequate. Nancy Tucker-Datrio, a spokeswoman for PSEG Power NY, said the energy center was happy to help local firefighters in need.

The energy company donated nearly \$6,000 to the Selkirk Fire Department for the purchase of the equipment. Bethlehem Energy Center is a natural gas power plant that is owned and operated by PSEG Power NY.

District Fire Chief Bill Asprion said the portable units will be used to help in efforts to fight brush and structural fires where electricity is not readily accessible. It will also help with search-and-rescue efforts in wilderness areas and pumping out water during large storms.

Selkirk Fire Department is made up of three fire companies with 75 volunteer members. The department serves 15,000 residents and businesses in a 32-mile radius.

"These units are critical to protecting the safety of our first responders. We are very fortunate that PSEG Power NY was so generous in their support," said Asprion.



# **Local bugler** answers the call

VanAmburgh among those picked to play at Kennedy memorial

The day President John F. Kennedy was buried, Sergeant Keith Clark — the Army bugler playing "Taps" — made a single mistake some refer to as the "broken note" that reflected the sad feelings of the whole country.

On Saturday, Nov. 16, the U.S. Army band and more than 100 buglers from around the country gathered to pay tribute to JFK, who is buried in Arlington National Cemetery.

Zachary VanAmburgh, a 13-year-old Shaker Junior High School student, was among them.

VanAmburgh was in Arlington representing Boy Scout troop 62 of Latham. The young trumpeter became interested in learning how to play "Taps" in the scouts and picked up the bugle. Through practice and dedication, he taught himself how to play "Taps" by listening to it repeatedly until he had figured it out.

"I thought it'd be cool, so I started to listen to 'Taps' and then figured out how to play it," said VanAmburgh.

The story of Keith Clark is legendary in the bugling community. Two weeks prior to JFK's assassination, Clark had played "Taps" for the President at the Tomb of the Unknown Soldier on Veterans Day and as usual did not miss a note. Clark was known as a perfectionist, and it was out of character for him to make a mistake, especially on the sixth note of "Taps."

The not-for-profit organization Taps for Veterans sponsored the event titled "A Bugle Call Remembered: 50th Anniversary of Taps — JFK." Clark died in 2002 and was also buried in Arlington.

VanAmburgh applied to participate in the ceremony by sending in a video of him playing "Taps" and was accepted. He was one of only four scouts to participate and one of the youngest. The oldest bugler in attendance was 91-years old.

VanAmburgh's mother, Julie, has always been interested in JFK, which is how her son became interested in playing "Taps" at the ceremony. His father, Sam, an Army veteran, has instilled the values of the military in his son, which is one of the reasons he has been so successful in Boy Scouts.

VanAmburgh said he plans to make Eagle Scout and join the Army. He has been the bugler for his Boy Scout troop for the last four years and has played "Taps" at flag retirement ceremonies presided over by his father.

The group of 120 buglers all played "Taps" together and then spread out in different sections of the Arlington Cemetery, where they played it solo.

"It was an honor," said VanAmburg, and that the best part of the trip, "was playing 'Taps' with the military buglers."

# Perspective owners go for chains

Franchise trends see retirement funds tapped; semi-absent owners

More people are cashing in their retirement savings to open up a franchise business, according to consultant Frank Dunne, with more than half of clients he has placed this year tapping such funds.

Dunne, a strategic franchise advisor in the Hudson Valley for FranNet, said most people probably have a similar thought when thinking about a franchise business, but the type of offerings is much broader.

"The first thing I think people think of is McDonald's and Dunkin Donuts and that kind of thing," Dunne said. "Really, those types of franchises only represent 6 percent of the entire franchise pie."

As the economy continues to recover, Dunne said he is seeing

more people not only tapping their savings to open a franchise, but also being semi-absentee owners. This allows the franchise business owner to keep their 9-to-5 job while also managing their own business.

"Most of the semiabsentee opportunities tend to be retail in

nature because they all have a fairly common template," Dunne said.

FranNet, which offers franchise c o n s u l t i n g services nationally, also says the odds for success are greater through of a franchise rather

for success are greater through opening a franchise rather than starting a business from scratch.

The company conducted a fiveyear study starting in 2006, which revealed approximately 92 percent of its franchise placements were open two years later. This compares to around 62 percent of small business ventures continuing operations after two years, according to U.S. Census Bureau studies. After five years, its franchisees saw 85 percent still in business, opposed to 50 percent of small businesses,

according to FranNet.

"Franchising has long enjoyed a reputation of being successful because of its systems," Dunne said. "You are mitigating the risk because you are following the franchisee's system."

New York state, though, does lag behind developing franchises

compared to some other states, Dunne said. He pointed to one largerscale franchise owner in the area that recently opened 20 Menchie's Frozen Yogurt locations.

The demographics of people looking towards opening a franchise are also changing from the budding entrepreneurs to individuals looking towards a new career. Sometimes this change comes after being laid off and not being able to find a job, Dunne said.

"There was time when the majority of people who sat in our workshops were aspiring entrepreneurs ... but the majority of the people we see now are in career transitions," he said. "The job market is not what it used to be, and there are really a great many of people that don't have the same opportunities that were available to them a few years ago."

About one third of franchises require a \$100,000 investment, Dunne said, either through a loan or personal capital. According to Dunne, there is a way to craft a "funding cocktail" through

using retirement funds, Small Business Association loans and private funding.

Using retirement funds to open a franchise business without accruing any penalties can be done, Dunne said, but it is "quite technical" in nature. He said the company works with "firms that have a pretty good defense record."

Dunne is moderating a franchise ownership forum the morning of Wednesday, Dec. 4, at the Albany Chamber of Commerce. The forum is being hosted by the state Small Business Development Center.



In 2012, Navy Veteran Tom Regan was looking for a way to honor the 1200 Capital Region veterans who have served from World War II to the present and who paid the supreme sacrifice — their lives — for our freedom.

It was then that he launched "Operation: Please Remember Me" — a project that commemorates those who gave their lives by raising 120 American flags on utility poles in Colonie from Route 9 to Route 155 from Memorial Day to July 4. Each flag represents 10 fallen heroes.

Tom met with local leaders and representatives from National Grid, Verizon, Trustco Bank and the Department of Transportation. He recruited volunteers for placing brackets and flags. And he solicited funds

from local area businesses and veteran organizations.

On May 18, 2013, a motorcade procession led by Gold Star Families proceeded along Route 9 (originally known as "The Military Highway") to kick off the operation.

"We remember their sacrifice, and the families they've left behind," said Tom, whose fellow serviceman and friends gave their lives in Vietnam. "I hope we will continue to pay them tribute well into the future."

Tom's dream was to honor these heroes.

And he is our hero for keeping their memory.

# Let the children play

Building a large, commercial enterprise next to a cemetery will always raise some concern. After all, you're talking about the potential for additional traffic and noise near the final resting place of family members or friends. It's a highly personal matter.

Therefore, it's no surprise that Afrim Nezaj's proposed four-field soccer park next to Memory Gardens in Colonie is generating pushback from the cemetery's owners and people who either own plots or are visitors to the cemetery.

While we understand their concerns, we believe these two entities can coexist as good neighbors.

The primary concern being voiced by opponents is that noise from the youth soccer games will interrupt the solemnity of funeral services at Memory Gardens. Nezaj had hired Chazen Companies to test the sound levels at a soccer complex in Rotterdam while five youth games were being played, and the recordings found the decibel levels to be below the normal level of conversation (60-65 dBs). And if that noise has to travel more than 100 feet to a gravesite, it shouldn't be enough to interrupt a funeral service. In addition, there will not be a public address system at the fields.

Others worry about the possibility of people parking at and crossing through Memory Gardens to get to the soccer complex. To address that, Nezaj stated he will build 377 parking spaces at the complex, and he is willing to construct a fence along the border with the cemetery to prevent people from cutting through.

If the soccer complex is approved, though, the Town of Colonie should hold Nezaj to his promises of being a good neighbor. After all, it's easy to make those promises when you want something; it's another thing to follow through.

What about the 75-foot high light towers and the multi-use sports dome that opponents say will detract from the natural beauty of Memory Gardens' surroundings? The land Nezaj plans to purchase is currently zoned for commercial use. If a developer bought the land and built an office park there, a series of three-story, brick-and-glass buildings has far more potential to be visually distracting than light towers and a dome?

As for the lights themselves, they shouldn't pose a problem for Memory Gardens. These days, athletic field lights are engineered to shine directly onto the action. The amount of light pollution leaking from the fields is minimal. And generally speaking, funerals are not held in the evening. Odds are, visitors to Memory Gardens will not see the lights from the soccer complex when they are turned on for evening games.

There are always the traffic concerns. The area of Watervliet-Shaker Road where Memory Gardens is located and Nezaj wants to place his soccer complex is a tricky one, as the road narrows from four to two lanes before widening again at the intersection with New Karner Road. However, Nezaj said he plans to build his entrance at the intersection of Watervliet-Shaker and Sand Creek roads, where the roadbed is currently wide enough to have turning lanes in both directions. Also, there is a traffic light at that intersection. It would just need to have a light devoted to the soccer park entrance to properly control the traffic flow.

Beyond the light and the turning lanes, traffic around youth soccer complexes doesn't differ much from traffic around youth baseball complexes or schools. You'll have some busy times as parents take their children to and from the fields, but it will be staggered. And with weekday games starting around the tail end of rush hour (5:30 to 6 p.m.), it shouldn't add too many more vehicles to that part of Colonie.

Nezaj seems willing to do what he can to address the concerns being brought up by Memory Gardens and its supporters.

"I respect what they do; they should respect what I do," Nezaj said in a Nov. 13 article in the Colonie Spotlight.

If the soccer complex is approved, though, the Town of Colonie should hold Nezaj to his promises of being a good neighbor. After all, it's easy to make those promises when you want something; it's another thing to follow through.

# How to give gifts from the heart

The holidays offer parents a perfect opportunity to teach kids of any age about the spirit of giving – not just to family and friends, but to those in need.

There are so many ways to introduce our kids to the beauty of compassion and thoughtfulness, and we're fortunate to have wonderful programs, both here in the Capital District and nationwide, where people can volunteer or gift things like toys, coats and meals.

Speaking of wish lists, many nonprofit organizations have them. Check websites, or call an organization to find out how a child can be personally involved.

Here are two specific charities where even the smallest gift makes all the difference:

Because Modest Needs is crowdfunded, even \$1 or \$5, when added to other donors' money, will save an individual or family from entering the cycle of poverty. With your help, children can visit the website, recommend an application to donate their dollar(s), and watch every day as more people add more donations. Best of all, once the request for help is funded, the recipient leaves a thank you "testimonial" on the website for your child to read and learn firsthand what a great impact is made with every dollar.  Ronald McDonald House Charities of the Capital District provides stability, housing and other resources for families so they can stay close by their hospitalized child at little or no cost. Kids can pop the tabs off soda/juice cans (or any cans) and collect them. # On the right path

V'ville party to celebrate Rail Trail portion opening; further improvements eyed for bicyclists

Friends of the Rail Trail will celebrate the official opening of a new three-mile section running through New Scotland as efforts continue toward expanding the trail's size and usage.

There will be a ribbon cutting at 1 p.m. on Saturday, Dec. 7, at the beginning of the new section of Helderberg Hudson Rail Trail in Voorheesville, near the intersection of Voorheesville Avenue and Grove Street. The new 3-mile section of the trail extends from that intersection to Upper Font Grove Road. After the ribbon cutting, there will be a holiday party at the American Legion located at 31 Voorheesville Ave., with anyone welcome to attend.

"We have been working on it for quite some time, and just this fall, two bridges were made suitable for pedestrian use," said Mark King, director of the Mohawk Hudson Land Conservancy. "It is a social gathering for folks to talk about what has happened, celebrate the successes and the future of the whole project."

Volunteers recently finished improvements to the Vly Creek bridge in Voorheesville, including constructing railings and a new deck to safely span railroad ties. improvements were also finished on the village bridge over Route 155, including installing fencing on each side for pedestrian and vehicle safety. Additional trail cleaning and mowing was done before opening the new portion.

The new three-mile portion is limited to pedestrian usage because of the existing trail surface quality and some unprotected, steep sections. King said bicyclists should not worry about being overlooked.

"This is an initial step to get folks exposed to what is out there and the opportunity that lies ahead to make this into a real first-class bike path," King said. "It has really been a great supportive effort in the Bethlehem section, and I think people appreciate it and they want more — to make it a real bike trail."

King said certain improvements must be made before bicyclists are approved to use the trail, with some steep drop-offs being a primary concern.

Albany County has started engineering and design work for a portion of the trail stretching from the South Pearl Street in Albany to the underpass on Delaware Avenue. That section would be completed as a paved, shared-use path for pedestrians and bicyclists.

The county is receiving federal grant funding to pave that portion of the trail, and King said additional grants are being sought to pave the rest of the Rail Trail.

"People are already out there using it and saying good things about it," he said.

King said getting the Rail Trail to this point has taken "a lot of work" over more than 20 years. The Friends of the Rail Trail volunteer committee, which formed out of the Land Conservancy, has worked to promote the trail and continue progress.

"It has involved tremendous numbers of people and a lot of effort from a lot of people to keep that momentum moving," he said. "We have been working really at a very grassroots level of getting local folks that are concerned and dedicated to the project to channel their energy ... instead of waiting for grants



# **Girl Scouts make fabric flowers for seniors**

#### Gathering one of the first to involve almost all Bethlehem troops

After moving to Delmar from New York City last year, Amelia Dombrowski wanted to send her mother a gift that lasted.

A costume designer who began offering sewing, craft and fashion classes to children last spring, Dombrowski got the idea to make flowers out of fabric and send them to her mom.

"I was someone who lived far away from my grandparents, and my kids live far away from their grandparents," said Dombrowski. "I wanted to find a way for kids to be able to interact with older people in a meaningful way."

Dombrowski said her mother had often worked in nursing homes and suggested having kids, possibly from her classes, make the flowers to give to local seniors. A friend then connected Dombrowski with Julie Levin, leader of Bethlehem Girl Scout Troop 1209.

With the holiday season approaching, Levin decided to hold an event for her own Girl Scout troop where Dombrowski would teach the girls how to make the flowers. The girls would then deliver them to local senior organizations in person.

Soon, word spread about the event and more Bethlehem Girl Scout troops wanted to join in. Eventually, girls from nearly all 50 troops within the Bethlehem

Girl Scout community wanted to participate.

"It's one of the first times we've all got together," said Heather Rutski, leader of Troop 1936 and Bethlehem Girl Scout Community chair woman. "We use to be three separate communities that never interacted with each other.

Because there was such a large interest in the event, Levin decided to include other activities. While the older girls were taught how to make the fabric flowers by stitching together pieces of felt, others made holiday cards to send to soldiers stationed overseas through the American Red Cross' Mail for Heroes campaign.

As "admission" to the event, girls were asked to collect old children's clothes from members of their family. All of the clothes were then donated to Mary's Corner, an organization through Ladies of Charity of the Diocese of Albany, which provides food, clothing and toys for infants and toddlers.

"Helping other people is the Girl Scout way," said Levin. "This is event being so large, I never could have imagined. I didn't think on a Saturday we would get so lucky."

There are nearly 200 Girl Scouts within Bethlehem's 50 troops. More than 100 girls participated in the event, and Levin said she hopes more activities will be planned for all Girl Scouts townwide.

The girls plan to deliver the homemade flowers throughout December.





# **Bethlehem clarifies** residency requirements

#### **Town board also drops longevity payments** for elected positions

The Bethlehem Town Board made changes to a local law that would establish residency requirements for certain town officials.

The measure was passed on Tuesday, Nov. 26, with unanimous support from town board members following a public hearing. No members of the community spoke in favor or against the proposed changes.

Supervisor John Clarkson had previously said the town law already had a provision in place but was not very specific about which positions were covered. All elected officials must live in the town, but the provision covering other employees wasn't as clear. The new requirements will more closely follow state law.

Clarkson pushed for the the Town of Bethlehem or residency requirements, town justices ... are willing pointing out the issues that can happen when a local law supersedes state law on the issue. As an example, he pointed to former Bethlehem Supervisor Jack Cunningham becoming the Colonie Commissioner of Public Works even though he didn't live in the town.

At the Nov. 26 meeting, residency was established for department heads and most board positions in the town, but some positions can be grandfathered in for exemptions, such as those of long-term employees. The town can also waive the requirement if officials are looking for a certain skill-set that isn't found within the town.

According to the memorandum, the town 'will continue to recruit broadly and will make every effort to identify qualified town residents for town positions. Out-oftown applicants for these position will be told that relocation to Bethlehem

At a previous meeting, will be necessary unless to grant a specific waiver.'

## **Employee salaries**

At the same meeting, the town board considered a change to the town policy for longevity payments of elected officials.

Longtime employees often receive longevity payments as part of promotions in addition to step increases and costof-living adjustments. Employees who have worked for the town for some time and then have run for elected office, such as former Highway Superintendent Gregg Sagendorph, have been eligible for these increases.

"This has given us concern because we have to treat all equally who stand for election and are elected to a position," said Clarkson. "We can't pay one person differently than another, however the practice had been the policy didn't differentiate between elected and nonelected officials.'

The new policy will take effect on Jan. 1, but employees already receiving longevity payments would be grandfathered in and would not have their pay decreased.

Elected officials who are department heads and the town supervisor will only receive salary adjustments for cost-ofliving increases during the town budget process. Clarkson said some of the added language had been the norm for some time, but had not been written into the policy manual.

The changes were passed by a unanimous vote from the town board.





progress ... being made between the squad and the village at least in regard to some meaningful communications," VAAS board member Jason Windsor said. "Some of the little things that have been stumbling blocks are getting worked through."

Albany County Sheriff Craig Apple reached out to the squad and village and recently acted as a mediator between the two parties. The meetings appear to have paved the way for less contentious negotiations.

"The meeting with the sheriff kind of clarified some things for everybody," Conway said. "We are all trying to get to the same place, and this is how we get there. I think maybe some of the inflammatory rhetoric has kind of gone by the wayside at least for know."

There was new language added into the proposed contract, spurred by the meeting with Apple, that would have the town, village and VAAS study and develop a comprehensive plan for townwide ambulance services. The contract language also states such a townwide plan would be implemented by 2015.

"Our ultimate goal is to reach a long-term planning process for the future of the agency to be able to cover the Village of Voorheesville and Town of New Scotland," VAAS Captain Ray Ginter said. "We need to move forward with the times, the volunteerism, the money aspect ... to make sure the residents have a viable ambulance service that they can rely on."

The only reservation expressed by some village board members was implementing the townwide plan by 2015. Conway said the board agrees to the concept though, but worries it could take longer to implement.

"It is definitely something that needs to be addressed and looked at long term," Conway said. "It is not going to happen overnight, but I think it is definitely the way it will be handled down the road."

An agreement has not been reached over how reserve funds would be handled, which was the main sticking point for village board members during this year's contract negotiations.

The village board reluctantly awarded approximately \$8,800 in reserve funds to the

Spotlightneys We're just a click away ambulance company to finalize this year's contract after refusing to approve the funds for several months. Board members indicated they would prefer municipalities handle such funds going forward and distribute the money to the company when needed, such as when purchasing a new ambulance.

Conway said the village has been in touch with the state comptroller's office and other professional organizations to evaluate how the municipalities could hold reserve funds and then transfer them to the company.

"That has not been fully vetted at this point," Conway said. "My impression ... is the ambulance service is open to that discussion."

Conway said the contract is similar to what was proposed by the village last summer before its changes were removed to end negotiations.

"Some of the language changes are language that we had offered up last year, but ended up pulling it," Conway said. "There is definitely a movement towards common ground there."

The Voorheesville Board of Trustees' next regular meeting will be held on Tuesday, Dec. 17, at 7 p.m., with the board's workshop meeting held earlier that night at 6 p.m.

The Glenmont teacher's current first-graders are getting a much different experience with the introduction of Ricky the Robot, who looks more like a person and has more functionality.

Rawitsch said he was introduced to Ricky at the third annual Tech4Teaching Academy held over the summer at Bethlehem Central High School. Ricky is a "humanoid robot" operated by the Capital Region BOCES' Northeastern Regional Information Center.

"As soon as I saw Ricky I fell in love, and I knew this was something first-graders would fall in love with," said Rawitsch.

Ricky is mainly operated by Hilary Dee of NARIC. The pair travel to schools throughout the Capital District and help students of all grade levels learn about programming. Older students learn how to code Ricky's functions themselves using the Python Programming Language. Younger children, like those in Rawitsch's classroom, learn a more simplified version.

Ricky visits Glenmont Elementary once a month. In November, each student in Rawitsch's class programmed Ricky with a riddle and clues that the other students were asked to guess the answer to.

Students worked with

Dee in a separate room throughout the day. Every boy and girl was given a different riddle, and Dee then helped the children program Ricky with the answer and three clues. To give each clue, the children pressed a different part of Ricky's head. Answers were given by pressing Ricky's feet.

Dee said working with the robot not only helps students learn about programming, but also helps with fine motor skills, reading and

writing, problem solving and communication skills. Students needed to type the clues and answers into different boxes. Then, they used the computer program to connect inputs and outputs so Ricky would react when specified areas were touched.

At the end of the day, each student was asked to stand before the class and help Ricky give the clues to their riddle. The student could call on a friend, and if they answered right, Ricky would give the answer and

wipe his brow.

Rawitsch said he thinks Ricky is easier for smaller children to interact with because he looks more lifelike than prior generations of robot technology.

"I'm trying each month to introduce them to different capabilities of the robot," said Rawitsch. "Last month, we learned how to make the robot say our words. The kids wrote stories and typed them into the program to make Ricky read them."

By the end of the year, Rawitsch said, he would like his students to be able to program Ricky using all of the skills they have learned.

Rawitsch said one of the challenges to his technology-based unit over the past few years has been the state's implementation of Common Core standards. The new guidelines have made it harder for Rawitsch to find the time to incorporate the unit into his lesson plans.

"At this time, the Common Core is narrowly defined as reading, writing and math skills. It does not include social studies and science, and Ricky is a great way to bring those lessons to life," said Rawitsch. "Bringing the robot in allows us to integrate some of our reading and writing with technology."

# Home for the holidays

oliday traditions may have been a little different in the late 1700s when the iconic Ten Broeck Mansion was built atop an Albany hill, but more than 200 years later, the historic home continues to welcome visitors for the holidays.

Tucked away in the middle of the Arbor Hill neighborhood sits a mansion filled with stories of long ago. The home, which was named "Prospect," was built in 1798 for General Abraham Ten Broeck, a Revolutionary War hero, his wife, Elizabeth Van Rensselaer, a Dutch patroon descendant, and their five children.

"At the time, it was all countryside with a view of the Hudson River," said Wendy Burch, Ten Broeck Mansion executive director.

The Ten Broeck family called Prospect home until Abraham Ten Broeck's death in 1810 followed by Elizabeth's death three years later.

Over the next 30 years, the character of the house and surrounding area began to change. Thomas

# Dance series aims to bring crowds to their feet

Old Songs hosts monthly gatherings featuring simple moves and a social element

Dancing isn't everyone's favorite activity, but one local man bets he can get even the most reluctant of dancers off the sideline and moving in no time.

Paul Rosenberg, of Homespun Community Dancing, has led community dances for more than 25 years. Still, Rosenberg will admit he wasn't the most outgoing dancer until he found his calling.

"For me, who was a very shy person about dance, I was so scared I would hide in bathrooms at weddings when the music would start," he said. "The thing that is great about the community dance is that anybody can do it from age 4 to 94. You can go at your own pace, and when you go at your own pace, you are part of the community."

Last month, Old Songs in Voorheesville kicked off its 2013-14 Community Dance series, which

Olcott, a prominent banker and philanthropist, purchased the mansion in 1848 and renamed it "Arbour Hill." The neighborhood began to grow as the Erie Canal developed through town, and many of the workers made the area around the mansion their home.

"There was an influx of all different people. Immigrants were working on the canal, artisans and servants working in the mansion all lived close," Burch said. "On Ten Broeck Street, on the eastern border of the property, there were very grand houses known as 'Millionaires Row.' They are still here, although most of them are broken up into apartments now."

Burch said the Olcott family and descendants owned the house for 100 years, however the lives of the two families live on through stories told within the mansion thanks to the historical association.

"It's a hidden gem in the midst of Arbor Hill," Burch said. "The Albany County Historical Association has had the mansion since the 40s. We operate it as a historic museum and cultural education center."

Burch said for the most part, all of the furnishings in the mansion are antiques from the Greek Revival period.

"We have interpreted it to a slightly later period than it was built. It reflects an 1845 feel," she said. "It was originally a Federal style house. The Olcutts added Greek Revival."

The society hosts a slew of events inside the historical home throughout the year from weddings to live concerts.

"We have tours, lecture series', concerts, exhibits, special events and really beautiful gardens that are spectacular in the spring and summer," she said.

In December, the society gives visitors a chance to step back in time and enjoy the holidays inside the mansion. Local florists and designers come decorate the interior with festive holiday decor.

"Every year the decorations are always different. Everyone is so ingenious. This year, they are excited with the theme 'Once Upon a Time.' They are coming up with fairy tales and stories," Burch said.

The festivities go on all month and include a holiday shop, a holiday tea, musical events, a children's story hour and more. On Saturday, Dec. 7, the mansion is open to give visitors an opportunity to explore.

"We will have music, a cookie walk, crafts for children and Sinterklaas will be on hand to greet the visitors and pose for pictures," Burch said.

The holiday shop will also be open during the open house where visitors can find handcrafted jewelry, holiday decorations and framed prints among the items available.

Burch said one of their most popular events during the holidays is the holiday tea.

"You come in and there is a selection of baked goods and refreshments. Tea is served, you sit down at the tables and enjoy the atmosphere or walk around," she said. "There are not that many 18th century mansions where you can sit down and enjoy a meal."


The event has been a holiday tradition at the mansion for close to 20 years.

is held monthly on the first Saturday through May. Rosenberg, who helps organize the series, will be calling the Dec. 7 dance featuring FireFlies, and people will be able to learn various dance styles, from contras to squares. At each dance there is a "covered dish supper" at 6 p.m., with the music lasting from 7 to 10 p.m. Admission is \$8.

"It is very good for the community because we offer something that nobody else offers in the community," Andy Spence, executive director of Old Songs, said. "It is to have a good time and get out of the house on a Saturday night and get some exercise."

Rosenberg said around two years ago he started "testing the waters" for interest by hosting dances at the Delmar Reformed Church. He also earns his living by calling an estimated 200 dances annually.

The whole idea for this dance series grew out of the tremendous success we have had ... playing at private parties, events and celebrations," he said.

Rosenberg broke out of his fear of dancing around 30 years ago when he was introduced to contra dancing, which he said is "hard to explain in words."

He described contra dancing as basically a more sophisticated form of group dancing. It is performed in long, parallel lines, generally with men facing women, and a couple will dance with another couple for

a little bit before going on to the next couple.

For the community dance series, he opts for a simpler take on contra dancing that's more accessible and easy to pick up. He said this allows people who might only want to attend dances occasionally to enjoy themselves.

"I felt like we needed to do something that was simpler than contra dancing for people that didn't want to come all the time and continue to improve," he said. "They are dancing with pure joy. It is not a matter of having to do anything right. It is a matter of being there and moving to the music."

Rosenberg said contra dancing has been spreading across the country, with communities sprouting up to support the complex dances.

Spence said Old Songs has been holding dances, along with contra dances, for a long time. Holding the dances also plays into keeping traditions going.

"It is part of Old Songs' mission to keep traditional music alive, and all of these dances are done with live music," she said. "The bands are good and the callers are good."

There are different performers playing music for the local dances, but the style tends to fall around what people would think of as Celtic or Appalachian, Rosenberg said. Nearly all bands will have a fiddler. FireFlies will have a flutist, which doesn't often accompany contra dances.

The music is very joyous. The music just lifts people," he said.

He said the music tends to be similar to the "natural rhythm of life," which is one's heartbeat and

Being in a large group, with everyone doing the same movements, he believes also helps people loosen up and feel the beat.

"There is something very appealing to being in a community type dance setting," he said, "I think it really goes back to thousands and thousands of years ago. This type of dance has been done since people realized you can move to music.'


