Crossgates ready to make room for more

Expansion would include space for two restaurants and two entertainment attractions

A small expansion at Crossgates Mall is planned to make way for two new restaurants and two entertainment attractions, but Guilderland planning board members were concerned about the lack of information provided at a recent meeting.

The Town Planning Board on Wednesday, Dec. 11, unanimously approved a preliminary site plan to

construct a two-story, 20,860-square-foot addition at Crossgates, which would expand the mall's space to lease by 2,100 square feet. Several conditions were attached to the approval, which generally included providing a more detailed site plan before the Zoning Board of Appeals reviews the project.

Robert Sweeney, the lawyer representing Crossgates, declined to disclose any potential businesses outside of being two restaurants on the first floor and two "entertainment venues" on the second floor. He also would not disclose if any agreements

Help is at hand

Bethlehem High School's 'digital natives' staff student help desk

With budget cuts looming and needed technical repairs increasing, Bethlehem High School's Tech Services Department had an idea. Why not establish a student help desk similar to ones already in place at many colleges and universities?

"Students are digital natives,

having grown up with much of the technology that exists today," said Chief Technology Officer Sal DeAngelo. "We have chosen to tap their innate comfort with technology to create a program where they can build skills and earn credits, while providing tech support to fellow students, teachers and other so-called digital immigrants."

The program is now in its second year and has already been deemed a success. Overseen by the school's two network and system engineers,

Mine owner seeks to expand

Limestone quarry site would almost double if town grants approval

Local excavation contractor Peter Frueh is asking the town for a permit renewal to expand the mining site he owns on Old Quarry Road.

The proposal would see the existing limestone quarry expanded from 5.3 acres to nearly 10 acres, and would lengthen the so-called "life" of the quarry so additional limestone could be extracted for Frueh's business. The project went before the Planning Board in the beginning of December.

"With the renewal of this mining permit, the owners felt it would be in their best interests to include some additional lands," said Edward Kleinke of Kleinke Associates, speaking on behalf of the applicant.

The mine was first

Albany County Styrofoam ban becomes law

McCoy announces green initiatives alongside signing bill, looks to expand ban past chains

Styrofoam containers are now banned from nationwide food establishments under Albany County's newly adopted law, but it could soon be absent from all local eateries.

Albany County Executive Dan McCoy signed the Food Service Waste Reduction Act into law Thursday, Dec. 12, at Bethlehem Town Hall flanked by local officials. The law bans polystyrene foam food containers, commonly known as Styrofoam, from being used in chain food establishments. The law also requires such businesses using disposable food service ware to use a "suitable, alternative product" that is compostable or biodegradable.

"The Styrofoam ban is only one small step in making Albany County the greenest county in all of New York state," McCoy said.

The local law will be effective in six months and includes escalating penalties for each offense. Penalties start at a maximum fine of \$250 for the first offense and increase to a \$1,000 maximum fine for the third and any following offenses.

Only food establishments with at least 15 locations nationwide would be affected by the ban, but McCoy is looking to expand the law to all food businesses within three years.

Representatives from several leading supermarket chains previously contested the law over concerns of its possible effect on prepared and packaged food, but McCoy confirmed grocers

would not be affected.

"They are exempt because they fall under state law, and county law cannot supercede state law," he said.

McCoy contested the law "doesn't go far enough" and the county needs to take "big, bold steps to truly" have a positive impact on the environment. He then announced three environmental initiatives the county will pursue.

"Styrofoam may be the problem in our landfill, but it is the landfill itself that is the true problem," McCoy said. "With the ban on Styrofoam, we will be able to save space, but the clock continues to tick."

To tackle landfill issues, McCoy announced he would appoint a

commission to find "viable options for long-term environmental, sound, economically beneficial discarding of waste." This will include revitalizing the regional solid waste study as the landfill is estimated to reach capacity in less than a decade.

McCoy's second initiative addresses obtaining additional open space, preserving historic buildings and maintain agricultural opportunities.

He set the goal of securing another 3,500 acres in the county, which he said spans 562 square-miles of land. McCoy's administration has acquired 372 acres for conservation, environmental needs or agriculture.

"This means that we can keep our community scenic, healthy and green," McCoy said. "We will continue to preserve the environment to benefit our county, including restoring the four and a half mile Rail Trail ... in multiple municipalities."

McCoy's also plans to establish a county public service agency, run by an appointed 7- to 11-member board, to develop a plan for recycling countywide.

Laura Haight, senior environmental associate

of New York Public Interest Research Group, commended county legislators and McCoy for passing the law.

"This terrific Styrofoam ban is a great holiday present for all of us at the end of the year," Haight said, "and with it, Albany County is

showing real leadership in demonstrating environmental sustainability."

Travis Proulx, spokesman for Environmental Advocates of New York, said there is "no upside" to using foam

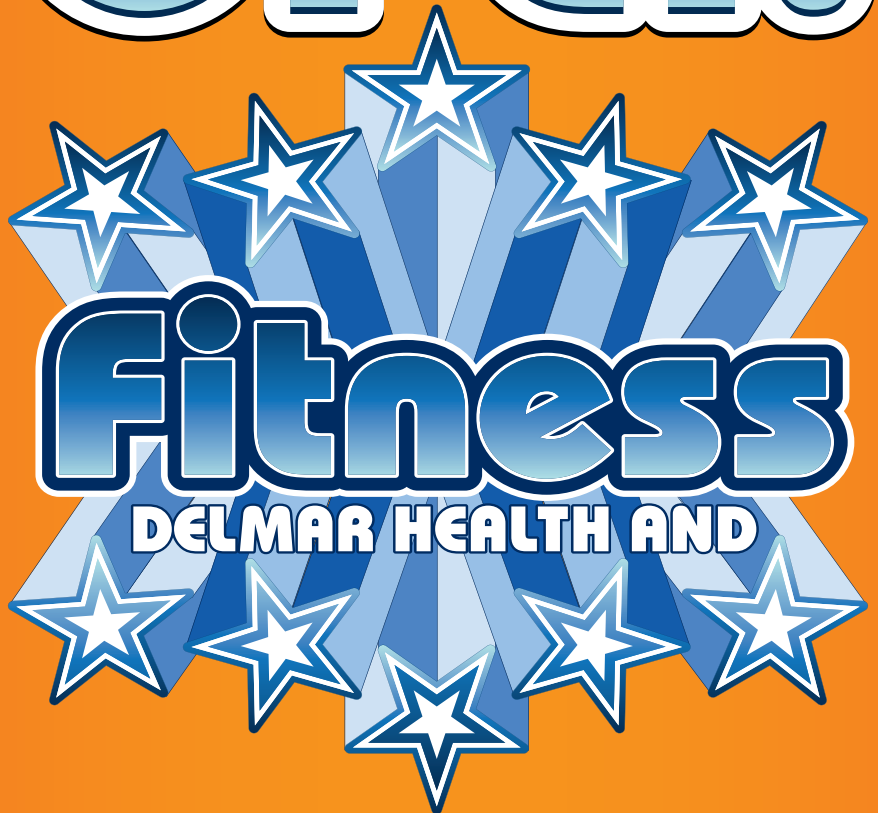

Heng Li, 27, of Brooklyn, was sentenced to 2-1/3 to 7 years in State Prison before Judge Stephen W. Herrick in Albany County Court Wednesday, Dec. 11.

On Nov. 13, Li pleaded guilty to one count of criminal possession of a forged instrument and one count of scheme to defraud, both felonies.

The arrest stems from a search warrant executed Aug. 5 by the Bethlehem Police, United States Secret Service, United States Department of Homeland Security, New York State Police, and other local law enforcement agencies pursuant to an identity theft investigation at the Golden Town Buffet on Route 9W in the Town of Bethlehem.

Li, an employee of the buffet, had used a credit card skimmer device to obtain personal identification information of 39 credit card numbers. He also was in possession of a forged Michigan driver's license.

Li was under an active deportation order at the time of the search warrant execution, as were three other employees who were present at the restaurant at that time.

Financial Crimes
Bureau Chief Daniel Lynch

handled the prosecution of this case.

An Altamont woman involved in a three-car crash was arrested for driving with a BAC more than twice the legal limit, with four children passengers in her vehicle.

Guilderland police arrested Andrea L. Gizzi, 38, of 6396 Gun Club Road in Altamont, around 6:10 p.m. Friday, Dec. 6, and charged her with four counts of felony aggravated DWI for having a child passenger, aggravated DWI for having a BAC of 0.18 percent and four counts of endangering the welfare of a child.

Guilderland police said Gizzi was involved in a three car crash on Western Turnpike and her vehicle was found off the road facing eastbound, with “major damage” to the front and driver’s side of the vehicle. When police asked her if anyone was hurt, she allegedly said one child passenger had stomach pain resulting from the crash.

Police said after further interview, Gizzi was allegedly observed to have watery eyes, a strong

odor of alcohol on her breath and had to be asked "several times" to produce her license, registration and insurance. A chemical breath test revealed she had a BAC of 0.18 percent.

The four children passengers in her car ranged from 2 years old to 9 years old, according to police, and were turned over to one of the fathers that arrived during the arrest.

Albany County District Attorney David Soares announced on Wednesday, Dec. 11, that Hopeton Labeach, 55, of White Plains, pleaded guilty to one count of money laundering in the fourth degree, a class E felony, before the Honorable Stephen Herrick in Albany County Court.

An investigation by the Bethlehem Police Department revealed that the defendant contacted an 89-year-old victim and told her that she won a monetary prize through Publishers Clearing House, but in order to collect her prize she needed to send the defendant money orders. The victim sent multiple money orders to the defendant, which totaled over \$7,900.

Hopeton faces 1 to 3 years in State Prison when sentenced on Jan. 8.

Your story on Lafarge ("Lafarge modernization plan moves forward," Nov. 20) marks an exciting period in the history of the Ravena plant.
The approval of our plans to complete construction of a new state-of-the-art cement facility by June 30, 2016, is positive news not only for the Lafarge team, but also the community. It will allow Lafarge to continue making progress to modernize the Ravena facility, protect good-paying local jobs and remain competitive in the global economy.

Although the existing plant operates according to all federal and state environmental and safety standards, the new, modernized plant will bring new air pollution control technology to further reduce specific air emissions and meet strict future applicable emission standards adopted by the Environmental Protection Agency.
Under the plan, Lafarge will commit an additional \$1.5 million to projects benefitting the local environment, make added environmental infrastructure

improvements at the existing plant and adopt new stricter emission limits for SO2 and Hg.
The several hundred million dollar modernization project will also help protect the plant's 112 existing union and non-union jobs, and create up to an additional 800 temporary jobs during the construction phase, which will greatly benefit our local economy.
And work is underway. The preliminary design phase is nearing completion and key equipment, contracts will be announced in the coming months.


The public's first visual signs of progress should arrive by mid-summer with the installation of major components for the new plant, and soon we will launch a new modernization-focused website to help you stay informed about our progress.
We're eager to get the new plant online and pleased that Lafarge's modernization plans continue to receive tremendous support from area residents and community leaders.

Tom Regan honoring the fallen

In 2012, Navy Veteran Tom Regan was looking for a way to honor the 1200 Capital Region veterans who have served from World War II to the present and who paid the supreme sacrifice – their lives – for our freedom.

It was then that he launched "Operation: Please Remember Me" – a project that commemorates those who gave their lives by raising 120 American flags on utility poles in Colonie from Route 9 to Route 155 from Memorial Day to July 4. Each flag represents 10 fallen heroes.

Tom met with local leaders and representatives from National Grid, Verizon, Trustco Bank and the Department of Transportation. He recruited volunteers for placing brackets and flags. And he solicited funds from local area businesses and veteran organizations.

On May 18, 2013, a motorcade procession led by Gold Star Families proceeded along Route 9 (originally known as "The Military Highway") to kick off the operation.

"We remember their sacrifice, and the families they've left behind," said Tom, whose fellow serviceman and friends gave their lives in Vietnam. "I hope we will continue to pay them tribute well into the future."

Tom's dream was to honor these heroes. And he is our hero for keeping their memory.

A call for common sense

You would think in today's information-crazed society people would relish the opportunity to talk on their cell phones while they are aboard a plane in flight.

You would be wrong. According to a recent survey conducted by Albany International Airport, 83 percent of leisure travelers and 60 percent of business travelers said they oppose the idea of allowing people to talk on cell phones once planes are more than 10,000 feet in the air.

We don't see the point of it, either. There is enough noise to deal with on planes (crying babies, over-zealous chatters) without adding fancy ring tones and people shouting at their long-distance conversation partner. No one expects sitting on a plane to be as quiet as sitting in a library or visiting a cemetery, but do we really need to hear people blaring into their phones, "Guess where I'm calling from?" or describing, in painstaking detail, their latest doctor's visit.

And other area travelers are of the same mind.

"I don't want to hear other people's personal conversations on a cell phone

invading my air space," said Mary Rozak, director of communications for the Albany County Executive's office.

It's not just Albany passengers who feel that way. Nationally, the survey numbers show the majority of people feel cell phones should remain silenced on planes.

It's not that cell phones endanger the pilot's ability to steer the plane. It's the idea of adding loud chatter in a small, cramped space that has people wanting the Federal Communications Commission (FCC) to maintain the long-standing policy that cell phones remain quiet once the plane reaches the runway.

Allowing passengers to text from the plane elicits a different response from passengers. While 55 percent of leisure travelers polled at Albany International Airport said they opposed texting, 64 percent of business travelers said they wanted the ability to send messages to family and colleagues while in the air. Chalk up the dichotomy to the two types of passengers' priorities. Businesspeople sometimes have to get and receive messages at a moment's notice, while those

who are heading out on vacation usually wait until they reach their destination before communicating with anyone.

Unfortunately, all that polls such as the one conducted at Albany International Airport can do is give FCC officials an idea of how people feel about the concept of cell phone use. The agency will determine for itself whether it will allow passengers to break out their iPhones and Androids.

Even if the FCC gives its approval, it's still up to the airlines to determine – with customer input – if they want to allow cell phones to be used. If the airlines are paying attention to the national poll numbers, odds are they will continue to ask passengers to keep their cell phones silenced on flights.

On the off chance the airlines also allow cell phones to be used, there is still a way for people to prevent planes from resembling long, cramped, loud metal phone booths. They can take personal responsibility for their actions and continue silencing their cell phones while they are in the air. If enough people do that, then the point of permitting cell phone use becomes moot.

Their style is a hands-on, no nonsense approach to determining where there is a need, and then setting about meeting that need. They are doers and givers, servers and workers. The club supports both local

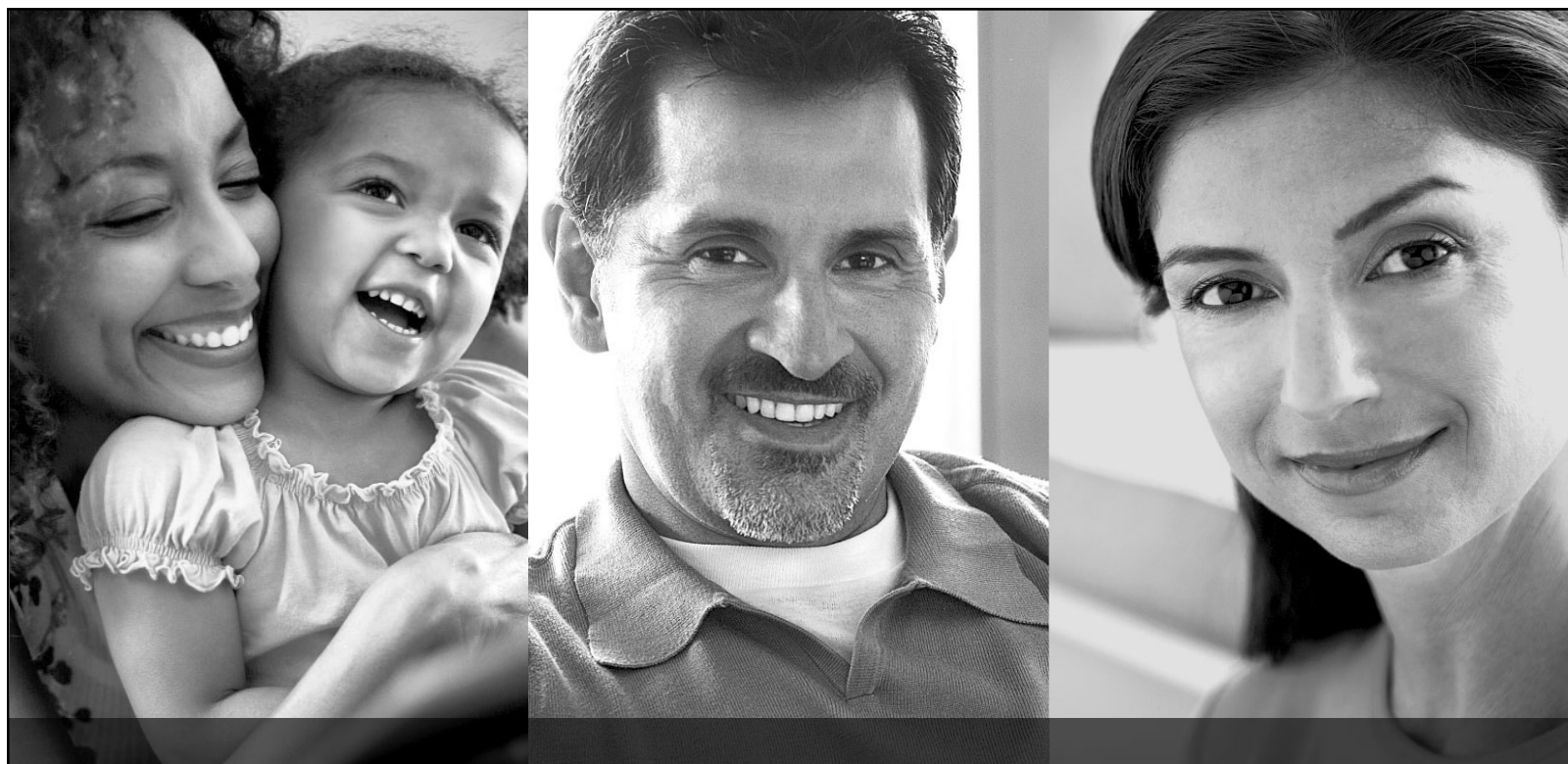

More fallout from rap song

Lawyer says cops overzealous in publicizing G'land cyberbullying arrests

A lawyer for one of the four Guilderland teens charged under Albany County's cyberbullying law said he is concerned with the way the Guilderland Police Department publicized the arrests, although police said the incident was handled the same as the department would any other case.

There were no television cameras or much media attention at all when the four Guilderland teens were arraigned Thursday, Dec. 5, in Town Court, with each boy facing an unclassified misdemeanor charge of cyberbullying. All of the boys were arraigned privately in the judge's chambers behind closed doors.

"The worst-case scenario in this case, the judge would have to give youthful offender status," said Andrew Safranko, a lawyer representing one

of the boys. "Because they are underage, the proceedings need to be closed and need to be done in chambers."

The court records are sealed, with the outcomes of the cases likely to never be revealed, but the boys' names have already been widely reported. At least one broadcast media outlet ran their photos, which appeared to have been from the yearbook.

Police never released mug shots of the four boys, because procedurally such photos are not taken with unclassified misdemeanor arrests.

Spotlight News has not printed the names of the four boys because it is the paper's policy to not release the names of anyone under the age of 18 charged with a misdemeanor. The four charged boys were 16

to 17 years old when the incident occurred.

Safranko said he has "a lot of concern" over the Guilderland Police Department releasing the names of the four boys.

"Frankly, I don't think that the police should have made the arrest in the way that they did, or have these guys come in the way that they did," Safranko said. "They know at some point this case is going to be completely sealed and done and over with."

Capt. Curtis Cox, of the Guilderland police, said the name of anyone who is arrested and is at least 16 years old is releasable and a matter of public record.

"Now, the youthful offender status, where everything gets closed to the public, is an action of the court," Cox said.

"Until it reaches that point, the information is public information."

Safranko pointed out that most misdemeanor arrests do not have a press conference announcing them, but Cox said the announcement was a necessity because of the magnitude of media attention the case had already received.

Cox said holding a press conference was the most expedient and fairest method to release the information.

"We have held press conferences before in other cases where we had high-profile or high media attentiveness," Cox said. "It was getting a lot of media attention, and historically when we have done a standard press release involving something that has so much media attention, we are conducting five or six interviews all day long."

Ultimately, Safranko said he believes the matter should have stayed internally at Guilderland Central School District. The four boys were suspended after the school conducted an investigation that

determined they were involved in making an explicit rap song posted online detailing alleged sexual encounters of students.

"For whatever reason, the Guilderland Police Department wanted to drag these poor boys through a dog-and-pony show for no reason," Safranko said. "With my particular client, he is already back at school and accepted responsibility for his action, which certainly was limited and believed the matter should have ended there. His action did not constitute a crime whatsoever."

Safranko said his client was responsible for making the intro and outro to the song, which he described as not "overly offensive."

Guilderland Superintendent of Schools Marie Wiles could not be reached before going to press on how many of the suspended students are back in school.

cyberbullying law before the four boys cases are resolved.

There has only been one other arrest made under the law.

"We had initially challenged this law as unconstitutional, and right now we are going before the Court of Appeals to declare this thing unconstitutional," said Melanie Trimble, director of the Capital Region Chapter of the New York Civil Liberties Union. "Any kid who says anything under this on (the) Internet could be charged."

Albany County Executive Daniel McCoy said he is confident the court will uphold the law, with the county preparing for its defense in January.

"While the Internet can prove to be a useful tool and a crucial part of our everyday lives, there are those who hide behind the screen and engage in cyberbullying," McCoy said in a statement. "This law sends the message that we will not tolerate this behavior. I am confident that the court will validate the law and our desire to protect people while online."

ACLU challenges law

There is also the possibility the state Court of Appeals could strike down the county's

Fliers: Keep the cell phone stowed

Survey at Albany airport shows most air travelers not in favor of in-flight calls

According to a recent survey conducted at the Albany International Airport, a majority of travelers overwhelmingly oppose the use of cell phones while in flight.

A survey of 428 business and leisure travelers conducted Dec. 2-5 indicated that most passengers don't want cell phone use to be allowed on airplanes. The survey comes as the Federal Communications Commission looks into whether or not to lift the ban on in-flight cell phone

usage.

"There is widespread support prohibiting the use of cell phones on airplanes. Travelers don't want to be bothered by hearing the person next to them talking about business or family issues," said Doug Myers, the airport's director of public affairs.

The survey revealed that 83 percent of people

traveling for leisure were opposed to the use of cell phones in flight, while only 60 percent of business travelers were opposed.

Even though cell phone use on planes is no longer a safety issue, a majority people said they just don't want to hear random conversations while traveling.

"Being in a confined

space for any period of time — it's already hard enough to read a book or magazine, listen to music or work on a laptop or iPad without already being disturbed by conversation around you," said Mary Rozak, director of communications for Albany County Executive Dan McCoy. "I would like the ability to stay connected to email and the Internet without having to pay an additional charge when an airline makes it available. I don't want to hear other people's personal conversations on a cell phone invading my air space."

The use of cell phones for texting doesn't seem to be as much of an issue for those surveyed, with 64 percent of business travelers and 35 percent

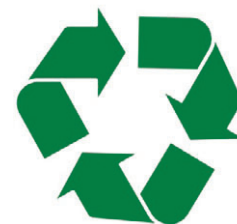
of leisure travelers approving.

"Personally I'd like to see them allow texting," said President of the Colonie Chamber of Commerce Tom Nolte. "I think you should be allowed to text, but I think the Tower of Babel could be a bit much."

On the FCC's official blog Roger Sherman, the acting chief of the wireless telecommunications bureau, said that 22 years ago the original regulations were put in place because of a fear that cell phone would interfere with systems on the ground. Technological advances have ensured that cell phones can be used without interfering with systems on the ground or the aircraft.

Even if the FCC gives the go-ahead, ultimately the decision will be up to the individual airlines on whether to allow in-flight phone calls.

"They'll have the final say because it's their aircraft," said Myers.

**Habitat for Humanity,

up for project**

The Book House of Stuyvesant Plaza is helping New Books for New Homes get books to children.

For the third year in a row, Habitat for Humanity is partnering with the Book House to acquire books for the program, which runs from Dec. 4 through Jan. 4.

“It’s a joint effort between Habitat for Humanity, the Albany City Area Reading Council and the Book House,” said Rachel King, a manager at the Book House of Stuyvesant Plaza. “We have sort of a couple of different displays of suggestions, but anyone can just come in and pick out a favorite book and buy it, and they get 20 percent off.”

The Book House makes some suggestions for people on what sort of books to choose, but Habitat for Humanity and the reading council take the books and organize them to best fit each home. picks up the books and goes through them, and sort of put together packages for each home. Habitat for Humanity gives us the information like are there kids in the family, (and) how old are they. So that way, we can find books that are for a 2-year-old boy or an 11-year-old girl,” said King.

In the first two years of the program, the Book House collected more than 800 books. This year’s books are going to 10 families that are moving into homes being built by Habitat for Humanity in Albany’s Sheridan Hollow neighborhood.

“Eight hundred books and 15 families later, we enter year three and a whole new group of children soon to call Sheridan Hollow their home,” said Michael Jacobson, Executive Director of Habitat for Humanity Capital District. “What can I say? When you connect the dots between home, health

and learning, anything is possible.”

The children the project helps are at a disadvantage in school because they don’t have all the tools necessary to make learning easier. The donation of new, age-appropriate books and library information to Habitat homeowners further reinforces the positive impact that a safe, stable home has on education.

Habitat for Humanity is a non-profit organization that builds homes for low-income families that are in need of a place to live. They use volunteers to build the homes and used mostly donated products and funds to build the homes.

The Albany City Area Reading Council is a professional, not-for-profit organization for educators in the Capital Region concerned with improving literacy instruction and opportunities for all children and adults.

have been reached for any of the proposed spaces.

There was little time for board members to review the proposal, with it placed on the agenda just the day before the meeting.

“I think the board has seen this sketch plan for about five minutes now,” Planning Board Chairman Stephen Feeney said. “I have had no time to look at this at all.”

Sweeney said he submitted information to the town and was placed on the agenda, but he did not indicate if the developer pushed for an expedient process.

Board members also commented on the lack of information included in the plan presented, with even the number of parking spaces before and after not readily available.

“It is unclear what’s being proposed is actually what’s going to happen,”

Feeney said. “We are looking at such a sketch plan it is hard to say what is really happening.”

Sweeney said the plan presented was intended to be the site plan and not a more preliminary sketch plan.

“We are willing to develop a specific plan in response (to conditions of the planning board) for the Zoning Board of Appeals,” Sweeney said.

Board members were mostly concerned how the expansion would impact parking, along with efforts to improve traffic flow in the two affected parking lots. The addition would be in front of the entrance in between Dick’s and the doors leading to the escalator up to the food court.

Sweeney said a rendering of the proposed addition was not completed yet, but the exterior of the mall would be renovated to a “more appealing” design through a “pop-out” style entrance.

The overall size of the mall is 1.6 million square

feet, with recent changes reducing the amount of leased space through the reuse of two department store locations. The new businesses are occupying less space than the former uses, which results in the expansion adding just over 2,000 square feet of space to lease.

Sweeney said the two parking lots would have spaces laid out differently to better suit the mall’s design.

“I think that it is a pretty universal opinion that it is both inefficient and doesn’t work very well to have the parking spaces perpendicular to the shopping center,” Sweeney said.

Some of the board’s conditions for approval included identifying the number of parking spaces reduced or added in the affected lots, providing appropriate curbing within parking lots to better direct traffic and increase landscaping, identifying the amount and type of material planned for landscaping,

and eliminating the proposed new parking lot access.

The approval also hinged on developers consulting with Capital District Transportation Authority on what, if any, impacts the expansion would have on bus terminal access. The bus stop is currently located in front of the expansion.

Sweeney said developers have discussed the expansion with CDTA and said it would not affect access to the bus stop.

“There always is ongoing discussions with CDTA and [these] dimensions, I don’t think, accommodates fewer buses,” he said. “The bus area has to be able to accommodate the same number of buses.”

There will be a public hearing on the proposal at an upcoming Zoning Board of Appeals meeting, with next scheduled meeting on Wednesday, Dec. 18. An agenda for the meeting was not available before going to press.

more than 45 students applied this year to be a part of the team.

“Since this is all about getting students prepared for the real, working world, they go through an interview process,” said Navaar Johnson, one of the district’s engineers who helps oversee the internship.

The students were asked simple, but important questions about why they applied for the job, what their skill-set was and were told what was expected of them. A total of 15 students were hired this year, with three more expected to be brought on next semester.

“Now in its second year, the student help desk has been a win-win for the district and for the students who staff it,” said DeAngelo.

Sixteen students were hired last year.

The students go through

a two-day training session before school starts for the year to learn about the types of repairs they will be doing and a lesson in having good customer service skills. They are also taught how to use the digital ticket system teachers and staff use to submit reports for items that need repairs.

Students learn a multitude of tasks, from changing printer cartridges and changing projector light bulbs to fixing cellular phones and upgrading software. Many of the students make new friends, and get to interact with other students and teachers from different grade levels.

“It’s really great experience for the future,” said Justin Brown, the district’s senior network and systems engineer. “This could eventually open them up to become a part of their college student help desk.”

The program is open to all students in 10th grade and higher. Students can

participate more than once, but can only get internship credit for one year. They work during study halls or lunch, so as not to disrupt their typical schedule.

Brown said a volunteer speaker from IBM comes in to speak with the participating students at certain times of the year. The hope is for the program to become an IBM-certified internship so they can get funding from the tech company in the future to expand.

Johnson said that with the students taking over some of the department’s less-involved tasks at the high school, there is more time to focus on the other schools as technology use expands at the lower levels.

“Hopefully by putting these students in an environment like this early, they’ll have an advantage over their peers once they get to college,” said Brown.

Garry DeGonza, a sophomore participating in the program for the first time, said he wanted to do the internship last year but had to wait.

“I’ve been interested in tech and gadgets since I was little, so this has been interesting,” said DeGonza.

The 16-year-old said he liked going into classrooms to help teachers. He was also able to get more experience working with Mac computers because he grew up around PC’s.

“A lot of my friends ask me about it and seem like they want to apply next year,” said DeGonza.

The Student Help Desk is also involved in helping develop Office365, an internal e-mail service for high school students and staff to help them coordinate assignments or group projects.

Brenna Raffa, a member of the student help desk who also works for the school’s

communications office, said the dynamic is almost the same as being on a sports team. The group works well together and could be seen as an alternate activity for those who don’t want to play a sport.

Brown and Johnson said their goal is to expand the program in the future. Next year, the student help desk

might open its services up to the community and repair the personal devices of students and staff.

“This is a program constantly in development,” said Brown. “We learn something new everyday and next year if we were asked where we were, there might be a completely different answer.”

containers for food.

“Many large corporations impacted by this measure have pro-actively identified environmentally responsible alternatives because they know this product isn’t good for their consumers,” Proulx said in a statement. “It is not reusable or recyclable, litters our sidewalks, leaches toxins into our food, and will outlive each of us by 500 years.”

Industry representatives previously said polystyrene containers can be recycled, but some lawmakers and residents claimed it’s not a viable option since there is no profit to be made for

recycling companies.

Bethlehem Town Board member Bill Reinhardt said residents are “very interested” in advocating for environmental issues. Reinhardt, who spoke in favor of the law at the last hearing, said he was looking forward to the other initiatives McCoy unveiled.

“I think these are wonderful steps in the right direction,” Reinhardt said, “but ... there is more to be done, and we will be working towards those other goals and these three initiatives with great energy and excitement.”

McCoy estimated a majority of residents speaking at the hearing he held on the law were from Bethlehem

and commended the community for its dedication.

“Bethlehem loves their recycling, and they love their green,” McCoy said. “What better way to do a ceremony like this ... than in the Town of Bethlehem. I was very impressed with the residents and leadership in the Town of Bethlehem for their impact on their environment.”

Bethlehem Supervisor John Clarkson said the town has a history of environmentally minded residents.

“It has always been a community that cares very much about the environment and we are doing quite a bit through our sustainable program,” Clarkson said.

Voorheesville voters to decide \$2.7M project

District proposes reconstructing roof, upgrading technology for future demands

Voorheesville school officials are hoping a scaled-back capital project targeting what it has deemed to be essential improvements will be approved by voters.

District voters will head to the polls Tuesday, Dec. 17, from 2 to 9 p.m. at Voorheesville Middle School to cast their ballots on a proposed \$2.7 million bond project. A majority of the project cost is tied to reconstruction of the high school’s built-up roof for \$2.345 million. Reconstructing walls above the roof also accounts for \$78,000 worth of work. Replacing network switches and adding 60 drops of wireless access totals a cost of \$279,500.

The Board of Education held a public hearing on the proposal at its Monday, Dec. 9, meeting, which included an overview of the project and its costs. There were few comments from the public on the project, with some questions over

financing and the timing of the expenditure.

“It’s no secret that the roof on the building has been in trouble for a considerable period of time,” Board of Education Trustee James Coffin said. “We have been watching it and there have been some minor fixes over time, but it has continued to get worse. We see that we have to address this issue.”

The approximately 82,000 square feet of the high school’s built-up roofing system was constructed during 1958 and 1968. The roof was last resurfaced 18 years ago. The reconstructed roof will be an ethylene propylene diene monomer (EPDM) rubber roofing system, which holds a 30-

year warranty.

Roof reconstruction will also address leaks and areas of wet insulation, with the new roof estimated to save around \$1,500 annually in natural gas costs based on 2012-13 energy rates, according to the district.

The high school gymnasium’s high wall above the roof is displaying white chalking on brick surfaces, cracking and possible water damage due to age. District officials said failing to make improvements could lead to more serious infrastructure damage.

Technology upgrades would address upgrading the district’s network, which does not have enough bandwidth to support forthcoming

state-mandated online testing requirements.

Coffin said board members and district officials were “cautious” on how the proposed project was developed, along with setting aside some funds in its capital reserve account. The proposal going before voters was whittled down from one estimated at more than \$11.48 million.

“We were looking at a much bigger project than this, and the board walked away from it because we can’t do these other things,” Coffin said. “It just became too expensive in very difficult times, and God knows what we are going to be facing down the road.”

Superintendent Teresa Thayer Snyder previously said delaying several improvements and upgrades allows the district to monitor community demographics and not incur “massive” debt if enrollment significantly declines.

The enrollment this school year is 1,176 students, approximately 116 fewer than on the first day of school in the 2002-03 school year.

The district would receive state aid to

cover 61.8 percent of the project’s cost, and \$555,000 of the district’s building project reserve funds would be tapped. All of the project funding is eligible for state aid.

Using reserve funds will lower the burden on taxpayers, so the maximum amount of borrowed money would total \$2,147,700.

“Utilizing the capital fund is prudent because the district does not have to borrow and pay interest on that portion,” Diefenbach said in a statement to Spotlight News. “In fact on the investment side, the interest being earned on the capital reserve is 0.04 percent, which makes it even more prudent to make the money work for the district.”

Building project reserve funds, also known as its capital reserves, are set aside to only be used on building projects. Over the years, the repair reserve has been used for smaller projects requiring immediate attention, but it cannot be used on larger projects such as roof renovations.

Coffin said the actual amount of borrowed money could come in

lower than projected. Coffin referred to a prior elementary school capital project coming in around \$500,000 less than what voters were asked to approve, so the district borrowed less money.


Board President Timothy Blow believes the estimates for the project are “very high,” and the district will be looking to save money.

“One of the things that is important to be aware of is we are working off an old roof, and you never know what you are going to find until you rip it off,” Snyder said. “Hopefully we won’t find any surprises when ripping that roof off.”


The bond would be paid off over 16 years and holds an annual tax increase per \$1,000 assessed value of 6.7 cents for a New Scotland homeowner, 7.3 cents for a Guilderland homeowner and 10.1 cents in Berne. A New Scotland home assessed at \$250,000 would pay \$16.75 annually for the project, with the potential impact over 16 years totaling almost \$270.

Reduced substitute rate savings unclear

Guilderland school board debates reduced pay-rate amid rising costs

Substitute teachers at Guilderland schools have seen less money in their pockets from the district, but it remains unclear if the district has realized any savings.

Guilderland Superintendent of Schools Marie Wiles presented an update on substitute teaching expenses at the Board of Education’s meeting Tuesday, Dec. 10. The

board adopted reduced teacher substitute rates for the 2013-14 school year in July, which was a daily rate of \$5 less than the prior school year. Four board members voted to rescind the reduced rates a month after it was adopted, but five members voted to keep it.

This reduced the daily rates to \$90 for elementary and middle school substitute teachers, \$60 for half-day substitutes at the high school and \$95 for full-day high school substitutes. The long-term substitute rate, requiring 15 consecutive

days substituting for the same teacher retroactive to the first day, was reduced to \$165 per day.

Wiles said concrete conclusions could not yet be drawn on the affects of reducing the rate.

“The bottom line in this discussion is it’s really too soon to tell whether the change in the substitute rate will create a substantial savings in substitute costs for this year,” Wiles said. “If we look at the total amount of costs that we have had since September we are actually up in our costs, but that is attributable to a number of variables.”

Wiles said there have been more long-term substitutes this school year, which is one

factor for the increased expenses.

Wiles said the fill-rate — or rather, the failure to hire a daily substitute — last school year had 17 instances where a substitute could not be attained. This school year, the fill-rate more than doubled to 42 instances. Wiles said at this point she could not link the change in pay-rate to the higher occurrences.

“We really need to track the data on costs through a longer period of time before we know what the financial impact is on changing our rate,” Wiles said. “Our building principals have felt the impact of managing unfilled positions and will continue to do so.

If the question is simply financial at this point, I would say the jury is out.”

The number of new substitutes requesting to be included to the district call list also declined, but Wiles did not specify how much it declined.

When the district does not fill a substitute position, there are a variety of different outcomes, Wiles said. A teaching assistant assigned to a different role could be reassigned. Several classroom teachers, mostly at the high school, could fill small increments of time to cover all the absent teacher’s classes. Sometimes services will be canceled, or programs are doubled up.

“There are a variety

of ways we scramble, frankly, to make sure that our students are supervised when we don’t have the regular classroom teacher,” Wiles said.

Board member Gloria Towle-Hilt said she was concerned over principals sharing instances where a substitute would be lined up, but then before school the substitute would call and cancel saying they got a “better offer.”

“That really concerns me,” Towle-Hilt said. Wiles confirmed this has happened.

Other board members also questioned whether any savings that might be achieved would be worth the cost educationally.

established in August of 2004, before the town required the submittal of a site plan review or special use permit application. The town’s Zoning Board of Appeals has since changed how the area was zoned from “Rural Not Zoned” to “Rural Light Industrial,” so the project must go before the Planning Board.

In 2004, the state Department of Conservation imposed 23

stipulations in order to gain approval for the original mine. Since the state’s Mined Land Reclamation Law preempts many local regulations, limitations are placed on the town “as it relates to mining activity.”

“The operator is interested in following the same level of quarrying as they have the last 10 years,” said

Kleinke. “This expansion is not looking to expand the amount of material processed significantly.”

When looking to

approve or deny the application, the Planning Board can only consider “ingress and egress to the site,” the routing of transport vehicles on local roads, making sure the conditions the DEC has imposed are followed and enforcement of restoration activities on site.

Kleinke said the packet of information originally requested by the DEC was “extensive,” and so is the packet of information submitted to the town now.

Many of the conditions have to do with noise,

air and water pollution, appearance of the site, and allowing archeologists on the site if additional artifacts are found.

The Planning Department said there is no record of complaints against the mining site.

Members of the Planning Board said they would like to see the DEC’s stipulations of the mining permit continued for the renewal to go forward.

A SEQR review is needed from the DEC before a public hearing can be held at the town level.

fourth quarter, and he hit a couple of big shots for them.”

Guilderland survived Albany Academy’s rally by making its final four foul shots.

“We missed a couple of free throws earlier on, but we made them at the end when it counted,” said Osinski.

Senior forward Matt Cerutti came up big for Guilderland with a 25-point performance. Vincent Simeone contributed 16 points, while Marc DuMoulin and Andrew Platek each added 10 points.

The Dutchmen return to Suburban Council action Tuesday when they host winless Niskayuna (0-3). Osinski said he’s already warning his players not to overlook the Silver Warriors.

“When I talked to the guys after the Albany Academy game, literally the first words out of my mouth were, ‘Do not lose to Niskayuna. We just beat Academy,’” said Osinski. “We’ve done a pretty good job thus far of guarding against (letdowns) by coming out ready to play.”

Big men come through for Guilderland

Try as it might, Colonie had no answer for Cerutti and DuMoulin. The two forwards combined to score 34 points and haul in numerous rebounds to lead the Dutchmen past the Garnet Raiders 71-57 in Friday’s Suburban Council South Division game in Colonie.

“I didn’t realize how much they’d crush us inside,” said Colonie coach Jim Boland. “Cerutti and DuMoulin absolutely crushed us tonight. We couldn’t hold them to one shot (per possession).”

“Matt brings in long arms ... and Marc has very good jumping ability. He showed that last year,” said Guilderland coach Ron Osinski. “And (Andrew) Platek can rebound the ball very well, too, even though he plays out there (at guard).”

Nolan Smith had 23 points for Colonie (0-3), but he was the only Garnet Raider to reach double digits in scoring. By contrast, Guilderland (3-0) had three in double figures – Cerutti (19 points), DuMoulin (15 points) and Vincent Simeone (16 points).

“He’s a great shooter,”

Boland said of Smith. “The problem is he’s only 5-9, 5-10 (in height). When other teams decide to double him, he has to find other guys to get the ball to.”

Colonie built a 20-14 lead in the first quarter on contributions from Smith, Ryan Nicholson and Nick Donato. But Guilderland responded with an 18-2 run that stretched from late in the first quarter through the early stages of the second quarter, and the Dutchmen never trailed again. By halftime, Guilderland had a 47-33 advantage.

“I don’t think we came out with good defensive pressure ... and they made us pay early on,” said Osinski. “They had a couple of close losses (to start the season), and I think they were excited to play us. I think we had to weather the storm.”

A Smith three-pointer helped Colonie trim Guilderland’s lead to 55-45 in the third quarter. However, fast-break layups by Simeone and Platek sparked a 7-0 run that put the Dutchmen ahead 62-45. The closest Colonie got to Guilderland after that was 14 points.

“We hung around,” said Boland.

the Indians in the early part of this season, and junior Fred Pechette is scheduled to return from injury Wednesday when the Indians meet Albany Academy.

To help the team along, Schipano is using his enthusiastic personality. He gives all of his wrestlers high fives and congratulates them after each bout, whether they win or lose.

“To know they have that enthusiasm behind them,

that makes them want to fight more for you and to do the best they can,” said Schipano. “As long as you keep their spirits up, the kids will fight for you.”

That philosophy was put to the test when Ravena competed in last weekend’s Linda Stuart Memorial Duals at Colonie Central High School. The Indians struggled through both days against several larger programs such as Colonie, Burnt Hills-Ballston Lake, Minisink Valley and Indian River. But, team wins were not important to Schipano.

“I only brought my top 10 guys there, so I was

treating it like it was an individual tournament,” said Schipano. “Our wrestlers went 38-30 over the two days, so I was pleased. We wrestled very competitively. We did not get pinned a lot, which was great.”

Kunkle was Ravena’s top performer at the Stuart Memorial Duals, as he posted an 8-0 record in the 220-pound division. Parker finished with a 6-2 mark at 170 pounds, and Powell finished 5-3 at 285 pounds.

Following Wednesday’s league match against Albany Academy, Ravena will have another chance

to test itself in a dual meet tournament when it hosts the Lewis Johnson Memorial Duals Saturday. The six-team field also includes Bethlehem, Brewster, Onteora, Roy C. Ketcham and Hoosick Falls.

“It’s a good mix, and on paper Brewster looks to be the powerhouse,” said Schipano. “That will be an interesting match for us.”

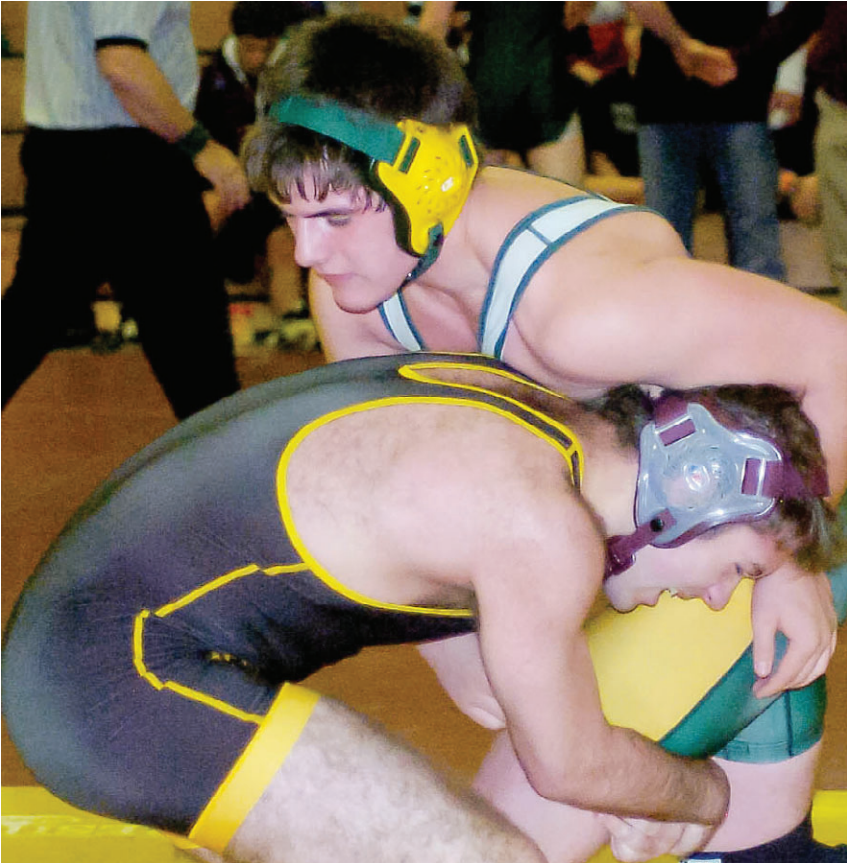

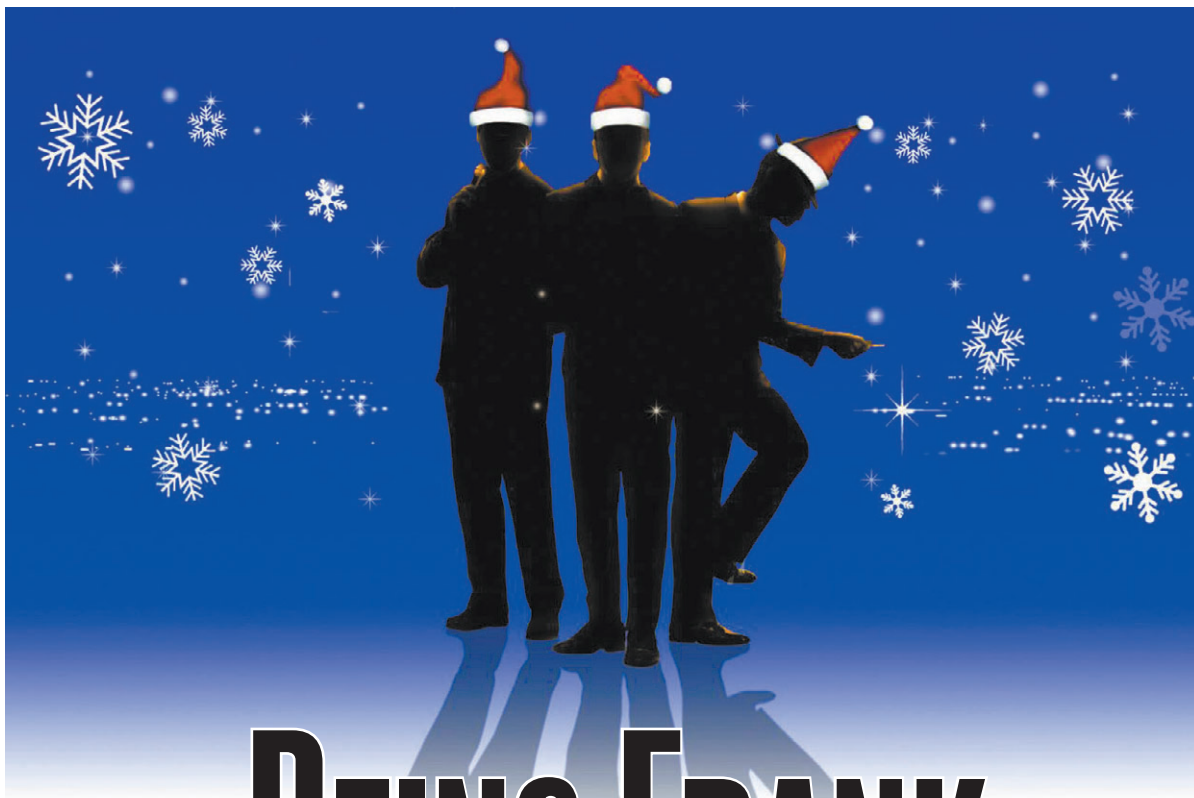

Performer channels Sinatra for 'Christmas With the Rat Pack'

He was not even born when "Come Fly With Me" was released in 1958, but he brings audiences to tears and inspires standing ovations when he dons the iconic black suit and belts out the famous Frank Sinatra song.

"It's interesting that most people say to me after a show, 'Well, I closed my eyes, and I thought it was Frank,'" said Tam Ward, the jazz singer who regularly performs as Sinatra.

The Scotland-born jazz performer in his early 40s said he is often considered a Sinatra of the modern days. His interest in music from The Great American Songbook started at an early age.

"My family had a tradition of singing at family parties. At some point in the evening after a few drinks, somebody would ask someone to sing," Ward said. "So I spent a lot of time listening to people sing."

As a teenager, you wouldn't find U2 or typical tunes of the 1980s playing on Ward's Walkman.

"I wasn't into music of the '80s at the time," he said. "I loved the old music ... Gene Kelly and all of that ... Bing Crosby, Frank Sinatra,

Dean Martin."

An interest in "the old movies," Ward said, led him in the direction of training as a professional dancer.

"But I wanted to do acting and singing and interact with an audience," Ward said.

It wasn't until the early 2000s that Ward found his calling as "The Chairman of the Board" when he began touring with "The Rat Pack Live at the Sands."

On Friday, Dec. 20, the stage at Proctors will be transformed into a lavish Las Vegas hotel lounge when Frank Sinatra, Sammy Davis Jr., Dean Martin and the Burrelli Sisters perform in "Christmas with the Rat Pack."

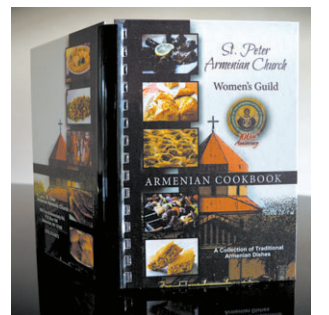

Recipes ripe with tradition

Cookbook honors Armenian culture with family favorites

The holiday season is a time for tradition.

At no other time of the year are people more connected to their cultural heritage, as friends and family gather to share old stories and new gifts. But more important for some could be those special family recipes, which are made only once or twice each year.

In an effort to raise money for needed repairs and upgrades to St. Peter Armenian Apostolic Church in Watervliet, the congregation's women have compiled hundreds of family recipes into a new cookbook.

of the church’s Women’s Guild and chairwoman of the Cookbook Committee.

Foley said the church holds a bazaar each year where the food is very popular, and volunteers often receive questions about what is in the food and how to make it. Since the demand was there, volunteers began holding cooking demonstrations and teaching how to make traditional dishes. One of the most popular treats is paklava, the Armenian equivalent to the Greek baklava.

The cooking lessons were a success, so the guild decided to put together a cookbook.

“Next year we will be commemorating the church’s 100th anniversary,” said Foley. “This is not only a nice way to share our culture, but a way to recognize the women who came before us.”

This is the second time members of the church have produced a cookbook. About 15 years ago, church members

opted to make the first cookbook, but it was small and looked more like a pamphlet. The women of the guild took these recipes and added their own to the new cookbook.

The book contains about 200 to 250 family recipes, many of which have been passed down for generations. Foley said the majority of the congregation are first- and second-generation Armenian, so some of the instructions read just like they would in “the old country,” but all are written in English.

The paklava recipe is included. So is a recipe for kadayfi with cream, another favorite Armenian dessert, and Manti, a canoe shaped dumpling filled with meat. Foley said all of the recipes are easy to follow, and the book is filled with recipes for every occasion in eight tabbed sections.

“This is not your standard cookbook,” said Foley, who believes it could be a unique gift for those looking to experiment with new foods. “This is a book with loads of different recipes to try.”

The book also includes

a history of the church, helpful cooking tips and a directory of Armenian cooking terms.

Foley said the guild is looking to raise the money for needed church repairs. They are also looking to upgrade the church kitchen, which has become just as important a meeting place for the community.

“Our congregation is small, so these things are important to us,” said Foley. “We host pot luck dinners there and invite members of the community.”

The Rev. Fr. Stepanos Doudoukjian also visits local colleges and schools to find exchange students or those of Armenian descent to invite them to participate in church events while they’re away. Foley said it helps with homesickness and is an added bonus for their parish.

“All of this helps keep our culture and heritage alive,” she said.

Foley said it’s an honor for the Women’s Guild to share their family recipes with the greater community.

is very supportive of our bazaar and festival in June,” she said. “It’s a privilege to share our culture with so many

people who have openly embraced it.”
