MHLC gets \$68.5k grant

State unveils \$1.4M in Conservation Partnership Program grants at local farm

Indian Ladder Farms was used as a backdrop and example during the unveiling of Conservation Partnership Program grants totaling \$1.4 million statewide.

# Dirt-bike dust-up

Owner of Hidden Meadows Golf Course says noise from neighbor's track is driving away customers

The owner of a Glenmont golf course went before the Bethlehem Town Board on Wednesday, April 23, with a signed petition in opposition to the noise generated by his dirt-bikeriding neighbors.

Joe Rappazzo said he has lost business since the property next door to Hidden Meadows was purchased and turned into

an amateur dirt bike course. The Z i m m e r m a n f a m i l y responded that they purposely purchased the large piece of land in a rural area so their children could



practice without disturbing the neighbors.

"We haven't had a single person complain except the owner of the golf course," said Suzanne Zimmerman.

The mother of three said she and her husband bought the property on Wemple Road so their sons could ride their dirt bikes. The family paid \$80,000 for 35 acres of vacant land last October.

In the summer months, the boys compete in motocross racing.

Rappazzo brought forth a petition with 75 signatures from neighbors and another petition with 50 signatures from customer against the

# **BIDA** wants to nix special tax status for Vista site

#### Group says that designation would have only applied to Breonics, which is not moving forward

Since it was officially made known Breonics will no longer be moving to Vista Technology Campus in Slingerlands, the Bethlehem Industrial Development Agency is seeking to remove the project's enhanced abatement status. BIDA Executive Director Tom Connelly said he was told by developers the Columbia 65 building would not be moving forward in the near future because Breonics is no longer interested in the location and there are no other prospects. The updates were presented at this month's IDA meeting on Friday, April 25.

"I'm concerned about this, and principally because of Breonics," said Connelly. "Breonics is gone. Our enhanced abatement was keyed to Breonics. I don't know if we would have given an enhanced abatement ... actually I know we wouldn't have given an enhanced abatement to a medical office building."

Breonics was first announced as a potential tenant for Vista last March. The company would have occupied about 6,000 square feet of a 27,000-square-foot building to be constructed behind ShopRite.

Connelly said the Columbia 15 project is also in jeopardy. That project was also supposed to house Cornea Consultants, a surgical eye-care facility, but the project has not yet received approval from the state Health Department. Developer Joe Nicolla has said in the past he would not go forward with construction of the building until additional tenants were in place.

Site plan approval from the town's Planning Board has lapsed on both projects. Planning Director Rob Leslie said all approved projects must begin construction within one year and be completed within two years. The developers can file for two

#### Nine area residents receive awards for their service

# Master parks plan in the works

#### **Proposed plan calls** for hiring a consultant

Bethlehem officials are hoping to move forward with the creation of a Parks and **Recreation Master Plan** for the town.

Director of Parks and Recreation Nan Lanahan gave the presentation on Wednesday, April 23. She said various town officials had talked of creating a parks master plan for years, but other projects had taken precedent.

"The purpose would be to develop a comprehensive plan for all of the parks townwide," said Lanahan.

The need for a master plan was established in 2007 with the Comprehensive Plan Oversight Committee. It was identified again in 2013 with the Comprehensive Plan Assessment Committee.

The purpose of the master plan would be to take an inventory of existing parks and discuss the needs of the town's existing facilities. The plan would take into account maintenance work that needs to be done, programming and seek recommendations for improvements.

Lanahan said a parks master plan will make the town a better candidate for grants, show new ways to share costs with outside groups, seek efficiencies and prepare a capital plan for future development. The group would be looking into park trends and demographics, what facilities are used the most, how to prioritize investments and usage policies.

The plan would also help the parks department work with youth sports groups to evaluate their needs. Many have said they are in good shape, but some are looking for help.

"We just don't have that a consultant would cost in-house, and the planning department is over taxed,' she said.

The parks and recreation director said she wanted to go forward with the Request For Qualifications process, so she could see what hiring

and what the town could get for its money. She wanted half of the funds to come from the New York state efficiency grant the town received last year, and half to come from the Parkland set aside.

Some board members

were willing to go forward with the RFQ. Others wanted to wait to see if less money could be used. Lanahan said the RFQ would allow for an estimate, but the idea was tabled for a later date so see if less money could be used.

# **Outdoor fire quelled near FMS**

#### **Cause of blaze** remains under investigation, limited damage to area

Simply getting to an outdoor fire near Farnsworth Middle School was the most challenging aspect for firefighters Monday, April 21, evening.

More than two-dozen first responders were at the scene of a small fire near the edge of the middle school's baseball field. The fire started around 5 p.m. and was extinguished approximately a halfhour later. Firefighters remained on scene for at least another hour and were spraying water on the burnt landscape.

Westmere Fire District spokesman Sean Maguire said there was "a little bit of a fire over the ridge" when firefighters arrived. Westmere firefighters requested outdoor equipment from Fort Hunter and Guilderland Center fire departments because of the fire's

location. Small trucks and all-terrain vehicles were used to reach the blaze.

Westmere Assistant Chief Tony Carrow said no buildings were in immediate danger.

"Outdoor fires are serious because they are not contained to a specific area and can sometimes be quite challenging," Carrow said in a statement.

Maguire said the danger for this fire was not because of its proximity to the middle school but its surroundings. Pine trees surrounded the area, and he said there was a lot of "dried out, dead vegetation" in the woods.

"That could continue to smolder, get underground and start to travel, so it's good that we knock it down back here before we have any problems,' Maguire said.

The fire reportedly affected less than one acre. There were no injuries reported.

Several 911 calls were received about the fire from nearby Presidential Lane residents and a school groundskeeper, according to local



The source of the fire remains under investigation, with a local official predicting on Tuesday, April 22, that an answer won't be known for "some time."

"They'll have to get in there and take a look and see if it was just natural from the warmth of the day, or if somebody had been back there," Maguire said at the scene.

Westmere Fire officials urged people to be aware of outdoor conditions, especially when conditions are dry. Local regulations restrict outdoor fires and open burning year-round. fires are permitted for cooking, it's important to have immediate access to an extinguishing agent appropriate for the fire.

"This time of year, even though the snow has recently melted, we haven't had a great deal of rain so that leads to some dry conditions outdoors," Maguire said. "On a nice day, like today, just a little bit of ignition can cause an outdoors fire."

# V'ville adopts budget exceeding tax cap

#### Village spending plan totals \$2.047 million

members approved a village budget exceeding its state mandated property levy tax cap on \$1,000. Tuesday, April 22.


budget, totaling slightly more than \$2.047 million, actually decreases overall spending almost \$75,500. Part of the around 3.5 percent decrease in appropriations stems from the village dissolving its court, which shifts over to the Town of New Scotland. Fund balance usage is also decreasing in the general fund to almost \$50,700. Money is also allocated towards refilling its water and two sewer district fund balances.

The village is increasing its property tax levy 4.5 percent, which totals more than \$287,700. This is the first time the village has exceeded its tax cap limit.

Village Mayor Robert Conway said village is raising an additional \$12,000 in taxes, which is quickly consumed as expenses increase. The cost for street lighting increasing is \$20,000.

"As usual, the board has struggled to maintain the budget as close to zero [percent tax increase] as possible," Mayor Robert Conway said. "We will

There were minor The 2014-15 village reductions in the adopted budget. Additional funds were allocated to recreation department salaries based on program needs, according to village officials. There was also a reduction for audits to correct levels.

Elected officials and village employees are receiving a 2 percent salary increase. A 2 percent increase was also given in the 2013-14 budget excluding the mayor.

Overall revenue in the general fund is budgeted to increase 1.1 percent and totals almost \$1.37 million.

Mortgage tax revenue was conservatively increased 10 percent and totals \$33,000. The actual 2012-13 mortgage tax revenue totaled about \$36,800 and appears to be on track for similar earnings in 2013-14.

Albany County sales tax revenue is budgeted to increase 1.2 percent totaling \$840,000. The actual 2012-13 sales tax revenue totaled more than \$875,000.



# From the Editor's Desk **Charter reform can't wait**

Reducing the size of the county Legislature is hardly a new idea, and it's one that most people — including a number of sitting legislators, Democrat and Republican — agree with. And yet, even with recent charter recommendations that explicitly state the number of seats should be reduced from 39 to 25, we fear we may be no closer to seeing that become a reality anytime soon.

We worry the same foot-dragging that has become a hallmark of this bloated legislative body will keep the Charter Review Commission's recommendations from making it to the voters in November so they can finally weigh in. What, you may ask, could possibly hold things up? Well, true to fashion, the Legislature has formed a committee to review the review commission's recommendations (yes, you read that correctly), and we suspect the back-and-forth that could ensue will make it impossible to meet the Sept. 30 deadline for any revisions to make it on the Nov. 4 ballot.

Granted, there are probably plenty of kinks to work out of the commission's proposal and some logistics to get squared away as to how a downsizing and redistricting will work, but we certainly hope the committee moves quickly and with voters in mind. The bottom line is, this reduction has to happen because a county legislature this size — the biggest in the state — is tripping over its own feet more often than not.

Some may argue that cutting the size of the legislature will reduce the close interaction residents have with their lawmakers, but a ratio of one legislator to about 7,000 residents is hardly an advantage when some of those legislators make very little effort beyond showing up at the monthly meetings. Others say the taxpayer savings from a downsizing would be lost if the remaining lawmakers have to increase staffing to deal with their bigger districts. We doubt that would be necessary, and, in an economy where private sector employees have been asked to do more with less for years, voters have little tolerance for wasteful spending. We can hope that our county legislators care as much about our money as we do.

Let's also not forget that the charter reform recommendations include so much more than just the proposal to downsize the legislature. It is a clunky document in dire need of updating. We'd like to add our voices to those calling for the legislature to prepare a final charter revision for voters this fall.

# Town looks at ways to keep land values fair, affordable

Editor, The Spotlight;

Reassessments are never easy, but using inaccurate and out of date values is far worse. It's the Town's responsibility to make sure assessments and related tax burdens are shared equitably. Homeowners in Bethlehem have been carrying too high a tax burden, and the vast majority will benefit from the reassessment this year. However, the process is causing some friction and concern, as it almost always does.

When the Town committed to reassessment several years ago, we knew that parts of the commercial sector, including big box stores, shopping centers and apartment complexes were undervalued, and the only way to recapture that value was to reassess. We did not know, however, that vacant land was even more significantly undervalued, and that it had not been covered comprehensively in the 2006 and 1998 reassessments. The inescapable result in this year's reassessment, which fully covered all types of property, was that vacant land saw a spike in assessed value.

Sharp increases in

preliminary assessments for vacant land understandably shocked owners. But many of these values are being revised downward through the informal review process set up especially for the reassessment. In addition, taxpayers can still grieve their assessment formally, by appealing to an independent Board of Assessment Review. For active farms there is an agricultural exemption, which like other exemptions wasn't included in the preliminary assessment numbers. This exemption covers about 60 farm properties still operating in Bethlehem and reduces taxable value of farmed land by about 75-85% on average, and prevents growth spurred by land values for farmed land. We would like to see more use of this exemption, as well as the DEC forest land exemption.

Town Boards do not set assessments, and you would not want them to many will remember the bad old days when assessments were used as a tool of politics. In this year's project, Bethlehem used a professional consultant to assist our Assessor's Office in revaluing the 13,000

properties in Town. The consultant made multiple presentations explaining the valuation methods, and I and other Town Board members have looked at many individual cases. These evaluations tell us that universal and accepted professional methods were used, and that following corrections through the informal and formal review process we will have a properly valued tax base, fairly apportioned. But it still leaves us with a dilemma, because we recognize that sharp increases are difficult for any taxpayer.

We are concerned both with the impact on farm families and with preserving green space. In February, the Town Board adopted an Open Space Program, including a commitment to evaluate all methods of encouraging open space preservation. Although state law prevents the Town from assessing any land below value, we are exploring options to legally provide tax relief for conserved land. The Town Board and I hope to be in a position to offer such options soon.

# Assessor's work flawed

Editor, The Spotlight;

The reassessment project in the Town of Bethlehem is flawed in several ways. The most obvious is how the values were established for agricultural and vacant land. Comparable sales of ag land in Bethlehem are non-existent, so GAR took values from Schoharie and Columbia counties and used a formula assessing the land incrementally on the acreage.

In Schoharie and Columbia counties there are more full-time and larger scale farms than in Albany County, especially in dairy, livestock and grain. Bethlehem is NOT an agricultural community. The land values given by GAR on farmland ranged from \$2600 to over \$5000 per acre. There is a high demand for land anywhere with a strong presence of agriculture like Washington, Rensselaer, Schoharie and Columbia. Competition is high for ag land and of course, the land is an essential part of the business itself. In Bethlehem, all farms are

part-time or substantially subsidized by off-farm income. The revenue generated by farm activities here will never be selfsustaining. Soil quality is lower in Bethlehem, which GAR could have seen from soil and water maps.

As an example, if I rented 100 acres to farmer for \$30 an acre, I would collect \$3,000. If the land is assessed at \$4,000 per acre, I would have to pay roughly \$10,500 in taxes. STAR and ag assessments will not relieve this kind of burden. How many landowners would want to keep their land with that scenario? There would be no buyer for this quality of land for \$400,000.

Then there is the nonagricultural undeveloped (or vacant) land. In many cases this classification was hit even harder. Most of it is not profitable in any manner by its use. It may be land that extends one's yard; some of it is not buildable and some of it is too wet to do anything with. The land is, however, valuable to the community by the character it preserves, the wildlife habitat it supports and the viewscapes enjoyed when one walks or drives through the town. It does all of this while not demanding services provided to the residentially developed community.

The Bethlehem Town Board, lead by Supervisor John Clarkson, needs to demand that GAR do the work it was paid to do and provide a quality product to our town. GAR did not do their due diligence, did not visit one parcel of land, used comparison values and formulas which do not apply. This is an injustice to those who have stewarded farmland and held onto open space for the sake of privacy and the beauty it gives to the community. It serves no good purpose to destroy greenspace when there is no call to do so, and in fact, there is a call to preserve it. GAR has not fulfilled its contract. Mr. Clarkson and the Town Board need to put a stay on this project until the job is done correctly.



# Library proposes budget

The Guilderland Public Library's Finance Committee has proposed, and the Board of Trustees has unanimously approved, a 2014-2015 budget of \$3,541,967. This represents an increase of \$49,832, or 1.42%, over the 2013-2014 budget.

The proposed budget maintains the service levels the community has come to expect from its public library, assures a continued supply of quality materials for public use, maximizes use of current resources, dedicates funds for building maintenance and is below the mandated tax cap. Specific budget allocations are available on the library's website at www.guilpl.org/ budget-2014-2015.

There will be a public briefing and comment session on the library's budget on Thursday, May 8, at 7 p.m. in the library's Tawasentha Room. The public is encouraged to attend.

The public vote on the proposed budget will be on Tuesday, May 20, from 7 a.m. to 9 p.m. at local elementary schools.

Also, part of this vote is the election of Trustees to fill four open seats on the library's board. Information on the candidates is available at www.guilpl. org/budget-2014-2015.

Generally speaking, individual line items on the proposed budget hold to the same spending levels as the current year's budget. There are three notable exceptions: One is that funding for salaries and benefits are reduced because of retirements and by bringing on replacement staff at earlier stages of their careers. Though staffing is down slightly, current levels of service and programming are maintained.

Another reduced item is under business operations, which offers savings in printing and postage costs by shifting the library's monthly postcard content to a local publication, Guilderland Our Towne. The staff and Board agree that it's vital to keep the community informed about the library's programming; partnering with an established local publication offers a more efficient, economical

solution.

The third exception is that the savings noted above are being devoted to investing in the library's upkeep through the establishment of a "Capital Reserve Fund." Initially funded at \$90,000 in the proposed budget, the purpose of the reserve is to set aside funds for fixing anticipated maintenance needs in our 22-year-old building.

The proposed budget is in line with the rate of inflation and is a prudent, responsible approach to underwriting the library's operations for the coming year.

The Trustees and staff are grateful for the community's continued support.



# Large landowners seek relief

Many turn out to protest as town looks into ways to ease the burden of increases

As large landowners once again turned out in protest against Bethlehem's townwide reassessment. officials said there was little they could do to help other than urge residents to go through the grievance process.

Large landowners, and some residents standing in solidarity, spoke out against the assessments for nearly two hours at the Wednesday, April 23, Town Board meeting. Those protesting had asked the town to hold off on the assessments for one year while officials looked into a possible tax credit for open space. Others were upset by the job performance of GAR Associates, the company hired to do the assessments.

"It seems like there is a bit of an inequity here, in terms of the way this is impacting (landowners) for something that is really beyond their control," said Councilman Jeffrey Kuhn.

Supervisor John Clarkson said it is believed that the

and had gone about their lives thinking their assessment was correct for the past eight vears.

"It really wasn't their fault that their assessment on vacant land was so wrong, if in fact it was," said Kuhn. He then asked what tools the town has to mitigate the dramatic increase in assessments, even if the properties are now assessed at full-market value.

Clarkson said the problem is there is very little the town can do, but he's been looking. The process of taxation is established by the state legislature in real property tax law, so towns have little jurisdiction.

Town Attorney Jim Potter said in a later interview that the town cannot simply stop the reassessment now that preliminary assessments have been sent to property owners.

"We now have the data of what is believed to be the fair market values of people's property," said Potter.

According to Potter, if the reassessment were stopped, it wouldn't be fair to those who had their assessments go down. Since the preliminary assessments were already sent, those people could then use the data provided to go to court for a lower assessment. He also said state law does not allow for the assessments to be introduced gradually, or for what's called a "circuit breaker," to be introduced.

for vacant land, with much of it in the town sold to developers.

For those who went through the preliminary hearing process, the results from those hearings will be available through the Assessor's Office on May 1. Residents who went through the process will receive letters soon after.

Anyone who did not go through the process or still believe their assessments are too high can grieve the assessment on May 27.

Because of the large amount of people who will likely opt to grieve, the Town Board voted to increase the number of members of the Board of Assessment Review from three to five. Appointments are first come, first serve, and will continue into the next day if need be.

Town Board members asked if there was anything that could be done to help Interim Assessor Laurie Lamberstan over the next month. Lamberstan said she was worried if newly trained workers joined her office, they would give out the wrong information to residents.

Kuhn suggested adding some staff from other departments so letters could be sent to large landowners who hadn't gone through the process of a preliminary hearing. He said some people may not have realized they could go through a preliminary hearing or that the time period to do so was over. He wanted those people to know there was still time to grieve their assessment and how to get the information they needed when appearing before the Assessment Review Board. The rest of the town board liked that idea and thought it would be helpful, particularly for older residents. Clarkson said they are going forward with that plan, but they can't begin until the new assessment rolls are updated on May 1.

# Thacher Park awarded \$3.8M for visitor center

#### State and private funds tapped for key step in park's master plan

John Boyd Thacher State Park nabbed \$3.8 million in state funding to build a new visitor center, which was a main element in the park's recently completed master plan.

Gov. Andrew Cuomo on Tuesday, April 22, announced the funding as one of the 69 projects to improve or repair 53 state parks and historic sites. Projects statewide received a total of \$90 million, with the Capital District receiving \$8.675 million for nine projects at five locations. The new visitor center at Thacher Park will feature new exhibits highlighting the parks history and geology, a multi-purpose space for the gatherings and visitor orientation services. Administration office space for park staff will also be included.

Chris Fallon, park manager at Thacher, said he was "thrilled" the state awarded funding for the new visitor center.

"We had been talking a b out it and were optimistic it would be put on the funding schedule, but to see it become official is thrilling," Fallon said. "We really had no place to showcase an exhibit — all the great things about our history and geology — so this will enable us to do that."

Fallon said the visitor's center is needed because

the main road into the park lacks an orientation spot for visitors. Unless someone has been to the park before, he said, they would not know where to go for information.

He said construction on the visitor's center is expected to start later this year with a hopeful opening, next year.

The location of visitor center will allow visitors to take in the park's views and easily access the nearby Indian Ladder Trail.

"It is going to be in a spot that takes advantages of some of the spectacular views we have here," Fallon said.

Cuomo, who made the announcement on Earth Day, said the statewide investment shows commitment to parks and



historic sites.

"New York is proud to have the nation's oldest state park system, and we will continue to do all that we can to preserve and guard these natural resources so that they can be enjoyed for generations to come," Cuomo said in a statement.

Office of Parks, Recreation and Historic Preservation Commissioner Rose Harvey said the funding would help make "much needed repairs," along with preserving our heritage, connecting people with recreation opportunities and "rev the engines of local economies."

Another area site receiving funding is Saratoga Spa State Park, which was awarded \$1.775 John Boyd Thacher State Park received \$3.8 million in state funding to build a new visitor center.

90-day extensions before the projects have to go back before the planning board.

The 11 organizations awarded conservation program funding will go towards a variety of initiatives, he said.

"The grants will leverage additional funds to expand the area's network of trails, protect natural areas, increase community connections to their food, strengthen land owners and community outreach and implement national standards for land trust excellence," Martens said.

Mark King, executive director of the Mohawk Hudson Land Conservancy, said the funding its receiving will be used to hire an additional staff member. "We really are fortunate to have so

many opportunities, and there is so much more we can do," King said. "So, building this capacity is really the key to it."

King said he has seen land trusts evolve over the years. The focused used to be on plants and animals, he said, but it has shifted to people.

"People are really at the key to what we are doing," he said. "Our vision is really to connect communities and people to land. We've all heard many times of how discontented we are becoming; well, land trusts are really the key to bringing that connection back to us."

noise. He said since the start of spring, the boys have been riding their dirk bikes on nights and weekends, and the noise is upsetting his golfers.

Zimmerman said her family was willing to work out certain times to ride that would suit the golf course, but the expectations had to be reasonable. Her oldest son, Kenny, works and goes to school, while her other children attend Glenmont Elementary. They typically only have time to ride on evenings and weekends.

"In the summer, they shouldn't be riding on the weekends because they will be away competing," said Zimmerman after the meeting.

She said the family has two acres at their house on Bender Lane, but the bikes were ruining the yard so they purchased the extra property.

Rappazzo said working out times has been an issue because the same times someone would want to ride a dirt bike, are the primary times people like to golf. Gilda Rappazzo also said the noise has been disturbing the sleep of her grandchildren.


The Town of Bethlehem has a noise policy for anything above 65 decibels, but it is only in effect from 11 p.m. to 7 a.m. Town Attorney Jim Potter said those times were selected because a lot of average tools that a homeowner may want to use are louder than 65 decibels, like a lawn mower or leaf blower.

"It's my sport. It's what I enjoy doing with my free time," said Jack, 23.

Both the police and town building inspector visited the property at Rappazzo's urging, but said there was nothing that could be done. The town also said there were few options.

"Is there any type of noise mitigation device that you could put on these things?" asked Councilman Jeffrey Kuhn

Jack said there are, but they hamper the performance of the bike. Zimmerman said later in the week that Jack spent \$190 for a new muffler at his stepfather's urging because his bike is the loudest.

Board members also asked if each side could pay to have a fence installed. Neither party thought a fence would help and said money was an issue.

"People don't have money to throw out like other people," said Wendy Muller, Rappazzo's daughter. "This is their livelihood you're throwing out. These are my parents. I'm not going to see them thrown out of their house because you have recreational problems."

Zimmerman said she brought her kids to the meeting because she wanted the board to see they were not teen delinquents but normal athletes like anyone playing baseball or soccer.

"They're not going out and getting into trouble, and they try to be respectful," said Zimmerman.

Rappazzo said after the meeting that if more people stop using his golf course because of the noise, he will have to close.

"I don't know if mufflers will solve the problem, but it may help. It took us years to build this business, and someone moves in one year, and we may have to go out of business," said Rappazzo. "It doesn't seem right."

Potter said it would be nice if the two parties could come to an agreement on their own, but he realized that's why they came before the Town Board.



# Voorheesville Area Ambulance Service contract signed

#### Town hands over reserve funds to VAAS, village holds onto reserves

This year's Voorheesville Area Ambulance Service contract signing with the village didn't go quite as smoothly as predicted months ago, but it's still around two months earlier than last year.

The Voorheesville Board of Trustees on Tuesday, April 22, signed a contract with its local ambulance service provider, but board members declined signing an addendum giving reserve funds directly to Voorheesville Area Ambulance Service. The funding has been a contested issue between the village and VAAS. The New Scotland Town Board chose to give reserve funds directly to the ambulance company.

This is the first year the ambulance service has had one, unified contract with the village and town. Previously, contracts were negotiated and written up separately.

The village previously created a reserve account earmarked for VAAS, which was funded in this year's budget at the contracted amount of \$4,680. New Scotland's portion of reserve funding totaled \$7,320.

New Scotland Town Supervisor Tom Dolin said the Town Board approved signing the contract and addendum after an executive session, which is closed to the public, at its Wednesday, April 9, meeting. The board did not indicate it would approve the contract after leaving executive session.

"We don't normally take action afterwards, but we had been without a contract since Jan. 1. They had been providing a service, and we hadn't paid anything," Dolin said.

There were two addendums attached to the contract, one for each municipality to sign, which stated the reserve funding would be given directly to VAAS by May 1. The addendums,

though, were not needed for such an action because the contract states a reserve account "may be maintained" by the village and town in respective accounts.

An addendum is considered an addition to the contract rather than a condition.

Dolin said the town opted to include the addendum to "expressly document" what action the town took this year. He said ambulance service members felt "very strongly" about maintaining its reserve account in-house.

He added the board also did not see why it should make a distinction for VAAS, because reserve accounts are allowed to be maintained within other ambulance service and fire companies in the town.

"It worked out fine in the past, so we didn't see any reason not to continue," Dolin said.

Voorheesville Village Attorney Rich Reilly and Mayor Robert Conway said they had not seen the addendum until shortly before the April 22 meeting. Dolin said town officials notified village officials it was turning over reserve funds, but did not send the new addendums.

Dolin said the addendum was included as "a courtesy" if the village wanted to pursue the same option. Village officials have been adamant about holding onto reserve funds until VAAS made a vehicle purchase.

In the village's newsletter mailed to residents last September, Conway had laid out five instances where the Town Board felt the company did not act as "fiscally prudent" as board members preferred. Conway has continued to say the village must protect taxpayer's money.

"I would not recommend signing the addendum," Reilly said to village board members during its workshop meeting before the regular meeting April 22. Terence Hannigan, an attorney representing the ambulance company, said VAAS was looking to purchase a new ambulance soon. Hannigan did not see why the village could not hand over reserve funds, since a purchase was planned.

Hannigan said the ambulance targeted for replacement is 12 years old, which has exceeded the standard useful life of the vehicle.

"The village, for some reason, has objected to the ambulance (company) having reserves, so they have fashioned this remedy," Hannigan said. "We will see if they mean what they say by turning it over or not."

Village board member Jack Stevens said the company already has enough funds in its reserve accounts to purchase a new ambulance.


"If anything was to happen in the future, ... whereby the ambulance was to shut their doors for whatever reason, then monies would be given away to a like or similar organization," Stevens said. "The village is looking just to protect that money, that's all.

"It would be money held in an account for them, and when they need it we would give it to them. Pretty simple concept."

Stevens reiterated the village was only looking to protect taxpayer money. He said the village had heard "rumors" the company was looking to purchase an ambulance, but only recently was told it would make such a purchase.

The contract did include a measure previously discussed to have both municipalities cooperate with VAAS to study and development a comprehensive townwide ambulance service plan. The 2014 contact, including reserves, totals \$90,240, with the town covering 61 percent and the village covering the remainder.

# **District keeps budget under cap**

#### **Cuts to staff and** equipment purchases help BCSD close gap

The Bethlehem Central school board has adopted a spending plan for the 2014-15 school year that does not challenge the state tax cap.

The adopted plan calls for more than \$92.6 million in spending for the coming school year and a tax levy increase of 2.99 percent. The proposed budget increases spending by \$2.2 million from the current school year.

The Board of Education adopted the budget at the Tuesday, April 22, meeting. This is the first time in three years the district will not be

challenging the state's tax cap

"We're hoping this plan maintains as much of our educational programs that we have, as well as provides what we hope would be reasonable to present to the community," said Douglas.

The district was facing a \$4.8 million budget gap for the coming school year. About \$1.2 million in fund balance will be used to close the gap, along with taking in an additional \$1.8 million through the tax levy. The district also received an additional \$580,000 in state aid.

To close the gap, the board needed find to \$768,000 in reductions. It was decided the district could do away with one social worker. An additional 3.8 full-time equivalent teaching positions would be reduced because of decreased student enrollment projections.

Other money was found though lowering equipment additions in both the technology and operations and maintenance departments. Money was also saved by purchasing supplies early.

The public hearing on the proposed budget is set for Wednesday, May 7, at 7 p.m.

The budget vote will take place on Monday, May 20, from 7 a.m. to 9 p.m. Also on the ballot is the election of three Board of Education members and a referendum to replace several buses.

# V'ville school board adopts budget

#### Tax levy would increase 2 percent; state aid boost restores cuts

An infusion of state aid restored some of the most contentious cuts slated for Voorheesville school district's 2014-15 budget, which stays within its state-mandated tax cap.

The Voorheesville Board of Education on Monday, April 21, unanimously adopted a spending plan totaling \$22.89 million, which remained essentially unchanged from its March 31 meeting. The property tax levy is increasing 2.04 percent, or almost \$328,000, which totals just under \$16.44 million. An additional \$144,000 of state aid was included in the state budget, with overall state aid totaling nearly \$5.15 million.

Board of Education President Timothy Blow said he was "relieved" with the final budget.

"We were able to restore many things that we had never wanted to cut to begin with," Blow said. "Not to mean that they are not potential cuts for next year. ... Until something changes in this formula of out of control expenses ... and fixed revenue it is not good for the school district."

Even with the boost in state aid, Voorheesville is still receiving less than it did during the 2008-09 school year.

The district is holding a mandated budget hearing on Monday, May 12, at 7:30 p.m. in the Large Group Instruction (LGI) room at the middle school. The budget vote will be held on Tuesday, May 20, from 2 to 9 p.m. in the middle school foyer.

#### Restorations and reductions

The boost in state aid shrunk the district's budget gap to around \$175,000. This allowed the board to restore two of the most contentious cuts, which were the elimination of one section of the fourth grade next school year and the phasing out of French classes.

Some school board members expressed reservations over limiting foreign language options to only Spanish. Part of the push toward phasing out French is declining enrollment in the language.

"Our plan is to continue offering French for the seventh grade next year, but going forward, enrollment is going to play a big part of that," Blow said on March 31.

Reductions remaining in the budget targeting outside of the classroom include:

Reducing clerical and aide time — \$67,900 in savings
Eliminating one full-time equivalent (FTE) custodian position—\$40,900 in savings
Reducing the humanities coordinators — \$4,650 in savings

Reductions hitting the classroom include:

Reducing 0.2 FTE speech position — \$13,700 in savings
Reducing 0.2 FTE in English, resulting in four eighth-grade sections — \$12,715 in savings
Eliminating family and consumer sciences offerings at the high school — \$19,180 in savings

Other positions restored in the budget include one computer teaching position, 0.5 FTE music teacher position and one elementary school science teaching assistant.

#### Combined classrooms eyed

School board members at the March 31 meeting also talked about the possibility of having combined classrooms during the 2015-16 school year. A combined classroom would involve two grades of students in one room.

Board member Diana Straut said combined classrooms could be effective if done carefully. She said parent volunteers could also help support a teacher in a combined classroom.

Superintendent Teresa Thayer Snyder said a prior district she worked for that implemented combined classrooms found the "payoff" was in the second year. Students did not lose any time learning new rituals in the blended classroom and stayed with the same teacher for two years, she said.

Voorheesville Teacher Association President Kathy Fiero expressed concern over the proposal to create multi-age classrooms without prior conversation with staff members.

Board member Kristine Gravino said the proposal is not planned for next school year, but as a future option.

"In the future, things are going to get worse in terms of budget cuts, and our enrollment is declining and it has been over the years," Gravino said.

# **RCS Schools flip the switch to solar**

Over the next 20 years, solar collectors sitting atop the four school buildings and bus garage are going to harness enough energy to clip at least \$800,000 from RCS utility bills – all at no cost to taxpayers.

The collectors have been installed on the roofs at the high school, middle school, A.W. Becker Elementary School, Pieter B. Coeymans Elementary School and the bus garage. Estimates from US Light Energy, the contractor working with RCS to develop the Power Purchase Agreement (PPA) for the project, show that electric charges will drop by \$807,076 (a 11.34 percent drop) over the next 20 years at a minimum.

"Solar energy is not the exotic, experimental power source it may have been 30 years ago," said Interim Superintendent Dr. Alan McCartney. "It is now providing energy in a big way around the globe and here at RCS."

McCarney noted that the sun's rays pouring onto the Earth creates more than enough energy in one hour to satisfy global energy needs for an entire year. Solar energy is the technology used to harness the sun's energy and make it useable. Solar energy produces no pollution and causes no harmful environmental effects.

McCartney also noted that schools across the nation

spend more than \$6 billion on energy costs every year.

"That is more than the amount that schools spend every year on text books and computer technology combined," he said.

The RCS school district is

doing their part to cut those energy costs. The system on RCS rooftops will provide a maximum of .79 Megawatts (790,000 watts) of solar power each day. A typical home uses about 20,000 watts of power each day, so the RCS system will produce enough power for nearly 40 homes each day.

Solar panels will also produce electricity even on cloudy days, usually around 10 to 20 percent of the amount produced on sunny days. National Grid will continue providing power to all of the buildings, so when the skies are cloudy, the current power grid will make up the gap between the solar-produced power and the needs of the


buildings.

The estimated 20-year savings looks like this: high school, \$180,059; middle school, \$173,701; AW Becker, \$179,302; PB Coeymans, \$171,179; and bus garage, \$102,835. The amount of savings is determined by the number of solar collectors on the particular roof. Because of the roof designs and elevations, each school has a different number of collectors resulting in a different savings figure.

McCartney also noted that in case a roof needs to be replaced or rehabilitated, the contractor will remove the solar panels and reinstall them at a small cost.


