Greulich's abruptly closes

Family-owned market in Guilderland shuts its doors after nearly 65 years; owes \$15k in property taxes

An iconic neighborhood market abruptly closed its doors in Guilderland more than a week ago, with more than \$15,000 of outstanding taxes on the property.

Greulich's Market closed Sunday, July 27, with apparently little warning

to longtime customers of the family-owned business. A message was posted to its Facebook page that afternoon informing customers of the decision, with many people leaving surprised comments.

"It's a sad day for Greulich's today, we sadly closed. We will let you know what we decide to do," read the Facebook post.

Bonnie Greulich, co-owner of Greulich's Market, declined to comment when contacted by Spotlight News about the closure

Road, which holds a full market value assessment of nearly \$430,000. The taxable value of the property for Albany County, town and school taxes was \$395,500, which has not increased for several years.

Guilderland Receiver of Taxes Lynne Buchanan said storeowners had previously paid taxes in a "timely"

New 214-acre preserve formed along Bozenkill

Dr. Becker's wish granted after his death

Dr. Milford Becker spent the last years of his life trying to preserve some of the land he owned, but he did not see his vision realized. Almost seven years after passing away, his wish is coming true.

Becker, who was a Guilderland veterinarian, reached out to Mohawk Hudson Land Conservancy 15 years ago inquiring about how to preserve his land. Becker died in August of 2007 at 91 years old, with his wife, Mary, also passing away before a deal was finalized. The Becker family, though, kept pursuing perseveration efforts and MHLC recently purchased the 156-acre Becker property.

Milford Becker's daughter, Linda, said her family lived at the corner of Bozenkill and Westfall roads for 42 years. She said they would walk to property almost every day.

"My parents loved the land and especially the birds," said Linda Becker. "My mother knew the call of every bird, and my father knew every tree on the property."

Mark King, executive director of the MHLC, said conservation efforts usually involve a long process.

"Land protection and conservation efforts tend to take a long time. They are expensive, and it is hard to get people to agree," said King. "Sometimes it seems like a miracle when it all comes together, and we couldn't be happier that it did."

MHLC also acquired 27 acres of neighboring land several years ago, which expands the preserve to 214 acres, including more than a mile and a half of stream frontage.

"It is a good amount of land, and it is really the conglomeration of three different acquisitions," said King. "It is a remote and very intact natural area."

The Bozenkill is one of the major tributaries of the Watervliet Reservoir, which supplies water to Guilderland and the City of Watervliet. The preserve includes heavily forested areas, steep wooded slopes, small fields and extensive stream frontage.

"These acquisitions will eventually allow access to a beautiful stretch of the upper Bozenkill and Bozenkill Ravine — areas that were inaccessible to the public," King said

in a statement. "We look forward to adding parking and trails that will make this an outstanding nature preserve within walking distance of the Village of Altamont."


According to Charles Gehring, director of the New Netherland Project, Bozenkill is a Dutch term; "kill" refers to a stream and "bozen" means angry or raging. The name becomes especially appropriate following heavy rains or during spring runoff.

Kim Elliman, president and CEO of the Open Space Institute, said preserving the 156-acre Becker property is a testament to the Beckers commitment to conservation efforts.

"As responsible stewards and lovers of nature, Dr. Becker and his family recognized the natural beauty and conservation significance of this special landscape. The designation of their homeland as part of this new preserve provides a wonderful tribute to them and their legacy of stewardship and generosity," said Elliman.

The Open Space Institute provided significant financial support for the project, according to King, and holds a conservation easement over the property ensuring its permanent protection.

Nature The Conservancy also supported the project through the Doris Saunders Plant Strategic Acquisition Fund, which the late Henri Plant and his family created to help protect the upper Bozenkill area. Henri Plant was closely associated with another preserve along the Bozenkill, the Christman Sanctuary, which spans 120 acres in the Town of Duanesburg.

Plant's daughter, Suzette, was pleased to see more land around the Bozenkill preserved. "Forty years ago, a small group of people first set out to keep the Bozenkill forever wild," said Suzette Plant. "It is wonderful that despite the number of years it is taking to acquire additional land, people are still committed to making the dream come true."

The MHLC paid approximately \$110,000 for the 214 acres of land, with an additional \$40,000 set aside to care for the property, according to King. An official name for the land has not been

determined, but King said it would likely honor the Becker family.

"We don't anticipate the real public opening until the spring," King said, "because we have to do some planning and figure out where to best locate trails and put in a parking lot."

An official announcement of the preserve formation will be held on Tuesday, Aug. 12, at 10 a.m., at the corner of Westfall Road and Bozenkill Road in Guilderland.

Woman found dead in Bethlehem home

Results of autopsy point to natural causes

Bethlehem police say the results of an autopsy performed Saturday, Aug. 2, indicate the woman who was found dead at her Delmar home on Friday died of natural causes.

Police received a call to respond to 63 Union Ave. around 10:30 a.m. Friday after an acquaintance stopped by the home and found the deceased, who police have identified

as homeowner Nancy Purcell, 60.

On Saturday, an autopsy was performed at Albany Medical Center Hospital by Pathologist Dr. Jeffrey Hubbard. According to a statement from Detective Sgt. Adam Hornick, based upon the autopsy, and the dozens of interviews and leads completed in this case, the cause of death has been ruled to be natural causes with no indication of criminal activity.

investigation into the circumstances that caused initial concern at the residence have been thoroughly examined and found to be consistent with the cause of death," Hornick said in the release. "This information was also confirmed by the completion of over 30 investigative leads and interviews of subjects in three different states."

On Friday, police were investigating the scene, as well as the manner of death and the amount of time the deceased has been in the residence. State Police were called in to help with the investigation because "there were things that aren't consistent" in the house that had raised some concerns.

The investigation was conducted jointly by the Bethlehem Police Department and the New York State Police Bureau of Criminal Investigation, and further assisted by the Albany County District Attorney's office.



On Friday, Aug. 1, Bethlehem police were investigating an unattended death at a home on Union Avenue. Police were called to the scene at about 10:30 a.m. after being notified by someone who had stopped by to check on the decease, who police have identified as homeowner Nancy Purcell, 60. Her death was eventually ruled to be the result of natural causes.

Suspect arraigned in Coeymans murder case

District Attorney's Office announced that Brandon Biers, 24, of Coeymans, was arraigned on one count of murder in the second degree in Albany County Supreme Court.

A grand jury previously returned an indictment alleging that between May 24 and 25, while at a residence on Biers Road in the Town of Coeymans, Biers caused the death of his mother by means of strangling her.

Biers was arraigned before Judge Thomas A. Breslin. He pleaded not guilty to the charges on Thursday, July 31, and was remanded into custody without bail.

Assistant District Attorney Shannon Sarfoh, bureau chief of the Special Victims Unit, is handling the prosecution of this case.

Car crash knocks down power lines

A Vestal woman had to be extricated from her vehicle after crashing into a telephone pole on Western Avenue, according to police.

Guilderland police responded to a car crash

The Albany County near Stuyvesant Plaza Emergency Response around 3 p.m. Sunday, Aug. 3. Police said Elanor McClellan-Mead was driving east on Western Avenue when she allegedly drove off the right side of the road and struck a wooden telephone pole. McClellan-Mead's vehicle then overturned and she became trapped inside it.

Members of Westmere. McKownville and North Bethlehem fire departments extricated her from the vehicle. McClellan-Mead received medical attention from the Town of Guilderland Paramedics and Western Turnpike Rescue Squad. She was the only person in the vehicle.

Police said she was transferred to Albany Medical Center with serious injuries.

Western Avenue was closed for an extended period of time because of downed power lines.

Guilderland police on Sunday evening said the crash was still being investigated.

Major drug bust in Albany County

On Friday, July 31, members of the Sheriff's Team executed two search warrants with the assistance of the Albany County Criminal Investigation Unit and special agents from the ATF, DEA and the Colonie Police Department. The search warrants were executed at 1779 Central Ave., Colonie, and 2185 River Road, Coeymans.

The search found 15.6 ounces of heroin, \$32,000 in cash, as well as some cocaine and marijuana.

Albany County Sheriff Craig D. Apple said four Albany men were arrested on drug charges following a four-month investigation by members of the Albany County Sheriff's Criminal Investigations Unit along with special agents from the ATF.

The investigation revealed that the organization was selling heroin at local malls in the food courts and Dave and Busters. As the organization grew, so did the methods of operation. According the investigation, local cab drivers were solicited to transport the drug dealers around the Capital District.

The organization was allegedly paying to lease the taxis and also paying the drivers in cash and/

or heroin and even had them working in shifts. Investigators and special agents assigned to the case conducted hundreds of hours of surveillance and were able to identify more than 20 members of the organization.

The men arrested were in Friday's raid were: Irving Prado, 40, of 1779 Central Ave., Albany; Donte Joseph, 23, of 2185 River Road, Coeymans; Cheick Sakho, 30, of 2185 River Road, Coeymans; and Nicholas Vervos, 60, of 20 Rensselaer St., Albany.

All four were charged with criminal possession of a controlled substance in the first degree, which a class A1 felony. Judge Peter Lynch of the Town of

Colonie arraigned all four in the Albany County Court. More arrests are expected in the case.

Other arrests:

 Guilderland police arrested Dylan R. Lafave, 20, of 28 Inman Ave. in Albany, around 4:10 p.m. Friday, July 18, and charged him with criminal contempt in the first degree, a felony, and criminal mischief in the fourth degree. Police said Lafave allegedly broke a wooden chair by throwing it. He was taken into custody without incident, according to police.

 Guilderland police arrested April M. Jubrey, 38, of 4678 Western Turnpike in Altamont, around 1:30 a.m. Sunday, July 20, and charged her with DWI, failure to dim lights, failure to keep to the right and failure to stay in a single lane. Police stopped her after allegedly witnessing her commit traffic infractions on Windingbrook Drive. Police observed her to allegedly have an odor of alcohol on her breath and glassy, bloodshot and watery eyes. She allegedly told police she consumed one beer at nearby bar. Police said she used the driver's side door to assist herself exiting the vehicle, and she almost fell over. She failed several standardized field sobriety tests. A chemical breath test revealed a BAC of 0.24 percent.

• State Police arrested Vipulkumar R. Desai, 39, of Guilderland, on Thursday, July 31, and charged him with DWI. State Police were refueling their vehicle at Stewarts. located at the intersection of routes 20 and 146 when a person approached them to report a man consuming alcohol in a vehicle in the parking lot. 



Putting Big Brother in his place

Police departments are increasingly turning toward technology to help them fight crime. It's only natural, considering the role technology plays in all of our lives. Officers can't be everywhere at once, so they are turning to video cameras to help them locate law breakers.

But at what point do these devices and the information they collect become an intrusion on our right to privacy? Sadly, we think that time has already come.

Think back to last year's scandal surrounding the National Security Agency's surveillance of cellphone conversations. Despite the NSA's claims that it was in the nation's best interest to monitor phone calls to locate possible terrorist activity, many of us felt violated because those were our private conversations its agents were listening in on.

Fast forward to 2014. The City of Albany is considering installing red light cameras to catch potential traffic law violators, while the Town of Colonie is installing license plate

readers along Fuller Road to monitor who is coming and going — just in case one of those drivers had committed a crime somewhere and happens to be passing through that part of town.

In both cases, law enforcement officials have said the use of these devices is strictly for investigating crimes. But after what went down with the NSA, we know that, even under the best intentions, that data can be misused. We should be able to drive on the streets of our cities and towns without feeling like we're being watched to see where we're going and what we're doing like every one of us is a potential criminal.

In Albany, there is a movement to stop the installation of the red light cameras. Protesters showed up at City Hall last month with nearly 250 signatures on postcards made to look like traffic tickets to voice their opposition to the cameras that have already been approved by the state Legislature. That might seem like a drop in the bucket when you consider

the city's population is more than 97,000, but it proves there are those out there who don't want their privacy compromised. And we feel there should be more who feel that way.

The Fourth Amendment in the United States Constitution protects us from arbitrary arrests and unreasonable searches and seizures of property. But it doesn't protect us from having what we do on a day-to-day basis being taped and held in a computer database for law enforcement officials to review at their discretion. They may need to go through the proper channels in order to gain access, but they can still see what many innocent people are doing in the hunt for one criminal.

We understand that the police and other law enforcement agencies need to do their jobs to protect the peace, but we believe an overreliance on mass data collection compromises the privacy of law-abiding citizens.

Big Brother doesn't need to watch us all to find the few bad seeds in our communities.

As of now, our kids have been to a bar mitzvah, a bat mitzvah, a wedding and many very formal services. We gave them the information needed to fit in if they didn't know what to do: look at the adults around you and see what they are doing. As adults, don't we do the same things when we aren't really sure what to do?

Teaching kids manners is something that doesn't happen in one conversation. Manners happen when your kids see how you behave and how others behave.

I am not saying my kids sit nicely in their dress clothes and behave all the time. There have been plenty of times when I have taken the kids out and let them get rid of some energy before going back to the conclusion of services. I know that my kids have limits. I know how annoying kids can be when they lean over repeatedly and whisper in that not so quiet voice: How much longer! Are we done yet?

Part of the reason my trio does well during religious services is because they like going as a family. We get to spend time together. We learn things together and talk through the different questions they each have. As a family, we observe rituals at home and the kids ask questions about that. There are so many questions. Imagine any child and the number of questions that he might ask in a day... and now multiply that by three. Sometimes, I feel like I am being cross-examined by some very stealthy lawyers.

My kids are not perfect. Shoot! They are some of the most whiney and contrary bunch of kids on some days. I have to admit that I am not the perfect

parent either. So, we work together as a unit trying to make this one part of our week better. We talk about what is expected, if there is anything new happening and sit in a place that makes a run to the bathroom less noticeable.

Another situation that seems to make kids into little demons is the waiting room. Any waiting room is a place for disaster. Or is it? I make a plan before I go anywhere that we might be sitting for a little bit. I have books, notebooks, pens and game ideas. We do the usual 'I Spy', tic-tac-toe, hangman and practice handwriting. We also do quick math problems, spelling quizzes and draw pictures. I have a one subject notebook for each of the kids and they write stories, questions and try to stump each other with made up words. We have gone through many notebooks, and I keep them for when they get older. I like the one subject because they are cheap, and the kids love having something that belongs to them. Sometimes, we put stickers on them and decorate the cover.

No child is going to be an angel all day. I am sure that my kids drive other parents crazy sometimes, and I am sorry for that. I am doing the best I can ... just like everyone else.

Woman tailors new business to fit the fashion needs of office workers with hectic schedules

In a former life, Heather Dwyer was a senior executive at an investment firm in an office park. After 14 years, she decided to take a break.

"It was a great place to work, but heaven forbid you needed to run out and buy something," she said. "I never had the time. I didn't even buy my own clothes. My secretary did, and if I didn't like something or it didn't fit, it went out with the 5 p.m. parcel pick-up."

Dwyer decided to take a vacation from her busy life. She wanted to travel and have some time to herself, so she took a trip some might compare to the novel "Eat, Pray, Love."

It was while climbing through the Himalayan Mountains in Nepal, Dwyer finally thought she had decided to go back to work. She was thinking of hiring some new assistants, and was figuring out her new schedule when she stopped herself.

"I just thought it doesn't have to be this way," said Dwyer. "I can make a change."

Thinking back to her former hectic schedule, she came up with the idea for a mobile boutique that could travel anywhere but would especially cater to the employees of office parks. Dwyer was still on her trip when she began making plans and drawing sketches of the boutique.

The original plan was for the shop to be pulled on the back of a semitruck. Those plans soon proved difficult, so she abandoned that idea but kept the name. Dwyer then opted to buy a large pick-up truck and had a custom-made trailer built to fit her needs.

"I wanted the inside to look like any small

Although there are some products inside, most items are custommade.

Semi-Lux specializes in dress shirts for men and women. There are a variety on the rack or there are books filled with different fabrics and designs that a customer can choose from. Dwyer will do the measurements on-site, and when the shirt is ready, it can either be shipped back or hand delivered.

Dwyer also offers business dresses, along with accessories for both men and women. Items include ties, socks, purses, jewelry and hats.

"Everything I sell is made in the USA and very high quality," said Dwyer. "I don't buy from someone unless I've been to the factory or the artist's studio myself. It's also not a forum for bargain hunters, but it's not as expensive as people think."

A custom-made men's shirt runs at about \$129.

Dwyer will also set-up private appointments for those who would like an office visit. Certain items can be re-designed to meet specific needs, with very detailed measurements taken for each person's body type.

Right now, the business is based out of Menands, but really has no set home because it can travel anywhere. Dwyer, who lives in Albany, said she will travel anywhere from Saratoga to New Jersey if she gets a call that she's wanted.

"I recently signed a contract to partner with a real estate investment trust, so I'm allowed to park on their properties with office space," said

Altamont gets its own history book

Keith Lee releases book that includes more than 200 historic photographs

At least one image will come to mind for most area residents when thinking about the Village of Altamont — its annual fair. A new book aims to highlight a few more historic images, too.

Village resident Keith Lee's book, "Altamont," was released Monday, Aug. 4, as part of Arcadia Publishing's "Images of America" series, and features more than 200 historic images. There will be a book signing and reception held Sunday, Aug. 10, from 3 to 5 p.m., in the community room at Altamont Village Hall.

The book is broken into seven sections beginnings, getting around, community, government, a summer retreat, rest and recreation, and the fair — featuring several previously unpublished images. The majority of images are from the village's Archives and Museum, which were primarily collected through donations over the years.


"There were times it was a bit of a challenge, but now that it is done, I am just so pleased to finally be able to show it to people," said Lee.

> Marijo Dougherty, curator of

the village Archives n Museum, spurred the idea for Lee to create the book. The "huge

trove" of photographs provided a good starting point, according to Lee.

After getting the idea for the book, Lee, who is the longtime partner of Altamont Mayor James Gaughan, said he looked to see if anything had been done before. There was a small chapter



book for the Town of Guilderland, but nothing as substantial as the now completed book.

"The residents, particularly the older ones, have a very definite sense of history," Lee said. "The people that became aware of the process of doing the book ... were encouraging and proud of the concept."

He said the most challenging aspect of the book was selecting images to use because each one had to tell a story.

representing part of Albany County, wrote the foreword for the book. McEneny described Altamont as a "unique American community," whose history is a "vital part of our heritage."

"The story of Altamont "You have to imagine is the story of people from many backgrounds who have collectively created what is to so many residents and visitors a truly special place in our nation and in our hearts," McEneny said in the book's foreword.

> Lee's favorite photo was one nobody in the village had seen for a long time, if ever.

> > He said there were

some residents who claimed to remember a two-story gazebo, but a photograph of the image had never surfaced. Shortly after the proofs for the book were sent to the publisher, the long-awaited evidence turned up.

Guy Gamello Jr., who lives near Kinderhook, contacted village officials about a couple of images he found in the attic of his family's home. The image of the two-story gazebo was on a glass negative.

Lee quickly notified the publisher of the surprising discovery and was able to swap out one image and place the rare gazebo photo in the book. Lee said sharing the photo was a "nice achievement."

Seeing the completed book was a rewarding experience for Lee, who has lived in the village for 30 years and did extensive research on the community. He is a volunteer of the village Archives and Museum and writes the brochure for the Victorian Holiday Weekend House Tour.

"It felt great to see it," Lee said. "I have read a lot of different Arcadia series books, but to have it — just the fact it is Altamont ... and I had a hand in it — is a great feeling.'



manner.

"They did not pay their school tax in September, so that amount was rolled over to the 2014 property tax in January," said Buchanan. "The amount that was rolled over was \$9,690."

There was still \$15,240 in back taxes owned as of Tuesday, July 29, according to county officials.

Bonnie Greulich also owns the residential property directly behind Greulich's, listed as 3401-3405 Carman Road, and paid off its back taxes on April 30. She had owed about \$3,200 in town taxes, which includes interest and penalties.

Most people will likely remember the store's fiberglass cow, which stood on the market's roof, serving as a community landmark.

Many people were also fond of its meat department. Several Facebook comments on the market's closing talked about the quality of meat offered, along with its premade meatball mix.

Store employees reportedly told customers on Friday, July 25, the store

The Facebook post is no longer on its page, but a post announcing a 50 percent sale on everything from that Friday is, which urged customers to "come quick before it all goes!"

No reason has been publicly given from storeowners for closing the store before The Spotlight went to press Monday, Aug. 4.

The store's website, greulichsmarket.com, also was taken down, with a message from the host stating the domain name expired. It had worked until at least Friday, Aug. 1.

Recreation Department first because that's where they are needed most.

"In our public places, we have a lot of seniors and children that are physically involved and in active sports," said Lanahan. "AEDs save lives, and our first response is to have these in place for any initial incidents."

Each AED costs about \$1,500.

One has already been purchased through the help of the initiative. Albany law firm Brown and Weinraub said they would sponsor one

defibrillator after they heard about the campaign, since some of their employees are Bethlehem residents.

"If someone is able to sponsor one of the AEDs, they are something really important to have in any sports and recreation facility," said Friends of Bethlehem Parks and Recreation President Joan Gavrilik. "I know someone's whose life was saved by one of these. We'd really like to have two more.'

Lanahan said because the Friends group is a nonprofit, it's easy for someone to make a taxdeductible donation. She said the town is required to have an AED available in places of public gatherings.

"I think this is someone no one can argue is important for the town to have," said Gavrilik.

The Friends of Bethlehem Parks and Recreation will also soon have the results of their online survey about park usage.

Residents were asked to take the survey over a three-month period, ending in July. The results have already been shared with the group's board.

"We got a lot of good responses, so we think it will be helpful for the town and friend's group in figuring out what projects to work on next," said Gavrilik.

The group is working on putting together a report

based on the findings, and it will be made public next month. Gavrilik said some of the responses were lengthy, and there were trends seen in many of the comments.

Lanahan said she and a new committee will soon be working on creating a new Parks and Recreation Master Plan for the town, and she believes some of the survey's results will be used. The department is also looking to eventually replace the Elm Avenue Park playground, so at some point fundraising may begin for that project.

Room to run

Local non-profits partner to make play space for dogs at animal shelter

A newly constructed play space for dogs at an animal shelter was created when four charitable and nonprofit organizations came together to help.

On Thursday, July 31, at the Mohawk Hudson Humane Society in Menands, officials from Habitat for Humanity Capital District, Seymour Fox Memorial Foundation and the Humane Society and CEO Youth Build, held a ribbon-cutting ceremony to celebrate the play space.

The dogs that are being held at the shelter are strays or part of animal cruelty cases. While they wait for their owners to pick them up or pending the outcome of a trial, the dogs need a safe place to exercise.

Bonnie Chavin, a board member for the Seymour Fox Memorial Foundation. said helping out with the

project fell right in line with what the foundation supports.

"This project seemed a perfect way to carry on Mr. Fox's kind acts. I know Mr. Fox would be grateful for the work by Habitat for Humanity and the Youth Build volunteers to make these yards a reality and for the wonderful work by the Humane Society to make it as pleasant and safe as possible for dogs under their care," said Chavin.

When Chavin approached the Humane Society to find out what she could do to help the animals, Executive Director of the Mohawk Hudson branch, Brad Shear knew it would be a good partnership.

"It started when Bonnie Chavin was taking a tour of the facilities just to see if the foundation could help out in some way, and when she saw the dogs in this building, which don't belong to us yet, didn't really have a good place to get outside and run around, she felt like that was a real need that was in line with what the foundation wanted to do,' said Shear.

Seymour Fox was a trial attorney in Troy who dedicated his free time to helping families in the area. When he died at 84 in 2010, in his will, he made a bequest that he stipulated be used to support charitable organizations engaged in making the world a better place. In 2012, a private charitable foundation in his name was created to provide funding for public charities.

It was the foundation that donated the funding for supplies for the project.

Habitat for Humanity is currently working on a project just across the Hudson River from Menands at Fox Hollow in South Troy, where the CEO Youth Build program is helping to build homes.

"Youth Build is a program for young

people, 16 to 24, who have dropped out from a traditional school setting and are selected into the program by Commission of Economic Opportunity (CEO)," said Kristin McGivern, director of program operations at CEO.

The project took about four and a half days to complete and consists of a large fenced-in area attached to the building so the dogs can run freely or play with volunteers without the fear of them escaping.

Habitat representatives

said the organization was eager to help with the project.

"When our Habitat children are asked about what they are most looking forward to when moving into their new home, we are delighted to hear, 'Mommy said I can have a puppy or kitten.' It made perfect sense to partner with our friends at the Humane Society to improve the conditions for our furry companions, as well," said Mike Jacobsen, the executive director of Habitat for Humanity.



"We have a tradition for very poetic shows ... we broke that promise and went to the streets," said Gabrielle Pauze, director of communications for Cirque Eloize as she described "iD." "Director Jeannot Painchaud created something completely different than what the company had traditionally created — it's a very urban, high-energy explosive show."

The show was first presented in 2009 and has been seen by more than 500,000 people in 50 cities across 15 countries. Cirque Éloize has been traveling the world since 1993 with shows such as "Cirkopolis," "Rain" and "Nomade." The company,



a leader in the world of circus arts, is known for its multidisciplinary artistic approach to contemporary circus, combining circus arts with music, dance and theater, and their latest creation is no exception — with something of an urban twist.

The show "iD" combines modern circus skills with urban dance, transporting the audience to a surreal metropolis with acrobats, break dancers and contortionists performing in front of eye-popping 3D projections.

"Up until 'iD,' it was all about the different types of circus disciplines which you still have with 'iD' — juggling and contortion — but in addition there is urban dance, hip-hop, extreme biking and rollerblading in the show," Pauze said.

She adds that it's not just the disciplines, but also the color and flavor of the show, including the music,

which is rock, electronic and poetic all mixed up in one.

Painchaud's aim was to create a futuristic city combining comic books, science fiction movies and "the rich universe of graffiti." Tangled up in the chaotic realm of reality is a story about two street gangs, friendships, love and identity ("iD").

"There is nothing else like it," Pauze said. "Everybody will find something. If you are more used to theater, you will find something enjoyable about it. The younger audience I have seen sitting there being captivated because of the color and action. Teens will like it because it's different."

Pauze adds that "iD" it's not a typical family show, yet it's definitely a show that the entire family can enjoy each on their own level.

The company sets up shop each summer at

Proctors. Last year, they brought "Cirkopolis" to the Proctor's stage. After its stop in Schenectady, "iD" will travel to South Africa, Russia and Italy.

Members of the company have been in town for weeks holding circus workshops for kids, teens and adults, doing community outreach projects and performing for youth groups. This is Cirque Eloize's second summer residency, as part of a five-year contract with Proctors.

"It's a way for people to enjoy the summer in a different way and also to discover circus arts," Pauze said. "One of our missions is to broader people's knowledge of circus arts."
