Treasure Cove makes a move

First United Methodist's thrift shop moves into neighboring building

For more than two decades, the Treasure Cove Thrift Shop was housed in the lounge of Delmar's First United Methodist Church. The shop finally moved to a bigger location in July, after nearly a year of planning.

Last September, Representatives of the church appeared before the Bethlehem Planning Board to seek approval to move the store to its property at 135 Adams Street, across the parking lot from the Kenwood Avenue church. The new location is much larger and allows for the store to be a permanent fixture in the community.

Treasure Cove manager Linda Graf said one of the main reasons for the move was so volunteers would no longer have to set the store up and put everything away each week when it closes.



It also allows the staff to create departments for easier shopping.

"Now that we have moved, the hope is we can stay open more days," said Graf.

The shop is still open on Tuesdays during the Delmar Farmers Market, but last month, it was decided the shop would also be open during the Saturday Farmers Market at Bethlehem Middle School. The volunteers may now open the shop for a third time each week on Thursday nights.

New route for Elsmere walkers

Town and state officials come up with safer options for students on foot

Elsmere Elementary students will find their walk to school to be a bit safer come fall, after the town instituted a new travel route.

Bethlehem officials petitioned the state Department of Transportation in order to change the route. The crosswalk in front of Elsmere Elementary will be removed before school starts in September, and students will now cross the road at the intersection of Delaware and Elsmere Avenue, and walk along the new sidewalk installed on Herrick Avenue.

"They know the route is a little bit longer, but we think it's much safer," said Bethlehem Supervisor John Clarkson.

The crosswalk in front of the school has been an issue for parents, students and school staff for years. In January 2013, the Elsmere PTA had a meeting with Clarkson, Police Chief Louis Corsi, town staff and school crossing guards Mary Root and Isabel Glastetter to discuss the matter. Some ideas included changing the speed limit and adding more signage and flashing lights for drivers.

Habitat benefit puts tents in Tawasentha

Event allows participants to show solidarity with those who don't have a roof over their head

Around two dozen people will take an extended stay at Tawasentha Park this weekend as they raise money to help provide a roof over another person's head.

The Capital District Habitat for Humanity will hold its Tent-A-Thon from Thursday, Aug. 14, to Monday, Aug. 18, with participants demonstrating their commitment to eliminating poverty

and substandard housing. The unique fundraiser allows participants to camp out in the Town of Guilderland park while raising money to support the local housing efforts. Security is also provided during the day so campers can continue their normal daily schedule.

The event started out with McKownville United Methodist congregation members sleeping in the parking lot behind their church. This is the 21st year the event has been held, and it has grown to welcome the general public and takes advantage of the scenic Tawasentha Park.

From addict to advocate for the disenfranchised

Matt Canuteson honored for his work helping those struggling with mental health and addiction issues

Matt Canuteson can truly relate to the people he works with. It's one of the key things that makes him so good at his job.

Originally from South Bethlehem, Canuteson began drinking as a pre-teen and then eventually moved on to drugs. He dropped out of high school and was incarcerated several times, starting as a juvenile and continuing into his early 20s. He also faced several bouts of homelessness.

"It's hard to say how I started," said Canuteson. "I probably used as a result of depression and some struggles I was having at the time. Then as the addiction progresses, you have a lot of struggles that are the symptoms of depression, so it becomes a cycle."

Canuteson, now 36, was adopted by white parents and grew up in Bethlehem. He said it was hard growing up not knowing how he fit in. Then, at around age 12, his parents divorced. It was around the same time he started using alcohol as a

coping mechanism.

He spent years struggling with the addiction and mental illness before finally meeting up with a peer group that had faced similar struggles but was able to make changes.

"There were people who put the seed in my head that recovery was possible, but it was going to be a lifelong process," he said.

He also began to notice his life wasn't going anywhere.

"That was my main wake up call. ... Everyone else was going to college," said Canuteson. "Everyone else's lives were moving along, and I realized I wouldn't have the future of a life, a family, a home. I was going nowhere fast."

It was then he made the decision to turn his life around.

He went back to college at the age of 23, and after graduating became the first youth coordinator for Families Together in New York State's Center for Mental Health Services Systems of Care Grant. He is also married, with two children of his own.

In 2009, he was hired at Policy Research Associates in Delmar. The company helps with research and technical assistance for families and consumers in the behavioral health field. Canuteson personally helps those struggling with

mental health, addiction and homelessness get treatment, obtain benefits and navigate the criminal justice system if needed.

"Matt is a young professional, but he's accomplished a lot," said Pamela Robbins, CEO of PRA. "From our angle, we're lucky to have him because he brings a lived experience. It's a key to incorporate that voice into the work we are doing."

That's why Robbins nominated Canuteson to receive a consumer/peer leadership Voice Award for his work as a national mental health advocate. The award is presented by the Substance Abuse and Mental Health Services Administration, which honors individuals "who share their personal stories of recovery and work to reduce the discrimination and misperceptions associated with people with mental and/or substance use disorders."

The Waterford resident will be in Los Angeles on

Wednesday, Aug. 13, to collect the award.

"I nominated Matt because he is very well accomplished in this field and is outspoken on having experiences that enable him to relate to others having those same experience," said Robbins.

Canuteson said he was grateful for the award, but it's the work itself and his own ongoing recovery that drives his efforts to make sure it's possible for everyone.

He said those with mental illness and addiction still face a lot of injustices, and that's mainly because of the stigma and false perception that they are dangerous. That stigma makes it hard to hold down and keep a job, be productive in society and stay clear of the criminal justice system.

"Our portrayal in the media also doesn't help," Canuteson. "You'll see headlines like, 'Crazy man commits crime,' but we don't do that anymore to other groups that are disenfranchised like the gay or African American communities. It's only these extremely rare cases that are used, but if we take that headline away, 99.9 percent of us aren't violent."

Canuteson said a better system is needed to encourage more people to help themselves through

recovery. There are more ways communities could work to help people with these issues regain their lives, by providing more housing options, education and helping to cultivate healthy relationships.

He also said poverty is a major factor that leads to addiction and mental illness and harms the recovery process.

"If you're someone who is struggling financially on a day-to-day basis, that's going to be an uphill climb, even for someone not suffering from the added stresses of addiction and mental illness," said Canuteson. "You have less access to everything from

treatment to support."

Canuteson said one of the good things about his job is being able to work with some of the best experts in the country and bring that back to a local level for people to access education and navigate the state benefits and criminal justice systems.

"I went through homelessness and incarceration, but now I think there was a purpose," said Canuteson. "It provided me with unique professional knowledge that I'm now using to make a difference. I love my job, and I always thought it would be a dream with PRA and do what I now do."

Road work in Bethlehem to slow traffic

Improvements on several streets expected into fall

Bethlehem residents should be prepared for road closures and slower traffic as multiple construction projects begin in August and continue into the fall. Travelers may want to avoid the following areas:

- **Borthwick Avenue**
The Town of Bethlehem DPW has been closing a portion of Borthwick Avenue for necessary utility

repairs since Thursday, Aug. 7. Borthwick Avenue between Nathaniel Boulevard and Kenwood Avenue is being closed daily on weekdays between 7 a.m. and 3:30 p.m. The road reopens daily after 3:30 p.m. The road closure is expected to last through Thursday, Aug. 14. Detours and flaggers will be in place. This section of Borthwick Avenue will be open to local traffic only via the Kenwood Avenue entrance. No through traffic will be allowed during the road closure.

- **Borthwick and Kenwood Avenues**
The Town of Bethlehem Department of Public Works, along with its contractor, began working on a new sewer main and connections on Tuesday, Aug. 5. Other associated sewer repairs will also be made along sections of Kenwood Avenue, Borthwick Avenue and Gardner Terrace. This work is part of a large sewer main replacement project and is being done in advance of the state Department of Transportation's planned

repaving project on Kenwood Avenue, which is scheduled to occur this fall. This work will generally be completed between the hours of 7 a.m. and 3:30 p.m. on weekdays during the month of August. Town officials said "at times during this project, you may experience construction-related noise, large construction equipment and vehicles in the road right-of-way, staged construction materials, traffic delays and detours, and temporary interruptions in water and/or sewer service."

- **Van Dyke Road**
Van Dyke Road, which closed Monday, Aug. 4, will remain closed through the end of September. The road will be closed at the intersection of Meads Lane and in the vicinity of 237 Van Dyke Road. The north portion of Van Dyke Road will be open to local traffic only. The project is being done to raise and realign the road, and is being funded through a federal grant and by the town.
- **Feura Bush Road**
The installation of a sidewalk on Feura Bush

Road will continue through October, depending on the weather. The Highway Department will be completing the drainage improvements and preparatory work, and a contractor will install concrete sidewalks when the Highway Department has completed its prep work. The town said to expect delays during construction, as lane closures are anticipated daily from 9 a.m. to 3 p.m. The sidewalk work will start near Glenmont Plaza and proceed west toward Wemple Road.

Hazmat crews respond to Paxwood Drive in Delmar

Hazmat crews from both the State Police and Albany County were called to 18 Paxwood Drive in Delmar on Saturday, Aug. 9, around 4 p.m.

Family members were reportedly cleaning out the home of an elderly resident who passed away, and unknown chemicals were found. According to the state police, representatives from Wadsworth Center called police about the chemicals, and police then responded.

Hazmat crews were on the scene for several hours, along with the Bethlehem police and members of the Elsmere Fire Department.

Neighbors were asked to stay in their homes during the investigation.

State police said the unknown chemicals were “suspicious and believed to be decades old.” Police also said the chemicals were eventually deemed not to be a threat to the community. They were turned over to Wadsworth laboratory for analysis.

DWI for driver found parked on a lawn

A Guilderland police officer who just went off-duty allegedly found an

Albany man drunk in his car parked on a lawn.

An off-duty officer, while driving on Carman Road, observed a Subaru Outback parked on a lawn around 5 a.m. Sunday, July 20, and investigated the scene. Police said Diego M. Ramat, 20, of 16 Delee Ave. in Albany, was lying across the driver’s seat. The off-duty officer called for assistance on his cell phone and then turned around to check on Ramat, who then drove off the lawn and across the road before stopping on the lawn of 3472 Carman Road.

Police said Ramat

had a strong odor of alcohol and bloodshot eyes. He allegedly told police he drove off the road while looking for cigarettes. Police later determined he was driving southbound and drove onto the grass, struck a pole with the passenger side of his vehicle and went back across Carman Road and crashed on the lawn.

After being transported to the police station for processing, Ramat continued requesting a cigarette and said he “would do anything or admit to anything” if he obtained

a cigarette, according to police.

Police said a chemical breath test revealed Ramat had a BAC of 0.21 percent. When he was taken to the bathroom, he allegedly urinated on the floor.

‘Johns’ make DA’s Frontpage

District Attorney P. David Soares announced last week that a new resource page was added to the Albany County District Attorney’s Office website. This webpage is titled “Frontpage” and offers an informational array of resources and services about the crime of sex trafficking. This webpage is accessible by clicking on the Frontpage logo on www.albanycountyda.com

In addition to defining “sex trafficking,” this webpage includes public service announcements; a list of local, statewide, and national resources; and a list of recent sex trafficking cases prosecuted by the Albany County District Attorney’s Office. The need for this webpage stems from the emergence of local cases that involve postings on the website “Backpage.com.”

Soares has promoted efforts to expand the approach to combatting crimes that involve vulnerable populations and improving access to victim services for these populations. These cases are prosecuted by Assistant District Attorneys in the Special Victims Unit (SVU). The Special Victims Unit, comprised of six attorneys, two investigators and a legal secretary, is dedicated to the investigation and prosecution of domestic violence, sexual assault, crimes against children, elder abuse, cases involving mental health populations and animal cruelty.

Injured ATV driver calls for help, gets DWI

A Delmar man called for help after being injured while riding an ATV and received more than medical attention, with police alleging he was driving while intoxicated.

An Albany County Sheriff’s Office deputy was dispatched to 82 Clipp Road in New Scotland for a man with facial injuries shortly after midnight on Sunday, July 20. Dispatch informed police the man was uncooperative on the phone and would not describe how the injuries were sustained.

When police arrived Mark S. Bonneau, Jr., of 1566 Delaware Turnpike, was found injured and standing next to an ATV. Police said Bonneau’s left eye was swollen shut, along with lacerations around his lips and blood covering his face.

Bonneau reportedly told police his friends called him and said they were stuck on trails, so he drove down Clipp Road to the trails. While on the trails, he struck a tree and was ejected from his vehicle, with his head hitting a tree. Bonneau told police he got back on the ATV and drove to his friend’s house.

He told police he was not wearing a helmet, and the ATV was not registered. He also admitted to consuming “a few beers” earlier while at a graduation party, according to police.

Police said he eventually submitted to a chemical blood test after initially refusing while riding in the ambulance and at Albany Medical Center.

Bonneau was charged with DWI, refusal to take a breath test, uninsured limited use vehicle and three ATV violations. He was scheduled to appear in New Scotland Town Court on Thursday, July 31.

It's time to slow down on Hudson Avenue

Editor, *The Spotlight*;

I agree with the statements quoted in Marcy Velte's article (*Spotlight*, July 30) made by the Highway Superintendent, Brent Meredith, and by Supervisor John Clarkson. The speed limit on Hudson Avenue should be lowered to 30 mph to conform to the rest of the town and to meet safety concerns.

I moved to Hudson Avenue in August, 2013. Our apartment has a porch fifteen feet or so from Hudson Avenue. Sitting there, I have observed all the traffic patterns, which vary depending on the time of day. Most of the traffic travels about 40 mph, partly due, I think, to the

fact there are residences only on one side of the road, it running parallel and adjacent to the rail trail. Speeds are higher westbound during evening rush hour. Delivery trucks also at times exceed the posted limit.

There is one additional safety problem. The occasional "hot dog" who takes advantage of the lengthy stretch between Delaware and Adams to speed. I estimate speeds well over 60, about the same as a fast run by the police when they use the road for an emergency, they, however, with plenty of warning to cars and pedestrians.

Especially in the summer, there are children riding bikes, walking dogs, skateboarding even, to

and fro all along Hudson. In my immediate area, one or two houses away, there are seven children under 12. Early in the morning especially, but throughout the day, there are joggers using both sides of the road. Adult bikers are also frequent. Many pedestrians cross the road at various points, mostly to get to Stewarts or to access the rail trail.

I would like to see a calmer Hudson Avenue. A thirty mph limit is a start. More frequent cruising by police might help. Perhaps the department could install a permanent or temporary radar unit that shows drivers their speed, especially at first when the change is made.

From the Editor's Desk

We can do better

We'd like to think our region is full of good Samaritans who are ready and willing to help at a moment's notice. Unfortunately, that's not always the case.

This week, we're printing two letters that deal with young women involved in bicycle accidents in our towns. The first one talks about an incident in Colonie in which a college-age woman fell off her bike along Albany-Shaker Road, and people drove past her and her sister until her sister stood in the middle of the busy thoroughfare to get someone to stop. The second one talks about a 9-year-old girl in Bethlehem who fell off her bike, and a person living near the crash site came out right away to assist.

While both women were helped, only one received assistance in a quick fashion. It took extreme measures for help to arrive in the Colonie case.

Thankfully, the injuries both suffered were minor, but their experiences were quite different.

Going forward, we have to ask ourselves if we're willing to jump in when we see someone suffering or if we're satisfied passing by the scene. Butting into a stranger's life is a tricky proposition because we don't know all of the circumstances surrounding the scene we see, but it shouldn't preclude us from doing our part to help someone in need. It can be as small of a gesture as asking if someone is all right or as grand as tending to a person's needs, including performing life-saving techniques such as CPR, if need be.

We shouldn't use our busy lives as an excuse not to stop and help, either. Is your boss really going to be mad at you for calling in and saying you've stopped to help someone you saw get involved in a car accident? Will your

family never forgive you if you miss dinner because you saved someone from harm and stayed to file a police report? The answer in each case is no – unless your boss or your family are selfish, unfeeling people.

We're not asking you to be a superhero. What we're asking is when you see something happen or come upon someone who is hurting physically or emotionally, you stop and find out what you can do to help. If the person says they don't need your assistance and you see they are otherwise all right, then you can move on. But at least, offer your help to them.

We should all strive to be like the woman in Delmar who came out of her house to help a young child who fell off her bike. It's not about gaining good karma points for you. It's about doing the right thing in general. We can do better.

Where was the assistance?

Three evenings ago, my two college-aged daughters were enjoying a nice bicycle ride in our hometown of Loudonville. They were traveling down a hill on East Hills Boulevard (near Albany-Shaker Road) when my youngest daughter hit a slippery spot on the pavement, and her bike hydroplaned. She was afraid of hitting a large area of rocks, so she twisted her body toward the curb in an effort to protect her head. Fortunately, she was wearing a helmet, but she was thrown onto the curb on a busy roadway, which does not have a shoulder. She was badly stunned and badly injured, and she was unable to get up right away.

My other daughter also hit the slippery pavement, but she was able to avoid slamming into her sister or suffering a crash herself. My youngest daughter was bleeding heavily in

several places, and her damaged bicycle had landed upside down in the street. The two girls were struggling to get up and into a safer spot, and they were concerned because they didn't have their cell phones with them. Unfortunately, the nearest house was at the top of the hill, and my oldest daughter was afraid to leave her badly injured sister alone on the pavement.

My daughters were absolutely stunned at the number of residents who drove around the bicycle in the street and ignored them in their moment of need. Several residents even slowed down and stared at them, as my daughter had blood running down her arms and legs, and then they drove off without offering to assist them.

Sadly, my daughters counted 36 cars who drove right past them, so they were forced to stand in the middle of the street and wave their arms for

help. One young man kindly stopped and allowed them to use his cell phone to call home for help. He even offered to drive them (blood and all) to our home. We are so appreciative that the young man was kind and helped them.

On the other hand, we are absolutely shocked that 36 other people didn't even stop to see if the girls needed an ambulance. What a sad commentary about our own townspeople. I suggest that everyone who encounters an injured person should at least stop, roll down the car window an inch or so and offer to call 911. Do not assume that everyone has a fully charged cell phone on his/her possession. Remember, one day you — or a family member — may be the one laying badly injured on the street.

Please take the time to help a stranger — it could be a lifesaving act.

Searchable archive live on library website

The full-text search is now live on the Bethlehem Public Library's online archive of Spotlight Newspapers.

The library recently finished building a Google custom search for the archive, which can be accessed at www.bethlehempubliclibrary.org/localhistory/spotlight.asp. In addition, they've also managed to link the obituary index with the archived papers. That link can be found at www.bethlehempubliclibrary.org/localhistory/obituary.asp. If you click on one of the letters, then one of the highlighted names you will be taken to the exact issue and page for the obituary.

The library completed its project to digitize 50 years of The Spotlight in May. The effort was done in

conjunction with the local newspaper to help preserve the town's narrative. Donated funds and a matching grant were used to pay for the initiative.

To complete the project, the library's entire collection of Spotlight newspapers from 1955 to 2005 were sent to a company in western New York that scanned the publications, digitized them and turned them into microfilm copies. They were then uploaded to the Internet to create a digital database.

Library Director Geoffrey Kirkpatrick said the library has received a lot of positive feedback about the online archive.

The next step in the process is moving forward with including editions from 2006 to the present.

General killed in Afghanistan is Guilderland native

U.S. officials blame ‘insider attack’ for shooting; Albany County flags lowered for weeks

A Guilderland native on Tuesday, Aug. 5, became the highest-ranking American military member to be killed in the Afghanistan war.

Maj. Gen. Harold Greene was killed when an apparent Afghan security force member opened fire on a group of coalition troops during a routine visit at a military academy in Kabul, Afghanistan, according to Pentagon spokesman Rear Adm. John Kirby. Fifteen other people were injured before the assailant was killed.

Greene, 52, was commissioned as an engineer after graduating

from Rensselaer Polytechnic Institute in 1980 and rose to the rank of two-star general. He had lived in Virginia for the past 22 years with his wife and children, who are all members of the military, according to Rep. Paul Tonko’s Office.

Greene’s body arrived Thursday, Aug. 7, at Dover Air Force Base in Delaware. He will be buried at Arlington National Cemetery sometime this week.

There reportedly were additional casualties, with several people seriously injured and others sustaining minor injuries, according to U.S. officials. An investigation into the incident is ongoing.

Albany County Executive Daniel McCoy on Wednesday, Aug. 6, directed flags on county buildings to be flown at half-staff for 30

days to honor Greene. Gov. Andrew Cuomo instructed flags on state buildings to be flown at half-staff on Thursday, Aug. 7.

McCoy said Greene would be remembered for the impact he had on others during his 34 years of service.

“On behalf of Albany County residents, I extend my deepest condolences to the family, friends and fellow soldiers of Major General Greene,” McCoy said in a prepared statement. “We are deeply grateful for his service to our nation and dedication to improving the lives of the troops in his command.”

Tonko, D-Amsterdam, also offered his condolences to Greene’s family and friends.

“He was a decorated soldier, a patriot and servant to our nation. His service and ultimate

sacrifice will never be forgotten,” Tonko said in a prepared statement.

Greene earned several military awards including the Legion of Merit, Meritorious Service Medal, Army Commendation Medal, Army Achievement Medal and Army Superior Unit Award. He also earned a doctorate in materials science from the University of Southern California and masters of strategic studies degree from the U.S. Army War College.

Tonko pointed to Greene’s death as a reason to withdraw troops from Afghanistan.

“Tragedies like this remind us that America’s longest war in history has gone on for too long. It is time that we responsibly bring our troops back home,” said Tonko.

conference Tuesday, was confident that Afghan security forces could take over military operations next year. He said there is “no indication” trust

has been degraded between U.S. and Afghan forces. He added security procedures had been implemented to mitigate and minimize threats.

Shrine Center seeking to install solar panels

Public hearing set for later this month

The Cypress Shrine Center is trying to go green by installing solar panels to offset their energy costs.

Representatives for Monolith Solar sent the application in to the Bethlehem Zoning Board of Appeals on Wednesday, Aug. 6. The Cypress Shrine Center is located at 27 Hannay Lane in Glenmont.

The hope is to install both ground- and roof-mounted solar

panels, but the project would need a variance because it would not meet front yard set-back requirements.

“The customer is trying to go green and save money at the same time by utilizing their land for solar power,” said Bruce Soloyan of Monolith Solar on

behalf of the owners. “I believe this (difficulty) would be self-created, but would not harm or hinder the community or neighbors.”

The plan calls for 88 panels to be placed on the roof and 122 to be mounted on the ground. Those mounted on the ground would be installed at the front of

the property’s 17.3 acres of land. Soloyan said the front had to be used because of the parking lot in the back of the property and the grade of the land to the side.

“The project will not take up much space of the owner’s property but will offset the electricity by a substantial amount,” Soloyan said.

The owners and Monolith Solar said the panels will not be in the immediate view of neighbors.

The public hearing for the project was set for Wednesday, Aug. 20 at 7 p.m. A short presentation by Monolith Solar will precede the public hearing.

Helping out, one muffin at a time

‘Muffin Man’ expands fundraising efforts to breakfast in bed service

A basket of muffins might not change the world, but one man is proving it's a good place to start.

Thaddeus Pinckney has spent half his life baking and donating muffins to those in need. A seemingly simple gesture, but to someone with an empty stomach, it could make a significant difference.

Pinckney, who many simply know as “the Muffin Man,” founded a non-profit organization years ago of the same name that’s dedicated to raising money to make muffins to donate to food pantries and food banks. The New Jersey native, who lives in Schenectady, is expanding from muffins to operating gourmet breakfast in bed delivery service to,

of course, donate more muffins.

“The more money we collect for breakfast in bed,

the more muffins we can donate,” said Pinckney.

He is kicking off his Breakfast in Bed service

on Friday, Aug. 15, and will be delivering to everyone within the Spotlight News coverage area. The menu includes various egg sandwiches on a bagel, muffin or biscuit, along with indulgent muffins such as carrot cream cheese, iced lemon and berry blast. Breakfast juice standards are available, along with some cupcakes for those with a sweet tooth.

The highlight of the service though is the prepackaged breakfast boxes including an assortment of food following certain themes, such as the “Hangover Brunch” and “Parisian Love Affair.”

Breakfast boxes also include a complimentary

edition of Spotlight News, along with a fresh flower and, for a limited time, a bottle of champagne.

A complete listing of all the items and boxes offered are on The Muffin Man’s Breakfast in Bed website at BreakfastInBedAlbany.org, which is also where customers place their order. All orders must be placed by noon the day before delivery.

Pinckney developed “The Muffin Man Gives” non-profit after getting a request in 2011 to donate muffins to an Arizona family in need. The parents just got new jobs after being unemployed for more than a year. Their paychecks would allow them to buy food in a couple weeks,

but until their paychecks came through they had no money.

All the family ate for roughly two weeks were the muffins, he said.

“I sent them a dozen muffins, and they took a muffin each day and split it between five kids,” said Pinckney. “They didn’t even have money for the boxed macaroni and cheese.”

Pinckney, 37, did have a background in food before stepping into the role of muffin man, but not the baking element of it. He has a bachelor’s degree in food science from Rutgers University and a master’s degree in marketing from the University of Albany.

He was actually more familiar with Kool-Aid, but when he wanted to find something to do with all the leftover blueberries he was using to make a fruit drink, his pathway towards muffins began.

“It was only just to put the blueberries in the muffins, because I had all these blueberries leftover,” he said.

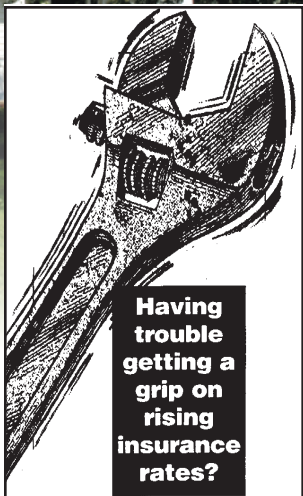
Some of the organizations receiving his muffins include The Regional Food Bank of Northeastern New York in Latham, Our Lady of Fatima Food Pantry in Delanson and The Sojourn House and Hillside Ministries Food Pantry, both in Schenectady.

“Now, I really have fun giving to shelters in the Capital Region and across the country, and that is literally all I live for,” he said. “I found I am able to not only help others, but help myself.”

Nearly two dozen homes eyed for N.S. development

Planning Board hears residential proposal for 62 acres formerly known as Camp Shelly

Developers are looking to create a 22-lot residential subdivision on a 62-acre parcel off Route 85.

New Scotland Planning Board members heard Camp Shelly LLC’s housing proposal at its Tuesday, Aug. 5, meeting, with the subdivision named Shelly Pines in its plat application. The lots range from 1 to 12 acres, with the majority within 2 acres. The property abuts the Town of Bethlehem line on the eastern side, and developers are planning to connect to Bethlehem’s water system.

Planning Board Chairman Charles Voss said he and town officials met with the applicant about a month ago to discuss initial thoughts on the site layout. The developer at that time

had a rough sketch, but revised it for the Tuesday meeting to present a preliminary plan.

Two new roadways would be constructed off Route 85, also known as New Scotland Road, with all but two homes along the project’s main road ending in a cul-de-sac. A ridgeline vertically divides the parcel, and there is a pond located near the southeastern portion of the property.

All of the lots will be deeded to jointly own the pond’s parcel and have access to it, possibly through a stone pathway.

The site was historically used as a campground, known as Camp Shelly, and is zoned residential agricultural.

so that we don’t have any lots adjacent to the water tank and former reservoir for the Town of Bethlehem.”

Costa said developers have had conversations with Bethlehem officials about connecting to its water line, but still need to contact its water board. Average daily water usage for the homes is estimated to be 10,500 gallons.

Voss said a municipal water supply would likely be needed to provide adequate water to homes.

“I just don’t think there is any way you could get enough wells to handle this type of development in that area,” said Voss.

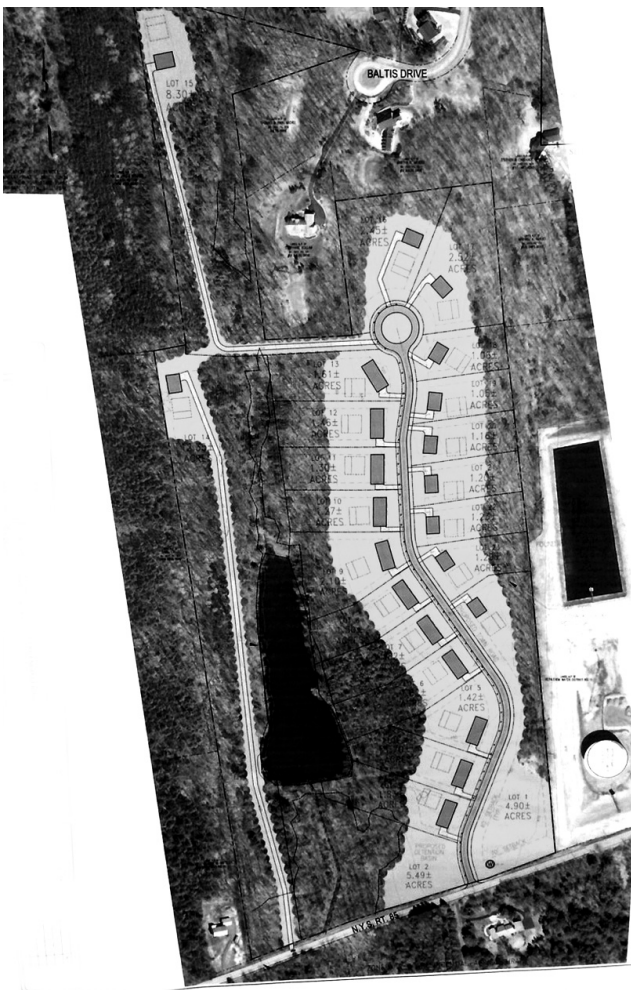
Stormwater would be managed through placing a retention basin near the sites entrance off Route 85, using swales to direct water, and discharged into a wetland area. The water would be properly treated before entering the wetland, according to Costa.

“We don’t expect this needing a huge retention basin,” said Costa.

Jameson Phillips, the applicant, said a company has not been selected yet to build the homes. Costa said the lots could be sold individually, to multiple companies, or even one company.

Phillips said ideally a few developers would build a certain amount of houses with a similar architectural style and follow a theme.

The applicant will return to receive site plan approval for the subdivision. The board only reviewed the project.

Colonie couldn't rally its way to victory a second time at the Little League Mid-Atlantic Regionals.

Jakob Lemperle's two-run homer in the top of the sixth inning trimmed Taney Youth Baseball Association's lead to one run, but the Pennsylvania state champs from Philadelphia prevailed 6-5 in the semifinals Friday, Aug. 8, in Bristol, Conn.

"Whenever we're losing, we're trying to get that tying run up (to the plate) because who knows what will happen next," said Colonie manager Mike McDonough. "We've won a lot of games like that, but we couldn't get it done

this time." The semifinal loss ended an exciting playoff run for Colonie that included a 5-3 victory over Taney Tuesday, Aug. 5, in the team's final pool play game. Colonie rallied from a 3-0 deficit to earn the win that put them in the regional semifinals.

"Even though they (Taney) jumped out 3-0 on us, it didn't feel like they were that much better than us," said McDonough. "We just stuck with the game plan."

In Tuesday's game against Taney, Lemperle gave Colonie a boost with a three-run homer in the bottom of the third inning to tie the score at 3-3. He then drove in the go-ahead run with an RBI triple in the fifth and pitched for the final out in the top of the sixth.

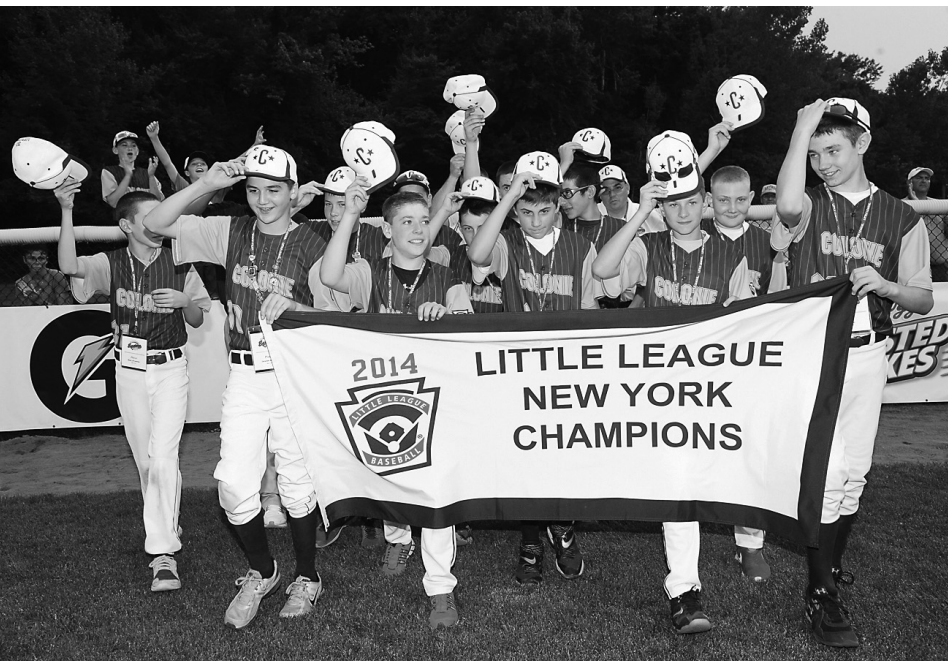
Lemperle came through

again in the semifinal contest Friday. His RBI double in the top of the third inning gave Colonie a 1-0 lead. Two batters later, Ian Parker followed with his own RBI double to make it a two-run Colonie advantage.

Tyler Catalfamo walked to lead off the top of the fourth inning for Colonie. Pinch runner Zane Nelsen stole second and scored three batters later when Jimmy Davis singled to put his team ahead 3-0.

The momentum swung Taney's way after that. A three-run homer by Taney's Zion Spearman in the bottom of the fourth inning tied the score at 3-3. Then in the fifth inning, Jared Sprague-Lott's two run double gave Taney the lead. In both innings, a Colonie error began Taney's rally.

"We didn't play as well

as we could have, and they made more plays than us," said McDonough.

Lemperle had been masterful on the pitcher's mound for Colonie in the semifinal until the fourth and fifth innings. Lemperle allowed one hit over the first three innings and finished the game with five hits, four strikeouts and one walk.

"He pitched well. It's just baseball," said McDonough. "I know all of

his teammates were proud of him, and he was proud of all his teammates."

McDonough said his team had a memorable time at the Mid-Atlantic Regionals, which also included a visit to ESPN's Bristol studios and having its semifinal game televised on ESPN.

"From the facilities to the action on the field to the host families, we were treated very well," said McDonough. "They fed us

well at ESPN, and I know the kids had a blast there."

McDonough said the next goal for this group of Colonie baseball players is to have similar success at the Babe Ruth level in 2015.

"I DVR'd (the semifinal game)," said McDonough. "I watched it once, and I probably won't watch it again. There are a lot more games for us to look forward to at the Babe Ruth level."

which has hosted the event for several decades. The University at Albany’s Bob Ford Field might have been a candidate with a seating capacity of more than 8,000 and a professional grade artificial turf field – two things Dietz Stadium doesn’t have. But, VanDerzee said scheduling five semifinal games in mid November at Bob Ford Field wouldn’t be possible. “It wouldn’t be a problem hosting it at UAlbany, The problem is, UAlbany is still playing football at that time of year and you never

know if they’re going to be hosting a playoff game at that point. So, you can’t lock in that facility,” said VanDerzee. As sectional chairman, VanDerzee said he witnessed some of the things Cerone did over the years while representing Section 2 at regional and statewide playoff games. “I understand the process, and I’ve been around it,” said VanDerzee. “There’s going to be a lot of working with the people at the Carrier Dome and all the sectional chairmen, but we’ve got a great team in place.” Likewise, Dorrance has seen firsthand what

VanDerzee has gone through as sectional chairman, since the two men work together at RCS. “I think that’s why the guys on the committee were comfortable nominating me,” said Dorrance. “They weren’t bringing in someone from outside of Section 2 to be the chairman. They know me, and they know I’ll have a great resource in the room with me (in VanDerzee).” Dorrance comes in at a time when Section 2 is seeing yearly shifts in league sizes and merging programs. Several schools moved up a classification level as Class B programs Green Tech and Lansingburgh joined

Class A, while the newly-merged Lake George/Hadley-Luzerne program moved from Class D to Class C, as did Schoharie-Duanesburg – which added players from Berne-Knox-Westerlo – and the private school triumvirate of Catholic Central, Bishop Gibbons and Saratoga Central Catholic. “Some people were worried that (mergers) would create super programs, but that hasn’t been the case around here so far,” said Dorrance. “I hope it’s something that allows kids to play football.” The other significant move in Section 2 is

Niskayuna’s decision to play an independent schedule at the Class A level this season. Niskayuna had been part of Class AA the last several years, but Dorrance said a lack of numbers at Niskayuna’s modified and junior varsity levels precipitated the request for the move. “Niskayuna is a unique circumstance. They did a good job of presenting their case (to the sectional committee), and this was the best outcome for them,” said Dorrance. “Hopefully for Niskayuna, it’s a one-time thing for them and not a growing a trend for the section.” There is a unique

circumstance at RCS, too. It now has a football coaching staff that includes the state high school and the Section 2 chairmen. “It’s great that the state chairman is coming from Section 2 and that the Section 2 chairman is coming from the same room,” said Dorrance.

High School varsity uniforms next spring, which he thinks will help turn around that program’s fortunes following a losing season in 2014. “The majority of them have been playing together since they were 8 years old,” said Kniffin. “I expect them to continue to have success at the high school

level, at the Mickey Mantle level and at the Junior (American) Legion level.” Kniffin added he sees great potential in several of his players. “There’s three or four kids who have the possibility of playing at a high level in college, if they want to,” said Kniffin. “Some of them may not choose to do so because they play other sports, and they use (baseball) as something to do between seasons.”

Bethlehem meets its goals

All-stars qualified for playoff round at regional tournament

The Bethlehem Babe Ruth 15-year-old division all-stars did what they set out to do.

Despite being eliminated in the Mid-Atlantic Regional quarterfinals with a 7-3 loss to Waretown, N.J., Tuesday, Aug. 5, Bethlehem manager Scott Kniffin said his team accomplished what the players and coaches mapped out in June.

"We had set our goal from Day 1 to get to the Mid-Atlantic

Regional. Our goal was to advance out of pool play, and whatever happened (after that) happened," said Kniffin. Bethlehem picked up wins over Bear, Del., and Frederick, Md., on the final day of pool play at the regionals Monday, Aug. 4, in Niskayuna to advance into the quarterfinals. The win over Frederick came at a cost, though. It took Bethlehem 11 innings to beat Frederick 6-5, which left the Eastern New York State champions thin on pitching when they played Waretown the next morning.

"I was very proud of our guys winning that 11-inning game, but it took a toll on our pitching," said Kniffin.

Pitching was Bethlehem's hallmark throughout its run from hosting the district championships to the Mid-

Atlantic Regionals. The starting rotation of Jack Rooney, Trevor Kniffin, Jake Smith and Cooper Martell guided Bethlehem through some of the top teams from around the Northeast. Along the way, Kniffin picked up a no-hitter in the state finals against Niskayuna and combined with Rooney to no-hit Metro New York champion Great Kills through six of the seven innings of a 5-4 victory in Bethlehem's first pool play game at regionals Saturday, Aug. 2.

"They were a very good group (of pitchers), and if they stay together – and they're all in

the same class (at Bethlehem Central High School) – they should have great success over the next couple of years," said coach Kniffin.

Smith was the only one of the four main pitchers who couldn't start at regionals. Kniffin said Smith suffered a shoulder injury prior to the start of pool play, which limited the amount he could pitch.

"He only pitched four innings at regionals for us, so that wound up hurting us," said Kniffin.

Bethlehem's hitters were also sharp throughout the playoffs.

Martell, Rooney, Kniffin, Jon Hogg and Ned Englebride were among those who had key hits during the team's playoff run.

"We hit better than .300 through districts, states and regionals," said coach Kniffin. "We didn't hit as well at regionals, but at districts and states you had to worry about our one through four hitters as much as our bottom four hitters."

Kniffin said many of Bethlehem Babe Ruth's 15-year-old division all-stars will likely appear in Bethlehem Central

Gary VanDerzee is no longer the Section 2 football chairman.

That's because the long-time Ravena-Coeymans-Selkirk coach is now the New York State Public High School Athletic Association's football chairman.

VanDerzee was approved to replace Dick Cerone as the state football chairman at NYSPHSAA's summer meeting Monday, July 28. Cerone had been at the helm for 33 years before stepping down.

"It's an exciting opportunity, and we'll try to continue what Dick Cerone did ... and try not to mess it up," said VanDerzee.

To replace VanDerzee as Section 2 football chairman, the committee stuck with the RCS

coaching staff and promoted Bob Dorrance to the position.

"I loved being on the committee, but I never thought about becoming the chairman. It wasn't even on my radar," said Dorrance, who joined the section football committee in 2007. "This just fell into my lap, and what a great opportunity for me that presented itself out of the blue."

"Bob has been on the committee for the last several years," said VanDerzee, who spent the past 17 years as sectional chairman. "He's worked closely with me, and he's gained a lot of respect from the Section 2 football coaches."

VanDerzee said in some ways, being the state football chairman is similar to being the sectional chairman. He'll be coordinating

all of that at the state level.

"I've talked to Dick Cerone, and he's given me a timetable to follow," said VanDerzee. "You have to do certain things by a certain time. You have to coordinate with the people at the Carrier Dome (in Syracuse) to set the dates and times for the state finals, as well as the folks out west and in Kingston for the regionals and state semifinals. You have to make certain all of the footballs are ordered for the season."

Player safety has been part of the national discussion for several

dates and sites for championship games, he'll be looking at classification numbers for all the schools and he'll be dealing with participation and safety issues. The difference is that he'll be doing

years now, and VanDerzee said he'll look at what is going on at the collegiate and pro levels to see how they address the issue before making any decisions for New York high schools.

"We're always concerned with participation and safety. We're always looking for ways to make the game safer for our student athletes and give them opportunities to participate," he added.

The one thing VanDerzee said he won't do at this point is look to move the eastern semifinal from Kingston's Dietz Stadium,

Give a hoot

Festive fundraiser for owls will have a folksy flavor

What do you get when you combine owls and music? Well, a HOOTenanny of course. This year marks Washington County's first HOOTenanny, a gathering at Oliva Vineyards Winery and Tasting Room in Fort Edward celebrating the wise old bird and folk music.

The event, which takes place on Saturday, Aug. 16, is the brainchild of two friends — one from Caffè Lena in Saratoga Springs, and the other from The Friends of the Important Bird Area (IBA) in Washington County.

"We came up with the idea of music, food and wine tasting and we took it from there," said Laurie LaFond, president and director of Friends of the IBA.

"We wanted to think of something that combined owls and music. That's where the idea for the HOOTenanny name came from."

The collaboration with Dianne Winter, the associate director of Caffè Lena, just seemed right, LaFond said. Adding that their missions easily intertwined together, and by bringing folk music to the grassy lands of the owls, it just fit.

"Historically, the folk movement has had ties to the environment and social awareness," Winter said. "This is our first fundraiser outside of a music hall — it's a fun, new type of event for us, and by working with IBA, the folk music community is also very environmentally conscious, so we

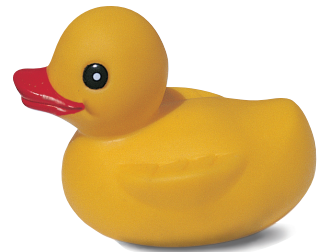

thought it would be a nice fit for our people to find another organization to support.”

Caffe Lena opened in 1960 and has helped to launch many of America’s best-loved songwriters, including Bob Dylan, Arlo Guthrie and Ani DiFranco. When the cafe’s original founder, Lena Spencer passed away in 1989, Caffè Lena was converted to a non-profit institution.

“One of our biggest missions is to launch new artists into the music world, and so supporting new musicians and paying them an appropriate fee for the work they are doing is not always something you can pass along by ticket sales,” Winter said. “Keeping folk music alive is something that requires additional support, and that is where the nonprofit end of our business comes in.”

The proceeds from the event will support Caffe Lena and will help the IBA with their first land acquisition.

Friends of the IBA is a nonprofit organization that works to protect endangered short-eared owls and other at-risk birds of the Washington County Grasslands.

LaFond is no stranger to fundraisers, having created the popular Winter Raptor Fest, which takes place each winter in Washington County.

“I founded and organized the Raptor Fest every year. It is very popular with our locals, but we draw people from out of the area too,” she said.

The Winter Raptor Fest allows visitors to experience native owls, hawks and falcons, including endangered short-eared owls and threatened raptors of the Washington County Grasslands.

“We have owl watches

where we take people out and see owls in the wild. They flock together in the winter and are active during daylight. They come up out of the hay where they roost and start flying in front of you. I have had them fly within 10 feet of me, over two dozen of them together,” LaFond said. “These owls used to be common in New York in

the early 1900s. Now, there are less than 100 average across the northwest and into Canada.”

While the winter event is for all ages, LaFond said HOOTenanny is geared more toward the adult crowd, combining wine tasting, a gourmet selection of hors d’oeuvres created by Spoonful Catering and a selection of bluegrass, ’70s

and country music.

The event takes place at a vineyard in Fort Edward in what LaFond describes as a very relaxed atmosphere.

“It’s a beautiful place.

It looks over the Hudson River. The room inside is for people to hang out in the wine bar and lounge area. The back porch overlooks the hills and pastures,” LaFond said.

The vineyard is located inside the Washington County Grasslands Important Bird Area. The 2,000-acre grasslands is located along the Hudson River flyway and is critical to the survival of short-eared owls in New York.

Winter said that since the event takes place in the vicinity of the land the organization is looking to protect, it was only fitting to bring Caffe Lena to them.

“We wanted to bring some of what the cafe is to the event. Thirteen Feet of Bluegrass will play a couple sets for the event,” Winter said. “By bringing the music there, we are bringing us there too.”

“HOOTenanny 2014” will take place on Saturday, Aug. 16, from 4 to 7 p.m., at Oliva Vineyards, 2074 Route 4 in Fort Edward. Admission for the joint fundraiser is \$40 in advance and \$45 at the door.
