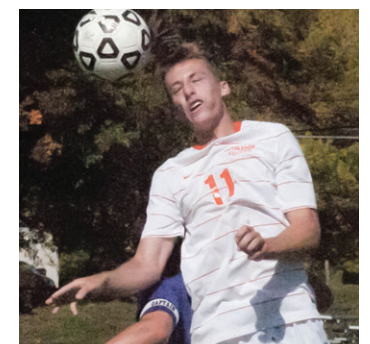

Tkaczyk, Amedore ready for battle

Candidates for the 46th Senate District meet for first debate of election season

CAPITAL DISTRICT — One of the most contentious state senate races is on track to be a cutthroat contest featuring a rematch between two candidates looking for a knockout victory.

Cecilia Tkaczyk, D-Duanesburg, and George Amedore, R-Rotterdam, met for their first debate on Tuesday, Sept. 23, at Proctors GE Theater in downtown Schenectady. The debate, hosted by *The Daily Gazette*, was moderated by *Gazette* City Editor Miles Reed and had a panel of media representatives asking questions, which included the *Gazette's* Haley Viccaro, the *Times Union's* Casey Seiler and CBS6 Albany's Greg Floyd.

Almost every seat was

filled at the GE Theater, with a majority of audience members rallying for their desired representative. The crowd was also as lively as the debate, as supporters would erupt in applause and cheering. The bleacher style seating even shook at times when several Amedore supporters stomped their feet as if cheering on their favorite sports team.

Amedore, in his closing remarks, summed up why both political parties are paying attention to the race.

"This senate seat is key of who holds the balance of power in Albany," said Amedore.

He continued, "We can't go back to 2009-10 where we had one party rule by the Democrat party."

Tkaczyk contested she has been a full-time senator and has residents of her district's best interest guiding her decisions.

"People want someone who understands their struggles — not someone who was handed everything on a silver

platter," she said, which garnered a mixture of boos and cheers. "People want a senator that's going to stand up and fight for this district and its fair share."

Reed then warned anyone in the audience sharing their "comments" would be removed, as people continued to interrupt Tkaczyk.

This divide was emblematic of the candidates and their supporters, with both sides seeing clearly different pathways for the 46th Senate District and the state.

Amedore and Tkaczyk essentially fell along their party line regarding passage of the New York Women's Equality.

Republicans have been generally supportive of the bill package, but refuse to pass one of the 10 points to the plan that codifies the Roe v. Wade decision in state law. The state's law regarding abortion was passed three years before the pivotal decision.

"The first bit of business we should be doing is passing nine points of the Women's Equality agenda," said Amedore. "It is unfortunate that we have a Democratic party in the state senate, my opponent, who is holding it up because of one radical measure that jeopardizes the health and life of women in the State of

New York."

The Safeguarding Reproductive Health bill, as part of the package, would allow women to get an abortion within 24 weeks of pregnancy or to protect her life, and protect physicians from criminal prosecution for providing such care.

Tkaczyk criticized Amedore for voting

against a bevy of bills while he was an assemblyman regarding pay equity, protecting domestic violence victims, sexual harassment protections and reproductive health issues.

"Women are not a second class population," she said. "We are not a special interest. We want all 10 of those points passed, and you need to stop lying about the last plank."

Amedore said he would vote against any "bad, one-house, Democratic charged" bill that would not facilitate equal pay for women. He contested the bill would do more damage to business in the state.

"This bill does more than just codify," he said.

The potential legalization of hydraulic fracturing, commonly known as hydrofracking, has also loomed over the state legislature.

Tkaczyk, regardless of the still unreleased state report, would not support the controversial method of drilling for natural gas.

"I don't think it can be done safely and don't think we have the regulations

in place that it could be done safely. We frankly have to make sure that we are protecting our environment and our communities," she said. "I support those communities that put in bans to protect their citizens from this process."

Amedore did not outright support it and said local control was needed through a review process for such activities. He said he did not see the issue as readily pertinent for debate.

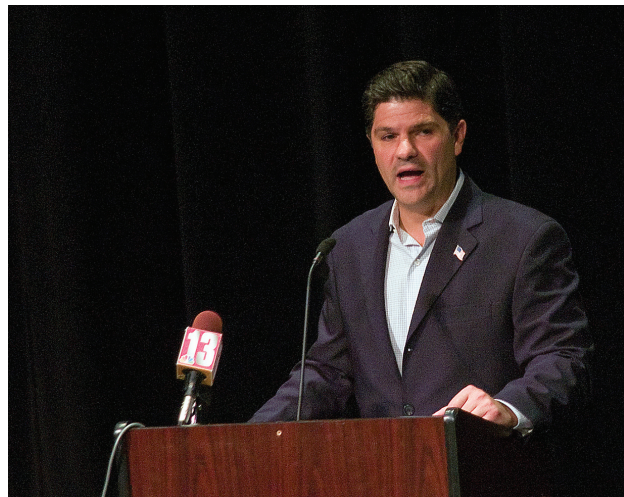
"Why are we continuing to talk about fracking?" he asked. "This is 2014. The State of New York is not going to be fracking."

He said the state should be investing in forms of alternative fuel and energy sources, such as making solar more affordable for residents and businesses. He ultimately said experts should decide if fracking should be allowed in the state, not lawmakers.

Common Core Learning Standards have also been a hot button issue and both candidates agreed it was at least not implemented properly.

Continuing to dance the night away

Old Songs announces third season of Community Dances with a sweet twist

VOORHEESVILLE — Despite social media being omnipresent in many people's daily lives, connecting a community can sometimes be difficult. A series of local events is hoping to change that by getting people on their feet and socializing in a more traditional way.

After two successful seasons, Old Songs, Inc., with underwriting support from Homespun Occasions, is ready to kick off its third season of Old Songs Community Dances at 7 p.m. Saturday, Oct. 4. Dances will then be held on the first Saturday of

every month through May. The first dance features caller Paul Rosenberg and music by Will Welling & Tamarack at the Old Songs Community Center, located at 37 South Main Ave., Voorheesville.

"There's a long tradition of the old-time community square dance as a way to relax and socialize," said Paul Rosenberg, of Homespun Community Dancing.

Community dances, while serving as a way to socialize and relax, can also serve as an enjoyable way to get some exercise.

"Back before labor-saving devices, people worked pretty hard just to make it through the day," said Rosenberg. "An evening of socializing with friends often included dances that were simple and fun as a way to relax. Today, many of us want to move and have fun, but don't have lots of time to commit

to learning complicated figures."

The desire for simple dances has spurred the growth of community dances, which aim to be accessible to people of any age or skill level. People seem to be falling in step, too, with the dances becoming popular locally,

according to organizers.

"We have had a very enthusiastic reaction by the participants, and attendance has exceeded our expectations. The mix and ages is more diverse than any other dance in the region because the focus is as much on community as it is on dancing," said

Rosenberg.

Andy Spence, executive director of Old Songs, said participants have ranged from families with children to older couples. She believes the approachability of the dances ensures everyone has a good time.

"We call them community dances because they should be easy for the community to come and enjoy the evening and not struggle over long tedious directions," said Spence. "There are not very many ways people can enjoy themselves in the evening other than going to a movie, a concert or sitting at home and watching TV."

A new element this year is a change to the potluck meal because it's shifting to a dessert and snack potluck that will be enjoyed during intermission.

"We did a meal for the last two years, and it went well, but we thought we would like to try something

different," said Spence. "It will be interesting because this sounds like more of a challenge, but also more tasty."

Changing the bands performing live at the dance, along with the callers, helps keep each of the dances fresh for those regularly attending. Around 50 people typically attended each dance last season.

"The tunes are often very different, and the instrumentation is different. Every dance has its own sounds," said Spence.

All forms for dances are taught during the event, so no prior knowledge is needed. The Community Dance goes from 7 to 9:30 p.m. and admission is \$8 per person, but anyone 12 and younger can get in for free.

Preliminary budget unveiled

Supervisor Clarkson proposes \$39.7M spending plan that includes cost of living raises for town employees

BETHLEHEM — In presenting the preliminary town budget, Supervisor John Clarkson said the Town of Bethlehem remains in good financial condition, and he has proposed a slight spending increase for the coming year.

Clarkson presented his budget on Tuesday, Sept. 23, along with Comptroller Michael Cohen. The proposal includes a 0.4 percent spending increase of about \$140,000. This is mostly to help pay for the rising costs of employee benefits and allow for a slight cost of living raise.

The proposed \$39.7 million budget would hold a tax levy increase of 1.8 percent,

which is below the state tax cap for the town. However, most homeowners should see a reduction in their tax bills following the townwide reassessment completed earlier this year.

About 6,000 homeowners will see their tax bills lowered next year. The tax rate should decrease an average of 4.1 percent. Another 2,000 should see their bills stay the same, while about 3,000 homeowners are projected to see an increase.

The current spending plan, called the “good news budget” by Clarkson when it was presented last year, also called for no cuts and mostly relied on the use of the town’s fund balance and grant money to stay balanced.

Clarkson said the one piece of bad news for 2015 is a sharp decline in the mortgage recording tax because of low refinancing numbers. That loss resulted in the town receiving \$225,000 less than last year.

The preliminary budget includes a cost of living increase for employees of 2 percent.

Clarkson said the raise was warranted because employees have had to take on a greater workload in recent years as positions were consolidated or went unfilled. Staffing has been reduced by 10 percent since 2008, decreasing from 241 employees to 216 in next year’s budget.

“Employees have risen to the challenge of doing more with less,” said Clarkson. “I think it’s our responsibility to compensate them fairly.”

The cost of living increase does not include emergency personnel, such as the police department and telecommunications employees. Those contracts are negotiated separately.

Two town positions are being eliminated through attrition.

When former Town Building Inspector Gil Bouchard retired earlier in the year, Justin Harbinger took his place. Harbinger’s former position will now remain vacant, reducing the number of building inspector assistants from four to three. Receiver of Taxes Nancy Mendick is also expected to retire next year. The remaining employee will then be moved to the Town Clerk offices for greater convenience of residents.

“With the use of lockbox processing and the transfer of tax receiving for schools to Bethlehem Central, Ravena-Coeymans-Selkirk, and perhaps Guiderland Central next year, there is certainly no more than one FTE of labor remaining in tax receiving,” said Clarkson in a later interview.

Town water rates will increase by 3 percent. The town expects to collect \$2 million in water charges next year, about \$241,000 more than 2014

because of higher rates and higher consumption.

Clarkson said greater effort will be put into finding more efficiencies for the town, and officials will work in the coming year to reduce overtime spending. One of the largest proposals has been to potentially consolidate the town’s telecommunications staff with Guiderland to provide greater coverage.

The budget also proposes \$215,000 in technology investments. The largest expense is \$97,000 for a computer system to update how the town manages timekeeping and scheduling for employees. A paper system is still used now. Other investments include new security cameras and recording equipment, upgrading the town clerk’s files to electronic records and modernizing the assessor’s office.

No comments were made from town board members about the proposal. Budget workshops are scheduled throughout the month, with the public hearing set for Oct. 22. Final adoption of the budget is scheduled for Nov. 12.

G'land school board cancels focus group

District to hold community workshop instead to generate ideas on building usage

GUILDERLAND — Guilderland Board of Education members have decided to cancel the upcoming focus group that would have discussed the building capacity study, which lacked widespread community support.

School board members on Tuesday, Sept. 23,

opted to cancel the upcoming daylong, community focus group scheduled for Nov. 1. The scenarios were originally intended to be the main element the focus group would have discussed. Those scenarios have since been removed from consideration, at least temporarily, following strong pushback from Altamont residents.

One issue that hindered the formation of the focus group was that applications were overwhelmingly coming from Altamont. The group was supposed to be representative of the entire school district, and anyone interested was encouraged to apply.

Board members previously voted 7-2 at their Aug. 19 meeting to set aside those scenarios presented in the building

capacity study in favor of community members and the board developing their own options.

Four out of the five scenarios to use space more effectively would have shuttered Altamont Elementary School.

District officials did schedule a community meeting for Monday, Sept. 29, which was held after *The Spotlight* went to press, to again discuss factors leading up to the study and review some of the data presented in it. Residents will have an opportunity to provide

feedback, following an overview of the process to date.

"Everybody will get a chance to speak," said board member Judy Slack. "If we have time, we will let people come back up."

A second community meeting will be held in a workshop format Thursday, Nov. 6, from 7 to 9 p.m., at Guilderland High School. District residents will be invited to share ideas for addressing some of the challenges currently being faced by the district regarding building capacity.

Later, an advisory group will be formed to review, discuss and consider ideas generated during the workshop, according to Slack.

"The focus group was one Saturday, and then you are done," said Superintendent of Schools Marie Wiles, "but this group has a much longer commitment."

During the public comment portion of the board's Sept. 23 meeting, there was more criticism lobbed at consultant Paul Seversky's building capacity study.

Nicholas Fahrenkopf, a six-year school district resident, said he was pleased to see the study's scenarios set aside.

"I wanted to applaud the board for taking action last meeting to set aside the recommendations that were a part of Dr.

Seversky's study. You would have not been able to have an honest and open conversation about really anything related to that without setting those aside," he said.

Fahrenkopf, who is an engineer, still worries "the faulty data and projections" in the study will lead the district to eventually close a school. He distributed to the board and audience some information regarding his concerns about Seversky's enrollment projections.

"Something is wrong here," said Fahrenkopf. "Unless you all know something that I don't about these methods, you should have some concerns about basing any important decisions on these projections. These methods appear to be arbitrary, with no degree of confidence shown and no error associated with it."



Survey takes pulse of economic climate

Town planner says answers could help Bethlehem better serve local businesses

BETHLEHEM — Bethlehem's Economic Development staff is asking business owners to participate in a new online survey from the town.

The survey was launched last month with the purpose of helping the town better meet the needs of its local businesses. It is part of a new initiative by Bethlehem's Economic Development and Planning Department to do more outreach with the business community in hopes of building better ties and attracting new companies to the town.

"We want to get an understanding of how the town can better meet the needs and desires of businesses," said Economic Development and Planning Director Rob Leslie. "We want to know how they are doing, how long they've been here, their plans for the future, and how many employees they have."

Leslie said the survey would be used to gauge the effectiveness of the town's current policies. It will also give them insight into how new policies should be enacted in the future.

"We want to know how to better meet their needs, because we want our businesses to succeed," said Leslie.

Leslie was promoted last year, following the retirement of former Economic Development and Planning Director Mike Morelli. A partnership between the town and Bethlehem Industrial Development Agency then led to the hiring of Senior Planner and Economic Development Coordinator

Elizabeth Staubach, so more resources could be placed on attracting new businesses to the town.

In June the town and IDA co-sponsored an Economic Development tour, which was one of Staubach's first projects. The event was meant to bring about awareness of the town's available commercial and industrial properties.

Staubach said another reason for the tour was to display how the town can meet a variety of needs for business owners. Small start-ups may be more attracted to one of the available spaces within an already established building, whereas industrial developers may be looking for vacant land near the edge of town.

"The tour resulted in a good networking opportunity with developers," said Leslie. "Liz and I are now in contact with them, and we are able to follow-up."

Similar events will most likely be planned for the future because of the tour's success. The business survey is being done in the same vein.

How the town responds to the information in the

surveys will depend on the number of participants and the types of answers they receive.

"We're looking to find out the types of businesses that are here, but perhaps if there was another business or industry located in town, it could also help those existing businesses," said Leslie. "One of the questions is directly about that, and if we found a common trend, perhaps that's where we focus next."

The goal is for the Economic Development and Planning Department to be better utilized by the town's business community as a resource. Leslie said often times the town can connect business owners with state programs to reduce costs or loan funds, but many don't know where to turn. The town can also help with scouting appropriate sites if a business wants to move to the town or grow.

"I think we have a lot to offer that people don't know about," said Leslie.

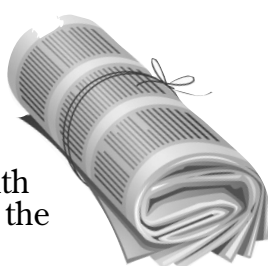

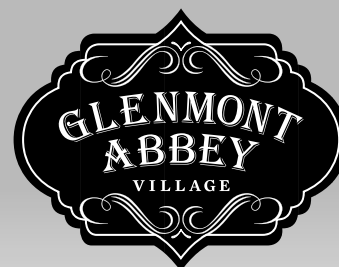

“But it was the Civil War that grew the game and that was the focus of Hubbard’s lecture.

“Prior to the war baseball was a gentleman’s game and played mostly in the North,” Hubbard said. “Southern plantation

owners did not want to introduce it there for fear it would take away from the work. It was the Civil War that gave baseball its blue collar appeal.”

Dutchmen break out against Falcons

Sentz, Long lead Guilderland to first win

ALBANY— The Guilderland football team broke into the win column for the first time in 2014 at another winless team's expense.

Quarterback Andrew Sentz threw for 198 yards and four touchdowns to lead the Dutchmen (1-1 league, 1-3 overall) to a 55-7 Empire Division victory over Albany Saturday, Sept. 27, at Bleecker Stadium.

Sentz also rushed for 102 yards and a pair of touchdowns for Guilderland, which built a 36-0 lead by halftime and never looked back.

Cameron Long did his part for Guilderland, as well. The junior halfback caught three touchdown passes for 123 yards and carried the ball four times for 41 yards and a score in his best offensive effort of the season. Long also intercepted Albany quarterback Tysheem Morris in the second quarter.

Morris scored on a 4-yard run late in the third quarter to end Guilderland's shutout bid. Morris finished with 59 passing yards for the Falcons (0-2, 0-4).

Guilderland's victory

was part of a greater theme for football teams in central and southern Albany County as Bethlehem, Ravena-Coeymans-Selkirk and Voorheesville all posted impressive victories.

Bethlehem (2-0, 4-0) remained undefeated with a 37-12 Liberty Division victory at Schenectady Friday, Sept. 26. The Eagles built a 12-0 halftime lead on a Ben Zonca 1-yard touchdown run and a recovery of a blocked punt in the end zone, and then they used a 19-point fourth quarter to put away the Patriots (0-2, 1-3).

Zonca rushed for 101 yards and three touchdowns for Bethlehem. Quarterback Nick Crisorio completed 10 out of 17 passes for 193 yards, including a 17-yard scoring strike to John Fredette.

Ravena (3-0, 4-0) also kept its record perfect with a 42-18 victory over Hudson in Friday's Reinfurt Division game. Tailback Steve Kross guided the Indians with 146 rushing yards and four touchdowns, including scoring runs of 24 and 11 yards in the fourth quarter to close out the game.

Voorheesville (3-0, 4-0) leveled Taconic Hills 42-0 in a Class C non-league game Saturday, Sept. 27, in

Tailback Matt Feller contributed 120 yards on 19 carries and a touchdown for Voorheesville on its homecoming day.

Re-enacting a slave's life

New Scotland Historical Society event to shed light on Solomon Northup's struggle for freedom

NEW SALEM — History will come alive as the New Scotland Historical Society presents Clifford Oliver Mealy's portrayal of the musician and kidnapped Saratoga resident, Solomon Northup.

The Life and Times of Solomon Northup program will be held on Tuesday, Oct. 7, at 7:30 p.m. The event is free and open to the public and will be held at the Wyman Osterhout Community Center in New Salem.

Mealy will give a brief history of slavery and how slavery "came to haunt the world." He will also discuss the life of Solomon Northup, a free black man in the 1840s who was kidnapped and sold into slavery in the south. His life inspired the movie "Twelve Years a Slave," based on his autobiography.

"This program was selected because of the interest following the movie," said New Scotland Historical Association President Alan Kowlowitz. "This event has both a local hook because Mr. Northup lived in the Capital District, and a larger tie-in to American history and the Civil War period."

Mealy lives in Greenwich, and was educated at Dutchess Community College with a degree in communications and media. He is a retired photographer from the New York State Bureau of Historic Sites.

"We think having someone do a re-enactment might be a bit more visceral, that someone may prefer over listening to talking heads," said Kowlowitz. "For some, a lecture can be seen as dry, and this event will be more enjoyable for children."

G'land GOP elects new chair

Town Republican Committee gets reorganized, pledges grassroots effort

GUILDERLAND — Doug Breakell is taking on leadership of the Guilderland Republican Committee, but his involvement behind the scenes started decades ago.

"My father used to bring me to committee meetings when I younger, so I have been involved with the committee for all of my life," said Breakell. "I'm honored to be selected to become chairman."

Breakell, a Guilderland resident for 34 years, was elected as chairman of the town Republican Committee during its meeting Tuesday, Sept. 16. Matt Nelligan stepped down after serving as chairman for four years. Breakell credited Nelligan with fostering growth within the town committee, which he is hoping to build upon.

Guilderland Republicans, while disappointed about

not nabbing any seats, were pleased with the votes being closer than some might have expected in the supervisor and town board races.

Democrat Ken Runion was reelected to his eighth two-year term and received 5,084 votes, 53.45 percent, while challenger Mark Grimm had 4,414 votes, or 46.4 percent.

Democratic Town Board incumbents were reelected with a similar margin.

Last year was also the first time Republicans had run a full slate of candidates in more than a decade.

"Next year, we are looking to pick some seats up on the (Town Board), because that is what we need to do to add some balance to town government," said Breakell.

Grimm said Breakell is a "very bright political strategist" and has been an inactive member in the committee.

Grimm said he hasn't decided if he will make another run at becoming town supervisor, but said he feels the GOP's presence is being felt more at the town level.

"The Democrats are now aware we are watching them, and I think it influences how they act," said Grimm. "Even though we are the party that is (not in power), we are having an influence on town policy."

The town GOP isn't really focused on next year's local elections though, because Breakell said, committee members are focused on helping candidates win state races, along with a congressional seat.

"Our focus right now as a committee really needs to be working on these statewide

candidates," said Breakell. "If you win some of these seats, it will put you on a good foundation for getting your message out for town elections."

When the committee looks for town candidates, Breakell said he'd be looking for people who are willing to put in the time and commitment to campaigning and connecting with residents.

"The only way to really advance Republican candidates is with a grassroots efforts — getting out there and talking to people, and getting the message out. Raising money is always a struggle for the Republican party in Albany County, so grassroots is the way to go," said Breakell.

While not naming names, he said some Republicans have already expressed an interest in running for town seats. The only elected GOP official is Highway Superintendent Steven Oliver.

Bomb threat closes Delaware Avenue

Head-on crash injures three

The Albany County Sheriff's Office arrested Kevin M. Grady, 57, of 611 Rowe Road in Feura Bush, around 5 p.m. Thursday, Sept. 18, and charged him with vehicular assault in the first degree, a felony, driving while ability impaired by the combined influence of drugs and

alcohol, reckless driving and failure to keep right. Police said a toxicology report revealed Grady had hydrocodone and alprazolam in his system at the time of the incident. The arrest stems from a motor vehicle crash on State Route 32 in the Town of New Scotland, in which three people were seriously injured.

Sheriff's investigators and members of the New York State Police collision reconstruction unit investigated the incident.

The investigation revealed that, at the time of the crash, Grady was operating his 2003 Chevrolet pickup truck while his ability was impaired by drugs. Grady's vehicle struck a 2002 Subaru head in the area of Onesquethaw Creek Road.

Grady was the sole occupant of his vehicle, and the other vehicle was occupied by three Westerlo residents, all of

whom sustained what have been classified as serious physical injuries. The identities of the victims are being withheld at this time, but they are described as being a 26-year-old man, 25-year-old woman and a 2-year-old boy.

Grady was arraigned in New Scotland Town Court and released under the supervision of the Albany County Probation Department pending further court action.

the time was joining.”

Starr is now 84 years old and is the oldest active member of the Bethlehem Grange. When she joined in 1949 there were about 230 members who attended meetings. Over time, membership in the organization has declined, and the building has fallen into disrepair.

“It’s not like it use to be,” said Starr. “Now we get 18 to 20 people at a meeting, out of the 66 members we have on the books. It’s kind of sad in a way. We’re just hoping we can keep it going.”

This year, the Bethlehem Grange celebrated its 140th anniversary. The organization was founded on March 7, 1874, with about 30 members. The original group met in Albany until it was decided the city was too far for the rural residents to travel.

The following year, a local resident gifted the organization with an old, former hotel to conduct its meetings in Selkirk. For several years, local residents gifted pieces of adjacent land to expand the property, but in 1920 a fire destroyed the building. Meetings were held at the First Reformed Church of Bethlehem for the following year, while the new building in the hamlet of Beckers Corners was constructed. The same

building is used today, although it was expanded in 1936.

The building was added to the National Register of Historic Places in 2002.

The National Grange of the Order of Patrons of Husbandry, known to most simply as The Grange, started just after the Civil War as a fraternal organization. Those who joined Granges were typically from rural communities. The original objective was to join the North and South together to cooperate in bringing farming practices up to date. The organization stressed the importance of family and promoting “the economic and political well-being of the community and agriculture.”

Starr said the organization was originally very secretive of its meetings and practices, and acted as a sort of lobbying group. Eventually, the focus turned more toward improving the local community and family activities, but nationally, it continues to champion the causes of farmers.

“It used to all be farmers, but anyone can join,” said Starr. “I think of our members now, only one is a farmer.”

According to The National Grange, membership has dropped by 40 percent in the last 15 years. Many local

organizations have disbanded. There are now only three Granges in Albany County left out of the previous nine, with Bethlehem being the largest.

Bethlehem Grange officials are now trying to entice more members and are beginning a fundraising initiative to revitalize their community center.

Carol Carpenter, who became master of the Bethlehem Grange in the last year, said the project is a long time coming. The group recently decided to disconnect the building’s telephone because they could no longer afford the bill. The roof also leaks at times, and the building needs a new paint job.

“A lot of our money has diminished as our older members die off,” said Carpenter. “We also had a situation a few years ago where a member stole from us, so we’re still trying to recover from that.”

The group has ramped up the number of activities it has hosted in the last year in order to raise more money and attract new members.

“My family joined

because we had started going to the dinners,” said Carpenter, who lives in Albany. “We eventually made friends, and they convinced us to become members.”

Anyone from Albany County can join, including children ages 4 and up. The Bethlehem Grange No. 115 – Junior and Youth was organized in 1929 and is still active. The group goes on trips, participates in local demonstrations

and classes, and each year helps with setup of the Altamont Fair.

“It’s a family organization that stresses family ideals,” said Starr. “That’s what I like about it. Anyone can join and participate.”

Carpenter said even though membership is low, the Bethlehem Grange continues to be a leader within the organization. The hope is for the location to remain active

for the next generation.

“It’s a tradition we would like to continue,” said Carpenter.

The next Bethlehem Grange event is a pulled-pork dinner on Saturday, Oct. 4, with all of the proceeds benefitting the Grange. Dinner will be served from 4 to 7 p.m. with apple crisp for dessert. The cost is \$10 per person. Eat-in or take-out is available at 24 Bridge St. in Selkirk.



Costume care a full-time job

However, days before the acrobats, jugglers and trapeze artists arrive in Albany, Melody Wood and her crew will find their way to town with more than 1,500 costume pieces, six washing machines, two dryers and a lot of thread.

“We start preparing wardrobe, dressing rooms, washings from the previous city,” said Wood, the head of wardrobe. “On that day, we do about 36 loads of

washing, send costumes out to the dry cleaner, paint the shoes, distribute the hats ... There is a lot of preparation that day.”

The “Dralion” wardrobe team includes four permanent touring staff and three local wardrobe employees from each city. The wardrobe team is responsible for maintaining and repairing all the show’s costumes.

“What we take care of

is everything from their heads to their toes — hats, shoes and everything in between,” Wood said. “Some looks can be made of eight or nine items.”

Once the artists arrive, Wood’s crew is busy ironing, doing costume fittings and checking every costume before putting them in the dressing room.

“We check for repairs, stains, missing buttons or beads,” she said.

Like most Cirque du Soleil shows, “Dralion” has its share of acrobatics, aerial and daring stunts. An aerial ballet captures

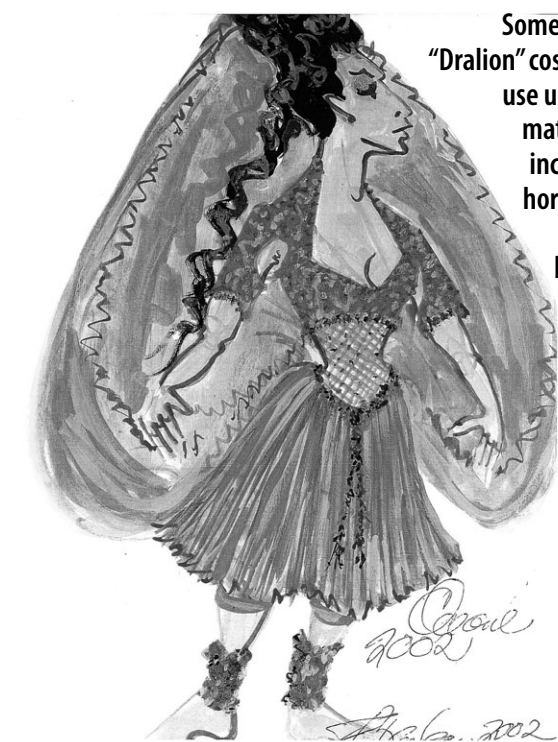

the passion and energy of its signature element: fire. Suspended from a hoop high above the stage, the artist presents an evocative choreography in which the hoop and body become one in a dance of acrobatic precision.

Another act has six men balancing long decorative poles symbolizing fire. A traditional act of the Chinese acrobatic arts, the performers keep the poles “in flight” overhead while performing acrobatic feats on the ground.

A blend of the traditional Chinese dragon and lion dances takes on new scope in an energetic tumbling sequence where artists perform acrobatic moves while balancing on large wooden balls as the “Dralion” characters surround them with a spirited dance.

Wood said rips and tears in the costume are the nature of the show. For this reason, each costume has a duplicate piece to be used as a replacement in a pinch, though Wood said

most of the costumes can be quickly repaired with a quick stitch.

“Dralion” is about a quest for harmony between humans and nature. The show’s name is derived from the dragon symbolizing the East, and the Lion symbolizing the west. Four elements take on a human form, and each element is represented by a color. The air is blue; the water is green; fire is red and the Earth is ochre. The show’s costumes are inspired by the colors.

Starting out with a cream color fabric in the paint department in Montreal, the costumes are painted and decorated with unusual materials.

Horse hair, metal, window screen, styrofoam, bubble wrap, bugs and Slinkies are used to bring the costumes to life. The artists in the costume workshop worked for more than three months creating the original costumes for “Dralion.”

For Wood and her crew, it’s an ongoing process, with more than 300 pairs of shoes cleaned and painted by hand every week.

Although Wood said most people are surprised that a majority of the fabric is machine washable, it’s the water in which they are washed that makes costume upkeep challenging.

“It’s been challenging being in so many different countries. The small thing like water. I am used to the condition and feel of the water in London. Water has a different feel everywhere you go and has a different effect on the costumes,” she said.

Despite all the challenges, Wood said she wouldn’t change her job.

“I love the people, and we are able to travel and arrive at these places and still find the time to go exploring and see new things and still entertain people everyday. It’s amazing,” she said.

Maxed out

Student Film Festival will screen the works of 10 finalists

ALBANY —In the course of a single minute, 100 hours of video are uploaded onto YouTube.com. The amount of material that has amassed on the website since its creation nearly 10 years ago has reached a point where the company's content database scans through the equivalent of 400 years of blooper, prank, monologue, gaming and cat videos every day.

In 1968, when Andy Warhol stated, "In the future, everyone will be world-famous for 15 minutes," he didn't know just how right he was.

Nearly 50 years after Warhol's remark, through a joint venture

with the Times Union, The College of Saint Rose will feature the "15 Minutes Max Student Film Festival."

The festival, which will hold a screening Friday, Oct. 3, is in its third year, and as committee member Liz Richard said, it calls attention to local talent in an ever-growing medium.

"The goal of the festival is to present the best student work in the region and present it to the community at large in the hope that it sparks more interest and production," said Richards, who is also a visiting instructor of communications at Saint Rose.

According to the program's website, it all started as a conversation among college faculty members recognizing

how today's technology has allowed almost anyone to record video and make it public. That conversation spawned the means of providing Saint Rose students with a "hands on" multimedia competency. From the use of video production assignments to learn foreign languages, to students producing online videos about the advantages and shortcomings of the YouTube culture, to new curriculum focusing on the study of new media, Saint Rose offers a

wide range of opportunities for students to become creative producers and critical consumers of digital video.

With the focus on showcasing the best short films produced by local college students, the festival celebrates and encourages everyone to take an interest in film and new media production.

Those students who contribute to the festival follow specific guidelines. First, the film must run no more than 15

minutes long — hence, the name of the festival. Other guidelines include honoring copyright laws, adhering to a PG-13 film rating, and following the Center of Social Media's Code of Best Practices in Fair Use for Online Video.

Students attending colleges within a 50-mile radius of Saint Rose were invited to submit their work for this year's festival by May. Categories include
