A saucy idea

Bethlehem High School students create own company for experience, charity

BETHLEHEM — The aroma coming from the kitchen of Bethlehem Central High School just after the final bell rang was mouth watering. The smells were so good, nearly a dozen staff members poked their heads in to see how the cooking was coming along.

"We get that a lot," said Clara Racette, a senior. "Teachers will stop by to see how we're doing, or sometimes they'll help us cook, if they have time."

As Principal Scott Landry grilled chopped zucchini, four other students and some adult volunteers cut onions and pulsed carrots in a food processor. Racette was counting cans of crushed tomatoes. It was all in preparation to cook their sixth batch of Landry's tomato sauce recipe, which would then be sold for charity.

"We honestly didn't think it would be so popular," said Racette.

The project started this winter after Landry saw student Matt Slatcher walking down the hall in is his white chef's coat. Slatcher, a senior, is studying Culinary Arts and Hospitality Technology through Capital Region BOCES Career and Technology School.

Dashing through the color

Local organizations to host ColorDash benefiting Bethlehem Central schools

BETHLEHEM — Many races and runs have been hosted in the town, but an upcoming event is promising to offer the most colorful experience yet.

The first ColorDash in the town will be held at Elm Avenue Park on Sunday, May 17, at 1 p.m. What sets the ColorDash apart from traditional 5k runs or walks is the colorful powder tossed at participants at each kilometer of the course. The powder, made of food-grade cornstarch and biodegradable vegetable dye, comes in several different colors, and participants end up resembling an abstract painting after crossing the

finish line. The Bethlehem Elementary Physical Education departments, Bethlehem Opportunities Unlimited, and Delmar Rotary are hosting the ColorDash, which has 50 percent of the proceeds benefiting the PE departments at local elementary schools.

The event costs \$40 for an individual, \$35 per team member, or \$85 and up for families when preregistering for the event online at cd5k.com. To register for the event, click on the "Locations" menu bar button on the website and then on the Delmar event. On-site registration the morning of the event costs an additional \$10.

Laurie Nolan, a physical education teacher at Glenmont Elementary School, said the idea for the event developed last year when fellow elementary PE teachers Joanna Crawford and Katie Charvat suggested it.

"Color events were becoming more popular,

and we thought it would be a great family and community activity," said Nolan. "We were not aware of any similar event being held in Bethlehem in the past."

Nolan wrote a grant request to Bethlehem Opportunities Unlimited (BOU), which the organization awarded, to help secure an initial sponsor. The BOU is covering the cost to rent the park pavilion and help with advertising fees. BOU members will also operate a concession stand offering healthy snacks to purchase.

"This is a good event because it is not timed. It is not an official road race," said Nolan. "The focus is entirely on participating and having a good time. Some participants will choose to walk, and some will run, but all will be covered with color at stations set up on the course. You don't have to be a certain age to be covered in color and laugh about it."

The event fee includes a t-shirt to wear for the dash and a goodie bag containing a race bib and safety pins, a color dash tattoo and a color pack for the "color explosion" at the end of the dash. There will also be a DJ playing music.

"A highlight of the day is the color explosion at the end of the race. Everyone will have a color pack to toss up in the air to conclude the race, and we are hoping to get some dancing going, too," Nolan said.

There no specific fundraising goal for the event, but Nolan said organizers are hoping for a "large turnout" from the community.

"We would love to see our past and present students at the ColorDash," Nolan said.

Participants can pick-up their registration packet starting at 11 a.m. before the dash kicks off at 1 p.m.

Bison Bedlam in Bethlehem

Bison shot dead by owners after 15 escape Schodack farm

BETHLEHEM — The herd of bison that escaped from a Schodack farm and caused havoc for residents in South Bethlehem and Coeymans, were dead no more than eight hours later.

In all, 15 bison were killed. Prophetically, the owner of the animals said his bison would "never" be corralled. The first shots were fired shortly after 1:30 p.m., on Friday, April 24. Within an hour, Albany County Sheriff Craig Apple said they were all dead.

An unidentified man was taken into custody by the Albany County Sheriff shortly after the shooting began. According to Apple, he specifically ordered the farmer's "hired guns" to kill an injured bison that appeared to be suffering after it was shot. However, the man allegedly proceeded to fire upon more animals without successfully euthanizing the first one. No charges have been filed as of Monday, April 27, but that could be in the future.

"It was turning into the wild, wild west," said Apple. "It was turning into a spectacle and it was time to end it." At 1:39 p.m., Apple said the animals were ordered to be put down.

Tom Gallagher, a large animal expert from Cornell Cooperative Extension, explained tranquilizers were never a practical option, nor was corralling them. Tranquilizers can only be used when in range of 30 feet. No one was able

to get close enough to the animals and because such a large dose would need to be used, the animals typically die anyway.

"(The tranquilizers are) safer to use," said Gallagher. "We would have used them if we were in a residential area."

George Mesick, owner of GEM Farms Buffalo in Schodack, said the same earlier in the morning. The adrenaline in the 1,100-pound animals can offset even an amount of sedative that high. Speaking with reporters, Mesick expressed more concern over the potential liability from the incident than the financial loss from losing the bison.

Bethlehem Police Lt. Thomas Heffernan said the situation turned into a public hazard once they escaped over the New York state Thruway. Earlier in the day, Heffernan said he was concerned because the animals, which can travel up to 40 mph, grew unpredictable the longer they were away from their pens.

Heffernan said the Bethlehem Police were given permission to shoot the animals earlier that morning, but they did not feel comfortable. Instead, they waited to confer with state veterinarians, and for the owner of the animals to arrive on scene.

No accidents occurred on the Thruway, but a number of cars slowed to a stop, and there was one close-call with a tractor trailer.

Selkirk resident Andrew Broadhurst said he was talking about news coverage of the bison with a friend as they watched from Route 9W when they found themselves within 300 yards of the herd.

"We saw a herd of buffalo coming down 9W. They hauled ass up there, then hauled ass over there (proceeding west behind Miller Road heading towards South Street," Broadhurst said.

The ordeal started Thursday afternoon, April 23, when the herd of bison escaped from GEM Farms in Schodack. They were believed to have crossed a railway and swam the span of the Hudson River to Selkirk. River Road residents then reported the herd near the intersection of River Road and Maple Avenue at approximately 6 a.m. the following morning. Within hours, Bethlehem Police employed the services of several agencies to assist in corralling the animals. Initial efforts appeared to be successful as the bison were kept near the banks of the Hudson River in a wooded area.

However, at approximately 11:30 a.m., the animals reappeared from behind a Peltz Road home and crossed River

Road. They approached a wire fence that ran along the length of the state Thruway and appeared to turn back around before being met by a throng of law enforcement officers, reporters and curious neighbors. There were nearly 100 people watching in all. That is when the herd jumped the fence and ultimately crossed the thruway.

The bison traveled approximately seven miles before they were met in a ravine at the Feuri Spruyt, south of Bridge Street in Selkirk.

It was the owner's responsibility to remove the dead animals. All of the carcuses had been removed the following day, and were in possession of the farmers. Marcy Velte contributed

Fifteen bison were shot dead by their owners after escaping from a farm in Schodack last week. The ordeal started on Thursday, April 23, when the herd first escaped from GEM Farms. They ended up in Bethlehem the next day after swimming across the Hudson River.

The project will likely be approved at an upcoming May meeting. A target opening date for the restaurant has yet to be announced.

Normans Kill landslide repaired

Town and county continue State of Emergency for areas bordering creek

BETHLEHEM — As major repair work is finished along the Normans Kill, officials wait for the state Department of Environmental Conservation to finish its investigation into what caused last week's landslide.

A mudslide dammed up the Normans Kill on Monday, April 20, blocking water flow down the creek and resulting in a "high potential" for flooding, according to local officials.

Crews from the Albany landfill used their equipment to dig a trench on land near the Capital Hills Golf Course, which town employees worked to lay pipes and pump out the additional water. Although the major work has been completed, both the county and town has continued their States of Emergency as minor work and stabilization efforts continue.

"Now that the safety issues for Bethlehem

residents are over, I would like to see everyone get reimbursed," said Bethlehem Supervisor John restricted. Clarkson, adding the state has already been notified of the intentions of local municipalities to receive funding.

The DEC is now looking into what may have caused the landslide. Clarkson said Normanside Country Club had begun grading work near the site in March before they obtained a permit. When it was found the work was being done, the town's Building Department contacted the business about getting a permit.

"We don't know what caused the landslide at this point," said Clarkson.

Dave Hostig, Normanside's director of operations, said they believed everything was properly in place before the work was done, and they don't believe their work was the cause.

"This is really an act of God, and a natural disaster," said Hostig. "This area is prone to it. It's not like this is unprecedented." He added their engineers are working with the town in order to make improvements.

For now, the country club is still open for golf, but the club house is closed and access to the maintenance shed has been

"We have to make sure everything is OK before we open it, and they are working with us," said Clarkson. "Normanside is an important local institution. We want to see it succeed and thrive."

Last Monday, Max Fischer of McCormack Road North in Slingerlands, said he noticed the creek rising in the morning. At first, he thought nothing of it as he looked out to a typical scene. He later walked towards the creek and noticed there was no brown discoloration, but there also was no current, as the level of the creek continued to rise.

"Then I said, 'Gee, is there something going on down below?" said Fischer.

Fischer arrived at the City of Albany's Capital Hills golf course shortly before 1:30 p.m., where several police and workers already onsite. There he learned his fear of a landslide was a reality.

According to Albany County Sheriff Craig Apple, an approximately "250-yard area of earth" slid down into the creek, entirely blocking it. "You

are talking about a lot of earth that has shifted," said Apple.

Albany County Executive Dan McCoy declared a State of Emergency for all areas bordering the Normans Kill countywide last Monday which became effective 12:30 p.m. until further notice. A "slop failure" on the Bethlehem side of the creek blocked water from flowing downstream. It was determined there was a high potential for flooding upstream from the landslide.

"All departments and agencies of Albany County are directed to take whatever steps necessary to protect life and property, public infrastructure and provide such emergency assistance deemed necessary," the County Executive's Office said in a statement at the time.

Clarkson said town engineers were first on the scene, and provided assistance to the City of Albany.

Officials remained on high alert throughout the day to see if any nearby residents had to be evacuated.

At a media conference held around 1:45 p.m., McCoy said the main concern was to get the

creek running again, but they wanted to make sure it was done in a safe way.

Apple said multiple agencies were brought in to find a solution, including the state Department of Environmental Conservation and state Office of Emergency

Bethlehem police have identified the body found earlier this week in the Hudson River as David Betterton, 41, of Dutchess County, following an autopsy.

Police said Betterton was reported missing to state police in Wappingers Falls on Jan. 19. The investigation determined the decedent became attached to a barge that was coming from New Jersey through the Hudson River channel on April 21, and became unattached while it was docked at the North Albany Port Terminal in Bethlehem.

The autopsy was attended by Bethlehem Police and state police. Cause of death was determined to be blunt force trauma and asphyxia due to drowning. Foul play has been ruled out and the investigation has been concluded at this point.

Police originally received a call on Tuesday, April 21, around 7:15 p.m. from an employee of the North Albany Terminal Company in Glenmont, reporting a body in the Hudson River near their dock.

Upon arrival, Bethlehem Police requested the City of Albany's Fire Department and Town of Coeymans Fire Department's Dive and Rescue Team to assist with removing the body from the water. Once removed, police said the body was transported to the Albany Medical Center Hospital morgue by the Albany County Coroner's Office.

According to police, the

body appeared to be of a white male in his 40s and had been in the water for an extended period of time.

Other arrests:

Dems name candidates

VanLuven in race for town board; county legislature nods pending

— One week after the town's Republican party announced its candidates for the upcoming 2015 elections, the Democratic party did the same, but the backing for some county legislature seats will have to wait.

The endorsements announcement was made at a Bethlehem Democratic Committee meeting on Thursday, April 23, at the Bethlehem Public Library. Although the endorsement for some Bethlehem representatives had to wait, selections were made for all six upcoming town races.

"We appreciate everyone's interest," said Democratic Committee Chairman Jeffrey Kuhn, emphasizing this year's strong slate of candidates.

Only one person stepped forward to be interviewed by the party's Executive Committee for each position in a majority of the races. John Clarkson was selected to run for a third term as supervisor.

"I'm very proud of the record we're established, and by we I mean myself, the town board, the Democratic party, and in a larger sense, the whole town," said Clarkson, emphasizing his beliefs that residents want sound fiscal management to prepare for emergencies and make town improvements.

Clarkson and the town board have been criticized in the past year for the handling of the town-wide reassessment, mostly by large landowners who felt comparable land was not found in order to make appropriate property assessment adjustments. Other criticisms include changes to scheduling policy at the Police Department, and last year's conservation easements law.

"We have a winning formula. That's not to say we never run into controversy, but if we never did that and never took a stand, we would not be doing our job."

Nanci Moquin was backed for a fourth term as town clerk, and Brent Meredith for a second term as superintendent of highways. Newcomer Alicia Rooney was also backed for Receiver of Taxes after she worked with Moquin to send out this year's tax bills when Nancy Mendeck retired last year.

Both Moquin and Meredith thanked the committee for their endorsements. Meredith said he plans to continue work on efficiencies within the department, but he too faced criticisms on the length of time it took for leaves to be picked up and snow removal. The town's GOP has yet to name its highway superintendent candidate.

For the town board, four people were interviewed. However, endorsements went to incumbent Joann Dawson and another newcomer, David VanLuven.

"I decided to run because when I look at Bethlehem, I see a great quality of life and services," said VanLuven. "But we can't just sit and expect that forever. We have a constantly changing economy, and social environment. We need to adjust and adapt what we do to continue in a way sensitive to our budget restrictions, and resident's ability to pay taxes in order to look to the future.'

VanLuven, an ecologist, is principal at VanLuven Environmental, an environmental consulting firm. He has worked on the town's Comprehensive Plan Assessment Committee and the Open Space Technical Advisory Group. He became a Democratic Committee member about three years ago during the Reform Democrat movement. His main goals are smart economic growth, updating the town's water and sewer infrastructure, and implementing energy efficiency.

Endorsements for county legislative districts have been postponed, after new maps were accepted as a result of ongoing litigation concerning the Voting Rights Act. Kuhn has formerly announced he would not be seeking re-election to the town board to run for the county legislature in the 34th election district, but the new maps accepted in federal court drew Kuhn out of his district. Kuhn said he would not primary against incumbent Charlie Dawson.

Bill Reinhardt also previously announced his intention to run for the county legislature, but would not be stepping down from his town board seat until after the election. He has not been drawn out of district, and if he is successful in his bid, would leave an open town board seat. It would then be possible for other town board members to appoint Kuhn to the seat if they wish.

The Albany County Legislature still has to vote on the new maps for them to be officially accepted. The Democratic Committee will be reinterviewing candidates for the 33, 34, 35, 36 and 38 election districts, before announcing their endorsements on May 7.

Since the new lines could also effect committee districts within the town, and potentially where resident's vote, the committee said members may start a public awareness campaign for the upcoming election season.

From throwing rocks to sinking baskets

he NBA playoffs are in full swing, and as many basketball fans know, Dr. James Naismith invented the sport at a YMCA in Springfield, Mass., in December of 1891. But did vou know that it all started with tossing rocks?

The story of how and why Dr. Naismith invented the game is pretty interesting, but first I want to note that the first game of basketball played outside of Springfield took place at the Albany YMCA building on South Pearl Street in 1892. The Albany Y had the first gymnasium in Upstate New York, not to mention one of the first indoor swimming pools in the country. The pool doesn't really figure in to the basketball story, but it's



worth a mention.

The scene: It's a cold, miserable winter at the YMCA International Training School at Springfield College 124 years ago.

The situation: Students are rowdy and shorttempered because they had to stay indoors to play, and video games and iPhones wouldn't be invented for another century. The director of Physical Education at the Springfield YMCA, Dr. Luther Gulick, tells Naismith he has exactly 14 days to come up with

a new indoor game to give the kids something to do. Gulick tells him to make it fair and not too rough.

The rocks: When he was growing up in Canada, Naismith played a game called Duck on a Rock, where a big rock is placed on a bigger rock or tree stump. One player guards the rock and others toss rocks and attempt to knock the rock off the stump. Yes, apparently this was a real game. The best way to accomplish this was to lob a soft toss over the head of person guarding the rock.

The rules: To make the game safe, Naismith decided just to: allow only passing the ball, not running with it (dribbling wasn't allowed at the time); attach a peach basketball on a rail that was 10 feet above the floor, and thus, over the players heads. This would make the basket unguardable and reduce body contact (clearly, Naismith didn't plan on 7-footers playing the game in the future), and to score goals, you had to throw a soft lob shot into the basket, sort of like he

Rock. In addition, there were nine men on a side, most fouls were called for running with the ball and some players were tackled anyway.

The game grew in popularity on campus, and then moved 85 miles west to the Albany YMCA at South Pearl Street and Steuben, a building that is on the National Register of Historic Places.

Over the next few years, basketball spread to YMCA's across the country and in 2015, on any given day, at any YMCA from Bethlehem to Bakersfield, you can find people playing basketball. And that, my friends, is how basketball developed from a young kid throwing rocks in Canada to the second most popular sport in the world. — Mark Hansen


G uy Schiavone has been an employee of Howe Caverns for more than a dozen years, and even he got excited over the prospect of walking through the attraction's newest tour.

What's in a name?



More than one hundred names and initials appear on Signature Rock, featured on Howe Caverns' newest tour to open Sunday, May 3. But one man left behind something a little more to help us identify him more than a century later.

t may be nothing more than Victorian Age graffiti, names of people long since gone etched onto a hunk of calcite in an ancient cave more than 150 feet below the earth's surface. But, for those who will embark on the journey once Howe Caverns opens their newest tour on Sunday, May 3, they will be walking among the ghosts of history.

In a time when people are predominately thought as being acutely conscious of social etiquette, it seems somewhat surprising to witness evidence of what we would now consider vandalism. Nevertheless, it is there, including the name of the man who first discovered the cave nearly two centuries ago.

Lester Howe's name stands prominently upon Signature Rock, the feature of Howe Caverns' newest tour, along with scores of others who are assumed to have accompanied him over the years before this particular leg closed in 1900. Many of the names are forgotten figments of the past, but one such person left behind enough of a clue to shed light for people of today to learn who he was.

In 1900, L.L. Boorn etched his name onto the soft mineral rock, along with the Greek letters of the social fraternity Phi Delta Theta.

"When you think of the legacy of Phi Delta Theta, in 1969 Neil Armstrong left his footprints upon the moon's surface," said Bob Biggs, executive vice president of Phi Delta Theta international fraternity, headquartered in Oxford, OH. Armstrong, before walking upon the moon, was initiated into the fraternity, one of the oldest in the nation.

When approached of the news of the new exhibit, Biggs was quickly able to sift through the organization's files on 250,000 members to identify Boorn.

Or, Leland Lowell Boorn, Union College Class of 1900, and brother of Phi Delta Theta.

According to Biggs, Boorn lettered in both track and football at Union College, and served as associate editor for the school's newspaper, the *Concordiensis*.

After graduating, Boorn married and later became a clergyman, before he died in 1916.

Despite the fraternity's wealth of information, there was no record as to how Boorn had died. Having died at a relatively young age, it is possible that Boorn was exposed to the Spanish Flu, which exploded into a pandemic at that time. Other strains of influenza turned deadly shortly afterwards.

The leg of the tour, which is set to open on May 3, was once a part of Lester Howe's original guided tour, when he first entertained guests back in 1843. Cave explorers would arm themselves with a lantern and sensible shows to explore an underground stream and ancient rock formations, perhaps also escaping the summer heat. The end of the journey was marked by a large flowstone foundation of calcite, which visitors took to etching their names upon. According to the attraction's website, those tours of the past lasted up to ten hours. That's due in large part to the lack of modern amenities like electric lighting and an elevator, of which presentday visitors now enjoy.

The newest tour, however, lacks such luxuries.

"We're thrilled to finally be able to introduce our guests to the full story of Lester Howe's discovery and provide them with additional history of the caverns," stated Anne-Marie Galasso, COO of Howe Caverns, owned and operated by Emil Galasso and Charles Wright since 2007. "We've been developing this project to further commemorate Lester's remarkable story for many years. We are pleased to finally be able to answer the public's number one burning question on our traditional tour, 'What's behind the dam doors?' and truly excited to be able to open this portion of the caverns to the public."

Those who have visited the cavern are familiar with the boat tour that ends abruptly at a manmade waterfall. Later in Howe's life, he was forced to sell pieces of his land away. Ultimately, the Schoharie man sold a portion that included Signature Rock, and that portion of the tour was closed off to visitors in 1900.

Since that time, the waterfalls have been nothing more than a mysterious place mark to fuel the imagination. Each year Howe Caverns hosts approximately 200 000

approximately 200,000 visitors, and is second only to Niagara Falls as the most visited natural attraction in the state of New York. The cave itself is carved into the limestone of a mountainside that overlooks the Helderberg Plateau.

Next week, people will start making reservations to discover for themselves what we've been missing all these years.

Schiavone said visitors will be outfitted with equipment to aid them on the new tour: coveralls, rubber boots, gloves and helmets with lamps. "It's like walking through a stream bed," he said, with some sections requiring visitors to walk in ankle deep water, and other areas forcing them to walk hunched over. "You should expect it to be a little challenging."

Due to the challenges of the tour, visitors will have to be at least 14 years old, and ideally in relative good physical condition. Schiavone also said the availability of the tour is dependent upon the weather, as rain can affect the level of the underground stream. But, for those who take on the challenge, they will be greeted by a number of historical gems left behind. "Elements that Lester Howe added to the cave," said Schiavone. "There's an old boat that was once used. There's an old pipeline he installed to provide water to the [old] hotel."

In all, the tour spans approximately 1,200 feet underground, where it ends as it did in the past, at Signature Rock. People will again be able to read the names of visitors from the past, incredibly preserved despite the elements. "That rock has been subjected to quite a bit of wear and tear," said Schiavone, explaining how the rock is often exposed to underground floodwaters, a potential to erode everything away.

Nevertheless, the experience in and of itself helps tie the people of today to those of yesterday, said the veteran tour guide.

"You get a feel of what those people had to go through," said Schiavone.

What once was lost

Vintage video games continue to provide fun for today's family

eneration X cringed at the news last month as a video of Bo Jackson having to explain his greatness to an unbeknownst teenager went viral.

Jackson, the two-sport professional from the late '80s, was a pop culture icon who transcended sports. Yet, it was painful to watch as he struck up a conversation with Drake LaRoche, the 13-year-old son of Chicago White Sox first baseman Adam LaRoche. Jackson rambled off his impressive resume, but nothing stuck a chord.

The kid obviously never played Tecmo Bowl.

Parents of the Capital District don't seem to make the same mistake as the elder LaRoche, with the advent of a handful of vintage video game stores peppered through the area.

"I find a lot of parents want their kids to play some of the older games," said Ryan Huges, coowner of Jay Street Video Games, a retail chain of stores devoted to the sale of vintage video games and game consoles. "They want them to enjoy and have the same kind of experiences."

In recent years, a market for vintage video games has emerged, partially stoked by Internet sales

through Amazon.com and eBay. Video game chain stores like GameStop have profited from used game sales for years. In 2010, GameStop reported that more than a quarter of their overall sales were of used video game products (26.4%), surpassing new video game hardware (19.3%).

It seems only natural for the trend to trickle down into its own marketing outlet.

"We're not reinventing the wheel," said Hughes. "Here's nostalgia. You used to have fun playing with them. Want to try it again?"

Games on chips housed in plastic cartridges continue to be durable over the years. As are the games from the generations that followed, so long as the CDs aren't scratched. The challenge lies mostly in the hardware, the console and controllers, that played the games. Should you break or lose your game machine from 30 years ago, there is a replacement available. Mad Catz has developed a series of Retrocon consoles that enable gamers to play vintage games from several different systems, on one machine.

"I almost exclusively play NES and SNES games," said 41-year old Delmar native Timothy Pittz."I have both original systems and a slew of cartridges, plus a Wii that serves as an emulator and is loaded with every game for both systems. I have a thing for pixelated sidescrollers.'

Nevertheless, when walking into a vintage video game store, it all comes down to personal taste. Hughes estimates that 90 percent of his customers are "just parents with their kids coming in to play a game."

Games from decades past can't compare to the complexity and aesthetics of those from today, but some continue to remain entertaining. And, when you can buy a game for \$5 versus \$60, the older game could win over the kids without breaking the budget.

"People collect everything," said Hughes. "It's real simple. There's a level of the nostalgia that takes place. There's nostalgia behind remembering cracking open a Nintendo game, sitting with your sister and your brother playing with it. It's just a formula for fun."

Police did well Friday

New days in recent memory can compare to the surreal nature of the events that went down last Friday.

Reporters throughout the Capital District slowly converged on an unseasonably cold April morning - with occasional snowflakes - across the street from a Selkirk home, behind which more than a dozen farm bred bison were loosely corralled by law enforcement officers.

The call for bison in this area was surprising enough. To hear they swam the span of a winter melt pregnant Hudson River out of Schodack near tipped the scales of belief, until the herd emmerged from the woods. One thousand pounds when mature, twice the speed of Usain Bolt when provoked to run, these beautiful animals appeared more stoic than posturing to intimidate anyone.

They posed a threat, nonetheless. For that reason, all of them were shot and killed by their owner shortly after noon.

The spectacle caught the attention of people over the Internet. Eventually, it caught the eye of a nation, with headlines

reaching as far as San Francisco before the end of the day.

Animal sympathizers and online pundits quickly turned on the perceived barbaric behavior of Bethlehem Police, the Albany County Sherriff's office and everyone else involved, with little regard of the facts. The hashtag #bisonlivesmatter became popular throughout all social media. Some took to attacking Albany County Sherriff Craig Apple in particular. All questioned why they did not use tranquilizers.

People are quick to judge, and have placed significant focus on the actions of police agencies in recent months; some of which, justifiably so, while others, completely unfair. Fact is, this situation was loosely controlled despite the best efforts of local police agencies. In addition to managing a 15,000-pound mass of fear and confusion, they concerned themselves over the safety of reporters and curious residents, some of which children, numbering close to 100. The worst case scenario was the herd causing a potential

nightmare accident on the New York State Thruway.

Throughout the morning, police officials expressed killing the animals would be the last course of action. Police are not farm hands. They're not trained to handle cattle. They did, however, show more restraint than what people are giving them credit for, having spent hours on the scene without brandishing their weapons. Once the herd escaped and trekked throughout South Bethlehem, the danger to society escalated. Between the potential of voyeurs being trampled and distracted drivers causing accidents, there should have been more people hurt by their own foolish actions. Thankfully, that did not happen.

Fact is, the owner said tranquilizers would not work. Cornell Cooperative Extension agreed. Experts all said sedation would not work. In the end, the police did not want to pull the trigger. In the end, they didn't. The owner's men ended the day. In the end, no one wanted this.

The police did their jobs, and did it well. For once, leave them alone.

"I had this crazy idea. Why not put the kids in charge of a business and prove to the world that if you give a high-schooler the responsibility to run a company, they could," said Landry.

For a while, the project was just an idea between Landry and Slatcher, with the goal of donating any money raised toward the "Sydney's Spinners" team in the American Diabetes Association's Saratoga Tour de Cure. Sydney Steinhardt is the daughter of a family friend in Guilderland, who was diagnosed with Type 1 diabetes four years ago. Since then, Landry and his own daughter, Alyssa, have been raising funds for Sydney's team in the cycling race.

To expand their idea, they needed more kids to participate. They also needed a recipe with wider appeal than the average bake sale cookie.

Landry said he's always found cooking to be relaxing, and he had a sauce he's made for almost 20 years. He figured it would be easy enough to make in large batches, and wouldn't be too complicated for the students.

"Although I like to cook, I'm not good at all that organization stuff," said Slatcher, who was put in charge of running the kitchen. "We needed help."

That's when Racette joined the team.

"They needed a logistics person, and that's what I do," said Racette, who wants to be a food science major. "I keep everyone organized and make sure all the schedules work."

Eventually, they hit a roadblock turning "Sydney's Cycling Sauces" into a business. So they asked 2015 Student Class President Sam Rogers to join them. He was instrumental in calling the state Department of Health and Department of Agriculture. He also helped determine the business could run as a school organization, with the potential to eventually turn it into a non-profit.

"The thing most people find tedious — and it can be really boring to look at certain aspects of running a business — I find it interesting," said Rogers, who want to major in international relations.

They now have five students who are a part of the business, with some parents and teachers who stop by to help cook. The first batch of sauce was made in January, which resulted in 20 jars being sold. They have since made their sixth batch, which puts the total at more than 200 jars of sauce.

"At the beginning, we wanted to raise \$300 for the Tour de Cure, but now we're at about \$800," said Rogers. "We thought just our family and some teachers would buy it, but it's becoming popular."

No additional sugar is in the sauce, and carrots are used as a natural sweetener, since the group wanted those with diabetes to be able to eat the sauce. So far, they are selling two different sauces — Landry's original meat sauce and a vegetarian version. Other varieties are in development.

Through community outreach, Hannaford Supermarkets has donated a majority of the ingredients. Phillip's Hardware in Delmar has also offered the business shelf space to locally sell their product.

Landry is so committed to the business, he gave up his office to the students. While he has taken over a staff conference room, his old office was transformed into the headquarters of "Sydney's Cycling Sauces." Rogers said he and Racette spend their free periods there working on marketing and shipping orders placed through their website.

"This is not a one-anddone type of project," said Landry. "I want this to continue into future school years."

The three seniors who helped Landry begin the project are now working to recruit underclassmen and train them before the school year is over. Not only would this ensure the business could continue, but it could help ramp-up production. Rogers said another goal was to afford the purchase of a second pressure canner to help the process go faster.

The group has also started a garden in the school's courtyard, so in the future, they can include ingredients they grew themselves.

"This has been an invaluable experience I couldn't have gotten in a classroom," said Racette. "I've learned so many things, from food safety to flavor chemistry."
