



## State Police arrest man for rest area fire

State Police make an arrest following the investigation of a fire on a Thruway rest

State Police arrested Nyri S. Baird, 19, of Guilderland, on Wednesday, Dec 28 for Criminal Mischief in the Third Degree, Arson in the Fifth Degree, Reckless Endangerment in the Second Degree, and Reckless Endangerment of Property.

On November 12, 2022, at about 8:10 p.m. State Police responded to the report of a fire at the Guilderland Travel Plaza on the Thruway in Guilderland. The investigation determined Baird had intentionally set the fire. Baird was working at the McDonald's at the location at the time of the fire.

Baird surrendered himself to SP Guilderland and was processed. He was issued an appearance ticket returnable to the Guilderland Town Court on January 12.

## 'Never unhappy'

Rev. James Daley, longtime priest of St. Thomas church, dies at 95

**DELMAR** — Rev. James D. Daley, the longtime pastor of the Church of Saint Thomas the Apostle who presided over the modernized renovation of its school, died Monday, Dec. 26 at the age of 95.


Daley served the church as pastor for 33 years, from his appointment in 1970 to his retirement in 2002. Before that, he was associate pastor at St. Patrick's parish in Troy and taught at Catholic Central High School. He subsequently taught at Mater Christi Seminary in Albany. He was diocesan vocations director before his appointment to St. Thomas the Apostle parish. In retirement, he assisted Rev. Geoffrey Burke at Our Lady of the Assumption parish in Latham and presided over Mass at St. Joseph's Provincial House.

"I love being a priest," Daley asked The Evangelist readers rhetorically in an editorial published in 2012. "How could I retire?"

Daley had already stepped down from the pulpit at St. Thomas. The shepherd was explaining to readers how he found himself in front of another flock while seeking to help his former associate in Latham.

"This is the priest who married us, baptized and gave First Communion to all our children," said St. Thomas parishioner Nelly Brown Bunk upon learning of Daley's death. She added how he "fought tooth and nail" with her mother, a theologian. "We loved him dearly."

The Elsmere Fire Department shared its condolences online with a message about its "beloved chaplain," who joined the department down the street soon after his appointment at the local church. He would remain there for more than 50 years.

"He was so proud to serve in his role for a department he truly loved."

Daley graduated from Vincentian Institute in Albany. After serving in the Army during WW II and studying at Siena College, he entered Mount Saint Mary's Seminary in Emmitsburg, MD. Ordained in 1954, Father Daley served at Saint Patrick's Troy until 1957. He did graduate studies at Catholic University in Washington from 1957 to 1959 and taught classical languages at the former Mater Christi

Seminary in Albany from 1959 to 1970. In 1970, he became pastor of the Church of Saint Thomas the Apostle, Delmar, where he served until his retirement in 2002.

"I have never been unhappy all these years," he wrote again in The Evangelist in 2019.


Daley was predeceased by sisters, Joan Brennan, Sister Maria Rosario (Regina) Daley, MM, Rose McAuliffe and Veronica Zimmerman; brothersin-law, Charles Brennan, John (Jack) McAuliffe and Harold (Bud) Zimmerman; and a nephew, Michael Brennan.

He is survived by numerous loving nieces, nephews, grandnieces, grandnephews, great-grandnieces and great-grandnephews.

The Rite of Reception of the Body was celebrated in Our Lady of the Assumption Church in Latham on Tuesday, Jan. 3. The funeral liturgy will be celebrated on Wednesday, Jan. 4, at 10 am at Our Lady of the Assumption Church

Interment will be in Our Lady of Angels Cemetery, Colonie. Donations may be made in Father's memory to Albany Diocesan Seminarian Fund, 40 North Main Ave., Albany, NY 12203

In August 2021, Daley was named with other clergy members in a summons of complaint filed in state Supreme Court in Albany County for alleged sexual abuse. Bishop Edward B. Scharfenberger immediately asked the independent Diocesan Review Board to offer advisement. Daley maintained his innocence through a statement released by the Albany Diocese.

She is survived by her husband of 47 years, Lee Dunnells; her children, Kevin (and Tracy) Dunnells, Kelly (and Kristopher) Lenney and Daniel (and Meghan) Dunnells; her grandchildren, Logan, Nicholas, Mackenzie, Jerzee, Dannie, Jacob and Allison; and siblings, Oren Jake (and Robin) Bates and Orvil (and Deborah) Bates. She is also survived by several nieces and nephews.

Services will be private at the convenience of the family.

# GHS students advocate for board resolution educating on secure firearm storage

GUILDERLAND- During the 2021-22 school year, a group of Guilderland High School students attended a board of education meeting to advocate for a resolution that would require the Guilderland Central School District to educate families on the importance of secure firearm storage.

Emily O'Connor, Conor Webb and Nora Whiteside spoke at a board meeting to explain the importance of safe gun storage education. Webb is the president of the Guilderland chapter of March for Our Lives, a national student-led organization founded in the wake of the 2018 shooting at Marjory Stoneman Douglas High School in Parkland, Florida.

The students' appeal to the board was based on recommendations issued by Everytown for Gun Safety, a not-for-profit organization working to end gun violence. The recommendations call for local initiatives such as pediatricians and school districts participating in safe gun storage awareness campaigns. It has been determined that such campaigns do much to save children's lives.

In June, the GCSD board of education passed a resolution that states the district will provide education to families on the safe storage of guns and acknowledges the responsibility of all adult stakeholders at each district school building in keeping students, teachers and staff safe from the threat of gun violence. The GCSD board joins school boards in Vermont, Texas, California, Arizona, South Carolina, Maryland and Georgia that have passed similar resolutions.

Utilizing a flyer included in annual registration materials, the district will inform parents and guardians about secure firearm storage and their legal obligations to protect minors from accessing irresponsibly stored guns. In addition, the district will continue to work with local law enforcement agencies, health agencies and nonprofits to increase community education on this topic.

The GCSD board resolution refers to research that shows an estimated 4.6 million American children live in households with at least one loaded, unlocked firearm and that in incidents of gun violence on school grounds, up to 80 percent of shooters under the age of 18 obtained their guns from their own home, a relative's home or friends.

The resolution also cites research proving that secure firearm storage practices are associated with an up to 85 percent reduction in the risk of unintentional firearm injuries among children and teens. Additional studies have found that 87 percent of children know where their parents' guns are kept and 60 percent have handled them and that addressing students' unauthorized access to guns in the home is a significant step towards intervention.

## Back on the move

Monday, Dec. 19, crews hired by the locomotives' owner, the Danbury Rail Museum, picked up each of the 100-year-old engines and moved them to a staging area. The two locomotives will then be split into pieces and loaded onto flatbed trucks for the journey to Conn.

"It has been a long time coming, but they are moved out of the way," Stan Madyda, a board member of the Danbury Rail Museum, said. "Lots of moving parts had to be in place to make this happen."

The two locomotives are pieces of history like no other in the world of rail transportation. The smaller of the two, the ALCO/GE S-1 was the first all-electric locomotive ever built. It was the prototype built in 1904 for a series of electric locomotives to service rail operations in Manhattan after a series of accidents prompted the NY Legislature to ban steam engines

within the city and its tunnels. The company built 47 of these motors, but this is the first.

The other locomotive, an ALCO/GE T-3a is the only surviving one of its class, which 36 were built between 1913-26. All the others have been scrapped.

Both locomotives were restored in the late 1980's and were showpieces in the train world. They were stored within the PSEG power plant on River Road for years until the company upgraded the plant and needed the room. The locomotives were pushed out onto a rail spur on Beacon Island where they sat exposed to the elements for over 30 years.

The Port of Albany purchased the land, asked for expansion and won a bid to build a offshore wind tower manufacturing plant beginning in 2018. Since then, the port is developing the site and the locomotives were in the way. The other two historic diesel locomotives attached to the two electrics had to be scrapped due to their condition.


The two museum pieces will rest on mats until they can be hoisted onto trucks to be permanently removed from the property, according to Madyda. The process will be completed in the spring.

- S-1 Numbered 100 also numbered 6000 The prototype for third-rail operations in New York City.
- Built and began testing in 1904.
- Only one of its kind.
- S Motors were built 1904-1909 and 47 were built in total. 228.000 lbs.
- T-3a 278 the only surviving engine of its class. All others were scrapped.
- It was built in 1926.
- T motors were built at ALCO/GE from 1913-1926. 36 were built in total. 285,000 lbs.


## **Truck fire at Walmart**







Karli Taylor, a fitness consultant, has made it her work to educate people about eating disorders. Taylor has dealt with her eating disorder since she was a teenager and continues her recovery to this day. Although some of her teachings focus on tips for those struggling with an eating disorder, Taylor does offer education to those who do not.

"In a way, it feels like it's worth it for me to have gone through something if I can use my experience to help people prevent going through something so tough," Taylor said.

The happy times of the holidays are often overshadowed by fear and guilt of food, and body image, size, or weight for those struggling with an eating disorder. The often negative thoughts are amplified this time of year and can even be added to by people who haven't been seen in years. Most of the time, people mean well by their comments about physical appearances, but for a person with an eating disorder, the reception of that comment isn't always considered positive.

For Taylor, there are three tips, or rules, to follow around the holidays to ease triggering thoughts or feelings for people with and without eating disorders. The first is to never comment

about weight, regardless of whether it is a positive comment. The second rule is to not comment on what someone is or isn't eating. The final rule Taylor offers, which is also the hardest, is avoiding making negative comments about your body or eating habits.

"Words matter," Taylor said. "You may mean it as a compliment, but you don't know what goes into that."

As a fitness consultant, Taylor can see how the fitness industry preys on people who may feel insecure about their appearance. It's only gotten worse with the adage of fitness influencers and the accessibility of social media, especially throughout the pandemic. There will always be another product and another influencer to sell it to you.

However, Taylor urges people to remember that what's seen on social media is a highlight reel of someone's life, not their reality. It is easy to pose for a photo a certain way or edit images and videos through software. That person or influencer may not, and probably doesn't, look the same way they do on Instagram as they do in real life most of the time.

"There's no such thing as a quick fix," Taylor said. "We need to break away from thinking we

need to be fixed."

In recent years the #selflove movement has overtaken social media. The idea, in earnest, is to celebrate all bodies regardless of weight, size, or shape. Although that message is a positive one, it's often too much of extreme for those struggling with eating disorders. To go from hating your body for whatever reason to loving it for all it is is a gigantic jump.


Taylor, therefore, pushes for body neutrality rather than the extreme of self-love. To come to a place of calm within your body is far more attainable than the idea of loving it completely. For Taylor, there are three steps to come to full-body neutrality.

"I always talk about the selflove structure," Taylor said, "It starts with self-awareness, then self-acceptance, and then selfappreciation. You have to get through all of those things to get to the 'I love myself' part."

Taylor also suggests pausing before reacting to someone's appearance or comments. Pausing and responding rather than reacting allows for an understanding of what your words mean and the impact they could have on people. In responding rather than reacting, Taylor hopes that everyone becomes kinder to one another.

By spending less time on what you look like or what the numbers are on the scale, Taylor wants people to focus on how they feel. She also wishes that people facing eating disorders would enjoy themselves this time of year without the guilt of food-heavy holidays. All in all, Taylor wishes people take care of themselves.

"Give yourself permission to say no, and the things you have to show up for show up for," Taylor said



## Clearing cookies

Tips to make a computer run more smoothly

omputers play an important role in daily life. Whether it's a handheld device like a s smartphone or tablet or a more traditional tool like a desktop or laptop, computers are ubiquitous and vital to life in the 21st century.

The daily reliance on computers is one reason why slow ones can be so frustrating. No one wants to miss a work deadline or struggle to read or watch a news story online because of a slow computer, but users know that such scenarios play out every day. Thankfully, slow computers are often easily fixed, and these strategies might help users' computers run more smoothly.

- Uninstall apps you don't use. Applications use up memory even if they're not used. Unused apps and other programs also may be updated automatically, leading to computer performance issues that make it hard to do things quickly. Many computers utilize apps that users are unaware of, so it's important that users familiarize themselves with such programs so they don't uninstall anything that is necessary for the computer to operate. Once that research has been done, users can then begin to uninstall apps they don't need or
- Install more memory. Extra memory can go a long way toward helping a computer run more smoothly and with greater efficiency. Online tutorials on sites such as YouTube can instruct individuals

how to install RAM on their laptops or desktops, and this quick and relatively simple step can be great for users who have seen far too much of the dreaded color wheel in recent weeks and months.

- Clear data from your web browser. Another contributor to poor computer performance is a lagging web browser. If websites are taking longer to load, the culprit could be a full cache, which includes files held as information about your internet browsing and viewing habits. Individuals who use the internet a lot but rarely empty their cache are likely dealing with lagging browsers that have nothing to do with their computers. Computers are different, but in general emptying the cache involves going into the settings of a user's go-to browser and choosing an option like "empty cache" or "clear browsing data." If this is what's behind a computer's poor performance, users will notice an immediate improvement upon emptying their cache.
- Turn automatic startup off. Many people may notice multiple programs starting up when they restart their computers. Though some of these might be apps users utilize every day, others might be set to start up the moment the computer comes on, even if they're rarely used. In the latter case, users can adjust the settings on their computers so only those apps they use with great frequency open upon restarting. Users also can improve performance by closing apps and internet tabs once they no longer need them.

A slow computer can be incredibly frustrating. But a few simple strategies can help users improve computer performance so machines can run more smoothly.



Spaghetti with Shrimp, Feta and Dill

#### **INGREDIENTS: Serves 4**

- ounces spaghetti (3/4 box)
- cup plus 1 tablespoon olive oil
- pound peeled and deveined large shrimp Kosher salt and black pepper

- tablespoons fresh lemon juice
- teaspoon grated lemon zest 1
- 3 ounces feta, crumbled (3/4 cup)
- tablespoons coarsely chopped fresh dill


#### **INSTRUCTIONS**

Cook the pasta according to the package directions, drain and return it to the pot.

Meanwhile, heat 1 tablespoon of the oil in a large skillet over medium-high heat. Season the shrimp with 1/2 teaspoon salt and 1/4 teaspoon pepper and cook, tossing occasionally, until opaque throughout, 3 to 4 minutes. Stir in the lemon juice and zest.







# The Jagaloons' "Walk, Don't Run, For The Border" By LUCAS GARRETT

An album that is over before you know it, "Walk, Don't Run, For The Border," by The Jagaloons is, simply put, a fantastic record rife with blistering riffs and pounding energy. The short EP blends together, as is typical for the genre, several musical cultures ranging from the Middle East, to Spain, with the lynchpin being Western-type harmonies.

"Baja Blast," features a lone guitar riff that starts the album, and a tightly played drum roll sound starts pounding in. Soon after, the whole band enters. What follows is an extremely fun tune, chock-full of well-executed pushes and pulls of rhythm.

arranged in such a way that really complement one another; at times it's hard to determine which is the lead and which is the supporting part. What I really like in this song, is how the drums, at certain times, are playing the exact rhythms as one of the guitars – it really helps to tighten up and gel the entire piece together. On top of that, some of the tremolo picking is highly reminiscent of Dick Dale's work and playing style.

"Cinnamon Twist," the second track, begins in a similar fashion; the presence of the keyboard helps to change things up. The two guitar parts are is track three, "Chalupacabra." The phenomenally rich textures of baritone guitars really stick out on this track. Finding that nice register between a bass and standard electric guitar, the baritone part produces such a nice, warm, and fat tone in between. Like the other songs, the drums on this are dynamic and crisp, and support the instrumentation nicely.

Diverting quite a bit from the other tracks, the closing song, "Nacho Boyfriend," features a chord progression, and a much

calmer energy. There're lots of genres that blend together under surf-rock, and this song is a great example of that – a lot of the melodic concepts are Spanish influenced, such as the harmonic minor scale. Between that, and the gentle coaxing of the guitar's whammy bar to create a dreamy atmosphere, this song is the perfect closer on an EP that leaves this listener yearning for more.


So why am I reviewing and still listening to the Super Dark Collective's Halloween compilation "Do the Fright Thing Volume 8"? Because it kicks!

If one were unfamiliar with the deep, vast currents of the American underground, one could easily listen to the "Do the Fright Thing, Vol. 8" compilation and assume it's scary, dark, and weird solely because of the fact that it's a Halloween album. However, anyone that has been paying attention to, or is interested in, the underground music scene (especially that of the Capital District) should hear this record and understand how much more representative, important, and vital it is to define the breadth and depth of the avantgarde in this region.

The album is filled with hardrocking hip-hop beats, overdriven noisy guitars, and plain straight up harsh electronic noise. Vocals are typically loud, angry and even downright vicious. This is a terrific cross-section of the kind of sounds you hear if you go to local small club shows pretty much anywhere in America, but especially upstate New York and the Northeast. So if you are a fan of indigenous, original, non-commercial music, you're going to love this. If you aren't, it's an excellent lesson in where underground music is right now and where it's most likely going in the next 25 years or so.

It begins with an aptly dark and spooky intro by local hip-hop artist Mundy, filled with samples, dark organs, screams, and cries of those that sound like they're about to be tortured. And if that's

And then the comp is kicked into the stratosphere with the almost unbearably terrific "Theme to Howling II" by the long-running power electronic duo ToUGH, made up of local glam punk king Drew Benton (Haunted Cat, Complicated Shirt) and former Trojan Chris Skinner (Denim and Diamonds). This spooky hard-hitting drum machine track walks a comfortable line

between old school Run-D.M.C. style hip hop — including the phenomenal glam thrash guitar attack featured on said — and postmodern noisecore electroclash. And to be blunt, it rocks so hard. It's Queen-like in its eminent superlatives.

The rest of the comp contains so many tracks it's hard to keep up, moving from style to style, hip hop to dark wave, indie rock to thrash punk, everything that the underground has been serving up to local crowds since

the late seventies. Yet throughout there are definite strands of connectivity, most of which is provided by the excellent production work of Shane Sanchez and Paul Coleman, both in the choices of tracks to include, order, transitions, and especially mixing and mastering an album that's both punishingly noisy and eerie enough to serve as any horror movie soundtrack, yet catchy and interesting enough to be listened to quietly in its own right (over and over if you're like me).





Some tracks should be highlighted for various reasons; for example, the excellent collaboration between Jason ('Wolfman') Martin and 100 Psychic Dreams (Shane Sanchez). This is a dream team-up between the lo-fi horror electronics of the Psychic Dreams and the typically self-conscious intellectual rapid-fire lines of Jason Martin, which always include an elusive yet overwhelming sense of humor if you're paying attention. And I'm not just talking about the "performance enhancing sportswear" or "attack Moondog the Protector" lyrics, but how the rant degrades into the echoes of Captain Beefheart's Dropout Boogie with the "adapt her adapt

And then there's the incredible fast thrash of phenomenal local post-hardcore group Wet Specimens that, as always, hits you so hard in the head (and the raised fist) that it's not only terrifying but enervating and inspiring. There are the prescient talents of Aunt Lonely's "Mini Dungeon" that sounds like future hyper video game music. And the juxtaposition of laid-back beats and horrifying stream-of-consciousness lyrics of local hiphop Soo do Koo's "Jackolanterns."

And so much more... where to begin, where to end? We've got tracks from overly prolific constantly performing local

legends like Sinkcharmer, Steve Hammond, and Mr. Cancelled all in a block.... and later on other prolific lo-fi recorders like k. Sonin (whose track "Amber" was unexpectedly loved by everyone other than this writer) and Asa Morris. And of course, there's the omnipresent E.S. Cormac with an excellent lo-fi noise rock track and a performance from new trio Merci Van whose shoegaze stylings he lays down the beats for, Super Dark Collective superstar Christopher Brown featured in four tracks and four different groups on the record (Couples Costume, King of Nothing Nowhere..), up and coming hard partying surf group the Sugar Hold early on the record and bookended by its visionary drummer and soundman, John Olander, later in his guise as avant-garde abstract electronic waves dealer "Art Class Warfare"

One could write several articles alone on all the local greats collected here and still miss so much that the author would be hung in effigy (this writer knows what he thinks is a good deal, but is unfamiliar enough with fully half of the groups on the album). Suffice it to say that in addition to collecting all the great legends, this is an eclectic collection of locals not often associated with the avant-garde noise scene;

like the U2-like Rhoseway, lo-fi folk of Ryan Stewart, the equally lo-fi extra spooky track by the Headless Relatives, the quirky, undeniably catchy pop tune about the Jewish Golem of Prague by Nathan Meltz (House of Tomorrow, Machine Music).

And have I mentioned the track where Scum Couch's Mark O'Brien sings a devastating (and devastatingly catchy — especially that rolling bassline into the chorus!) tune about the escape from the prison at Dannemora backed by a group called Off Hours?

There simply isn't enough time or ink to describe how terrific, eclectic, diverse, inclusive, and yet all somehow of a similar stripe this compilation of tracks is. So the best thing to say is to get yourself a copy! There is literally something here for everyone, and even if you're not particularly interested in some of the music or are intimidated by electronic noise or avant-garde it's a terrific education on the local scene past and present! There are a million reasons to listen to every fine track on this groundbreaking compilation, but only one reason not to. Because you're too FRIGHTENED to. You're not frightened, are you??!!! Then DO THE FRIGHT THING!

# Precious Metals' Debut EP 'Candid Chemicals' By LUCAS GARRETT

Precious Metals released their debut EP "Candid Chemicals" late last year, and what they released is short, but amazingly compelling. If the instrumentation – which has effectively thorough and well-performed arts on each instrument – doesn't grab a listener's ear, the vocals definitely stand a chance to. With sounds reminiscent of early 2000's alternative rock, to 2010's indie rock, and just a splash of pop, Candid Chemicals really packs a punch, and with just five songs!

Starting off the record is "Jacqueline." A blazing guitar interlude serves as the intro, and is soon joined by the full band. J. Lee's vocals are nothing if not unique in terms of tonality and delivery; he has a strong command in his upper register. The song's arrangement is compelling. Prior to the guitar solo, the guitar, bass, and drums have some nice interplay with one another. During the tune's bridge, the vocal is affected nicely with some kind of overdrive effect and it serves well to break up the production aesthetics of

this particular piece. Afterward, we hear a final chorus, short interlude, and then the song's conclusion.

Following is the tune, "Sweet Talkin'." Starting the tune off with a repetitious and chill guitar part allows the listeners a chance to lock into a groove. Before long, the band joins in, sprinkling halftime sections here and there into the mix. This functions as a great way to break up the rhythm and makes the song more interesting – for lack of a better word – to hear and enjoy. The synths in this track aren't obtrusive but rather incorporated in a way that is reminiscent of some great electropop sounds of the early 2000s. The song really explodes just as it ends, with a fantastically written and executed guitar solo.

The third, and title track of the record, "Candid Chemicals," begins yet again with guitar, though this time around the tone is far grittier. Throughout the record, while the bass and drum parts aren't overtly difficult sounding, they're always locked in tight with one another, and this song is no exception. There are times during this song's vocals that are extremely reminiscent to some pop deliveries from Michael Jackson! While certainly not comparing either singer to one another in a strict sense.

the control that White has over his vocals cannot be ignored, and should definitely not be understated.

What's interesting about "Tequila Dreams," track four, is the way in which the vocal and guitar part work with one another. Starting off this piece with guitar and vocals, the two coordinate in such a way that creates a sort of "train rhythm," despite the fact the guitar is mainly playing half notes (for this song, notes that take up two beats of the bar). As the drums enter, this overall train rhythm is further reinforced. All-in-all, the song moves at a great clip and is in many ways a masterclass of how to arrange parts in a way that makes each instrument sound hugely vital to the groove.

Capping the record off is

"Independence Day." This tune begins differently: dreamy synths and keyboard parts. Having different instrumentation introduce a piece was extremely welcomed by this listener's ears. What's more, is how the arpeggiated guitar part is simple but placed very well; it's far more subdued than other guitar parts listeners are greeted with on other tracks of this album. In many ways, the song becomes more and more anthemic as it develops. During the latter half, a refrain is

repeated several times, before the drums crescendo and the song hits its peak. Following this, we hear a brief fade out before one more powerful chorus to close out the song and thus the record.

I really enjoy Candid Chemicals. It works to be powerful in all the right ways, while paying special mind not to go "over the top" with any particular instrument. It's perfectly balanced with groove, skill, and songwriting abilities while never daring to be overtly flashy. In this sense, it's a testament to J. Lee White's maturity as a songwriter and a performer. Fans of alt-rock, indie, and pop should check this record


