McCoy unveils economic development initiatives, investments in renewable energy projects in State of County

SLINGERLANDS — A little more than eight months stand between now and when Daniel McCoy counts his votes for another term as Albany County Executive; nevertheless, the Democrat had both parties in agreement following his 12th State of the County Address on Thursday, Feb. 24.

McCoy held his annual address from inside Plug Power Inc.'s new manufacturing facility. Its placement, within a technology business park starved for technology, was a capstone achievement for the legislator. When it opened just over a month ago, the 350,000-foot hydrogen fuel cell facility made good in offering new jobs and helping push a green movement. Local politicians praised McCoy's efforts from the start.

Bad timing for theives

Suspects steal from Hannaford while detectives are inside investigating

DELMAR - A pair of serial thieves stealing from the Hannaford supermarket on Delaware Avenue got a surprise on Tuesday, Feb. 21 at approximately 8 p.m.

Two Bethlehem police detectives were at the store conducting an investigation into numerous shoplifting thefts that had occurred at that location when they observed a male exit through the produce area of the store without paying for merchandise.

The male, later identified as Robert Shutter, 39, of Albany, entered an occupied vehicle that was already running and being driven by another man, Michael Hoban, 66, of West Sand

According to reports, when one of the detectives

approached the vehicle, it drove away and exited the parking lot. The detective activated the patrol vehicle's emergency lights and siren in an attempt to stop the vehicle but it accelerated to approximately 80 mph down Delaware Avenue. passing cars in the wrong lane, then onto Southern Boulevard, I-787 and I-90 eastbound. The vehicle continued to flee until it crashed in the City of Rensselaer where the suspects were arrested by members of the Bethlehem and Rensselaer Police Departments.

Shutter and Hoban were checked by EMS personnel on the scene, but both refused treatment. An inventory of the car found the stolen items: two containers of Tide pods, several pieces of beef and chicken, two bags of frozen fish, eggs, Snapple iced tea and a frozen pizza. All perishable items were returned to Hannaford. Police also located a

quantity of jewelry that were not consistent with the men.

Upon investigation and police interviews with the two men, police found that Shutter intentionally targeted Hannaford stores due to a small number of staff working at that time and they had an easy exit through the produce door.

In the police report, Shutter said since the fall, he repeated the same procedure at other Hannaford locations including, Wolf Road in Colonie 10-12 times, Central Avenue in Colonie 6-10 times, Delmar 6 times and Latham Farms in Latham only once because he got caught.

Shutter was wanted on three outstanding warrants and a suspended license while Hoban was an active parolee with several felony convictions and did not have a valid license.

The officers charged Shutter with petit larceny



Prepare to say 'bye'

County to clear trees around troubled Slingerlands bridge before it's replaced

SLINGERLANDS — The county will begin work on the anticipated Rail Trail Bridge Replacement project on Monday, March 6.

The county Department of Public Works issued a traffic advisory for local residents, announcing tree removal efforts will require intermittent lane closures along New Scotland Road each weekday between 7 a.m. and 5 p.m.

The initial project will last an estimated three weeks as a temporary Rail Trail pedestrian detour is constructed.

Over the years, the current bridge has weathered the abuse of time and modern-day traffic. Knarled support beams reveal the scars from misguided commercial trucks ignoring signs indicating the span's height of 11 feet, 2 inches. Crumbling cement has led the County to close both sidewalks that run adjacent to New Scotland Road.

The bridge, a 100-year-old relic from the Delaware and Hudson Railroad, has been struck several times in recent years by commercial trucks unable to bypass. It's to be replaced by a new, two-girder bridge. The \$1.9 million span will replace the aging, 42-foot-long structure, while raising it to 15 feet, 6 inches above the roadway to meet state requirements.

The County had obtained the bridge in 2008 despite a report that deemed the metal structure

and surrounding concrete to be in poor condition. The span has since been incorporated into the popular rail trail, used by pedestrians and bicyclists between Voorheesville and Albany.

Two years later, the County was prompted to make temporary repairs following a New York state Department of Transportation report that warned the bridge's "load carrying capacity" was in danger.

Construction on the new bridge was slated to begin in the summer of 2020; however, the outbreak of COVID-19 that spring halted those plans. A lawsuit with Sprint Communication was settled last year, with the County agreeing to cover costs of moving communication lines that

currently run along the bridge.

In 2019, the County estimated that the bridge was struck by nine times over the preceding 11 years. A Queensbury motorist was arrested in 2021 after driving the cement truck he was operating into the bridge. The truck was lodged underneath the bridge for hours, causing the roadway to be closed before the truck could be removed.

The new construction is expected to allow the neighboring Slingerlands Fire District to travel under the bridge, improving response times. The southern sidewalk on New Scotland Road will be removed, allowing for an ADA-compliant sidewalk on the opposite side. The wider roadway should also provide shoulders for cyclists.

A needed break

Town approves property tax exemption for firefighters, ambulance volunteers

DELMAR – The Bethlehem Town Board unanimously approved a property tax exemption for volunteer firefighters and ambulance volunteers at its meeting on Wednesday, Feb. 22.

Town Board members took the unusual step of passing the measure immediately upon closing the public hearing the same night. The Town mostly heard from members of local volunteer fire departments who said the tax break will help efforts to recruit new members.

"We worked hard to pass this tax exemption," said Town Supervisor David VanLuven, "because it will support the brave men and women who give so much to our community as volunteer firefighters and ambulance volunteers."

The exemption will equal 10 percent of the assessed value of the property for qualified volunteer firefighters and volunteer ambulance service personnel.

According to statement released by the Town Board the following day, the Volunteer Firefighters and Ambulance Workers Exemption will have no fiscal impact to the town budget.

Projections by the Town Comptroller indicate that the owner of a home with an assessed value of \$261,000 (the average home value in the Town of Bethlehem in 2022) would see an increase of \$0.80 to their Town of Bethlehem property tax amount.

Applicants for this exemption will need to have two years of certified service and reside in the Town of Bethlehem. The exemption is exclusively for residential purposes, and the property must be the primary residence of the volunteer.

Volunteers with more than 20 years of service may qualify for a lifetime exemption as long as they maintain a primary residence in the Town of Bethlehem.

The goal is to attract more homeowner residents to join and remain in the Town's volunteer emergency services, and to help make home ownership more affordable for younger volunteers who want to remain in Bethlehem.

The urgency behind approving the exemption stems from fast approaching, state-mandated deadline


By approving the tax exemption before the state-set deadline of March 1, the volunteer firefighters and ambulance volunteers can begin getting the benefits in the next tax year. Passing the law after March 1 would have delayed the benefits to the 2025 tax year.

"A lot of upfront work went into carefully crafting this new local law," VanLuven said. "I am so grateful to Jim Potter, Terry Hannigan, Rick Webster, and Tim Hannigan for working quickly and collaboratively to write it."

DELMAR — Each vear the Board of Education election takes place on the date of the budget vote, the third Tuesday of May. This year, on May 16, voters in the Bethlehem Central School District will elect three members of the Board of Education. Members of the Board of Education are elected by the voters of the district to establish policy and direct the administration of schools in the district.

Board members serve volunteer, three-year terms. They receive no salary or other compensation. Those elected this year will each serve terms beginning July 1, 2023 through June 30, 2026. Individuals are eligible for election to the Board if they are qualified voters of the district (district resident, U.S. citizen, 18 and older) and can read and write. New York State Education Law does not limit the number of terms of office a member may serve.

The number of signatures needed on a nominating petition changes from year to year. Petitions require a minimum of 25 signatures or 2 percent of the number

"The Town worked closely with the Albany County Executive's office and Columbia Development to make this project ... possible," said Bethlehem Town Supervisor David VanLuven.

The County Executive outlined investments in mental health and addiction support, renewable energy, infrastructure upgrades and the creation of strategic shovel-ready sites for future development during the afternoon presentation.

'This facility built by Plug Power is a symbol of what can be accomplished in the face of COVID and other adversities when we work together in a partnership as one community, and that is what makes the state of the county strong," he said. "Over the last year, we have seen a transformation in Albany County with a number of projects including the South End Grocery and the offshore wind development in the Ports of Albany and Coeymans – while we also planted the seeds for future growth.

The former Ann Lee Home site that has stood vacant for more than a decade in Colonie will come down as it was announced to be demolished last May. The nearly 38 acres of strategically located land will soon be transformed into a shovel-ready site for a future developer. Redevelopments like this, McCoy said, are driven by the Advance Albany County Alliance.

In order to continue Albany County's economic growth, the County Executive said the local development corporation will be consolidated into one building next to the Capitol, along with the Albany County Industrial Development Agency, the Albany County Capital Resource Corporation and the Albany County Land Bank Corporation. This will create a one-stop-shop for those looking to do business in the county.

McCov also called for the creation of an Arts and Culture Subcommittee within the Advance Albany County Alliance local development corporation, responding to the devastation of the pandemic. The goal of this subcommittee, he said, is to provide a mechanism to



create an essential backstop for this industry to ensure it continues to flourish for generations to come.

"Despite our progress, we are still feeling the lingering impacts of the pandemic, in terms of mental health, workforce challenges and more, McCoy said. "We need to continue to be focused on tackling critical issues like opioid overdoses and teen suicide rates, but we also need to tackle those challenges by utilizing smart analysis and a data-driven approach. For the first time ever, Albany County now has a fellowship program. These individuals are aiding our Departments of Mental Health and Children, Youth and Families to develop a curriculum for coping mechanisms, support

systems and more."

Albany County Legislative Minority Leader Frank A. Mauriello (R,C- Colonie) said he and his party agreed the County was "making good progress" following McCoy's speech.

"Our Republican and Conservative Conference members agree with County Executive Dan McCoy that Albany County is making good progress," he said. "The eight percent property tax rate cut this year was something the Republican and Conservative Conference pushed hard for. The Executive and Legislature are making strides in mental health, sensible green initiatives and economic development. One improvement opportunity would be to get more real data on how

successful we are in moving people from dependency to independence. That should be one of our core missions."

During the State of the County presentation, the new state-of-the-art Data Analytics, Research and Technology Center was unveiled. Investments have been made to transform part of the Shaker Place tower into an innovative technology and data center, which will be instrumental in the development of cutting-edge programs, the execution of county operations and future responses to storm, health and other emergencies.

"I'm also proud to announce that Albany County alone has received \$1.5 million for 2023 from the State Opioid Settlement Board.

We've already received \$1.6 million from other settlements with over \$10 million over the next 16 years from current settlements. The expectation is that other settlements will follow. This funding will bolster our addiction treatment and recovery efforts, with additional funds coming in future years. Furthermore, I'm looking forward to officially releasing our American Rescue Plan funding application process in April. This will allow us to work with the community to heal even more of the wounds caused by the pandemic and continue to move forward," he continued.

McCoy announced several plans he said would fortify the County Climate Resiliency Plan. The State of the County Address included plans for Albany County to fully convert its vehicle fleet from combustion engines to electric within the next five years. The plan is backed by the recent tripling of the electric vehicle fleet with the purchase of four electric Ford F-150 Lightning trucks and eight Chevy Bolt electric utility vehicles.

Two public works department highway garage replacement projects in Coeymans and Knox will exemplify renewable energy and will come equipped with roof-mounted photovoltaic solar arrays.

Registration open for CDPHP Workforce challenge

ALBANY — CDPHP and the Hudson-Mohawk Road Runners Club (HMRRC) are pleased to announce that registration is now open for the CDPHP Workforce Team Challenge, a 3.5-mile road race starting and ending on Madison Avenue in downtown Albany near the Empire State Plaza. This year's race is set for Thursday, May 18, at 6:25 p.m.

The registration fee is \$30 for in-person or virtual participants. HMRRC will be offering a free 90-day membership to all registered participants.

Race organizers invite businesses to start spreading the word to employees about registration. This event is a perfect opportunity to bring remote or hybrid workforces together for some healthy and friendly competition!

Local not-for-profit Trinity Community Center (soon to be renamed Open Table Community Center) in Rotterdam will receive important funds from this year's race. The "three legs" of the open table, all crosscut by a focus on diversity, equity, and inclusion, are food security; mental health and wellbeing; and arts, culture, and self-expression.

Trinity Community Center's Bread of Life Food Pantry currently operates three times per month. With financial support from the 2023 CDPHP Workforce Team Challenge, the pantry will seek to operate weekly as demand has significantly increased because of skyrocketing food prices. While poverty rates in Rotterdam are relatively low, the United Way's 2020 ALICE Report (Asset Limited Income Constrained Employed) indicates 39 percent of residents are below the ALICE threshold and 38.4 percent of children in neighborhood schools receive free/reduced meals.

Teams and individuals are encouraged to make contributions to this important initiative at the time of registration.

The CDPHP Workforce Team Challenge is organized by and serves as a significant fundraiser for the HMRRC. In addition to raising funds for local charities, the race also helps to fund HMRRCs college scholarships, grants, and free race programs for local youth.



More victims and charges for Guilderland man

ALBANY - New York State Police have announced the arrest of Louis Maniscalco, age 40, of Guilderland for two counts of Predatory Sexual Assault Against a Child, an A-Felony, as well as four counts of Rape in the First degree, and four counts of Sexual Abuse in the First degree, both felonies.

Investigators based out of the Latham barracks received multiple tips related to the investigation of Maniscalco after he was arrested on two previous cases and similar charges in the Town of Guilderland.

Maniscalco was first arrested on December 20 for attempted criminal sex act and two counts of attempted sexual abuse. He was sent to Albany County Jail in lieu of \$5,000 cash bail or \$10,000 bond. The publicity surrounding that case prompted multiple other victims to come forward.

On Thursday, Jan. 12, State Police arrested him again after an investigation into claims from at least two more victims in Guilderland. Investigators charge him with predatory sexual assault against a child, two counts of sexual abuse, criminal sex act and attempted criminal criminal sexual act, all felonies. All the additional victims are under the age of 12

The newest charges stem from an investigation determining he had sexual contact with multiple children in the City of Albany.

Maniscalco is still being held on cash bail at the Albany County jail and will be arraigned in the City of Albany Court in the future.

Maniscalco was arrested in December on similar charges and jailed pending bail. Another victim came forward from Guilderland in January and now two victims came forward from Albany.

Coeymans woman arrested on animal cruelty charges COEYMANS -

On Monday, Feb. 13 at approximately 7:30 p.m. members of the Albany County Sheriff's Office and the Town of Coeymans Police Department responded to a residence in the Town of Coeymans for a report of possible animal cruelty.

Upon arrival, deputies were met by the resident, Ellaine Vanetten, 55, of Coeymans, who owned the numerous animals. Vanetten willingly showed the dog in question to the Deputies and the Officer.

At that time, it was discovered that a total of five dogs were living in a shed that was converted into a kennel. All five dogs in the kennel were observed to be malnourished and in need of immediate veterinary care. The kennels were also observed to have been not properly kept, as the dogs were living in their own waste. The dogs were turned over to the Sheriff's Office who, in turn, released them to the Catskill Animal Hospital to provide care for the animals.

Vanetten turned herself in to the Sheriff's Office and was arrested and charged with five counts of Overdriving, Torturing, and Injuring Animals; Failure to Provide Sustenance, a misdemeanor. Vanetten was released on appearance tickets and is due to appear in the Coeymans Town Court on March 16.

Man involved in 2021 burglary arrested on warrant

SELKIRK - Bethlehem police traveled to the Saratoga County jail on Tuesday, Feb. 21 to face burglary charges for a October 2021 incident at the Creekside Docs Motel on River Road.

Jeffrey Boldish, 38, of Troy was found by the staff of the hotel locked in the laundry room and laying on the floor when they arrived for work at 6:30 a.m. Boldish woke up when the staff banged on the door and fled the hotel.

A short time later, Bethlehem police located him walking on River Road and took him into custody. Boldish had an outstanding State Parole warrant and also officers found a stolen driver's license and credit card in his backpack.

He was arraigned at the time and sent to Albany County jail on the warrant, but was released at some point.

She was released back to DOCS under a conditional discharge. She was charged with petit larceny and was given a one-year adjournment in contemplation of dismissal.

Art of Photography

Sacca was responsible in the setup and curation of The Art of Photography. In addition to Sacca, Colonie photographer, Michael A. Panzarino, will be exhibiting 22 other area photographers. Their passion for their craft, the sharing of other creative's work to the public, along with their dedication of assisting a gallery they call home, are the main reasons for having the exhibition.

Art Associates Gallery Inc., located on 21 Railroad Ave in Albany, is a frame shop and art gallery ran by owner, Attila Zalavary. Originally from Budapest, Hungary, Zalavary learned about the art of framing in his home country before moving to New York City in the mid 1960's to work for a large framing manufacturer in New York State. He also worked alongside his father in the

business, J. Zalavary Ltd., where the father and son did work for renowned artists as Salvadore Dali, famous musicians, and actors at their Upper East-Side Manhattan location.

In 1988, Attila and wife, Kinga, moved to Albany and started their framing business and art gallery, Plaza Poster Gallery, inside the Empire State Plaza. The business stayed in the plaza for 14 years until Attila teamed up with Geraldine Walsh, the previous owner of Art Associates Gallery Inc. to help manage the store. Zalavary, now owner,

has managed the store for over 20 plus years.

Art Associates Gallery Inc. remains a hidden gem to discover in Colonie for most artists looking for a location to frame and conserve their art, as well as for displaying and selling purposes. Located at an industrial park in an industrial building, the gallery has monthly exhibition shows, celebrating everything from Women's History Month, Black History Month, groups as the Upstate Artist Guild, and the ever-popular photography exhibition, Dino and Friends. Dino and Friends was the first ever exhibition, let alone, a photography exhibit, to set a record for most visited exhibition on opening day and most viewed exhibit in a month back in January

As with all for-profit small businesses, Art Associates Gallery Inc. wasn't immune to the effects of the pandemic and other additional setbacks. The pandemic caused havoc to the business. The ownership of the building where the business resides changed ownership and the new rent price remains uncertain. Two of three renters pulled out from renting their gallery spaces out at the gallery, and Attila was out of commission in the hospital for six weeks for knee surgery.

In come Panzarino and Sacca to the rescue to help Attila out for an excellent

"I put this together to curate an exhibit for photographers. I am a photographer. I know an awful lot of photographer friends, for the sole purpose to help the gallery out. Covid really wreaked havoc on a lot of small businesses. It got to the point where nobody was coming around. We're way past covid and it's still been struggling, and I wanted to help here. And from a previous exhibit with Dino (Petrocelli), I realized that I could do one much larger in this much new larger space and that was the idea behind it. I'd been running with it ever since. Attila's helped me out with quite a few artist's contacts, as well as mine, and it's put together 24 of some of the area's finest photographers. A lot are well-known, and we hope to make it annual. Next year, we're gonna use the entire space, not just this

room, and will go from 24 to hopefully, 40, which we could easily put in here. It's just to bring recognition, and it is a benefit. Each one of the artists contributed \$50.00 a head to be in here. That was the crux of the whole idea and I think it's gonna be quite the event. When you go from three partners down to just him, the rent is a lot more. It's much more of a burden," said Sacca.

Who's included?

Sacca and Panzarino aren't just the only photographers taking part in *The Art of* Photography. Other featured photographers include Peggy Becker, David Brickman, Natalie Cartz, Linda Conley, Chris DeMarco, Michael Gallitelli, Trish Hennessy, Jay Keebler, Rodney LaPage, Rudy Lu, Fred Neudoerffer, Lance Nevard, Vinnie Otto, Dino Petrocelli, David Ryan, Anthony Salamone, Kemo, Jon Selow, Rick Sheill, Margo Singer, Yan Wang, and Cheri Warren. The Art of Photography will run concurrently with Art by Women of the Capital District, featuring the creative works made by the area's women artists. The exhibition openings will be held March 3, 6 p.m.midnight, and will be on view through March 31.

Sacca and Panzarino are excited for opening night and look forward to meeting the other photographers who will join them on opening night. They're excited to observe patrons coming into the gallery to view their creations. Both photographers have some things they're looking forward to within this special exhibit.

"I'm meeting people that I never knew were here and hopefully that carries on with the stranger that walks into the show and comes in to see all this. We're gonna have a 14-year-old kid who photographs. He makes these figurines, and he photographs them in hand-made landscapes and backgrounds, and he's gonna be coming with Linda (Conley) and I can't wait to see his stuff. That's just a taste of the variety. You're gonna have portrait, landscape, wildlife. Some photographers were in Germany, Africa, and Utah, so you're gonna see all kinds of stuff here and that's a nice slice of what Albany has to offer. Luckily, we have a home for it."

"Hopefully, we'll continue to have a home and that's the purpose of having this show; to bring the money in, to get the artists in here, and to help the gallery out with internal help, and in turn, it's gonna help out the whole area. People want to see it; they want a place to see it. Hopefully, this will be here for Attila in the future so that's my goal. I don't care if I sell a single print. I don't care, just as long as we have a place to hang it," said Sacca.

"I really want people to come in, not just talk to me because you know me, talk to people. A lot of these photographers I don't even know. And I'm gonna love, now, bumping elbows with them for the two days that we're going to be setting up, and then the night of the show, to learn more about them, also. That's why I'm really looking forward to the show. It's going to be just incredible." Added Panzarino.

Sacca hopes to have *The* Art of Photography to be an annual exhibit. He wants to double the number of exhibiting photographers from 24 to 40, and have the exhibit take place in April so that both the small and large gallery spaces of Art Associates Gallery Inc. will be used. If the local business remains open and more patrons discover its existence, more photographers can use the gallery as an exhibition space and Attila can continue his framing work.

"Going back to the last one we had, Attila and Kinga had never seen that many people come to an opening, because they were coming to see the eight artists that were here that time. The photographers all had different stuff. Every section of the wall that you looked at was a totally different genre of photos. And it was so much fun seeing people come up and appreciate your art. It just wants to make you do more. I had friends telling me oh this is good, this is good, this is good, and I appreciate all their input and everything, but when a total stranger comes through and is in awe by one of your photos, it's just incredible what it does for your insides."

In addition, Benton noted, the "Indian costumes, war clubs, head dresses etc. are for the most part based upon exhibits of Iriquois [sic] life in the State Museum at Albany, N.Y." 

uring Lent, many Christians engage in Friday fasts. The fast involves avoiding meat and leads many to fish- and vegetable-based dishes for their Friday meals.

Expanding the possibilities for meat-free meals becomes a priority during Lent. This recipe for "Sea Bass Tacos" from "Judy Joo's Korean Soul Food" (White Lion Publishing) blends the flavors of Korean cooking with Mexican cuisine.

Sea Bass Tacos

INGREDIENTS: Makes 8 tacos

3 3/4 ounces tempura flour

3 3/4 fluid ounces soda water

ounces sea bass fillets, skin removed, deboned and cut into 3/4- x 11/2-inch strips Vegetable oil for frying Sea salt

Kimchi salsa

31/2 ounces cabbage kimchi, chopped into 1/4-inch pieces

ounce tomato, diced into 1/4-inch pieces

ounces pickled jalapeños, diced into 1/4-inch pieces 3/4

Slaw

4 teaspoons yuzu juice

3 tablespoons Kewpie mayonnaise

red onion, thinly sliced 1/2

1/2 cucumber, deseeded and julienned

1/2 Asian pear, peeled and julienned

To serve

- 8 taco shells (5 inches in diameter)
- 8 teaspoons sour cream
- small tomato, finely diced Baby coriander (cilantro)

INSTRUCTIONS

First, make the kimchi salsa. In a medium bowl, toss together the kimchi, tomato and jalapeños until evenly mixed, then set aside.

Next, to make the slaw, whisk the yuzu juice and mayonnaise together in a medium bowl. Stir in the red onion, cucumber and pear. Cover and leave in the fridge.

Half fill a heavy-based saucepan with oil and heat to

Make the tempura batter just before frying. In a bowl, whisk together the tempura flour and soda water, making sure to keep it lumpy.

Salt the sea bass on both sides. Working in batches, dip the fish into the tempura batter, and fry for about 3 to 4 minutes, until the batter is golden brown and the fish is cooked. Place on a rack to drain off any excess oil and keep warm while you cook the rest.

Heat the taco shells according to the packet instructions.

Line the shells up on a plate and add a piece of the fish to each one. Top with the slaw and then the salsa. Garnish with a dollop of sour cream, diced tomato and baby coriander.

Steps to avoid feeding the dragon

Study shows opioid prescriptions rarely needed after urologic cancer surgery

ALBANY — A study by Albany Medical Center urologists, published in JAMA Surgery, concluded patients who had major abdominal or pelvic surgery rarely needed prescription opioid medications to control their pain after they were discharged from the hospital. Further, no adverse effects were seen regarding complications or recovery in patients who did not take opioid pain medications after their surgery.

"These results are exciting as they indicate we can essentially eliminate opioid prescriptions after urologic cancer surgery, which is important not only *Nearly ninety-eight* percent of patients in the NOPIOIDS group did not require an opioid medication for their pain... for an individual patient's recovery, but also for reducing excessive opioids and potential misuse in the community," said Badar M. Mian, MD, professor in the Department of Urology at Albany Medical Center and the lead author of the study.

Conducted between May 2017 and June 2021, the study included more than 650 Albany Medical

Center patients who had an open (traditional) or minimally invasive radical cystectomy for bladder cancer, a radical or partial nephrectomy for kidney cancer, or a radical prostatectomy for prostate cancer.

Patients were divided into three groups: a control group who were prescribed opioids at discharge, a lead-in group who were prescribed opioid medications with reduced dose, and the "NOPIOIDS" group who were not prescribed opioid medication following their discharge from the hospital. Patients in the NOPIOIDS group were given detailed instructions on when to take two over-thecounter pain medications, acetaminophen and ibuprofen, in place of any opioid medication.

Nearly ninety-eight percent of patients in the NOPIOIDS group did not require an opioid medication for their pain; those who did had all undergone kidney surgery and were not able to use drugs like ibuprofen due to concerns about kidney function. Further, less than three percent of patients in the NOPIOIDS group called the clinic with pain-related issues. The group also saw no increase in complications that could result from inadequate pain control and limited mobility, such as pneumonia, deep venous thrombosis, pulmonary embolism, or readmission.

"Use of opioid medications for pain control causes side effects such as nausea, constipation, sleepiness, and confusion which can

further slow the recovery," said Dr. Mian. "All patients should expect adequate pain control to allow them to function after surgery. This study shows that pain control and recovery don't have to be compromised if we emphasize presurgical patient education about opioid alternatives, and instruct the physicians to employ a number of readily available nonopioid measures to control pain and maintain normal function."

The full study, "Implementation and Assessment of No Opioid Prescription Strategy at Discharge After Major Urologic Cancer Surgery," is available on the JAMA



CONCERT REVIEW

Czech National Symphony Orchestra at Troy Savings Bank **Music Hall**

TROY - Ever think you know a piece of music, but then you hear a performance of it that brings new sensations, ideas, and feelings, that shows you new detail and dynamics?

That's what the Troy Savings Bank Music Hall was designed for and still manages to do wonderfully well as two classics of symphonic music's Romantic Period proved on Saturday in the hands of the Czech National Symphony Orchestra.

Before the Brahms and Beethoven main events, the

orchestra offered a spirited appetizer. In the bristling finale of Antonin Dvorak's Czech Suite, conductor Steven Mercurio literally jumped above the podium (as Beethoven was said to do when he conducted). Mercurio's aggressive physical style energized this brief dance-y, robust, sunny series of melodic episodes whose variety showed the ensemble cohesive and powerful from the first downbeat.

Next, violinist Robert McDuffie starred in the Violin Concerto of Johannes Brahms, composed in 1878, three years before the Hall opened. Both the Brahms and the Beethoven (composed in 1812) called for identical instrumentation: two each of flutes, oboes, clarinets, bassoons, horns, and trumpets, plus timpani and strings. In other words, the ensemble was rightsized to the Hall's sloping stage

- which cowboy-booted Asleep at the Wheel singer Ray Benson once joked might send him skidding off into the audience. But I digress.

Both the Brahms and the Beethoven were praised and reviled in their times, too. Of the three-movement Brahms quick, slow, quick – conductor Hans von Bulow complained it was "written not for the violin but against it" while Henryk Wienlawski called it "unplayable." Soloist McDuffie would quickly disprove this; but when Brahms composed it, he and others were pushing aside the concerto convention of the time, promoting the soloist to a nearly equal footing with the orchestra. The program described this as matching "tender, lyric violin and the robust orchestra." However, just as McDuffie's physically vigorous performing

matched Mercurio's, the violin soloist held his own in both the fast movements that bookended the adagio with muscular, emotive projection and a caressing sweetness in the adagio

At speed, McDuffie dazzled, precise even in blinding-fast runs; in slow passages, he charmed, but with a mature beauty far from the merely pretty. He knew what the music was saying, and he told us.

The concerto's Allegro non troppo first movement contrasted a sedate orchestral opening with McDuffie's forceful attack, accentuated with foot-stamping and grimaces like those of Itzhak Perlman, or like guitarist John Mayer on a rock stage. For all its athletic energy, the Allegro also featured a high, soft solo violin passage that made the Hall sing. As the movement ended after

an emphatic build-up, applause rang out and a fan called "Thank you!" Both audience expressions are breaches of classical concert hall protocol, but both were also earned.

While the oboe introduced the Adagio, McDuffie reclaimed it confidently, an elegant poetic serenade that ended in a conversation between the soloist and woodwinds.

McDuffie seemed energized by the applause that followed, smiling in fierce happiness as he and the orchestra conversed in the complex dialogs of the closing Allegro giocoso, ma non troppo vivace. This finale included a propulsive march and exuberant cascades of bold unison playing.

Big-time standing ovation.


