Draining and maintaining

Felony DWI and Leandra's Law

Man had no license, 3 DWI convictions, with a child in car

GLENMONT - Bethlehem police arrested an Albany man on three felony charges on Route 9W after reports say he was driving with no lights Tuesday, April 11 at approximately 9:36 p.m.

Officers stopped the black 2019 Ford and identified the driver as Kenjuan Green, 42, of Albany and that he had a dog and child in the back seat.

He was identified by his State ID and the officer observed Green to have bloodshot and watery eyes and a strong odor of an alcoholic beverage emanating from his breath.

He was given and failed field sobriety tests and tested positive for breath alcohol on a pre-screening device. At the police station he refused to provide a breath sample.

An investigation showed Green had three prior DWI convictions in the past 15 years and the child in the car was under 16 years old.

He was charged with felony DWI, felony aggravated DWI - child passenger and felony aggravated unlicensed operation. Additionally he was charged with two counts of misdemeanor aggravated unlicensed operation and acting in a manner to injure a child. Green was also ticketed for multiple traffic violations.

Green was arraigned by Bethlehem Judge Ryan Donovan and sent to the Albany County jail due to prior felony convictions.

Police also contacted Albany County Child Protective Services.

Third time for 2020 DWI

DELMAR - An Albany man was arrested on Tuesday, April 18

after he was brought to Bethlehem Town Court by Albany County Sheriff's Office on a bench warrant from the Court.

Jose Guaman-Bunay, 30, of Albany, was at the Albany County jail for another reason and found to have the warrant stemming from not showing up for court on a 2020 incident on Delaware Avenue.

This is the second bench warrant for Guaman-Bunay. He was arrested in May 2022 by Glenville police. At that time Guaman-Bunay was arraigned by Bethlehem Judge Andrew Kirby and released under the supervision of Albany County probation. He did not show up for his court date in June 2022 and another warrant was issued by the court.

The original arrest was on December 7, 2020 for DWI, unlicensed

Same Crime, Fifth Time

V'Ville man arrested again for 2019 Five Guys burglary

DELMAR - A Voorheesville man was arrested for a fifth time for the same 2019 burglary at a Five Guys restaurant in Glenmont because he has not shown up for court again.

Robert Tracy, 43, was arrested and charged with burglary, a felony, and conspiracy, possession of burglar tools and petit larceny, all misdemeanors, on July 20, 2020 after a year-long investigation. He was sent to Albany County Jail, but Bethlehem Town Justice Andrew Kirby signed a bench warrant for Tracy on Sept. 8, 2021, after he did not return to court.

Albany police arrested him on Jan. 6, 2022, on that warrant. Tracy was arraigned by Justice

Ryan Donovan and was scheduled back on Tuesday, Jan 18, 2022. He was then released to State Police on another warrant. He was released after being processed on the State Police warrant.

Then on Friday, April 15, 2022, he was turned over by Colonie police on another Bethlehem bench warrant for failing to show up in January. This time, he was remanded to the Albany County Jail to await a hearing on Tuesday, April 19, 2022.

According to the Bethlehem Town Court, he appeared at that hearing and was sent back to the Albany County Jail to await a Tuesday, May 17 2022, court return date, but somehow he was released and did not show up again.

On Saturday, April 15, Albany police arrested Tracy on another Bethlehem warrant. He was arraigned again in Bethlehem Town Court and sent to the Albany County Jail. He was back

in court on Wednesday, April 18 according to the Bethlehem Justice Court.

Actually it is more Bethlehem police also have interacted with Tracy in at least one other incident. In May of 2021, Tracy was identified by loss-prevention employees at Price Chopper in Slingerlands as trying to carry unpaid items past the point of sale.

According to reports, the responding officer made contact with Tracy before he passed the point of sale, but was in possession of the goods. Price Chopper recovered the goods and Tracy was not charged in the incident after signing a trespass warrant banning him from the store, but the driver of the vehicle that was waiting for him was arrested.

Lisa Sullivan, 39, who is homeless, was driving a 2006 Chevy Tahoe that was reported as a file one, unauthorized use by State Police in Princetown. That

designation is used when someone rents a vehicle and does not return it. Sullivan was charged with misdemeanor use of a vehicle with no consent. When the officers were searching the vehicle before it was towed, they found a large quantity of used needles with drug residue, a glass pipe with crack cocaine residue, and four jars containing heroin residue. She was also charged with criminal possession of a controlled substance.

Sullivan was given an appearance ticket for the charges, but never showed up for court on June 1, 2021. Tracy was detained and turned over to State Police on an outstanding warrant for them.

Sullivan was arrested on April 15 by Albany police at the same time they arrested Tracy. She was arraigned by Bethlehem Town Judge Ryan Donovan and released. She is scheduled to return to the Court on May 2.

The Kenwood Avenue water tower, located at 308 Kenwood Ave., was drained in December due to a leak. Before taking the tank offline, town public works officials applied for grant funding to get a new tank, but the funding was denied.

"We're in the process now of trying to secure grant funding to help us pay to replace it with a new tank so we don't put all the costs on the rate payers and the customers in town," Bethlehem Commissioner of Public Works George Kansas said.

The Elm Avenue tank, located at 504 Elm Ave., has been drained for overall maintenance. Crews are currently removing cellular equipment from the face and top of the tank so it can be resurfaced and painted. The tank will be repainted inside and out, and a mixer will be added.

The mixer will be used to mix chlorine into the water constantly. The chlorine is added to the water to safely store and transport it, as well as reduce bacteria and pathogens. It also will give the water the taste that most people are used to.

"The painting is long overdue, but the mixing is a good improvement as well to add to the project," Kansas said.

With both towers offline, Bethlehem public works sent a letter in early April to the volunteer fire departments asking for their cooperation.

The letter asks that the fire departments limit the amount of water being used during training. This request also asks them to refrain from using the larger hoses and multiple hydrants if possible. This request does not apply to fighting active fires.

"They asked us to refrain from using LDH (Large Diameter Hoses) for training purposes until later in the year," Elsmere Fire Chief Marc Futia said. "We can still train, and the most important part of that training is for our firefighters to handle the larger hoses. Compared to regular inch-and-three-quarter hoses, it is like moving a whole couch versus a single chair."

The chiefs said that the central part of the training for town departments, however, will still take place.

"We can still train on our tower and we can still put out fires," said Delmar Fire Chief Dan Ryan, referring to the Kevin M. Shea Training Center on Center Lane in Glenmont.

The site provides a facility where the town's firefighters train on a weekly basis.

The training center features a tower that simulates fighting an interior structure fire. The chiefs say that training is crucial to success in knocking down fires in a quick attack.

The water system has yet to see any decrease or dip in water delivery to residents. However, the request to the volunteer fire department is to prevent any such dip from happening.

Public works anticipate the maintenance of the Elm Street tower to be complete by fall. In the meantime, the town will be pulling water from a six million-gallon storage tank in New Scotland. Water will also be supplemented by an agreement made with the City of Albany to provide Bethlehem 1.3 million gallons of water per day, but the

town can use up to 2 million.

"Our system is handling [the needs of fighting fires] OK," Kansas said. "We are not anticipating any restrictions against our residents."

Although public works has asked for the volunteer fire department's cooperation, there are no restrictions for residents. The system has upheld residents' demands and the department is confident it will continue to do so. With spring here and summer approaching, public works officials are assuring residents that their water usage will not be an issue.

All in all, Bethlehem public works is hopeful of the progression of the maintenance project on Elm Street. They are also confident in the water system that it will meet the demands of residents while the tanks remain offline.

"Our system hasn't missed a beat," Kansas said.

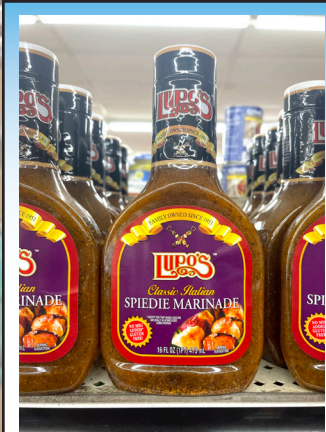

operation, drinking in a motor vehicle and parking on a highway.

On the most recent arrest, he was arraigned and released back to the sheriff's department.

Slingerlands man charged with more child porn

SLINGERLANDS - On Wednesday, April 18, State Police arrested Andrew Pegler, 35, of Slingerlands, on a warrant for ten additional counts of Possessing a Sexual Performance by a Child, a felony. The Superior Court Warrant was issued on April 7 as a result of an indictment.

Pegler was arrested at the Bethlehem Town Court and transported to SP Latham for processing. He was then sent to the Albany County jail.

He was originally charged with possessing and promoting images consistent with child sexual exploitation via the internet in July, then charged with possessing stolen items from his neighbors, including items used to perpetrate the online crimes.

State Police arrested and charged Pegler on an additional charge of criminal possession of stolen property, a misdemeanor, on Tuesday, Aug. 30. An investigation by Bethlehem police revealed the thefts of items from various neighbors including: a Lenovo laptop, a passport, a driver's license, wallet, multiple thumb drives and external storage devices, a laptop bag, and multiple pieces of women's underwear. Details of that investigation and the items were turned over to State Police.

Pegler was charged on July 21 with possession of

a sexual performance by a child and promoting a sexual performance by a child, both felonies, and obstructing governmental administration and resisting arrest, both misdemeanors.

His arrest followed an investigation stemming from a cyber tip received by the New York State Internet Crimes Against Children Task Force and the execution of a search warrant at his residence.

Albany Med Offering New Targeted Therapy for Brain Tumors

ALBANY – An Albany Med Health System neurosurgeon is the first in the region to offer GammaTile Therapy, a novel approach to treating brain tumors. "With GammaTile, patients begin receiving radiation immediately following placement and continue to receive treatment as they go about their daily lives, thereby decreasing the burdens of repeated appointments and improving the quality of both the patient's and the caregiver's lives," said Dr. Farhangi.

More than 200,000 patients are diagnosed with an aggressive brain tumor in the U.S. each year. Aggressive brain tumors tend to be resistant to standard treatments and have a high likelihood of recurrence. 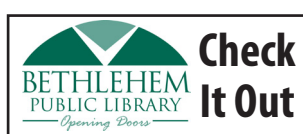

Associates with Envision Architects, Creighton Manning Engineering, CT Male Associates, CSArch, Hyman Hayes Associates, kW Mission Critical Engineering, Labella, MJ Engineering & Surveying, Mosaic Associates, Ryan Biggs Clark Davis Engineering & Surveying, and Stantec. An additional structure will be part of the exhibit and will be constructed by Girl Scouts from the Girl Scouts of Northeastern New York in support of Girls CAN Do, an annual program the scouts participate in that encourages not only STEM but service to their community. All “building

materials” used in the displays were purchased from Price Chopper/Market 32, the presenting sponsor, and will be donated to The Food Pantries for the Capital District, a coalition of more than 65 food pantries in Albany, Rensselaer,

Saratoga, and Schenectady Counties, at the end of Canstruction.

Visitors are encouraged to bring canned goods (tuna, beans, canned vegetables, soups/chilis, and fruit) to Crossgates Mall and participate in the Canstruction competition and food drive. Visitors can use their canned goods as ballots to vote for the winner of the People’s Choice award. A jury of designers, local business owners, and local dignitaries will also judge the structures. Awards include Best Original Design, Best Meal, Best Use of Labels, and Structural Ingenuity. Additional awards include Largest Cash Donation and Best Signage. Along with juried prizes, a People’s Choice Award will be bestowed on the structure that gains the most votes (most food donations) from visitors.

Music moves through Albany

Festival highlights a diverse mix of performers and celebrates the local music scene

ALBANY — The MOVE Music Festival returns to Albany on Saturday, April 29. Beginning at noon, the festival will journey through the city as a celebration of local artists and music.

“We’re excited to be back,” said Ed Peters, who is the new owner of the MOVE Festival.

Regarding the festival’s three-year break during the COVID-19 pandemic, Peters said, “We feel like everybody has really been excited to have live music back.”

The festival will feature 12 continuous hours of music, with one show at the beginning, one show at the end and numerous solo performers in between.

From noon to 3 p.m. at The Fuze Box, the bands Black Belt Jones, Ike’s Wasted World, The Frozen Heads, and

Trebled Youth will start off the festival.

From 3 p.m. to 7 p.m., the event will travel down Madison Avenue and Lark Street on a musical journey that involves the whole community and businesses along the way.

“With this festival, we have a wide range of artists,” said Lo Baboulis, assistant to Peters. “We have a thrash metal band playing at the Fuze Box, but we also have an acoustic singer-songwriter at Ben & Jerry’s, a pop artist at Savoy, and hip-hop at Pint-Sized.”

During the Move Down Madison and Lark, Kyla Silk will be performing at Capital Wine, Bebhinn McDermott at Ben & Jerry’s, Niki Kaos at Alacrity, Tim Candlen at the Lark Street Tavern, Ryan Leddick at the Local 217 Tap Room and Kitchen, and JB aka Dirty Moses at Pint-Sized.

“There is something for everyone,” said Baboulis. “We were focused on that because we want to bring people together.”

Local businesses are showing their support for the event by finding creative ways to celebrate the talent that will be performing. Madeline Hogan will perform at Fresh ‘n Pressed from 3-3:45 p.m., and there will be an exclusive drink to honor her performance.

The event features a carefully curated lineup, including Eddie Award-nominated Sydney Worthley, who will perform at the Savoy Taproom from 5:30-6:15 p.m.

After the Move Down Madison and Lark, the showcase performance runs from 8 p.m. to midnight. at Lark Hall. Listen Up Award-winners Seize



Atlantis will be at the Lark Hall, along with Embe Esti and The Sugar Hold.

“It’s 12 hours of music,” said Baboulis. “That was our goal.”

The MOVE Music Festival is made possible by sponsors including Radio Radio X, Albany Distilling Co., Everyday Art, Imprint Universe, Lark Street Business Improvement District

(BID), and Gabriella Romero.

“It’s a group effort with a lot of people coming together,” said Peters. “This is about the community pooling our resources together.”

Time to think about a healthy summer

Tips to help

Colds might not be as common in summer as they are in winter, but anyone who has ever had a cold when the weather outside is warm and inviting knows just

“Everything in the park will be about the 75th anniversary,” said Keith Morales, special events coordinator for the City of Albany Office of Cultural Affairs.

The festival, which takes place over Mother’s Day weekend, Saturday and Sunday, May 13 and 14, promises to have something for everyone to enjoy.

“We have a large mix of vendors,” said Morales.

“About 40 plus food vendors, more than 80 craft vendors, over 15 to 20 art vendors, and about 20 to 30 public information vendors that are nonprofits and organizations promoting different causes.”

Headlining musical events on the main stage are American Authors, Eastbound Jesus, The Age, Karina Rykman, Precious Metals and Guster.

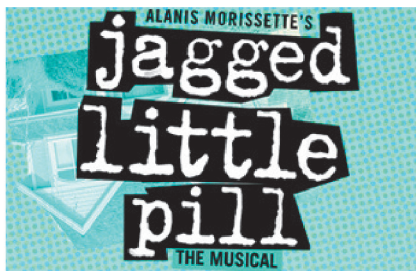

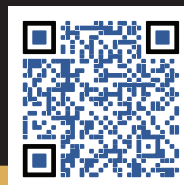

a sun-protection factor (SPF) of 15 or higher before going outside. Sunscreen should then be reapplied as necessary and especially after swimming or excessive sweating. The American Cancer Society notes that sunburn that blisters can increase risk for skin cancer, but sunburns

Celebrate Cinco de Mayo with a quintessential Mexican dish

Cinco de Mayo is a festive occasion that celebrates Mexican culture and food. Cinco de Mayo commemorates a minor Mexican victory over France that took place on May 5, 1862 at the Battle of Puebla. While it has never been a big deal in Mexico — especially in comparison to celebrations of Mexico's independence — Cinco de Mayo has become a festive phenomenon north of the border.

When it comes to food and beverage, many people see Cinco de Mayo as an excuse to indulge in a few margaritas and dine on tacos. Those who prefer more authentic fare may want to explore further. Pork loin is a quintessential Mexican dish. It can be prepared in many ways with rich spices. This recipe for "Stuffed Loin of Pork" from "The Complete Mexican, South American & Caribbean Cookbook" (Metro Books) by Jane Milton, Jenni Fleetwood and Marina Filippelli, is stuffed with a

ground pork mixture to make it even more savory.

Stuffed Loin of Pork (Serves 6)

3 to 3 1/2 pounds boneless pork loin, butterflied and ready for stuffing

For the stuffing

- 1/3 cup raisins
- 1/2 cup dry white wine
- 1 tablespoon vegetable oil
- 1 onion, sliced
- 2 garlic cloves, crushed
- 1/2 teaspoon ground cloves
- 1/2 teaspoon ground cinnamon
- 1 1/4 pounds ground pork
- 2/3 cup vegetable stock
- 2 tomatoes
- 1/2 cup chopped almonds
- 1/2 teaspoon each salt and ground black pepper

1. Make the stuffing. Put the raisins and wine in a bowl. Set aside. Heat the oil in a large pan, add the onion and garlic, and

cook for 5 minutes over low heat.

2. Add the cloves and cinnamon, then the pork. Cook, stirring, until the pork has browned. Add the stock. Simmer, stirring frequently, for 20 minutes.

3. While the pork is simmering, peel the tomatoes. Cut a cross in the bottom of each tomato, then put them both in a heatproof bowl. Pour in boiling water to cover. Leave the tomatoes in this water for 3 minutes, then lift them out on a slotted spoon and plunge them into a bowl of cold water. Drain. The skins will have begun to peel back from the crosses.

4. Remove the skins completely, then chop the flesh.

5. Stir the tomatoes and almonds into the pork mixture, add the raisins and wine. Cook until the mixture is reduced to a



thick sauce. Let cool.

6. Preheat the oven to 350 F. Open out the pork loin and trim it neatly. Season the pork stuffing with salt and pepper to taste. Spread on the surface of the meat in a neat layer, taking it right to the edges and keeping it as even as possible.

7. Roll up the pork loin carefully and tie it at intervals with kitchen string. Weigh the pork and calculate the cooking time at 30 minutes per pound, plus another 30 minutes.

8. Put the stuffed pork loin in a roasting pan, season with salt and pepper, and roast for the calculated time. When the loin is cooked, transfer it to a meat platter, place a tent of aluminum foil over it, and let it stand for 10 minutes before carving and serving with the roasted vegetables of your choice.
