DIVERSIONARY JUSTICE SERIES: Part Two

Beyond Drug Court

U-CAN, Bethlehem treatment court, Albany County mental health court



ALBANY - Although diversion programs first began as an alternative to incarceration based on what some call restorative justice, these programs now vary beyond drug courts. By offering individuals an off-ramp to the traditional criminal justice system, their main focus is on helping people become more positive forces in society through long-term treatment.

"The purpose of diversion and these problem-solving courts is to not only make the person whole but to teach the person how to stay whole for the rest of the person's life," said Albany County Public Defender Melissa Aiezza-Carpinello, who works with Albany County Drug Court. "You're giving people a whole second chance at the life they really want."

Although Albany County Drug Court is the largest of these programs in the area, it is by no means the only one available. Problem-solving courts have expanded since its inception to address issues beyond substance use disorders, offering treatment for mental health concerns, fostering mentor relationships, and taking on restoration at even the local level. three of these programs: Judge Andra Ackerman's youth diversion program U-CAN, Bethlehem's own treatment court run by town Judge Ryan Donovan, and Albany County's mental health court.

U-CAN

On Friday, July 14, Ackerman convened her court in Albany County to officially change the course of one young man's life. By reducing his charge for criminal possession of a weapon to a misdemeanor, she and the rest of her team brought his participation in a year-long youth diversion program known as U-CAN to a close. Their work will stay with this man for the rest of his life, who is now without what Ackerman calls the "concrete necklace" of a felony conviction.

U-CAN is an entirely volunteer-based diversion program that was started by Ackerman and Senior Advisor for Strategic Communications at the NYS Unified Court System John Caher in 2017. The program was propelled by a troubling trend Ackerman saw in her court: a train of young and often unsupported kids, many of whom seemed to be on an inevitable path to state prison.

"Judge Ackerman thought maybe there was a better alternative for some of these people, and that alternative is U-CAN," Caher said.

U-CAN offers young people an off-ramp to the traditional criminal justice system by pairing them with community mentors for a year. During that time, participants are placed on interim probation and must meet regularly with their mentor, maintain a job, make an effort to obtain their GED if necessary, undergo drug and alcohol testing, and comply with any other condition that Albany County Probation Officer Melissa Bulger deems appropriate. They

must also appear before Ackerman once every month for an update and evaluation. Upon successful completion of the program, most participants are offered a misdemeanor plea.

"U-CAN is very much a tough love program," Caher said. "The judge demands accountability. Every transgression will be met with a consequence."

According to those involved in the program, community mentorship is central to U-CAN's success.

"When I was going through hard times, I could always count on my mentor being there for me," one former participant said. "I could actually trust her."

"Most of our mentors, after they finish the year, sign up to do it again," Caher said, adding that both he and Ackerman have served as mentors themselves.

Participants in U-CAN are typically young, have no significant priors, and no known gang affiliation.

The program does not accept individuals who are active shooters. In order for a case to be admitted into Albany County Court, the district attorney, defense counsel, Albany County Probation, U-CAN team, and Ackerman must all offer their consent.

Many of the cases that Ackerman sees in Albany County involve criminal possession of a weapon (CPW), according to Caher. He added that U-CAN now operates in Albany Family Court, Erie County, Schenectady City Court, Schenectady Family Court, Syracuse City Court, and Binghamton City Court as well.

"U-CAN was never created to take on gun cases, and frankly when we started, I never imagined that we would allow into the program someone charged with criminal possession of a weapon," Ackerman said. "We took a few of those cases ... and because nearly all of the young men and women that were offered this chance did great, the portunity was offered to

chance did great, the opportunity was offered to others."

Given the recent uptick of gun violence in Albany County, how Ackerman's court will handle a select subsection of CPW cases qualifying for U-CAN is set to change slightly. Moving forward, these individuals will be required to spend a longer amount of time on probation after completion of the year-long program in Albany County. This change only concerns select CPW cases and should not impact U-CAN's ability

to reduce felony charges to misdemeanors. It went into effect directly after Ackerman's most recent session on July 14.

According to Caher, U-CAN has seen incredible success in just a few years and is still looking to expand its reach across the state. He added that programs should be up and running in Ithaca City Court and possibly Tompkins County Court soon.

"It bothers me that I know there are many young people out there who would benefit from the program and who would succeed in the program that are sitting in state prison because that option was not available to them," Caher said. "That should not be."

There is no understating the ability of U-CAN to redirect the courses of some young people's lives.

"U-CAN literally changed my life," one former participant said. "When I first went to jail, I was lost and I had nowhere to go, no good support system and what you did

Slingerlands man charged in fatal crash

Head-on collision took the life of Colonie senior

DELMAR -Bethlehem police charged a 71-year-old Slingerlands man for causing the death of 17-year-old Michael Kleinke Jr. after a horrific Route 85 crash on May 11 and driving

On Tuesday, July 25, detectives charged Thomas F. McGrath with manslaughter and aggravated vehicular homicide, both felonies, and DWAI-Drugs and reckless driving, both misdemeanors. He was also ticketed for failure to keep right and moving from a lane unsafely.

McGrath turned himself in at the police station, was processed and arraigned in Bethlehem Town Court by Judge Andrew Kirby at \$75,000 bond or \$50,000 cash. McGrath did post a bond and was released under the supervision of Albany County Probation and his driver's license was suspended pending prosecution. A return date was set for August 15.

The fatal accident took place just south of the thruway overpass in the Town of Bethlehem at approximately 2:08 p.m.

According to reports, a Mercedes driven by McGrath and a Ford Mustang driven by Kleinke collided nearly head on.

Calls to 911 went to both the City of Albany and Bethlehem and both municipalities sent first responders due to its location near the City line.

First responders began patient assessment on the occupants of both

vehicles, performed vehicle stabilization, and began the extrication process as it had been determined there was heavy entrapment of Kleinke in Mustang, but both drivers had to be extricated.

McGrath was freed by firefighters by prying open the Mercedes door, but the Mustang was a much larger problem, according to reports. It took approximately

an hour to remove Kleinke from the wreckage. Kleinke was taken to Albany Medical Center where he died from his injuries.

to family members, he was returning from a doctor's appointment in Slingerlands when the accident occurred.

McGrath's Past

On July 1, 2015 State Police arrested McGrath on Route 81 in Greenville and charged him with DWI. The case was adjudicated in Greenville Town Court and was pled down to DWAI.

This is an important detail because the reduction to DWAI means that police can only charge him with

misdemeanor DWAI-Drugs in the current case, not elevate it to a felony.

State law allows for those convicted of DWI charges within the prior 10 years to be charged with felony DWI, which holds a maximum sentence that includes time in state prison.

According to DMV, a person is eligible to apply for a conditional license one year after a conviction of DWAI. McGrath did have a license at the time of the accident.

An internet search of McGrath's name also revealed additional felony DWI charges, as other media have reported, but those charges from 2011 were for Thomas J. McGrath of Pomona, not Thomas F. McGrath. Both men are now 71, but Thomas J was born in October and Thomas F. was born in May.

McGrath's attorney Steven Coffey confirmed that he did not have a felony DWI in 2011.



BOE files notice of appeal in Bethlehem candidate case

Uniting Bethlehem party town board candidate was put on ballot after Supreme court overturned BOE

ALBANY - After State Supreme Court Judge Michael Mackey ruled on July 7 that Uniting Bethlehem party candidate Kellin Rowlands did have enough signatures and ordered him to appear on the ballot this fall, the Albany County Board of Elections is appealing the judge's decision on procedural grounds.

Originally objections were filed on June 5 by Bethlehem resident Jeff Baker for 256 of the 1,078 ballots submitted by Rowlands on May 26. Baker is a member of the Bethlehem Democratic Committee and serves as its 2nd Vice Chair.

The BOE reviewed the complaint, held a hearing and then ruled to remove Rowlands on June 14 because he was five signatures short of the required number.

The appeal, however, is not coming from the objector or the Bethlehem Democrats, but rather from the BOE, which is made up of Democrats and a Republican commissioner. The BOE hired an outside law firm, Fusco Law Office, to represent it in court on the original court case and Baker and the BDC also hired Greenberg Traung to represent Baker. Both were listed on the notice of appeal, while it also listed Matt Clyne as Rowlands' attornev.

According to Adam Fusco, the BOE is seeking to have the entire decision restoring Rowlands to the ballot thrown out. He said there were three areas of concern: The petitioner did

not provide due notice by not providing sufficient particulars of signatures to challenge; they did not bring the actual signers into court to testify and Mackey did not immediately rule on a procedural challenge brought by the defense.

Fusco also challenged the decision because Clyne was also a witness as a signer as well as Rowlands' attorney.

A date will be set by the Appellate Division Third Judicial Department soon for oral arguments. Fusco said it should be decided by September.

Because this is not a decision for a primary election, but rather the general election, the courts do not have as much pressure to rule in the appeal, he said.



for me just literally changed my life and opened up a lot of doors for me."

Bethlehem Treatment Court

Donovan was one of the first justices in the area to begin operating a diversion program at the local level. Established in 2017, his treatment court has since evolved to address issues beyond addiction, such as mental health

"We care a lot about the people in our court and we take no pleasure in people going to jail," Donovan said. "The idea is that we are an instrument for positive change in people's lives."

Unlike Albany County Drug Court, Bethlehem's treatment court only takes on cases at the misdemeanor level. Sentencing is suspended and participants are placed on interim probation for a year, during which they must comply with the conditions of the enhanced arrangement. These conditions are similar to Albany's and include required drug testing, mandatory attendance at treatment, as well as regular meetings with lawyers, probation officers, and Donovan himself.

"It's not a one size fits all program," Donovan said. "We tailor the program to the person."

Upon successful completion of the program, participants can have their

misdemeanor conviction reduced to a violation or even dismissed entirely. If violating the conditions of enhanced probation, they may instead be placed in jail and sentenced for the rest of the interim.

"We hold them accountable and we let them know that we care. that someone's here and that we're listening, Donovan said. "Giving someone structure is a way to show we care about them."

Although attendance is currently down in Donovan's court, the program has seen up to 10 participants in years past.

"There's no capacity," Donovan said. "There's no limit to what we would do to try and help people."

Donovan attributed this below average number of cases to enduring effects of the recent pandemic.

"During the pandemic, we did everything we could, and we still lost most of the people in the program,"

he said. "We haven't really recovered since Covid."

Nonetheless, Donovan's treatment court continues

to be a viable alternative to incarceration, offering individuals a life beyond mere diversion out of the criminal justice system.

"It's there to do what the judges are supposed to, which is actually help people, not hurt them," he said.

"It's been my saving grace and it's saved my life," Skyler, a former participant of the program, said. "If it weren't for Donovan, I'd be dead, in jail again or a lost cause."

Albany County Mental Health Court

The pervasiveness of mental health concerns is by no means a countyspecific or even statespecific issue. Lack of a well-built mental health system has allowed the crisis to consume communities across the entire country, and Albany is no stranger to its effects.

"This is one of those things that just cuts across every community," Albany County District Attorney David Soares said. "It's something that every family struggles with."

"We don't appear to have the resources to handle the real problem, which is mental health," Donovan said, whose own diversion program also treats mental health issues. "If you want to put resources somewhere, it's mental health."

To help address the issue, Albany County established a mental health court in March 2021, which

was the first of its kind in New York's Third Judicial District. The program is run by Judge John Reilly at Albany City Court and involves mostly nonviolent misdemeanors and some nonviolent felonies. It requires that all participants be examined and meet criteria set by the Albany County Department of Mental Health identifying them as having a serious mental illness. According to Albany County Assistant District Attorney Renee Merges, the court has seen five successful graduates since its inception.

Like all diversion programs, Albany County's mental health court is based on the drug court model, Soares said.

"This model was very effective in the sense that it forces us all on that journey, which is why when a person graduated, it's all of our graduation. And if a person fell off, then collectively we all shared in that feeling as well," he explained. "It's one of the few moments in our system that we can all root for the same thing."

Albany County Drug Court Resource Coordinator and Project Director for New York's Third Judicial District Craig Stratton explained that the need for mental health services often becomes apparent in drug court.

"A lot of individuals, although they had a substance use disorder, saw the mental illness become more of a primary, opposed to substance use being a primary," he said.

Merges, the main difference between drug court and mental health court is what they termed a "longer runway." While participants in drug court spend an average of 17 to 20 months in the program, those in mental health court are kept on a more flexible time frame.

"It's tragic, and it's a complicated issue because vou don't want to use a criminal justice tool to address someone who isn't taking medication," Soares said. "What you also cannot have is someone who should be taking medication not taking medication and harming other people."

Albany County's mental health court was initially created to

address both treatment needs of participants and public safety concerns of communities. But given recent criminal justice reforms adopted by New York State in 2019, specifically bail reform and discovery reform, both According to Soares and Soares and Merges feel that the court isn't being utilized as effectively as possible.

"We're not seeing that court being maximized to its fullest potential because we're not populating that court with the possible applicants who, but for the ability not to detain and arrest, there is no other mechanism to get [them] into court," Soares said.

These reforms, according to Soares, have made it increasingly difficult to hold and thereby obtain mental health evaluations from individuals who might otherwise qualify for judicial diversion programs. Their impact extends to Albany County Drug Court as well, resulting in what Soares described as a

> revolving door in court for many people with substance use disorders.

"We see addicted defendants with multiple charges continue to be released whereas in the past those same individuals would have been assessed and connected with service and drug court much earlier on," he said. "Without that mechanism to get people into the criminal justice system, I don't know what you do."

Complete streets and Heath Barn projects remain on track

Town taking next steps to move big projects forward

DELMAR -The Town of Bethlehem keeps working through the summer heat to push forward the revised Delaware Avenue "Complete Streets" and Heath Farm projects.

Since the Complete Streets public comment period closed in early July, CHA Consulting, the town's project consultant, has been preparing a summary report of the responses.

That report should be available to the public by mid-August.

When asked whether the public comments revealed a preference for any particular design presented at the town's June 15 public meeting, Director of Planning Robert Leslie said he believes the design designated as Alternative 2A

and the most extensive of the three is winning. That design includes installing a raised median at the Elsmere Avenue intersection, gateway treatments and a modified mid-block HAWK pedestrian crossing signal.

According to Leslie, after absorbing CHA's summary report, the town's next step will be to meet with New York State Department of Transportation representatives to review the three design alternatives.

"The NYS DOT has to approve any improvements because it is the owner of the road," said Leslie. "We will listen to their concerns and thoughts."

He said he expects that meeting to take place in late August.

"We will be speaking to the DOT about our ideas and goals for decreasing the travel speed and increasing pedestrian safety and pedestrian crossings across the road," Leslie said. "We will talk to the DOT about our goals and then about the solutions."

Heath Barn Project

Simultaneously, the town continues to move forward on the historic Heath Barn project. Town residents are invited to participate in a "story map" feedback survey available online at historicheathfarm.com.

The survey asks respondents to indicate preferences regarding proposed possible land uses for each of six focus areas on the 309 acre parcel located in Glenmont and Selkirk. The property was purchased by the town last year. Each section of the survey also allows respondents to provide additional comments. The survey closes on Aug.

"The public has one more month to give their feedback on their vision for the property," said Leslie.

The Town also continues to solicit applications for appointment to the 10-member Historic Heath Farm Advisory Committee that was established in June. According to a town publication, the committee will "provide community insights and technical guidance to help the town craft an overall vision for the properties and structures on the 307-acre Heath Farm properties, and help the town implement the actions and next steps necessary for achieving this vision."

Anyone seeking appointment to the committee may submit a letter of interest and resume to Lauren Axford, open space coordinator, at laxford@ townofbethlehem.org by Aug. 31.

Leslie said by the time the committee is established and meets, the town will have the survey results, which will provide "a good start for them to think about plans for the property."

Education and history meet the future at Brookside Museum

Students can take a deep dive into the past through interactive programs

BALLSTON SPA — Education and history meet at the Saratoga County History Center's Brookside Museum in Ballston Spa, where the exhibits explore the county's legacy, and partnerships with area schools inspire future generations.

"Saratoga County: Our Home" opened on May 20. Visitors can explore the 400-year timeline of an immersive, artifact-rich journey through Saratoga life, business and nature. The exhibit is divided into themes such as First Nations, Defense, Water, Farmers and Woodsmen (an homage to the lumber industry).

"We have included

tourists and millworkers," said Director of Education Anne Clothier. "As well as the African-American history. We have the history of gambling, travelers, and popular culture. It ends with 'Looking Forward."

Guests are invited to time-travel through Saratoga history as they view objects from the Brookside Museum's collections. Artifacts include a Bible printed in Amsterdam in 1718, an 1804 tin chandelier from the present Medbery Inn, a windowpane etched by Washington Irving during his Ballston visit, a section of the 1832 railroad track from Schenectady to Saratoga, and a roulette wheel seized in a 1950 police raid.

"With the 'Saratoga County: Our Home' exhibit, we made a very strong effort to ensure that some of the forgotten areas of the county are included," said Clothier.

Through photographs,

family trees, and artifacts, "A Saratoga Family Tale" uses genealogical information and materials donated to the History Center to tell the interwoven stories of soldiers, prominent individuals, and family connections. The exhibit follows the Medbery, Clark and Betts families from their various Colonial settlements to their eventual settlement in

One notable artifact is Col. James C. Clark's uniform. Clark served as an officer in the Corps D'Afrique, a unit of black soldiers, and was stationed in Louisiana around the time of the siege on Port Hudson. His wife, Sara Betts Clark, recorded her

and weaving wool. In the fall, the "Native New York" program focuses on the history of Native Americans in the area.

More than 100 letters from a Civil War soldier in the Schuylerville area are part of the "Civil War Letters" program, which has been presented to area students for more than a decade.

"It's hands-on activities with replicas and historical evidence, like a living museum. They get to try on the uniform, see and feel the cooking equipment, and everything else that the actual soldier used in real time. They get hands-on experience. That's the best thing about it. They get a real, deeper connection with that," said David Zeh, a seventh grade history teacher at Maple Avenue Middle School in Saratoga

Springs whose students took part in the program in June.

"The seventh graders got to work on transcriptions of the soldier's letters and also work with original artifacts and modern replicas, having a deep dive into learning about everyday life in the Civil War, both on the front and on the home front," said Clothier.

Over the past several semesters, Siena College has been partnering with Brookside Museum.

"They've adopted archival items to transcribe for us and to develop additional information on those documents for us," said Clothier. "That includes lesson plans and information on all sorts of topics. Last semester, they focused on an autograph album from the 1830s."

While some students

focused on the biographical information and DNA, others focused on more of a literature and poetry aspect, trying to find out if the rhymes and poems included had come from newspapers or books from that era.

"We also had a couple of students come up with lesson plans, comparing this autograph book to the way students use yearbooks today," said Clothier. "We were happy to see all the things that these Siena students were able to develop, and we look forward to utilizing those in the future."

"Whatever streams are funding this, it's important they continue, because it's important to be able to have highly qualified people going around to present these things," said Zeh. "It is helping educate local youth on what happened in the area they lived in during certain periods of history, especially during the Civil War. It's important to have these museums."

Greens and grains are the recipe for a healthy salad

uinoa has long been a mainstay of healthy cooking and is an important component of vegan cuisine. Quinoa is rich in protein and fiber and has various vitamins and B minerals. Quinoa also is a complete protein, which means it has all of the essential amino acids in the amounts the body needs.

While quinoa is technically not a grain (its grains are the seeds or fruits of cereal grasses), it often is treated as a grain and classified as a "pseudocereal." Encyclopedia Britannica utilizes that term to describe non-grasses that people consume as if they were traditional grains. The Whole Grains Council even classifies quinoa as a whole grain due to its method of preparation and nutrient profile.

Quinoa can be delicious in many forms and be an alternative to rice, pasta, couscous and other grains in cooking. Try this "Green Quinoa Salad" from "Plant-Based Gourmet: Vegan Cuisine for the Home Chef" (Apollo) by Frances Gordon.

Green Quinoa Salad

Makes 6 to 8 servings as a side, or 4 lunch portions

Quinoa mix

- ounces white quinoa, rinsed and dried tablespoon coconut oil
- teaspoon whole coriander seeds Pinch sea salt

- cups spinach, hand torn stalks celery, diced stalk from a fennel bulb, diced green bell pepper, diced large cucumber, diced with skin left on avocados, diced medium parsnip, peeled and diced white onion, thinly sliced and chopped cup chopped fresh cilantro cup chopped fresh Italian parsley cup chopped fresh dill
- jalapeño, diced (with seeds if more heat desired)
- garlic cloves, crushed and minced
- 10 basil leaves, chopped
- tablespoons sesame seeds, toasted tablespoon freshly ground black pepper

Dressing

- avocado
- tablespoons extra virgin olive oil
- tablespoon fresh lime juice
- 1/2 teaspoon salt
- 1/4 teaspoon ginger powder
- 1. Combine the quinoa and coconut oil in a saucepan over medium-low heat and cook, stirring, to gently toast until the color of the grain darkens slightly, about 2 to 3 minutes.
- 2. Add the coriander seeds, sea salt, and 4 cups room temperature water and bring to a boil, then reduce the heat, cover, and simmer for 10 minutes. Uncover and simmer for another 5 minutes.

- 3. Combine all the salad ingredients in a large bowl. Let the quinoa cool for 15 minutes, then add to the bowl and toss to help wilt the salad greens. Mix well.
- 4. Combine all the dressing ingredients in a blender and pulse to combine. Then transfer to a small mason jar or salad dressing bottle with a tight-fitting lid. Shake vigorously until it looks creamy, then toss with the salad.
- 5. Let cool at room temperature, then chill for at least 1 hour before serving.

memory and ability doesn't have a name.

"All they know is that things are changing. They don't really understand why, but they adapt, and they adjust, and that's what happens in the story," said O'Brien Carelli.

Though Poppy does things that don't make sense – he hides his wallet in the freezer and calls his shoes his "boats" – the narrator adapts even without fully understanding what Poppy is going through. The narrator shares with Poppy the things he used to love, and helps him enjoy the things they used to do together.

"If he's mad at his brain, I share

mine," reads one line from the book.

"I talked to a lot of people – fellow caregivers – and they are constantly amazed at how children adjust and do what's necessary to maintain the relationship," said O'Brien Carelli.

For caregivers, finding the time and energy to care for a loved one who can no longer care for himself is a balancing act, especially when added to the stress of work or raising a family. This tension isn't something that a child can ignore.

"They're living in families where [family members] are high-stress or worried about someone, and children pick up on those dynamics. They pick up on those vibes. And this book will hopefully help them to sit down and say, 'Let's talk about what's going on, and how you can make things a little better.' And it eases

the minds of children. That's kind of what I was aiming for," said O'Brien Carelli.

In her Author's Note addressed to adult readers, O'Brien Carelli discusses some of the gaps in understanding that adults, as well as children, may have about dementia. Readers of all ages can take something away from "I'll Remember, Poppy," even if it's just remembering to have a little extra empathy for a loved one with dementia.

"This is something that hopefully would facilitate conversation, clarify things and also help family members be a little more compassionate," said O'Brien Carelli. "I see it as a book that children can read with adults, or adults can read with children, to help them better understand what's happening to someone that they know and love."

y family has always had the drive to do the right thing, and stand up against injustice. We speak out and stand up for those who need someone. "Enjoy stories, songs and fabulousness at a family-friendly and inclusive event with local drag performer Noelle Diamond. This is a chance for people to see others who defy rigid gender restrictions and imagine a world where people can be their authentic selves. Drag Story Hour uses age-appropriate programming to help children develop empathy, learn about gender diversity and difference, and tap into their own creativity."

On July 10, I brought a crew of people who believe in free speech to the Bethlehem Public Library Trustees meeting. There was a chance for public input at the beginning and end of the meeting. We signed in and took our seats. None of us knew what we were


going to say. We believed that maybe there would be a civil discussion and it would end there. Not at all. People spoke with passion both for and against the story hour. The initial 30 minutes that were for public comments lasted two hours.

Arguments against the event included theories that the LGBTQIA+ are sexualizing, recruiting and grooming children. There are adults who believed that the story hours would feature a striptease by the Drag Queen. The beliefs that children will be told inappro-

priate stories and be given propaganda were other complaints. The Bible and a variety of verses were brought out, as they always are in these situations. The United States Constitution was also discussed.

My family and other proponents spoke about inclusion, love, repre-

Back to school prep starts now

Don't wait until the last minute to establish good school year habits

t's hard to believe summer is almost over. Just as you've gotten into a new summer routine, it's time to start planning for back to school. Going from the laid-back summer routine to a rigid school schedule can be stressful for everyone in your home. Avoid some of that stress Vanessa by planning ahead. Don't wait until the weekend before school starts to make some changes. Here are some tips you can start now to help make the process smoother and more manageable:

Establish routines. Start gradually implementing regular routines a few weeks before school starts. Set consistent wake-up and bedtimes, mealtimes, and study schedules/learn-

learning activities during the summer break. Encourage reading, writing, and problem-solving exercises to keep their skills sharp. Start small, 10-30 minutes, depending on their age. Then slowly increase the time and amount of work so they don't feel overwhelmed when they are sitting in the classroom all day.

Prepare in advance. Make a checklist of school supplies, uniforms, and any necessary paperwork or forms that will be needed for the first week of school. Shop for supplies early to avoid last-minute rush and stress. Sort, label, and pack everything ahead of time.

Create a family calendar. Use a shared calendar or a planner to keep track of • important dates, deadlines, and activities. Include school events, extracurricular activities, and family commitments to ensure everyone is on the same page.

Address anxieties. Some children may feel anxious about going back to school. • Encourage open communication and create a safe space for them to express their concerns. Validate their feelings and reassure them that their worries are normal. Share positive experiences from previous school

Run through your routine: This can be helpful for everyone but most impactful • for little ones - especially those going off to school for the first time. Practice your morning routine: get dressed, pack snacks and lunch. You can even go down to the bus stop or make the drive to school. This way your child knows what to expect.

Discuss expectations. Talk to your child about their expectations and goals for the upcoming school year. Set realistic expectations together and

discuss how they can achieve them. It's essential to provide support and encouragement while also fostering independence and responsibility.

Starting early and going slowly will give you the best chances for success. Remember, each child is unique, and age is a factor in your planning. It's important to tailor your approach to their individual needs. 

Helping others help themselves

Philanthropist says that responsibility goes hand in hand with success

This is the second in a two-part series.

ighty-three year old John Barr has a balanced, enlightened, different and cleaner view of what has become a dirty word: capitalism.

"The benefits of capitalism is to gain growth, but what's incumbent upon the recipient of success is to participate in the system that made you wealthy," he

For Barr, that directs him toward philanthropy and volunteerism.

"You have to look at ways you can help people with less resources than yourself," he said. "One entrepreneur remarked that he hopes the last check he gives away bounces."

In his work with a food wagon, Barr regularly addresses the delicate balance between compassion and enabling.

"I deal with it every day, and I don't run away from it," he said. "You have to be careful how to love the needy so you don't take away what they can do for themselves. It's difficult to give money away because you have to figure out ways that won't cripple people; but you can't use that as an excuse not to give it away. You have to teach them how to fish and not feed them so that they can become more of who they were meant to be."

In short, Barr concludes that "love will give you the roadway on how to handle those with less than you."

He plows ahead with social works at places like the YMCA where he serves on the Board of Directors. One such program is "Togetherhood" which is one of the national programs of the YMCA that encourages members to go into the community and find and meet needs of neighborhoods or areas.

"The needs don't come to us," he clarified. "We go and find the needs. No budget. Strictly volunteers."

On the personal side of success, he feels that gain can lead to sloppiness in terms of stewardship. Barr takes that seriously and guards himself against unwise personal spending and its unintended consequences.

"Enjoy spending money," he said. "If you do that, you'll find some special things for yourself, but you won't spend a lot. If you buy with

joy, you won't buy foolish things because most of those things that people buy are for other reasons."

Barr's peace with his success and his simultaneous desire to use his wealth for those who are struggling for a better life for themselves and their loved ones continues to play out day by day in a 'You have to look at ways you can help people with less resources than yourself.'




