



# County mental health crisis programs to grow

Expansion of services to include funding for ACCORD, mental health court, LEAD program, homeless support and the reopening of Mercy House in Albany

ALBANY - In June 2021, a new Albany County pilot program to assist those involved in mental health crises began in the Hilltowns. Now officials are ready to roll it out as part of an expansion of mental health programs and services.

On Wednesday, Sept. 20, local officials gathered in Albany to announce that ACCORD (Albany County Crisis Officials Responding and Diverting) would expand into the City of Albany after an internal working group comprised of members of the Albany Police and Fire Departments analyze what processes, investments and protocols would be necessary to implement ACCORD in the city. The target date to start rolling teams in the City of Albany is 2025.

"This program works. We have had over 350 calls with the program," Albany County Sheriff Craig Apple said. "This is ready to go now; it is proven and needed.

If you want a program like this to be successful, the county should run it for all of the county."

Currently, The program only runs in the Hilltowns, and according to Apple, it would be a great help to free up law enforcement for other calls.

He said that the program should be consistent in the way it operates, regardless of what municipality it operates in.

"I wish it could be run that way because I don't think we will be as successful having different ways of operation," he said. "We believe in this program, and it has been proven to work."

The ACCORD program currently consists of two response teams with social workers from the county's Mobile Crisis Team and paramedics from the Sheriff's Department, who have been trained to handle situations involving mental health and nonviolent emergency cases where law enforcement is not essential. According to Apple, law enforcement responds to all the potential calls, then, if it is safe, the Accord team comes in.

"We then can connect the person with the services they need, whatever that may be," Apple said.

In the first year of operation, 240 emergency calls were diverted to the ACCORD team resulting in 549 total encounters with 210 different individuals

with the majority of calls related to general medical assistance and services/ transportation for those experiencing immediate mental health emergencies, according to a September 2022 study of the program by SUNY Albany.

In most cases, the ACCORD team was able to de-escalate the situation, assess the individual's needs, and offer coping strategies and referral services for care. The team also followed up with the individuals and their families to offer continued support and additional services when necessary.

"In the short time the ACCORD program has been in operation, the results have shown the need for more mental health staff supporting the needs of Law Enforcement," Apple said at the time of the report's release.

"Long before the pandemic, we were in the middle of a mental health and overdose epidemic. This was only made worse by COVID, the economic shutdown and isolation. On top of that, we are now faced with an affordability and homeless crisis. However, today we further show our commitment to getting Albany County residents the mental health and support services they need to recover, get back on their feet, and thrive," Albany County Executive Daniel McCoy said.

According to McCoy, the county and City of Albany will commit \$1.8 million

to the full-scope of services including an expansion of the Albany Alternative and Treatment Court (Mental Health Court), the first time it's been expanded since the pilot program was first launched in February of 2021. The Mental Health Court offers those charged with nonviolent misdemeanors or non-criminal violations an opportunity to be diverted into court-supervised and community-based services and treatment instead of facing incarceration. Additional funding will provide administrative support in order to expand the number of slots in the program, which currently stands at 15.

In order to address the ongoing homeless crisis, county funds would be utilized to reopen the former Mercy House homeless shelter in the City of Albany through a collaboration with Interfaith Partnership for the Homeless.

According to the county, the shelter closed in July 2022 due to rising costs of operations. Additionally, combined funding from Albany County and the City of Albany would support Albany CARES and an engagement program of social workers to directly interact with homeless individuals on the street to more effectively enter them into the system of care and find stable, long-term housing.

"The Albany County Legislature has one goal in mind when it comes to mental

health crisis events in the area and that is, to keep everyone as safe as possible. The best way to do that is to provide tangible and proven successful resources to those struggling in crisis. These new investments will increase direct access to mental health professionals, create a new array of judicial services for those in need and increase shelter services. Thank you to our county legislators who passionately advanced these initiatives in partnership with the County Executive's office and the City of Albany," Albany County Legislature Chairman Andrew Joyce

The original ACCORD pilot program was funded in December 2020 with an initial investment of \$170,000 to fund two additional social worker positions in the Department of Mental Health. Another \$30,000 is being invested for the partnership between the county and UAlbany.

"Across the nation, communities are reimagining crisis response strategies. In Albany County we have developed a cutting-edge alternative that builds upon the Department of Mental Health's decades of experience providing mobile crisis services and reflects emerging standards of community care," said Dr. Stephen Giordano, Albany County Mental Health commissioner. "Partnering with the Sheriff's Office to pair up mental health experts with medics provides a compassionate response to persons in crisis and frees up law enforcement to focus on public safety matters."

SUNY Albany recommended to expand the ACCORD program in the 2022 report and called for a long-term investment that includes additional training and collaboration between police, local officials, mental health professionals and the

## Annual fall fest and run on the rail trail

SLINGERLANDS-Albany County will host the 2nd annual Fall Festival & 5K on the Albany County Helderberg-Hudson Rail Trail and at the adjacent Firefighters' Memorial Park, on Saturday, September 30 from 11am to 4pm. 

## **Empire BlueCross Foundation Grant to Support Regional Food** Bank, SPHP Partnership

ALBANY – As part of its ongoing work to increase access to nutritious food and improve the health of all New Yorkers, the Empire BlueCross

Foundation, the charitable arm of Empire BlueCross, recently announced a threeyear, \$450,000 grant for the Regional Food Bank of Northeastern New York. The grant will support the Food Farmacy Program, which provides participants and their families with a three-day supply of fresh produce, low-fat dairy and lean meats, and protein on a weekly basis.

The Food Bank is partnering with St. Peter's Health Partners and Saratoga Hospital to develop on-site food pantries that distribute meal packages tailored to patients' chronic diseases in conjunction with nutrition education and counseling, with a goal of supporting more than 1,600 patients over the next three years.

"Our mission at the Regional Food Bank of Northeastern New York to not only feed our neighbors in need but to also provide them with healthy and nutritious food," said Tom Nardacci, CEO of the Regional Food Bank of Northeastern New York. "With Empire BlueCross Foundation's generous



## **Should I Keep Money in Savings or Checking?**

o you ever find vourself wondering, "Should I keep money in savings or checking?" It's a common question, asked by many. ## When to Use a **Savings Account**

to raise \$14,644 from a pancake breakfast to benefit eight families, totaling 14 people, displaced by a fire that swept through their apartments on May 30 at 9 and 11 Equinox Court just off Kenwood Avenue.

"It was a community effort that also rallied other organizations including local churches, community organizations, banks, doctor's offices, and other businesses that contributed, as well as all of the fire departments who responded to the blaze," said Slingerlands Fire Department Chief Craig Sleurs.

Ladies Auxiliary President Emilie Moss cooked up and served a pancake breakfast fundraiser at the firehouse on June 18 that featured pancakes, French toast, sausage and bacon.

We could not have done it without the support of the Slingerlands Fire Department and the many



volunteers who were on hand for a couple of nights of prepping, serving food, clearing tables, and taking out the trash," said Moss.

She said other support was received through inkind donations of food, like milk and half and half from Meadowbrook Farms Dairy. Reliable Brothers, Inc. donated part of the sausage served and discounted the cost of the rest.

Moss joked that the hardest part was trying to figure out how much to purchase.

"At first we had no idea

what to expect because we had never cooked for a couple of hundred people before," she said.

Moss found a formula online for large catering and relied on that to purchase 72 pounds of bacon, a grocery cart full of eggs, another grocery cart full of pancake mix boxes and a flatbed of juice.

Set up in the Slingerlands Fire Department's engine bay and main room at New Scotland Road, with four griddles spilling outside the building, volunteers made



sausage, French toast, bacon These young entrepreneurs and, of course, pancakes, for the attendees.

From 8 a.m. to noon, more than 350 people attended the breakfast, and many stayed to eat the 72 pounds of bacon and pancakes made from 52 pounds of mix. Others "just walked up to the table even though they were not there to eat and donated money," said Moss.

Added financial support came from a lemonade stand set up at the firehouse during the pancake breakfast by three elementary age children.

contributed \$160 to the recovery fund from all the lemonade they sold that

After the breakfast, the fire department continued to receive donations in the mail. The Albany County Firefighters Burn Fund, a not-for-profit organization associated with the Albany County Firefighters Association that assists fire victims in Albany County, also made a donation.

She said another kind of donation was made by the Treasure Cove Thrift Shop on Adams Street in Delmar, who invited the fire victims to come and take clothes they needed from the store.

Moss reported that members of four of the eight displaced families attended the breakfast. She also said that one additional family pulled up in their car, but was too overwhelmed to attend

After the donations finally tapered off, the fire department recently disbursed the last of the recovery funds. Each of the eight families received just over \$1,800 in total, said Moss. She reported that "many tears were shed" when they met the families to give them the donations.

"They were in somewhat disbelief that total strangers would do this for them and they were extremely grateful and humbled by the funds they received," she said.

"Typically we don't have that many signal 30 fires [confirmed large structural fires] in the district," said Moss.

She explained that "anytime there is a fire of that magnitude, they try to

The precedent-setting CHPE project will power over 1M residencies, reducing harmful emissions by 3.9M metric tons and significantly improving air quality for all New Yorkers. ## After the burn

do something to help those individuals impacted by the fire, but this one was on a much bigger scale.'

"The families lost everything in the fire," Moss stated.

She recounted that one of the fire victims, a mother,

was incredibly grateful because she did not have any insurance and said the money would be "a huge help to her family."

Moss said her personal experience provided added motivation to fundraise for the eight families.


"When I was a child I lost part of my house at Christmas time to a fire," she said. "Going through something like that stays with you and you just want to help people."

Sleurs spoke to one of the families two weeks ago.

"They are more than happy [with the donation]," he said. "Even though they lost everything, they are still happy that we are giving back to them."

The May 30th fire burned down two four-unit apartment buildings at the Equinox Court apartment complex and took two hours to be brought under control. Departments had to return the next morning to extinguish the rubble again after it reignited.

"In my 38 years as a firefighter and in my last six years as chief, I never had a fire of this magnitude," Sleurs marveled "We



On June 2, Bethlehem police arrested a 35-year-old Delmar man for allegedly lying to the police about starting the fire. Juan Miranda, who lived in one of the burned buildings, allegedly was smoking a marijuana cigarette in the courtyard between 9 and 11 Equinox Court shortly before

the fire started and discarded the end into the vard.

According to an Information/ Complaint filed in the Bethlehem Town Court, Miranda allegedly made a false written statement during the police's investigation of the fire. It is alleged in the Complaint/Information that Miranda "identified a fictitious suspect in the case causing the fire when later he admitted to starting the fire."

Described as a Class A Misdemeanor, the violation is punishable by up to a year in jail and a fine of up to \$1,000. Miranda was released on his own recognizance.

Miranda's case is still pending and he is due back in court on Oct. 17, according to the Town Court's Clerk's office. Damara Fredette, Miranda's attorney and an Albany County public defender, said Miranda had entered a plea of not guilty at the time of his arraignment.

In the meantime, Sleurs said he understands that each family has a new residence and "is moving forward with their lives."





The songs are bittersweet here, hilarious at times, but often laced with a guiet sense of longing and dread: a text message goes unanswered; an old classmate descends into the dark depths of internet conspiracies; a relationship unravels in the middle of a lake. And vet, taken as a whole, the result is an undeniably joyful record that refuses to succumb to the weight of the world around it, an ecstatic reminder of all the beauty and promise hiding in plain sight for anyone willing (and present enough) to recognize their moments as they arrive. 



manager has over 40 years on the road and overseas managing the music tours of accomplished artists.

Last year, Feulner published his book, "Stars Don't Carry Their Own Baggage." It follows the story of an up-and-coming '80s band, Cherry Thieves, as they go through the early stages of their career during 1985–1986 through the eyes of their tour manager, Richard Scott (Feulner).

"I wrote the book because I want the lady (who's sitting at an outdoor table outside the Clifton Park Uncommon Grounds) to know what's going on and what really happens and for the guy who works at the auto department store as he only knows what he sees on TV," Feulner said. "I wrote it the way I wrote it because I wanted everybody to get an understanding and not just tell dirt."

## From Local Beginnings to Rock Star Status

Feulner was a drummer in high school when he lived in Schenectady and played in school bands. Beginning at age 22, he performed in clubs around Clifton Park, Saratoga Springs and Glens Falls with area bands during '70s.

He became tired of playing cover tunes and wanted to advance his musical career beyond just playing inside clubs. He knew that playing music, especially original music, was all he wanted to do. Eventually, he began asking around the music community if anyone needed a drum technician.

Feulner was put in touch with both Blotto and the Penny Knight Band, who later became the band Cashmere, and traveled with Knight's band all over New England. When Blotto needed a drum tech, Feulner was sold.

For a few years, he helped the band out and had a lot of fun, Feulner said. However, he knew that he needed to meet people who were involved in the music scene or worked for a record label, and he went out of his way to befriend them and keep in touch.

Feulner's life changed when Blotto performed a monthly show at The Chance Theater in Poughkeepsie. The theater's stage manager was looking for a crew for Johnny Winter. Winter, the Texasbased blues guitarist, had the biggest record deal of any artist in the '70s, and Feulner and Blotto's guitar tech took on Winter's U.S. and European tours, opening for Jack Bruce of Cream.

"So we went out and did a whole U.S. tour, and while doing that tour, the tour manager who hired me was not advancing any of the shows and nothing was done properly," Feulner

recalled. "The crew guys and I were getting upset, and so I said, 'I'm going to tell him that I'm taking over the tour."

Winter's previous tour manager, Bob, was sent to rehab by Winter's management office in New York City, who heard that Feulner did a great job taking over Bob's job and offered him the tour manager position.

"It wasn't what I wanted to do with my life. I wanted to be a rock star, but you know, hey, it was the closest thing," Feulner said. "I'm glad that it all turned out this way because I've had

a very good life and I've got to live like a rock star, but I don't have the fame so I can go anywhere and nobody knows who I am and nobody bothers me, so it's better to be rich than it is to be famous, as a friend of mine once said."

## **The Tour Manager Life**

For more than 40 years, Feulner has worked and established friendships with a who's who of established musical artists, such as Robert Plant and Alison Krauss, Johnny Winter, Slipknot, Seether, Hall and Oates, The Eagles, Keith Urban, Trans Sibernian

Orchestra, Boz Scaggs, Winger, Jesus Jones, Great White, Danny Vincent's Invasion, Dream Theater, to 90s country artists, Jo Dee Messina, Suzie Boggus, Deana Carter, and his recent involvement with Mexican duo, Rodridgo and Gabriella.

Feulner's responsibilities as tour manager revolve around accounting and show logistics: transporting the artists to their destination, show location, and leaving the show to the hotel or next destination. Feulner is responsible for booking hotels, plane flights, and tour buses. Feulner wakes up early in the morning sending emails and conducting business in preparation for Rodrigo and Gabriella's current European tour.

## 'Stars Don't Carry Their Own Baggage'

Writing a book wasn't something Feulner had in mind until Covid arrived. He and the entertainers were out of work, and he wasn't sure what he was going to do with himself for the first time.

"I just started thinking about writing a book. I wasn't even thinking about putting it out, just to pass the time and something to do," Feulner said.

He made a list of the 38-39 bands that he worked with and put his thoughts onto paper. It took him two weeks walking around with a pad of paper jotting down anything he could remember. Feulner eventually wrote between

60-70 stories; only half of the stories were used in the book. Those stories were then sent to a publisher for feedback.

Although the publisher loved the stories, thought they were funny as hell, and knew it was going to be a great book, they wanted names – names of the bands and the artists. Feulner said no.

"Some of these people in the book are friends of mine. I'm not gonna get people divorced, I'm not gonna make bands break up, I'm not gonna get managers fired," Feulner said. "I don't want to give names. That's not why I am writing this. My friendship's more important than the money."

Feulner didn't disclose

the names of the celebrity musicians whose stories he told. However, he did hint that one of those stories was based on his days in Cashmere.

All the stories in the book are true, Feulner said. The only thing that was made up were the band names. Also, to protect the identities of the celebrity musicians and Capital Region musicians who are friends of Feulner, he created fictional names for the manager, road crew, publicists and record companies, switching their names with other friends.


Feulner incorporated his local friends into the story as a tribute as they helped him along the way in his career.

## The Origins of 'Cherry Thieves'

"It was really hard to find a band name," Feulner recalled. "I was out driving during Covid and listening to the radio, and it just popped in my head. I can make up a band, I can use all my stories, and I'll use them as my vehicle."

It was trial-and-error coming up with band names, and he came up with between 25-30 factitious names, but they were already in use. He came up with additional names that weren't used and asked his family and friends for input. Some of the feedback was mixed.

Feulner liked the word "thieves" and wanted to use it in a name. While driving, "Cherry Thieves" popped into his head. He wanted to think of a band that would be around in the '80s.

He looked online and discovered there was no band called Cherry Thieves anywhere. He e-mailed friends in New York and Nashville and asked if they'd heard of a band by that name.

"They wrote back a couple of days later and said, Tve never heard of this band.'... I was like, yes, I got a name," Feulner said.


The two acts that open for Cherry Thieves were two additional names that he originally came up with for using for the book.

## The Book Cover Inspiration

Feulner's son, Glenn Feulner, a Capital Region artist, was responsible for creating the Cherry Thieves band logo and the cover art for "Stars Don't Carry Their Own Baggage."

"We probably had like five different covers. I said (to my son), Just think about what it is, "Stars Don't Carry Their Own Baggage,"" Feulner said. "So I said, 'Let's try something with suitcases' ... so finally we got this, so I was happy with it."

The front cover depicts a guitar case at the lower center of the book, surrounded by dozens of suitcases. Some of those suitcases have labels



depicting the typical rock'n' roll stereotype: sex, lies, booze, and the Cherry Thieves sticker. And its significance?

"You're just living out of a suitcase. Everybody is – whether you're the rock star or you're the road crew – everybody's living out of the suitcase. That's kind of where I got the vibe," Feulner explains. "I was trying to think about different things, and I was like, yeah, suitcases. Everybody has a suitcase on the roads and sometimes too many, especially female artists. Some people carry too much; other people just come with a paper bag."

his book to his celebrity musician friends that he worked with over the years, and they were impressed. It made it as though they were sitting at the bar talking to Feulner as he was telling the stories, he said. Several of those musicians who read the book even called to ask why a certain memory of theirs wasn't in the book or perhaps, wanted to be featured in it.

Feulner sent copies of

"I don't know. Maybe when I retire, but right now, I'm too busy," Feulner said. "It's crazy."

Being a tour manager is what Feulner knows and does best and he has no complaints about his career. He wants to continue his job for five more years. Once he turns 70, then he'll stop. He said if he wasn't doing this job, he would be mowing lawns.

"I appreciate all of my friends and my family. Anybody that helps me, I've always been kind to them, would do anything for them, and repay them by doing something good for them and helping them out." Feulner concluded. "I try to help people and return the favor so to speak."

# Unique ways to reduce cancer risk every day

The human toll cancer takes is significant, both on the lives it claims and on the friends and family of those victims. Estimates from the International Agency for Research on Cancer indicated 10 million individuals across the globe lost their lives to cancer (excluding nonmelanoma skin cancer) in 2020. New research indicates those numbers could be on the rise.

A study published in the journal The Lancet in 2020 found that deaths from cancer are now more common in some high- and middle-income countries than deaths from cardiovascular disease. Authors of the study, which examined incidences of cancer among adults between the ages of 35 and 70 in 21 countries across five continents, concluded that cancer is like to become the leading cause of death in middle-age.

Though cancer is a formidable disease, many cases of cancer are preventable. In fact, the things people

do every day can go a long way toward lowering their cancer risk by a significant margin. Certain behaviors, like avoiding smoking, are widely known to reduce cancer risk. But some lesser known actions also can help individuals lower their risk.

Quit when you hear the click at the gas station. The Air Pollution Control District of Santa Barbara County in California notes that gasoline vapors include a variety of toxic substances, including benzene. Benzene is an air pollutant that adversely affects the central nervous system, the respiratory tract and the immune system. Modern automobiles now click when the gas tank is full and it's vital that drivers avoid adding any more gas after they hear that click. Drivers may be accustomed to topping off after the click, but doing so can affect the vapor recovery system in a car. That system is designed to keep toxic chemicals like benzene out of the air. Topping off can needlessly expose drivers and their passengers to benzene, which the U.S. Department of Health and Human Services considers a carcinogen, or cancer-causing chemical.

• Grill wisely. Millions of people anxiously await the return of warm weather so they can once again fire up their backyard grills. Various studies have suggested there's

a link between well-done grilled meat and cancer. One study conducted by researchers at Vanderbilt University found that high intake of well-done meat increases exposure to heterocyclic amines (HCAs), a type of carcinogen that forms in cooked red meat. That doesn't mean individuals should put away their grills, but a change in grilling habits could help lower

fluids. Drinking more fluids is one of the easier things people can do every day to reduce their cancer risk. The American Cancer Society recommends individuals consume eight cups of water per day, but millions likely fall far short of that amount. That's unfortunate, as research presented at the American Association

for Cancer Research International Conference on Frontiers in Cancer Prevention Research in 2011 found that high fluid intake was associated with a 24 percent reduced bladder cancer risk among men. In addition, a separate study funded by the Strauss Institute and published in 2020 in the International Journal of Environmental Research and Public Health found that women with breast cancer consumed less water and total fluids than women who did not have breast cancer. The researchers concluded more investigation into the link between drinking more water and reducing breast cancer risk is necessary, but noted that drinking water is harmless, convenient and beneficial to many aspects of health.

Though cancer could soon become the leading cause of death in various parts of the globe, many of those deaths can be prevented. And even the simplest measures can make a difference in cancer risk.





# The best pumpkins for pie

Beginning in early fall, pumpkins begin to arrive at farmer's markets, supermarkets, nurseries, and fall harvest festivals. Pumpkins are versatile in that they make colorful fall home decorations, but also can be utilized in all sorts of recipes. In fact, pumpkins are a type of winter squash.

While some people may be quick to think that the larger the pumpkin the better it is for baking up delicious treats, that's actually not the case. According to the gardening resource Gardener's Path, although most pumpkin cultivars are edible, the

Once you've selected your perfect cooking pumpkins, it's time to whip up a pumpkin pie. Enjoy this recipe, courtesy of McCormick, which can be served

anytime from Halloween through Christmas.

## **Classic Pumpkin Pie**

Serves 8

Pastry for 9-inch pie crust

eggs, well beaten
