Glenmont teller from Colonie takes plea, four others charged on federal charges

ALBANY - A federal grand jury indicted five Capital District suspects on Thursday, Sept. 21, who were involved in a ring that defrauded a local credit union and its members.

According to the indictment, unsealed on Oct. 3, between February and October 2022 Allahson Allah (formerly known as Gwyn Cancer), 53, of Albany; Evan Cutler, 24, of Queensbury; Davon Parson, 20, of Troy; and former teller at SEFCU Glenmont, Caeshara Cannon, 33, of Colonie, to steal the identities of credit union members and take out loans in the victims' names.

Cannon pleaded guilty on Sept. 14 to federal charges of conspiracy to commit bank fraud and aggravated identity theft prior to the indictment of the other four co-conspirators. She faces a sentence of 32 years in prison and must pay restitution of \$77,200, according to the plea agreement. The agreement also says that the government cannot charge her with additional crimes related to this case.

In the indictment, Allah was charged with conspiracy to commit bank fraud and two counts of aggravated identity theft. Cutler was charged with conspiracy to commit bank fraud and four counts of aggravated identity theft.

## Three centenarians tell it like it is

Members of Peregrine Senior Living's 'Century Club' reflect on the past and present

DELMAR - Some assisted living facilities tout their bridge clubs. Delmar's Peregrine Senior Living at Delmar Place hosts a "Century Club" whose membership includes three of its 85 residents who are 100 years old or older.

George Coffey, the oldest at 103, Muriel Faulkey, the "middle child" at 102, and Leland Case, the group's 100-year-old "baby," recently sat for a spirited discussion of their over 300 years of life experiences.

'We feel lucky to be with each other since we are all at least 100 years old," said Coffey, the

group's philosopher. "You may be 100, but you can still think younger. ... It makes a difference in your lifestyle and actual being. If you can't think a little younger, you will get older.'

He stressed that he never looks back.

"I impressed on my children that you keep your eyes pointed ahead and don't start looking back and say 'I wish I did that," he said.

Coffey, who lived all over the country and had a car dealership, said he has lived as long as he has because he's "a hard-headed Irishman.'

"My mother was from Brooklyn and my dad was born on the Isle of Man, and if that isn't a combination I don't know what is," he said.



are one year apart, both grew up in Greenville. They reconnected when Faulkey moved to Peregrine Senior Living in October 2013. They did not recognize each other, but they started talking and realized they had grown up together.

"We talked so much and had so much fun talking about the things that happened in Greenville," said Faulkey.

Faulkey said she and her Coffey and Faulkey, who husband were teachers, and

when they got married, they moved from Manhattan to Greenville. After they retired, they traveled all over the United States and Europe together, first by camping here in the United States and then flying to Europe.

"We had a wonderful life together until he died," she reminisced.

Case, who was born and raised in Knox, Penn., later lived in Ravena. He spent his professional life driving

a tractor trailer for 35 years and retired nearly 40 years ago in 1985.

He said he has seen a lot in his 100 years, noting outhouses changing to indoor plumbing, ice boxes to refrigerators and coal to oil heating. Coffey recalled when Freihofer's bakery sold all their pastries and bread by horse and

wagon.

"Those horses were so used to the routes that when the driver wasn't even in the carriage; the horse knew right where to go and even knew where to turn around," he recounted.

All three agreed that rather than finding these changes to be remarkable at the time they were occurring, that they didn't really notice as the world was changing.

"I just didn't think about it," said Faulkey.

"Change doesn't upset me because there is nothing you can do about it," Coffey said. "You get to this age and look back and say it wasn't so bad and it could have been worse."

However, he noted the "demoralizing" of cities and towns is, for him, the most disappointing change over time.

Case objected to the proliferation of "gadgets."

"There are too many gadgets," he said. "They last three to four years and then something takes the place

Coffey and Case also agreed that in today's world, the most important thing for the next generation to do is to get an education. Case, who dropped out of school in 10th grade to work, is particularly proud that three of his four children got college degrees. Faulkey, a former teacher, acknowledged that an education for young people is important, but said "to do right and treat people well is the most important thing you can do."

When asked if they currently have any vices, Faulkey said hers is a weekly hot dog with lots of mustard. Case smiled and said, "a beer every once in a while, oh yeah." Coffey said he had quit his vice -15 years of smoking two packs/day of unfiltered Lucky Strike cigarettes.

Based on varying reports, the average life expectancy in America is between 77 and 81 years old. According to the 2020 U.S. census, only 819 Americans were 100 or older.

"It's rare to have one person who is 100 years old [at an assisted living facility], no less all three," said Peregrine Senior Living Executive Director Christopher Oertel. "We feel lucky to have them all."

At that, Coffey immediately quipped, "Do you feel so lucky to have me that I'm eligible for a 100-year-old senior discount for my monthly charges?"

## Illegal employee accused of rape released then picked up by feds

Only one of five arrested are still confirmed in federal custody.

COLONIE - One of the five non-US residents who live at the Surestay Hotel on Wolf Road that were arrested two weeks ago is still in federal custody as of Sunday.

The charges included rape, burglary, assault, menacing and criminal possession of a weapon. The two men charged with the most serious crimes were remanded by Colonie Judge Norman Massry on October 4, then picked up by Immigration and Customs Enforcement(ICE) when they were released. The other three were picked up by ICE the same day as arraignment.

That has changed, however, and as of Sunday only one is still listed as detained by ICE. Simrandeep Singh, 21, who was an employee of the hotel, lived there, and also is in the country illegally, was charged on October 4 with rape.

He was released under supervision of probation after a preliminary hearing in Colonie but was picked up by ICE and remains at the Buffalo Federal Detention Facility.

According to the Albany County District Attorney's office, Andres Yaraure-Pina, 21, was charged with robbery, a felony, and petit larceny and criminal mischiefrecklessly damaging property after an incident at Cricket Wireless on Central Avenue on October 3. He was arraigned by Colonie Judge Norman Massry and sent to the Albany County



jail without bail and was arraigned again on October 11 in Albany County Court in court on November

by Judge Little. He is scheduled back

11. Yaraure-Pina was arrested in Queens on July 29 and again on August 19 in separate incidents. He was charged with a felony and two misdemeanors. It is unclear if he is still in local custody.

Cleiver Manzanilla-Morales, 18, was charged with assault with intent to cause injury on September 29 after an incident at the hotel. According to the District attorney's office, he was scheduled for October 10, but did not happen because he was in ICE custody. He is no longer listed as detained by ICE.

Michael Rodriguez-Cortez and Jhonathan Pena-Quintero, both 26, were involved in a fight at the hotel where a knife was brandished on October 1. They were both charged with attempted assault with

a weapon, a felony, and

menacing with a weapon and criminal possession of a weapon with intent to use, both misdemeanors. They were arraigned and taken into ICE custody, but no longer are listed as detained.

According to the District Attorney's office, the cases were returned to Colonie Town Court as assault in the third degree and they were scheduled to appear there on October 18. Assault in the third degree is not a bail eligible offense unless it is charged as a hate

ALBANY - Amidst song, speakers and prayers for the

Israeli defense forces, hostages taken in Israel by Hamas and murder victims, the area's Jewish community came together on Tuesday, Oct. 9 at Albany's Congregation Beth Emeth to show its support for Israel. Countless more attended by live stream video. The rally was also attended by Governor Kathy Hochul, Congressman Paul Tonko and other Albany County and local representatives, such as City of Albany Mayor Kathy Sheehan, Assembly member Patricia Fahy, and Albany County Sheriff Craig Apple.

"Tonight is about proving that hatred will never win. Tonight is about proving that terrorism will never win. Tonight is about proving that fear will never win," said Beth Emeth Senior Rabbi Greg Weitzman.

Jeffrey Handelman, the President and Chairman of the Board of the Iewish Federation of Northeast New York began by noting the presence of personnel from the Albany County Sheriff's Department, the FBI, the State police and the City of Albany City police department.

Speaking to the synagogue's packed sanctuary, Hochul assured the Jewish community that her "number one priority is the safety of all New Yorkers" and that she had activated the State Police and intelligence centers to monitor messages being shared on social media. "We will let the terrorists know they will find no comfort here," she said.

"We stand with Israel," she stated unequivocally. She also told the crowd that today the Israeli flag flew over "my house" – the governor's mansion

in Albany and that beginning Wednesday the Israeli flag will fly over the State's capital as a show that "we are with Israel."

Hochul was followed by several other speakers, including Tonko who told the crowd, "We stand before you as a friend of the Jewish community and "a voice in Washington." He assured them that "we will make sure every opportunity is made available to join against Hamas." "Man's inhumanity to man overwhelms us with grief,"

Tomko also advised that a "strong" bi-partisan resolution is before the House that "will call out the actions of Hamas and make sure there will be sanctions" and "resources provided." He said he hopes the bi-partisan resolution will move through quickly. He added that the resolution was an "acknowledgement that

such hate, such darkness is not allowed to continue" and, like Hochul, concluded, "We all stand for Israel."

Union College Professor of History Stephen Berk told the audience never to forget what they have seen, what they have heard, what they have read, as he recounted the slaughter of innocent men, women and children and the taking of hostages. "Let us be clear, Hamas is a genocidal organization" he said and noted it has been from its founding in 1988. "We are dealing with an enemy with no moral bottom," but he predicted that "Israel will win."

At the event's conclusion, the area's rabbis and cantors led the room in the singing of the Hatikvah, a song of hope and the Israeli national anthem.



## Feds charge local SEFCU suspects

Parson was charged with conspiracy to commit bank fraud and two counts of aggravated identity theft, and Taylor-Sterman was charged with conspiracy to commit bank fraud and one count of aggravated identity theft.

The federal charges came after the U.S. Attorney's Office for the Northern District of New York took over the case from the Bethlehem Police Department in December. The case unfolded after Bethlehem officers and detectives responded to a report of someone trying to cash fraudulent checks at the Slingerlands SEFCU branch in October 2022. Their investigation, with the

help of Broadview Fraud Prevention, quickly found that it was not an isolated incident.

SEFCU and CAPcom announced a merger of the two local credit unions in June, to rebrand under a new name, Broadview Federal Credit Union. Branches at the time of the first incident displayed the SEFCU and CAPcom signage.

#### The Ring

In her capacity as a Glenmont branch teller, Cannon allegedly accessed, stole and forwarded personal financial information of SEFCU members to at least four others in the ring, who then received the personal loans and withdrew money.

On Oct.13, employees at the SEFCU branch at 12 Vista Blvd. in Slingerlands called police to report a man was attempting to use fraudulent identification to withdraw \$20,000 from the credit union. Police arrested Parson inside the credit union. At the same time, they stopped Cutler in the parking lot for driving without a license in an uninsured vehicle.

Once the two were in custody, police said they started to piece together a larger scheme, with the assistance of SEFCU Fraud Prevention, that involved two additional people. Taylor-Sterman had applied and received a loan a week before under a name she allegedly received from Cannon.

## The investigation timeline

• **Aug. 13, 2022** - Parson and Cutler allegedly cash a \$9,000 check at the SEFCU Glenmont branch against the funds of a SEFCU customer with information provided by branch employee Cannon.

• **Sept. 21, 2022 -** Cutler applies for and is approved for a fraudulent personal loan of \$25,000 at SEFCU with the information of a male SEFCU customer received from Cannon using a fake NY driver's license.

• **Oct. 7, 2022 -** Taylor-Sterman applies for and is approved for a \$25,000 personal loan at a SEFCU branch with the information of a female SEFCU customer received from Cannon using a fake NY driver's license. Taylor-Sterman withdrew \$5,000 immediately from the new account and returned with her boyfriend, Cutler, to withdraw the remaining \$20,000.

• Oct. 13, 2022 - Bethlehem police were called to the SEFCU Slingerlands branch to investigate Parsons attempting to withdraw \$20,000 from the branch using a fake NY ID Card of another Male. Cutler, who was driving Parsons, was stopped trying to flee in a vehicle by police in the parking lot, gave officers a fake name because he had no license due to DWAI conviction. The vehicle also had no insurance.

Parsons and Cutler are arrested. Parsons has three outstanding warrants from Warren County.

• Oct. 14, 2022 - Bethlehem police interview Cannon and execute a search warrant at her residence. Police find a defaced and loaded handgun, cash and a large amount of concentrated cannabis and cannabis packaged for sale. She was arrested for the identity theft charges, but the Albany County Sheriff's office is investigating the weapon and drug charges.

• Oct. 21, 2022 - More victims have come forward and further charges are expected. The total money stolen exceeded \$100,000.

• Nov. 28, 2022 - Cannon is arrested on weapons charges.

• **Nov. 30, 2022 -** Bethlehem police report the case has been referred to the U.S. Attorney's Office.

• **Sept. 14, 2023 -** Cannon pleads guilty to federal charges of conspiracy to commit bank fraud and aggravated identity theft.

• **Sept. 21, 2023 -** Allah, Cutler, Devon and Taylor-Sterman are indicted by a federal grand jury.

also obtained personal identifying information of other people, which they used to fraudulently obtain loans from SEFCU and then withdraw the proceeds in cash," an Oct. 10 statement from the U.S. Attorney's office said. "The conspirators used fake New York State driver's licenses, with pictures of the conspirators but bearing the personal identifying information of others, during the loan application process.'

They then allegedly applied for and received approval for personal loans, receiving cash in the transactions. Police said the first of several transactions began when Parson and Cutler allegedly cashed a \$9,000 check at

the Glenmont branch in August and continued until the ring was broken in October.

The credit union said through a spokesman that it is continuing to monitor the situation.

"Maintaining the safety and security of our employees, members, and their assets is our top priority. We are cooperating with law enforcement to ensure this situation is resolved swiftly and justice is served," Jubie said in October 2022.

Bethlehem police originally charged Cutler with felonies of grand larceny, identity theft, possession of a forged instrument, falsifying business records and misdemeanors of false impersonation, criminal impersonation, operating a motor vehicle without insurance, conspiracy and aggravated unlicensed operation.

# Celebrating Emergency Nurses Week

Everyone, no matter how sick, injured, or

broken, deserves compassion and care no

matter what cards they were dealt in life.

ALBANY - Dynamic. Dedicated. Determined. These are just a few of the words Christine Pakish, MSN, RN, uses to describe the emergency nursing team at Albany Medical Center. As the assistant vice president of Emergency and Trauma Services, Pakish oversees a team of about 100 nurses—a close-knit group that cares for 80,000 Emergency Department (ED)

"Our patients can present at any time with any condition. Our nurses can handle any challenge that comes to them, and they have a great sense of morale," Pakish said. "They work very well as a unit, and they're always willing to do whatever it takes to get the job done."

These nurses are at the front line for the most critically sick and injured patients in our region. Albany Medical Center is the busiest Level 1 Trauma Center in the state and the only one in northeastern New York. In April, it was verified as a Level 1 Pediatric Trauma Center—the highest designation a hospital can attain after a rigorous review by the American College of Surgeons. Albany Medical Center's emergency services also include those of the Massry Family Children's Emergency Center, the only one of its kind in the area.

When a patient arrives at the ED, whether via ambulance, helicopter, or on foot, they are immediately evaluated for the level of care they need. Many times, life-saving intervention is the next step. Any patient, at any time, with any condition may turn to the ED. Emergency nurses are highly skilled and must be trained in various specialties. When they arrive for their shift, they receive their assignment. From there, they expect—and embrace—the unexpected.

"Our nurses must be skilled in a wide range of areas to evaluate, treat, and stabilize our patients," said Pakish,

who has worked in emergency medicine for nearly 30 years. "They must also navigate a fast-paced environment. An ambulance may arrive with a cardiac arrest one minute,

a helicopter may land with a trauma patient the next, and then a car accident comes over the radio. A day in the life of an emergency nurse is coming into an unexpected environment and an ever-

ED nurses define grace under intense

"I work well under pressure," said emergency nurse Fate Micarsos, RN, BSN. "I can maintain a level head when urgent needs arise. I love working in a fast-paced environment and can stay in control. And the ED is certainly a place to exercise those skills."

Colin Dalton, RN, is an emergency nurse who works the night shift. He became a nurse simply because he wanted to help people.

"Everyone, no matter how sick, injured, or broken,

deserves compassion and care no matter what cards they were dealt in life," he said. "My favorite part about being a nurse is being able to make a difference


in someone's life on their worst day."

Each October, this team is honored as part of Emergency Nurses Week, recognizing the dedication, compassion, and strength that emergency nurses display especially in the most challenging times. Wednesday, Oct. 11 is Emergency Nurses Day; and this year's theme for the day is

"Calling all Superheroes." This is a special theme for Pakish, who describes her nursing colleagues as superheroes.

"What makes us superheroes is what we can do, what decisions we can make in a split second and know what we can do to take care of that patient and get them treated," she said. "We don't call for outside help. We don't look for somebody from the outside to rescue us. It's like a firefighter. We're first in the building while everybody's running out. People look to us during what can be the most frightful point of their life and they look at us to save them, to comfort them, or even to hold their hand. Not everyone can say

Paris Jarrell, RN, BSN, who works the night shift in the pediatric emergency department, added, "We are superheroes because of our willingness to do whatever needs to be done for our patients, at any hour of the day, any day of the week. No, we don't swing from rooftop to rooftop or climb up tall buildings, but we save lives. Our patients and their families trust our hands to save and change the lives of their loved ones, and we summon the strength to do that on every shift. While we may be seen as superheroes, it is also important for everyone to remember that we are still human. Ours is one of the most rewarding



# New York Forward project takes one more step to the finish line

State representatives take a tour of the Delaware Avenue corridor

DELMAR – Town of Bethlehem officials took several individuals representing three New York State agencies on a tour on October 11 of Delaware Avenue's commercial corridor as the next step in the Town's effort to win a New York Forward grant. The Town seeks an award of \$4.5 million of State money to fund capital improvements.

Bethlehem's Director of Planning Rob Leslie reported that the evaluators wanted to see every site listed in the Town's application. Accompanied by representatives from Bethlehem's business community, the group took the opportunity to



describe what is sought to be accomplished at each site that was visited.

Leslie remains hopeful that Bethlehem will be an awardee this year. He said he understands the State needs to be persuaded how the proposed projects would be "transformative" and "revitalize the project area." Leslie said he hoped the

first hand visit did just that.

"We further emphasized that the grant is necessary to get the projects off the ground and to move along and we also emphasized that in the application this year," Leslie said. "Now, we wait until December or January for the grant decision."

# Open House addresses Kenwood traffic concerns

More input sought from residents, businesses and community groups impacted by traffic on the busy road

DELMAR – At Tuesday, Oct. 10, open house at Bethlehem's Town Hall, the town unveiled a set of potential solutions to pedestrian and traffic issues for the 2.2 mile Kenwood Avenue corridor between Delaware Avenue and the Delmar bypass. The proposed solutions, shared with about 30 attendees, specifically addressed issues elicited through public comments received by the town as part of its Kenwood Avenue Traffic Calming project.

Opening the meeting, Supervisor David VanLuven asked the attendees to consider, as they listened to the proposals, "How serious are we about slowing traffic on Kenwood Avenue?" He stated that traffic enforcement was not the answer. "We will never have enough police officers to enforce the speed limit on all 240 miles of roads in town all the time."

"If we are really serious about slowing traffic on Kenwood, we need to make changes to the roadway, and the challenge with that is that is a change to the roadway and we typically don't like change," said VanLuven.

Joe Cimino, one of the town's two consultants from CHA Consulting, presented a range of solution. He called some – that could be accomplished by the town alone – "low hanging fruit." Other proposals represented long range planning projects that would require future capital funding from the federal or state government.

Mike Hurtt, the other CHA consultant present, emphasized that the proposed solutions were made in response to specific concerns raised by the public.

The most significant concern was pedestrian safety. The most common pedestrian safety complaints involved the lack of adequate sidewalks, unsafe driver behavior, inadequate cross walks and buffers between sidewalks and traffic and bicycle accommodation.

At highly trafficked intersections, such as Adams Place, Delmar Place, and the entrance to Magee Park, the consultants proposed installing "mini-roundabouts." Hurtt explained that a mini-roundabout is a very compact and small central avenue that can be flush with the ground or slightly raised, so it keeps a "compact footprint." Although compact, it "is a great way to slow traffic because you still have to navigate around the roundabout and slow down," Hurtt said.

Other proposals involve widening and extending certain sidewalks, like those

near Bethlehem Central Middle School. Adding crosswalks, crossing signals, and high visibility markings to crosswalks and even placing "see me" flags at crossings also peppered the proposals.

For bicycle safety along Elsmere Avenue, Hurtt proposed putting sharrows on the road pavement that notifies drivers they share the road with bicycles and that "the bicyclists have a right to be on the road"

Parking issues at Magee Park at Kenwood Avenue and Route 32 were also addressed. Hurtt said the parking issues there caused obstructed vision when leaving the parking lot. He said people also unsafely walk in the street to get to the park from their cars when they are forced to park on the street due to insufficient parking in the park's lot. A formal parking lane, together with adding a sidewalk, was proposed so that park users could get from their cars to the park safely.

Some of the proposals, ones again described as "low hanging fruit," included crosswalks at Dumbarton Drive and the Waterline, sidewalks extended from Oakwood Place to Elsmere Avenue, a cross pad installed at Brookview Avenue, added speed radar warning devices and curb ramps with detectable warning pads on Elsmere Avenue, and shrub trimming to increase visibility, were already implemented over the summer.

Hurtt said that all of these proposals are "just for consideration" but "we are not leaving anything on the table." A second open house will be scheduled. A complete list of proposals can be found at www. kenwoodavestudy.com.

Van Luven said that the town is "looking for continued public input through Oct. 29 on the project website."

Bethlehem Director of Planning Rob Leslie said he was pleased with audience reactions to the proposals that were voiced during one-on-one interactions after the presentation.

"I felt everyone was interested in seeing the potential solutions," he said. "There was a lot of positive energy in the room."

However, he "would have liked to see more people attend." Leslie also encouraged the public to participate by viewing the open house videotape and submitting comments on the website.

After the comment period closes on Oct. 29, CHA will prepare a report for the town to use "as a planning study for projects that can be done at the town level and long range planning projects that would require funding," said Cimino. He hopes their report "would help with that funding."



## Feds charge local SEFCU suspects

misdemeanor criminal impersonation.

Cannon was charged with felonies of grand larceny, identity theft, possession of a forged

instrument, falsifying business records.

All four were arraigned in Bethlehem Town Court in October 2022 by Andrew Kirby and released on their own recognizance at that time. Parson was handed over to the Warren County Sheriff's office.

During the investigation, Cannon was also arrested on Monday, Nov. 28, after Sheriff's investigators and Bethlehem detectives executed a search warrant in October stemming from

the fraud investigation. During the search, investigators found Cannon to be in possession of an illegal .22 caliber handgun.

According to Albany County Sheriff Craig Apple, investigators found the weapon was defaced to remove the serial number and Cannon did not have a

permit to have a handgun. Further charges may be coming, he said.

In this incident, she was charged with two counts of criminal possession of a weapon, a felony, and one count of criminal possession of a weapon, a misdemeanor. She was arraigned in Colonie Town Court and released on her own recognizance.

## Drones over schools prompt calls

**SLINGERLANDS** - On Thursday, Oct. 12, Bethlehem police received reports of a drone being flown over Slingerlands Elementary, Eagle Elementary, and the Bethlehem Central High Schools. Officers responded and were able to locate the drone pilot.

The drone pilot was interviewed and provided his Federal Aviation Administration (FAA) credentials for drone operation and provided information regarding why he was flying the drone in the area. The pilot works for CoStar Group which is a commercial real estate company that assists commercial real estate buyers, sellers, and investors.

Detectives did conduct an investigation into the matter which included contacting the FAA, verifying the pilot's credentials and discussing regulations regarding drone activities.

The CoStar Group was also contacted regarding notifications to the Bethlehem School District and the Bethlehem Police Department regarding future activities that require them to fly over school grounds.

According to the FAA, the drone pilot has the legal authority to fly the drone over these locations as they are not designated "no fly zones".

## Felony DWI on **Delaware** Avenue

DELMAR - Bethlehem police observed a gray 2020 Nissan Rouge traveling at a high rate of speed on Route 85 on Saturday, October 7 at 1:48 a.m.

According to reports, officers clocked the vehicle with radar traveling at 75 mph in a posted 55 mph

The officers stopped the vehicle on Delaware Avenue. While interviewing the driver, Michael Ragone, 45, of Clarksville, officers observed him to have bloodshot and watery eyes and an odor of an alcoholic beverage emanating from his breath. He told police that he had two Heineken beers at 9:30 p.m.

He was given and failed field sobriety tests and tested positive for breath alcohol on a pre-screening device.

At the police station he provided a breath sample that returned a .06 percent BAC.

He was charged with DWAI, a misdemeanor, but because Ragone had a prior conviction for DWI in the past 10 years, he was charged with felony DWI.

Ragone was also ticketed for speeding. He was given an appearance ticket and a bill of particulars and released.

# Motown and more at Proctors

Benefit concert featuring Doc Horton and the Jay Street Band to support organization that promotes music as an antidote to violence

Horton and DJ Hollyw8D
are teaming up to bring
"The Motown and More
Experience" to Proctors. The
concert, to be held Sunday,
Oct. 22, is a fundraiser for
DJ Hollyw8D's non-profit
organization, More Music
Less Violence, and will also
serve as a platform to debut
Horton's solo single "Reality."

More Music Less Violence, according to its website, focuses on creating a new era of musicians through non-violent expressions. The initiative helps to create a curated lineup of musicians to perform in front of an audience in a safe zone while building a community in a positive environment. Its mission is to create a world and have music as a tool to inspire unity and collaboration through the arts and music.

More Music Less Violence" appealed to "Doc" Horton ("Doc" as he likes to be

called), and he greatly admired the work that DJ Hollyw8D does for the cause.

"In order for human civilization to survive, it is necessary for adults to invest in the social, intellectual, emotional and spiritual development of youth. The most important investment is time," Horton said. "DJ HollyW8D provides a great service

to the community with his organization More Music Less Violence."

Horton reached out to DJ HollyW8D to collaborate with him on the creation of a benefit concert. The show will feature music from Horton's band, Doc Horton and The Jay Street Band. In addition to Horton, the band's current lineup includes Randall Martin, Silas Blackmon, Dan Goss, Calvin Young, Ky McClinton and Enoch Thompson.

## Who is Hayward Derrick "Doc" Horton?

Horton, a Niskayuna resident and a professor at the University of Albany, is originally from Norfolk, Va. In Fall of 1977, Horton, a senior at the time, was in the midst of completing classes for his bachelor's degree at Norfolk State University when he came up with his original song, "Reality."

At the time, he was concerned about

the state of the world, and he composed and wrote "Reality" in a similar vibe as the Marvin Gaye song "What's Going On?"

"Ironically, I wasn't thinking about Marvin. I was thinking LIKE Marvin," he said. "Reality' is a call to everybody to care about everybody and to treat each other as human beings. In reality (pun intended) we don't! That message is just as relevant today as it was in 1977."

#### **Collaboration With a Producer**

Horton met a young producer, Rothstein Beatz, through Clubhouse, and like him, was a Norfolk State graduate. Beatz worked with Horton in modernizing the song lyrics and the melodies that he created for his songs, including "Reality." Horton called Beatz a musical genius.

Horton is following Beatz's guidance into further developing his musical career at the national level. Although he has plenty of songs that can be used for three albums, he said he will release a new song every six months, allowing each song to breathe while building his following.

Once the demand is there for Horton's original content, he will release his first album.

#### The "Reality" Tour

Horton will release "Reality" Friday, Oct. 20, on all digital platforms, including his own "Doc Horton" app also released on the same day. Horton and his band will take their "Reality" tour first to Proctors, Frog

Alley Brewing Company (Dec. 15) where they will open for The Refrigerators, and in January 2024, Horton is booked for a solo show at Caffe Lena. After the Proctors show, he will return to Norfolk, Va., for a show.

Horton is also planning on making a music video for "Reality" in the future. At some point, he will have a touring band and plans to hire local musicians for each venue for his national tours. For now, Doc Horton and the Jay Street Band will perform in the Capital District and surrounding areas.

#### **Doc Horton and the Jay Street Band**

Doc Horton and the Jay Street Band have played all over the Capital District in its many configurations for 11 years. Horton recently produced shows at both the Taj Mahal and the Electric City Barn in Schenectady and had previously performed at the Renaissance Hotel in Albany, The NAACP Martin Luther King Celebration in Saratoga, The Albany Capital Rep, Jazz on Jay, The Troy Community Softball Festival, The Juneteenth Festival in Hudson, and other Capital District open mics.

The Motown and More Experience tickets are currently available at the Proctors box office and can be purchased in advance or on the day of the show. Advanced tickets are \$16.50 for adults, \$11.50 for children 12 years of age and younger. Day of show: \$21.50 for adults and \$16.50 for children. ## Mia x Ally hatch new tour

Albany area. "I'm excited to be bringing this duo project into my home. Having it sell out first and quickly makes me feel so positive. I'm really grateful for the local support."

From crowd favorites to original music, everything from their first "Shipping Up to Boston" tour is magnified on "The Devil Went Down to Georgia" tour. The show's atmosphere is designed to be upbeat, fun and energetic, with lights and even humor, during a section where both Asano and Duncan try to play each other's instruments.

"It's a rock show. People don't expect that. There's a lot of connotation that comes from these two traditional instruments," said Asano. "Both of us have a lot of respect for these instruments.'

Both classically trained musicians, their aspiration is to pay homage to Irish and Scottish music, rock, and more while simultaneously pushing the boundaries of what is possible, individually and together.

"We have such a deep respect for our roots," said Crowley-Duncan.

As a multi-instrumentalist, Crowley-Duncan began an interest in bagpiping after connecting to her adopted family's Scottish heritage. When the COVID-19 pandemic began, she started performing Scottish and Irish music on Facebook livestreams for her friends. After noticing how people enjoyed it, she branched out to the wider audience of Tik Tok and found viral success.

Colorado-born Asano began playing violin when she was 5, continuing to play classical music for the next 17 years. At 13, she discovered electric violins and "became obsessed" with contemporary styles of violin music, from bluegrass to pop. In 2020, she started posting on Tik Tok and went viral, right after Ally's first viral moment in November.

It was through Tik Tok that they first discovered each other's work.

"We were fans of each other," said Asano.

Asano's cover of the Wellerman Sea Shanty initially connected them together.

"I had such admiration for the kind of content she was making," said Crowley-Duncan. "I felt like we had a lot of similarities with where we were going with taking our niche instruments on the app. We just started duetting each other's videos, and it

people," said Asano.

"Those videos became so popular," she added. "Together on stage, there is just this really magical energy. There's this undeniable chemistry that people picked up on. We realized that we have something special here, so we felt the need to pursue it and share it with the world."

In addition to their own separate careers and tours, the duo Mia x Ally has enabled them and their music to flourish in a supportive environment. Asano and Crowley-Duncan referred to each other as "sisters" and

"best friends."

"We've been able to grow, separately and together," said Crowley-Duncan. "It's this beautiful thing.'

"It's this very unique situation where we're both established as individual artists, and that's how we started out," said Asano. "But together, we have this really special thing. Mia x Ally happens when we're in the same room making music together!"

For their new album "Mia x Ally: The Viral Hits," Crowley-Duncan and Asano curated a mix of fan and personal favorites. Two songs on the album that were written specifically for electric

violin and bagpipes allow them to marry traditional music with their unique sound.

"There's so much meaning within the selections for the album," said Crowley-Duncan.

"We like naming our tours after the places we're visiting. We're carrying on the theme for this one," said Asano.

A theme that is also essential to them in all of their work is suicide prevention, awareness, and support. Asano dedicated six months of streaming proceeds from her cover of the Power Rangers theme song to the

American Foundation for Suicide Prevention in honor of actor Jason David Frank. The song will be performed at the show and ties into their personal mission of raising awareness.

"Mental health struggles are so widespread," said Crowley-Duncan. "Suicide is so widespread that, unfortunately, most people have a connection to or have lost someone. We want to make sure that as we grow as artists, that personal connection to the things that have shaped us as artists and people is still part of what we're standing for."

Asano highlighted the intention and love behind all their work, citing her appreciation for their fans' open-mindedness and support.

"It's something that's really special for both of us," she



The Spot 518: Where does the Hillberry Festival take place? What is the festival all

*Rix:* We are in Arkansas. Oftentimes, these festivals are, you know, threeday festivals where the audience comes in. Most of them camp for the whole weekend, and there are bands all weekend in multiple stages, and we are out in the middle of nowhere on some farm or in some big field, so I don't know where I am really! Today, I know we're in Eureka Springs, Ark. I believe we did play this festival years ago as well. Tomorrow, we'll be heading to a different festival in

The Spot 518: How many music festivals does your band take part in a year?

Rix: I don't have a good count on that, but every summer, really starting in the spring, festival season begins and by the time June is over, we have pretty much quit doing routed tours and are flying from festival to festival for most of the summer. This year, it went longer than most. We're still doing festivals through October. We'll start a proper tour on a bus where it's five or six shows a week, sleeping on the bus, at the end of October.

Festival season is long weekends, usually Thursday through Monday, and we'll play one to three festivals, usually in different states so it requires flying in between them. By the time festival season is done, we are really ready to get back to bus touring, where we always have all our own gear, all our own light show, and a bus to be home away from home. And then come spring, it's a nice change to get outdoors and play festivals again.

The Spot 518: Do you enjoy performing at festivals more or the bus tours? Or both?

Rix: It's good we get to switch it up. Keeps us on our toes. If we had to pick

one, we'd probably pick bus tours where we can do our whole show every night and we have all our gear. But after having everything so dialed in, it's good to get thrown into the sometimes uncomfortable situations of playing on backline gear, not really knowing what you're going to get and having to adjust to changes in some discomfort aka festivals. It's good for the music and it's good for life and our sanity to be a little uncomfortable. Good for

The Spot 518: How is your tour going so far for you and your band? What was the creative process like in the making of this new album?

Rix: Tour is great right now, one reason being, we have started working on new music for what will be the next record. Over time, we've realized that having a creative musical endeavor during the tour, that is in addition to the show itself, really helps keep the show fresh every night. It keeps us inspired so the process backstage, and in soundcheck, of working on new ideas, gives the show a fresh energy each night. It puts our heads and hearts in a different place after exploring new music. So when we play the material from all our previous albums, it feels new again.

The process of creating the music for our latest record, "Heart is the Hero," took place on the road for much of it. It was the first time we did so much of that. But we all worked on our own as well and got together in Nashville a few times in between tours to flesh out ideas. Some ideas we'd record on our own and send to each other and see if they created a spark. So it went in all directions between us. But we did a lot of rehearing on the road for this last album, which was new to us. But it was very intentional, one reason being we decided we would record to 16-track analog tape, which is one of the best



sounding ways to record, but also limiting, in the best ways as far as the process goes, which was the most important intention behind it. Long story short, we were trying to be able to play everything live in one take as much as we could for this record. No editing after the fact if possible.

TheSpot518: Will you be performing all of your new songs from the album at the Palace Theatre stage as well as some older songs?

Rix: We are playing many songs from the new album but mixing it up. We try to make every tour and each night different. Also there are many songs from our catalog that people really want to hear, so we will include some of those every night, as well as mixing everything up each night. We make a different setlist every night. If the previous night was not that far away from where we are, in case people are coming to both shows, we want to make sure we give them a new experience, and we also look at what we played the previous year in that city and try to make it different. And we try to keep it fresh for ourselves and a little challenging in that way. Our new thing is to try to pull out an old song that we haven't done in a long time each night and challenge

TheSpot518: How many albums, including your new album have been released?

Rix: I've been a member of the Wood Brothers for more than 12 years, so it's been a lot! Looks like we have 12 records, some are live records.

TheSpot518: Why did you decide to record the songs on the 16-track analog tape compared to composing the songs on

Rix: Recording to tape, and 16-track in particular, is actually more about process than sound for us at this point. Yes it does sound amazing, and no, there isn't anything quite like it, though plug-ins can get very similar sounds close to it. But the real point is the process. We had no screens on during the entire making of the



record. And there's nothing wrong with screens, except ... in practice, they're kind to us. You end up staring at the screen, energy goes way down, it's easier to fall into a psychological low energy funk of sorts. You spend a lot more time in editing and analysis mode, less in playing creating mode. The results can be good, but they are never the same as playing more and playing a great take. Don't get me wrong, you can make a great record that way. It just isn't the same feeling from the music.

TheSpot518: Tell me a little about your opening act who will be performing at the Palace Theatre.

*Rix:* Maya de Vitry is a badass human and artist. We met her first when she was a member of The Stray Birds and they did a tour opening for us years ago. She's soulful, honest. She's in the "Americana" genre.

TheSpot518: How are you enjoying being a member of The Wood Brothers?

Rix: The Wood Brothers were my favorite modern day band before I joined them over a decade ago, so that was a very surreal experience at the beginning. I couldn't be luckier, in that the music is creative on a level and full of influences that I love. It is always evolving and it turns out they and the whole organization from management to touring crew to Chris and Oliver are full of trust and kindness. We've all been at it a while so we've learned what kind of world we want to live in and try to create that.

TheSpot518: What bands were you previously with prior to The Wood Brothers?

Rix: The longest was a band called the Gabe Dixon Band. Lizz Wright,

Rix: I don't know, but a few times. I remember seeing an amazing rainbow out

I work in a different place, pretty much in a different state almost everyday of my life for over 20 years, so even the most ornate theater can sometimes get filled in memory like another line on the highway. I do remember a good vibe and I know it's a beautiful space ... But that rainbow!

TheSpot518: What was it like working with Loggins and Messina?

Rix: Loggins and Messina was a trip. That was the first time I had my own tech to set up my whole rig, etc. It was a learning experience, different from anything I'd done prior. It had its good and bad but, glad I did it.

TheSpot518: Will you be going overseas for the new album?

Rix: Next year, we are headed to Europe, but still for this album cycle. The Wood Brothers haven't been overseas in a while, it will be a nice change and excited to see if they remember us.

TheSpot518: What can fans anticipate when they go to the Palace Theatre for your show?

Rix: We'll go on a journey together with new songs and old. We'll laugh, we'll cry. For real though, we'll just all try to be present and connect and be with the uniqueness of the

ALBANY – The 2023 Albany Medical Center Prize in Medicine and Biomedical Research has been awarded to three scientists whose research has advanced the study and understanding of the microbiome, bacteria, and how they communicate in the body and their role in disease and health.

They accepted the award at a special ceremony in Albany on Oct. 5.

The recipients are:

- Bonnie L. Bassler, PhD, Squibb Professor & Chair, Department of Molecular Biology, Princeton University; Investigator, Howard Hughes Medical Institute
- Jeffrey I. Gordon, MD, Dr. Robert J. Glaser Distinguished University Professor, Director, The Edison Family Center for Genome Sciences & Systems Biology, Washington University School of Medicine
- Dennis L. Kasper, MD, William Ellery Channing Professor of Medicine, Professor

of Immunology, Harvard Medical School; Senior Physician, Brigham and Women's Hospital

The collective work of Drs. Bassler, Gordon, and Kasper has helped the world understand the roles played by our microbiomes – the complex and dynamic communities of microorganisms with their vast arsenal of microbial genes that dwell in different locations in our body.

Dr. Bassler pioneered investigating how bacteria "talk" to each other across species and coordinate their behavior. Her work has shown that disrupting this communication can prevent bacterial infection, paving the way for new antibiotics.

Dr. Gordon developed the field of human microbiome research and revolutionized our understanding of how variations in gut microbial communities affect health and disease – including the nutritional status of infants and children living in low-income countries – and how this knowledge can

yield new approaches for treating the global health challenge of malnutrition.

Dr. Kasper was the first to discover that the gut microbiome was critical to development and modulation of the immune system and to explain the mechanisms for this interaction, which is vital to health. The findings of his work have implications for a range of immunemediated disorders, including inflammatory bowel disease, rheumatoid arthritis, and lupus.

Each scientist is credited with advancing this scientific area of study that began more than 150 years ago. Their research impacts myriad facets of human biology throughout our lifespans.

"I am honored to present the Albany Prize to three pioneering scientists whose work has led to greater knowledge of the microbiome and its impact on gut health and disease, immune system function, immune-mediated diseases, and nutrition," said Alan S. Boulos, MD '94, The Lynne and Mark D. Groban, MD '67 Distinguished Dean of Albany Medical College and chair of the National Selection Committee. "Their work is leading to advances in research and improved global health, including our ability to battle infectious diseases and potentially other common human conditions."

In 2000, the Marty and Dorothy Silverman Foundation dedicated \$50 million to award the \$500,000 Albany Prize annually for 100 years. It is intended to encourage and recognize extraordinary and sustained contributions to improving health care while promoting innovative biomedical research. It is one of the most significant prizes in medicine and science in the United States. Drs. Bassler, Gordon, and Kasper will share the prize.

Each recipient is nominated by their peers.

"Dr. Bassler's research provides a completely new way to think about microbes

and, moreover, how to combat them. Pathogenic bacteria claim millions of human lives per year," wrote Ned S. Wingreen, PhD, associate director of the Princeton Center for Theoretical Science, who nominated Dr. Bassler. "Quorum sensing [cell-to-cell communication] plays an essential role in virulence. We know this, in large part, because of Bonnie Bassler's extraordinary research. She has provided humanity with unprecedented new possibilities for antimicrobial development."

In his nomination of Dr. Gordon, David Perlmutter, MD, Washington University's executive vice chancellor for Medical Affairs, wrote, "Global food insecurity is forecast to sharply increase due to such factors as climate change, health and economic disparities, land and water shortages, and geopolitical upheaval. Dr. Gordon's pioneering interdisciplinary work

at the interface between microbial science, food science, and nutritional science is creating new approaches for addressing this challenge."

Anthony S. Fauci, MD, former director of the National Institute of Allergy and Infectious Diseases and a distinguished university professor at Georgetown University's School of Medicine and McCourt School of Public Policy, nominated Dr. Kasper, writing, "He has discovered and highlighted key molecules that have important therapeutic potential. Most importantly, he has provided a central understanding of the vast importance of the microbiome in the development and regulation of the immune system. His work provided mechanistic insights and pathways of exploration for others to investigate the immune and other organ systems.

## **Two Past Albany Prize Recipients Awarded 2023 Nobel Prize**

ALBANY - Katalin Karikó, PhD and Drew Weissman, MD, PhD, who received the 2021 Albany Medical Center Prize in Medicine and Biomedical Research, have been awarded the 2023 Nobel Prize in Physiology or Medicine.

In making the announcement, the committee noted that Drs. Karikó and Weissman were awarded the Nobel Prize for their discoveries "that enabled the development of effective mRNA vaccines against Covid-19."

"Through their groundbreaking findings, which have fundamentally changed our understanding of how mRNA interacts with our immune system, the laureates contributed to the unprecedented rate of vaccine development during one of the greatest threats to human health in modern times," the announcement

Together with Barney Graham, MD, PhD, Drs. Karikó and Weissman were awarded the 2021 Albany Prize for their critical roles in accelerating the development of two mRNA

The Albany Prize is awarded annually to a physician, scientist, or group whose work has led to significant advances in health care and scientific research with demonstrated translational benefits for improved patient care.

Two previous Nobel Prize winners have been among the ranks of researchers honored by the Albany Prize. Ten Albany Prize recipients have now gone on to win the Nobel Prize.





## Healthy soup offers many different benefits

ood is a critical component of healthy living, helping people to reduce their risk for illnesses and even helping them to overcome colds and other ailments. The properties of soup, for example, can chase away chills and offer other benefits. Soup is hydrating, and the ingredients included in the recipe may be able to do everything from tame coughs to reduce mucus to boost the immune system.

This recipe for "Navy Bean and Collard Greens Soup" courtesy of John La Puma, M.D., ChefMD, includes collard greens. When one chops or chews collard greens, he or she gets the powerful, helpful chemicals isothiocyanates and indole-3-carbinol. They can help the liver produce enzymes that detoxify cancercausing toxins in the body. In addition, the soup includes tofu, which will adopt the flavor of other ingredients and add a form of lean protein along with the beans.


### **Navy Bean and Collard Greens Soup**

- cups vegetable broth, such as Pacific Organic brand
- cups coarsely chopped stemmed collard greens, preferably organic (1 bunch 10 to 12 ounces)
- 1-1/2 cup packaged julienned (matchstick) carrots
- 1–1/2 teaspoons chili garlic puree or chili paste with garlic
- (12 ounce) package extra firm tofu, cubed in bite size pieces
- (16 ounce) can unsalted navy beans,
- cup grated Romano cheese

Combine broth, collard greens, carrots, and chili garlic puree in a large saucepan. Bring to a boil over high heat. Reduce heat; cover and simmer 10 to 12 minutes or until greens are nearly tender. Stir in tofu and beans; cover and simmer 5 minutes or until vegetables are tender. Ladle into shallow bowls; top with cheese.

Tips: Great northern or cannellini beans may replace the navy beans and Swiss chard may replace the collard greens if desired. Also, look for chili garlic puree or

chili paste with garlic in the ethnic section of the supermarket. Because the beans are unsalted, there is no need to rinse them before
