Legislature floats new drone law



Local Breslin and Fahy introduce law to restrict flying drones over schools and critical infrastructure after BC incident

DELMAR - An October 12 incident over three Bethlehem schools prompted a quick response from local State lawmakers in introducing a law to restrict unauthorized drones from

Three Town Board candidates vie for voters

Town Highway Superintendent candidates also gave statements

DELMAR — Amid sparring over one candidate's failure to file a required campaign report and accusations about brackish water in the town water supply and other water/air contamination, the League of Women Voters, Bethlehem Chamber of Commerce and Spotlight News presented a forum on October 24 showcasing candidates for Town office this year.

Both Highway Superintendent and three town board candidates appeared at Bethlehem Town Hall to field questions from voters. The event featured Town Board candidates Joyce Becker, Kellin Rowlands and Tom Schnurr and highway candidates Marc

Dorsey and Craig Sluers. All candidates were invited, but only three of the four candidates running accepted. Republican Theresa O'Neill declined the invitation to speak to voters.

Candidates answered questions from voters that had been submitted by October 16 through a digital lock box or at the in-person event itself. Each question was required to be topical in nature and not directed to any candidate. Each candidate answered the same question.

Incumbent Board member Becker, a democrat, is seeking her third, four year term in office, the other incumbent, Dan Coffey, chose not to run again. The other candidates — Rowlands, representing the Uniting Bethlehem Party, has no prior political experience and Schnurr, a democrat, is a member of the Bethlehem Democratic Committee. The election will fill two



seats on the board.

The Uniting Bethlehem party was recently created through Rowland's petition process. After a two-month court battle with the Albany County Board of Elections, he and the party will appear on the ballot. The BOE challenged the validity of signatures presented in the nominating petition and disqualified Rowland, but a court order reversed the decision of the BOE. The BOE appealed and lost in a 5-0 decision. In the end, Rowlands had 20 valid signatures more than the required number of 928.

During the questioning, the three candidates for Town Board agreed on

several issues, such as each other candidate's dedication to do what's right for the town, their passion and desire to make the town better. They also agreed that some issues raised would need further study and analysis, such as whether to create a public safety commissioner to oversee all emergency responders, the impact of short term rentals and need for additional water infrastructure.

None of the candidates opposed the Town library holding a drag queen story hour.

They also all agreed that the Republican candidate who declined to join the forum either should have

been there or, as Becker stated, "missed out on a wonderful opportunity."

However, the candidates significantly diverged on how open and accessible the Town's Board is to the concerns of residents. Rowlands stated "the poster child for why I sit here is the Town's lack of responsiveness to the concerns of its citizens," referring specifically to real property involving the Port of Albany.

During the forum, Rowlands fell back upon the Port project several times to demonstrate what he believes to be the current town board's lack of responsiveness and resident lack of access.

He claimed the Town has failed to take action about "toxic heavy metals" he claims have been leached from the Beacon Island CCR landfill into the Normanskill, Hudson River and around Glenmont from burning coal over time and endangering

residents in Glenmont. Rowlands cited no specific report or data. Becker stated that the Town Board has no authority to make decisions on that property and referred residents go online where they can find guidelines for the port project and research testing of water and air.

Spotlight News reviewed documents from the Port of Albany project and could not find any water testing that showed chemicals or metals leaking into the rivers.

Becker also rejoined that she is "always willing to listen" and noted that the Town Board often allows speakers at Town Board meetings to exceed their prescribed "three minute limit to hear concerns of residents."

"If I get an email from a resident I will respond," she said. She also later cited the recent Heath Farm land project as an example of

Legislature floats new drone law

operating in low-altitude airspace over schools and critical infrastructure.

There are currently no restrictions in New York for licensed operators to fly drones below 400 feet near schools or infrastructure such as power and chemical plants, refineries, dams, pipelines, fuel storage facilities or drinking water treatment plants. On Thursday, October 26, officials gathered at Eagle Elementary School to announce a proposed State law to change that.

"At a time when safety concerns are a top concern of parents, the use of any unauthorized drone over a school is unacceptable and poses potential threats to privacy and security," said the bill's co-sponsor Assemblymember Patricia Fahy (D-Albany) in a statement. "I commend the (Bethlehem) Superintendent for alerting us to this problem and I am pleased we could act immediately to address it."

In the Bethlehem schools incident, police received multiple reports of a drone flying over Slingerlands and

Eagle Elementary schools and the High School while school was in session, but close to dismissal.

This was one day after the attacks in Israel and tensions in the community were high. Bethlehem School Resource Officers and Det. Michael Berben and Det. Caitlyn Krage were able to locate the pilot of the drone.

"We were notified by principal Baker that there was a drone over Slingerlands elementary," Berben said. "At that time, we made swift action and notified school officials to have a response to get children inside and figure out the location where this drone was being operated from. We were able to identify that and found out the reason and cause for it."

According to police, the man, who worked for a commercial real estate company, CoStar Group, was taking aerial photos of the schools and was licensed by the Federal Aviation Administration (FAA). CoStar is company that assists commercial real estate buyers, sellers, and investors.

During the investigation,



Berben contacted the FAA and found out that schools were not designated as "no-fly zones" and the pilot did not need authorization to fly over them.

According to the FAA, drones are legal to fly at altitudes below 400 feet in most places. A drone cannot fly near airports or military installations that are designated on a FAA mapping system. Many drones have the GPS coordinates of the maps programmed into them and will not allow the pilot to fly there.

Schools and other critical infrastructure such as power, water, sewer and chemical plants and power substations are not on the maps. The new State law would add a local layer of restrictions below 400 feet.

"I was quite surprised that

there were no restrictions under 400 feet. Over 400 feet, that is regulated by the FAA," Fahy said. She also said that it has made it permissible for local municipalities to regulate that air space.

Although the process of passing the law has begun, there is still much to do.

"There is a great deal of work to be done to make it an effective and complete law," State Senator Neil Breslin, D-Bethlehem, said.

Breslin explained there are many complexities involved in making sure all angles are covered and that it can be properly enforced.

He said his staff was analyzing the topic and engaging experts before developing the final language.

"To find out that any licensed drone operator can map the layout of any school

at any time has been deeply unsettling," Bethlehem Superintendent Jody Monroe said.

"This legislation will give schools a layer of protection that does not currently exist."

One of the things people may not realize is that drones are used in other parts of the world to carry more than cameras and are used in war, Berben said.

"While this situation was legitimate, we were surprised after speaking with (the FAA) at how few restrictions there are," He said.

The CoStar Group was also contacted regarding notifications to the Bethlehem School District and the Bethlehem Police Department regarding future activities that require them to fly over school grounds, Deputy Chief James Rexford said in a statement.

"This is another one of those situations where you have a great product and some great technology, but along with that comes some unintended consequences and many people have become enthusiasts," Albany County Sheriff Craig Apple said. "We need to protect our infrastructure, especially our most valuable and vulnerable infrastructure which is housed in the buildings

behind me, our kids. We want to keep them safe."

"We need to think about where drones are and aren't allowed and where they do and don't belong because our technology is evolving more rapidly than our cultural norms and laws are able to account for," Bethlehem Town Supervisor David Vanluven said. "This sometimes creates great challenges."

Both North and South Colonie Schools fall into the category as Bethlehem, but many of their school buildings are within more restricted airspace surrounding the Albany International Airport.

For example, the restrictions limit drones to 100 feet near Colonie High School and 250 feet near Shaker High School due to the proximity to the aircraft flight paths, instead of the 400 feet maximum in unrestricted zones.

"We need to think about where drones are and aren't allowed and where they do and don't belong because our technology is evolving more rapidly than our cultural norms and laws are able to account for," Bethlehem Town Supervisor David Vanluven said. "This sometimes creates great challenges."

Learn about Kenwood Ave project and make your voice heard

To the Editor-

I recently watched a town meeting where they discussed proposed changes to Kenwood Avenue between the bypass and Delaware Avenue. Supervisor VanLuven mentioned that the main objective of these changes is to reduce the speed of traffic on Kenwood Avenue, which is currently known as one of the fastest roads in town. He also mentioned that some people may oppose any change simply because they dislike it. While I understand that there may be an issue with speeding for drivers exiting the bypass, I was unaware that speeding was a problem all along the stretch. I was hoping that pedestrian accessibility and safety would be the primary focus of the redesign. There is a

portion of the road that is so thin, that a pedestrian was hit by the rear view mirror of a car. Moreover, I respectfully disagree with the notion that opposition to change is solely due to aversion. In fact, many of us welcome change when it aligns with the majority's interests and enhances our community.

The proposal to install mini roundabouts at various locations along Kenwood Avenue, such as Adams Place, Delmar Place, Oakwood Place (near the Middle School), Elsmere Avenue, Dumbarton Drive, and Winne Place, has been put forward. While I understand that this is just one of the solutions being considered and is a more long term solution, I believe the other alternatives

are more suitable. Mini roundabouts may be the latest trend in traffic management, but their implementation on Kenwood Avenue raises several concerns. These roundabouts can be challenging for pedestrians to navigate and may create additional difficulties for drivers, especially when they need to yield to pedestrians in close proximity to a roundabout entrance or exit. This situation could be particularly problematic for school students and cyclists. Additionally, the increased traffic redirection caused by roundabouts might lead to cars cutting through side streets to reach Adams Place, creating potential safety issues.

The road is well-traveled by students attending Bethlehem Middle School and

St. Thomas School, and it is crucial that we prioritize their safety. Rather than focusing solely on speed reduction, we should concentrate on making the road safer for those who walk to school and navigate the busy intersections. I encourage the town to consider lower-cost alternatives that promote safety while still addressing the concerns related to speed. These alternatives should enhance the overall pedestrian experience and reduce the risk for students traveling to school.

I strongly urge all residents to visit the town website to voice their opinions on this matter.

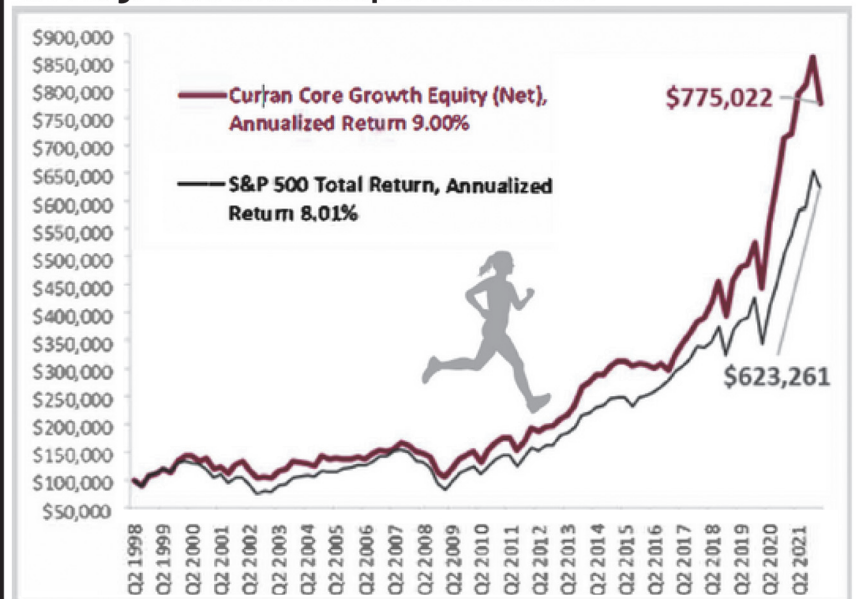

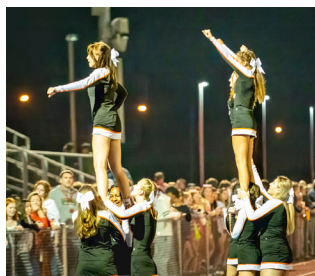

town resident participation in town governance.

Rowlands later praised the Heath Farm process of “civil engagement” that he called successful, but said the project was “a misuse of resources.” Both Schnurr and Becker enthusiastically supported Proposition 2 that allowed the town to purchase the Heath Farm property and to secure open space for the Town.

Schnurr recognized the “fantastic work of town staff”, but acknowledged there is “a need for a better system of resident input and to track those issues.” He said he would work to put such a system in place and to increase “information sharing” by “getting notices out to communities better” and “engaging in different forums around town.”

Rowlands also claimed that Glenmont residents do not have “access to high quality water”, that “in several instances Town of Bethlehem water is semi potable and brackish” and that he is concerned about “contamination of heavy metals in the drinking water.” Both Schnurr and Becker said they had not heard that.

In a phone call on Thursday, Oct. 26, Rowlands pulled back some of his comments.

“I was not accurate on my comment about the water being brackish,” he said.

Also Rowlands said that someone sent him data on social media about the heavy metal contamination of the public water. He said he would find it and send it to Spotlight News. He has not done so at deadline.

Spotlight News reviewed the water quality reports found on the Town’s website at townofbethlehem.

org/719Water-Quality Reports and they showed no such contamination or brackish water in the Town water system.

“Assertions that the Town water supply is brackish (meaning it has high levels of salt, like ocean water mixed with river water) or contains heavy metals are inaccurate”, Town Deputy Commissioner of Public Works Paul Penman said when reached for comment on the claim that the Town’s water was brackish or contained heavy metals.

Another source of contention during the forum involved Rowlands’ failure to file certain campaign finance reports.

Early on in the forum, Schnurr alluded to that issue by referring to voter need to “know where support comes from” and to follow the laws on transparency. He said, “it is hard to write laws if you’re not going to follow them.”

Schnurr later repeated

that assertion in response to a submitted question that asked the candidates about how their campaigns were financed and whether they had filed their state campaign finance reports in a timely manner.

After Schnurr said he had filed his, Rowlands stated, “I wish I could say the same” and admitted that he had been “derelict and delayed” in “at least one of my filings.” He blamed his omission on not having a “legacy infrastructure upon which to draw” because he is an unaffiliated candidate. He further stated that as an unaffiliated candidate, “I am accountable to myself. I do my own finances. I am writing the rules to be an unaffiliated candidate because it is largely without precedent and at the end of the day I am more than happy to stand up here or in any other forum and take full accountability for anything I may have shortcomings in.” He did not state that he would make the requisite filings.

Schnurr then pointed out that “the rules apply to everyone”, “are not new, they are not hidden” and were written by the State of New York, not a political party. Ultimately, Rowlands agreed that “the rules do need to apply to everyone” and “do need to apply to me.”

Highway Superintendent candidates Dorsey and Sleurs read prepared statements.

Dorsey, who highlighted his construction work background, touted the accomplishments of his last two terms as Highway Superintendent. He named building department morale, extensive re-paving of town roads, continuing waste and garbage pick up during covid, renovations to the town fueling station, and the construction of new sidewalks among those achievements.

While Dorsey recognized that both he and his rival “love the town” and have been “life-long residents”, he said that

he has “become a proven leader.” If elected, he said would reduce the use of road salt and strive to make operations more energy efficient.

Sleurs opened his statement by focusing on his over 38 years of fire service and his and his family’s long and strong community ties. He promised that, if elected, he would “do my best to make the town a better place” by managing the budget and looking for ways to save money.

He also promised residents “if you call about an issue I will meet with you and work with you as a stakeholder to resolve the problems to the best of my ability.” He said he has already heard a lot of concerns about traffic safety and would work to “provide low cost, effective solutions.”

REVIEW: Mia x Ally at The Egg

Shaker HS Alumni hatched first show of "The Devil Went Down to Georgia" Tour

ALBANY - The egg has hatched and out came a beautiful concert from viral sensations, Mia Asano and Ally Crowley-Duncan (aka Ally The Piper) at the Hart Theatre.

The Egg Performing Arts Center was the launch pad for "The Devil Went Down To Georgia" tour. The ladies, alongside drummer Dominic Marraffa III and Dov Beck-Levine on guitar, were loud and proud, with solid songs heard in two performance sets and an encore performance of "Through The Fire and Flames" as a tribute to DragonForce.

After the Albany show, Mia x Ally brought their tour to New York City, Virginia, and North and South Carolina. Starting Nov. 2, the quartet will perform at Jack Rabbits in Jacksonville, FL. The next New York show for them will be at the Wescott Theater in Syracuse January 11.

From starting out as a member of the Capital District Youth Pipe Band to viral stardom, Crowley-Duncan is proud of where she began her career. She showed fans and residents where she originally began her career as a competitive bagpiper by having members of CDYBP, alongside director Maureen Connor, perform two routines alongside drummers and bagpipers at the end of intermission.

Pre-Show VIP Experience with Mia and Ally

Prior to the show start, fans who purchased VIP tickets were treated to a meet and greet with Asano and Crowley-Duncan. The ladies stood at a small circular table handing out stickers, VIP badges, signed a VIP only photograph and posed for selfies. Fans also took advantage of their time to purchase band merchandise as well.

TheSpot518 was the first arts and entertainment publication to interview Mia and Ally prior to their Albany show, and were the only publication on site to interview the ladies inside the Egg dressing room where they spoke about their tour and career.

The ladies were grateful and honored to be interviewed by photojournalist Amaris Ford and in fact, according to Asano, that was the first joint interview that both she and Crowley-Duncan had done together for a publication, she said.

Crowley-Duncan thanked me for taking the time to come to The Egg to see them perform and chat with

them. My presence meant a lot to them, Ally said and for that, I'm blessed.

Performing at this venue was a full-circle moment for Crowley-Duncan. To go from being recognized by Metallica for Crowley Duncan's performance of "Fade to Black" on Tik Tok, being interviewed on local television, and originally selling out their show at the Swyer Theatre only to have it moved to the bigger theater space has been welcoming.

"So many full-circle moments...And it's like, yes you're from here, it's such a special thing to be able to have the whole band coming out and doing this, and for us to start doing this tour, it just feels nostalgic and meaningful." Crowley-Duncan said. "It's hatching!"

The idea for their "hatching tour" theme came about with Asano and Crowley-Duncan through a Zoom call with their manager, Phoebe (Fiona Bloom). With their first show being at The Egg and with several of their performed songs being "bird-themed" ("Free Bird"), it was the perfect fit, Asano recalled.

Asano's Berklee College of Music classmates and friends, Marraffa III and Beck-Levine helped bring their originals and covers from their album, "Mia x Ally: The Viral Hits" to life on the Swyer Theatre stage. The men also assisted the ladies in song arrangements and helped carry the tour gear on and off the bus.

Mia x Ally: The Viral Hits was officially released on Oct. 27 and the album was heard in its entirety at the Albany and New York City shows where it was officially debuted.

"I like to perform with other musicians whenever possible." Crowley-Duncan explained. "The difference having a live musician with you on stage, you can really feel it, so when we were discussing turning this into a touring show, it kind of was like not even something that we had to talk about, it's like, let's bring Dom and Dov with us. I love being able to collaborate live."

The Live Show

Listening to an electric violin, bagpipes, drums, and an electric guitar being played in unison for the first time may at first seem to be an odd setup but with the talented expertise of the musicians, they turned those sounds and melodies and made it into a powerful rock show that works.



The band performed "Mia x Ally: The Viral Hits" in its entirety, with its first three songs in the first set, "Shipping Up To Boston" (Dropkick Murphys), "Fairy Tail", and "Iridium" rocking and in tune in its booming start. Aside from their collaborations, the ladies each took the stage solo to perform songs that were dedicated to their instrument; Asano's original "Lunar" (with Ally on whistle) and Crowley Duncan's "Megalodon".

Fans also got to hear a medley of songs that the ladies bonded and collaborated over through the power of Tik Tok, as well as popular theme songs from the Pirates of the Caribbean, Star Wars ("Duel of the Fates"), Game of Thrones, and the Halo video game franchise.

The second performance set was just as epic and powerful. With Mental Health Awareness Month coming to an end in October and with Nov. 19 being the one year anniversary of the passing of the Power Rangers actor, Jason David Frank, the band performed a two-song tribute to Frank with the playing of the Power Rangers theme song and "What Was I Made For?" (Billie Eilish from the Barbie film).

The soft, quiet, yet powerful performance of "What Was I Made For?" was profound. Asano on the violin, plus Crowley-Duncan's flute playing and the backing piano melodies was carefully crafted and beautifully played to honor Frank and others whose lives were taken and impacted by suicide.

The sale proceeds of Asano's cover of the Power Rangers theme song, as well as Crowley-Duncan's tiny emotional support axe will benefit American Foundation for Suicide Prevention throughout November.

The remainder of the show remained upbeat and continued on its rock show hatching. Fans listened and enjoyed the re-covering of Ozzy Osbourne's "Crazy Train", "Fade to Black" (Metallica), "Free Bird" (Lynyrd Skynyrd) and "The Devil Went Down to Georgia" (Charlie Daniels Band) in a whole new light under the electric violin and bagpipes and revolutionizing how these songs can be heard to fans and future listeners.

Mia x Ally are impressive and with their soaring talents will land them to new opportunities and special moments that the performers will cherish. And this is just the beginning. The egg has hatched and Mia x Ally are ready for takeoff to success.

A season to breathe

The season kicked off Sunday, Oct. 29, at the Troy Savings Bank Music Hall with ESYO's Symphony Orchestra performing Antonín Dvořák's Symphony No. 9, "From the New World." Lois Lyman Concerto winner William Lauricella performed Rachmaninoff's Second Piano Concerto in C minor. The Bethlehem student has the unique privilege of being the only person to win the competition twice.

Lauricella remembered his elation over his win in 2020.

"I was so excited to play with the orchestra, but due to COVID-19, we couldn't play for some time," he said.

He was given the opportunity to record his performance at Proctors with a smaller ensemble.

"I loved the performance," he said, "but I'm very much looking forward to playing a concerto in front of a live audience, especially at the Troy Savings Bank Music Hall."

ESYO's music director and symphony orchestra conductor Etienne Abelin said Lauricella is a very talented musician.

"William is a fantastic young artist, not only as a pianist but also as a percussionist. His marimba playing, for example, is extraordinary as well," said Abelin. "To play an intricate piece such as Rachmaninoff's second piano concerto is a fantastic accomplishment and a fabulous challenge for both him and the orchestra."

When selecting his piece, Lauricella found compelling parallels between Rachmaninoff's life and ESYO's theme. Before this composition, Rachmaninoff had received significant criticism for his previous work.

"Writing this piece really helped him get to a better state," said Lauricella, noting how the Second Piano Concerto in C minor was

Rachmaninoff's way of pausing to breathe. "It's a beautiful piece of music and a great piece to listen to. It's such a big and powerful piece to start off a program and season."

Lauricella describes the piece as "celebratory" and "romantic," as it focuses on breathing and connecting with one another.

him the music brings them back to life."

Abelin praised Lauricella's selection of Rachmaninoff and its connection to ESYO's theme.

Connecting with people through music is essential to Lauricella, as he dedicates his time to concerts at assisted living facilities, nursing homes and local organizations like the Ronald McDonald House.

"I am proud of him for touching people's lives of all ages," said Lauricella's mother. "Every year, William gives a piano concert at his great-grandmother's senior

housing facility in California. His great-grandmother is 102. We call it her birthday concert. Residents with dementia hum along with him as he plays classical piano music, and they tell

"This piece is pure breath; it moves organically, constantly gently slowing down and speeding up; it's very fluid and still has a strong sense of pulse," he said. "I think it embodies our theme beautifully."

The concept of breath will be explored in several ways throughout the 2023-2024 season, from musical selections to the way they are performed. In addition to learning to breathe together, musicians will explore various interpretations of breath through the repertoire, such as how a composer such as Shostakovich was able to "artistically breathe" under an authoritarian regime.

"I look forward to seeing our theme explored in many different ways, starting with experiencing ESYO orchestras play without conductors, which is only possible when all musicians breathe together," said Abelin.

Attendees throughout the upcoming season are invited to draw in a collective breath with the musicians as the orchestra explores this dynamic, harmonious approach.

"Breathe! reminds me that I need to collaborate

with the orchestra," said Lauricella.

This collaboration between the musicians will be at the heart of the upcoming season.

"If an orchestra doesn't breathe, it's not really alive," said Abelin. "This year, we will breathe more fully with each other and with the music, so we can live in the present moment and truly connect with each other and the world around us."

For Lauricella, this upcoming season is an

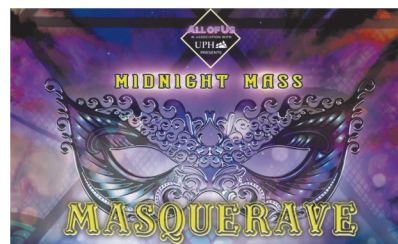
important reminder to him of "how far the orchestra and I have come."

Colonie Central High to host concussion seminar

Trainers and association team up to highlight identification and treatment

COLONIE – Monday, Nov. 6 at 6 p.m., the Brain Injury Association of New York State (BIANYS) and the New York State Athletic Trainers' Association (NYSATA) will be hosting a concussion prevention and education seminar at Colonie Central High School.

The Concussion Outreach Prevention & Education (COPE) seminar is a program designed by BYANIS and NYSATA that provides valuable information on how to successfully return a concussed student back to their sports and their classrooms, as well as ways to prevent concussions.

Both BIANYS and NYSATA are well-known and established statewide organizations with an expertise in concussions. While BIANYS helps victims of concussions and has a history of concussion education, NYSATA has a prevalent role in recognizing concussions and managing recovery.

Their seminar will offer perspectives from medical staff, athletic trainers, and education professionals on the signs and

symptoms of concussions, management and treatment, preventative measures, and guidelines for returning to play.

"There are between 1.6-3.8 million sports-related concussions a year, and this isn't even the leading cause of concussions," said Michelle Kellen M.Ed., a BIANYS Professional Development Manager and panelist for the seminar.

Concussions are a concerning and common occurrence in youth sports; a blow to the head can cause nerve injury, decreased blood flow, and inflammation that gives concussions their symptoms: nausea, dizziness and confusion, to more severe symptoms such as slurred speech, seizures or loss of consciousness.

Kellen says that while the average recovery time is typically around two weeks, for some, symptoms can last much longer and can develop into persistent post-concussion syndrome if left unchecked.

"Long-term outcomes [of concussions] are still poorly understood," said Thomas Barber, a Doctor of Osteopathic Medicine and a Primary Care Sports Medicine Fellow for Albany Medical Center. "What we do know is that repeated head injuries in a short time can lead to chronic symptoms and poor long term outcomes. That is why recognition, diagnosis, appropriate treatment and return to play is so important."

Barber says that the strongest predictor

of poor long-term outcomes is repeated, short interval head injuries, which means recognizing a concussion and its symptoms is important to protect the athlete's long-term health and keep them playing at their

highest level for as long as possible.

While the seminar is geared towards athletic trainers, coaches, and parents, it is open to the public and all are encouraged to attend.

Pediatric Infectious Disease Physician Dr. Jency Daniel Joins Staff

ALBANY – Jency Daniel, MD, has joined the Division of Pediatric Infectious Diseases at the Bernard & Millie Duker Children's Hospital at Albany Medical Center, a member of the Albany Med Health System, and has been appointed assistant professor at Albany Medical College.

Dr. Daniel will see patients from birth through young adulthood who have various types of infections, including sepsis, severe skin/soft tissue/bone/joint infections, complicated respiratory infections, and travel-associated infections, infections in immunocompromised patients, and more.

Dr. Daniel completed a pediatric infectious disease fellowship at Children's National Hospital and a Residency Fellowship in Health Policy at George Washington University in Washington, D.C.. She completed her residency at Maria Fareri Children's Hospital at Westchester Medical Center. She earned her medical degree at Albany Medical College after completing the Siena College/Albany Medical College Humanities in Medicine Program.

"During my fourth year of medical school at Albany Medical College, I did my student rotation with the Pediatric Infectious Disease

Division Chief Dr. Debra Tristram, and that solidified my desire to pursue pediatric infectious disease," said Dr. Daniel. "It's exciting to be back at Albany Medical Center, but this time as Dr. Tristram's junior colleague. I wouldn't want to do anything else, anywhere else!"

During her fellowship, Dr. Daniel was a medical officer with the U.S. Food and Drug Administration, taking part in the clinical review of new antimicrobial study protocols and large-scale safety and efficacy data analysis. She also served as a trainee liaison for the American Academy of Pediatrics: Section on Infectious Diseases Executive Committee.

Dr. Daniel is passionate about legislative advocacy, public policy, and health care equity and looks forward to sharing those interests with medical students and residents at Albany Medical College.

Dr. Daniel loves finding hidden gems in the community like restaurants or museums off the beaten path, loves TV, movies, and music.

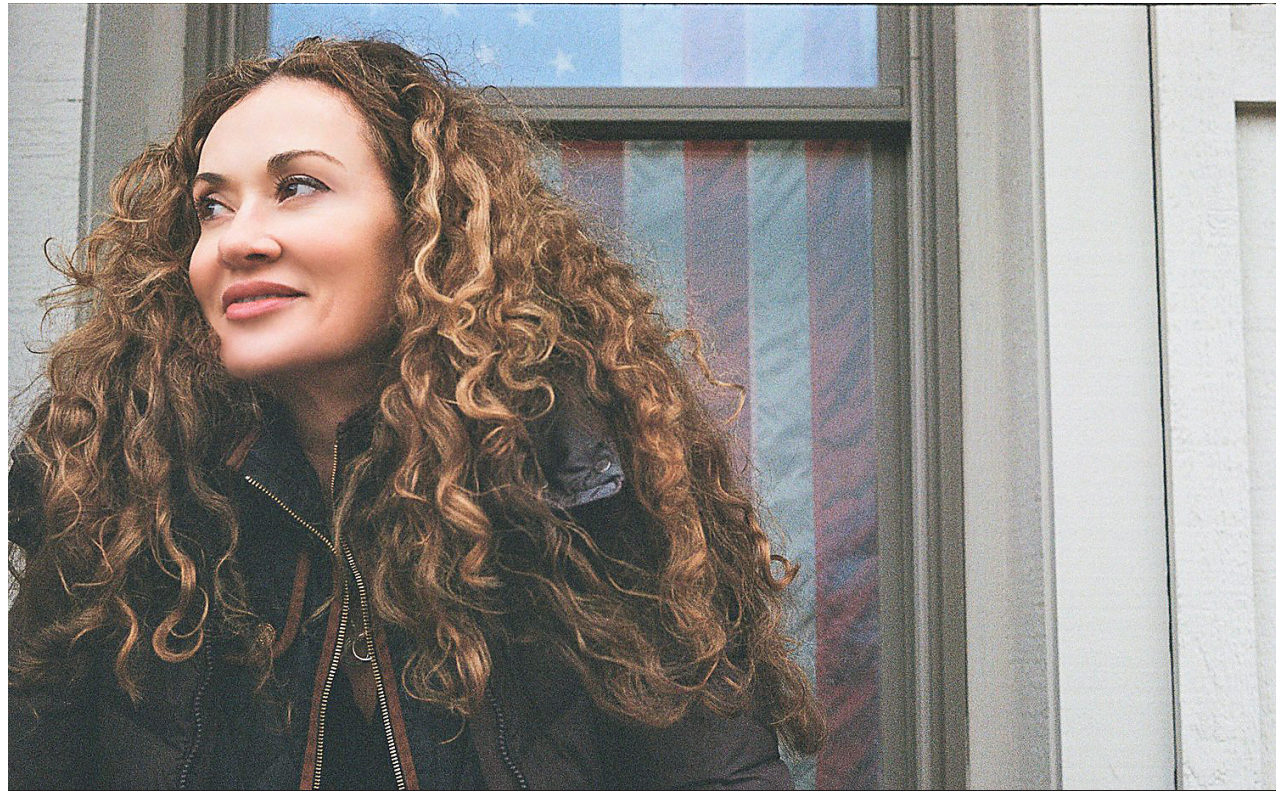

Indigenous Art Across the Homelands
Each One Inspired: Indigenous Art Across the Homelands examines the sources of inspiration for Indigenous artists across what is now New York. Featuring over 60 original artworks from the NYSM Contemporary Indigenous Art Collection, this thematic exhibit focuses on the connections to lands, community, the natural world, ancestors, and histories that continue to inspire Indigenous artists whose ancestral lands lie within what is now New York. Changing New York
In 1929, after eight years in Europe, photographer Berenice Abbott (1898–1991) returned to New York City. She was inspired by its dramatic transformation. New construction was everywhere; hundreds of 19th-century buildings had been torn down to make way for dozens of skyscrapers. She was determined to capture this momentous change in photographs.

Thomas Hart Benton
In 1956 Thomas Hart Benton was commissioned by Robert Moses, chairman of the New York Power Authority, to create two murals for the powerhouse building of the state's first hydropower facility in Massena. They feature Jacques Cartier's explorations of the St. Lawrence River and the Gulf of St. Lawrence. Alternately titled The Seneca Discover the French and Jacques Cartier Discovers the Indians, the murals depict the 16th-century encounters from two points of view.

Stonemason to Sculptor
When Henry DiSpirito (1898–1995) emigrated from Italy in 1921 he was already a trained stonemason and bricklayer. In Utica, New York, he found work in those trades but longed to devote his life to art. He found his calling in the direct-carving style of sculpture. Most of his subjects were animals or human figures, rendered in fieldstone or wood. He exhibited at the

Whitney, MoMA, and SculptureCenter in New York City, and at museums and galleries across the state. Renowned for his sculpture, DiSpirito was an accomplished painter as well. In 1963, he was appointed the first artist-in-residence at Utica College, a position he held until his death. Through his art, DiSpirito developed a deep connection with students and faculty, as well as the larger community in Utica. December 23, 2019 to December 31, 2023.

Celebrate a popular chocolate dessert



It is hard to determine who created the brownie, but dessert devotees no doubt appreciate that individual's now beloved creation.

Brownies are one of North America's favorite baked treats. They actually are classified as a bar cookie rather than a cake, and the dessert earned its name from the deep, brown color of its main ingredient.

There have been many variations on the brownie through the years, and the lively debate whether crunchy end pieces or chewy middle slices are preferred continues. There may be less debate about how flavorful it can be to mix cheesecake with brownies, which is just what happens in this recipe for "Marbled Chocolate Cheesecake Brownies" from "Chocolate" (Love Food), by the editors of Parragon Books, Ltd.

Marbled Chocolate Cheesecake Brownies

Makes 12

- 3/4 cup unsalted butter, plus extra for greasing
- 3 tablespoons unsweetened cocoa
- 1 cup superfine sugar
- 2 eggs, beaten
- 1 cup all-purpose flour

Cheesecake mix

- 1 cup ricotta cheese
- 3 tablespoons superfine sugar
- 1 egg beaten

Preheat the oven to 350 F. Grease an 11 x 7-inch cake pan and line with parchment paper.

Melt the butter in a medium saucepan, remove from the heat, and stir in the unsweetened cocoa and the sugar. Beat in the eggs, then add the flour, and stir to mix evenly. Pour into the prepared pan.

For the cheesecake mix, beat together the ricotta, sugar and egg, then drop teaspoonfuls of the mixture over the chocolate mixture. Use a metal spatula to swirl the two mixtures tightly together.

Bake for 40 to 45 minutes, until just firm to the touch. Cool in the pan, then cut into bars or squares.

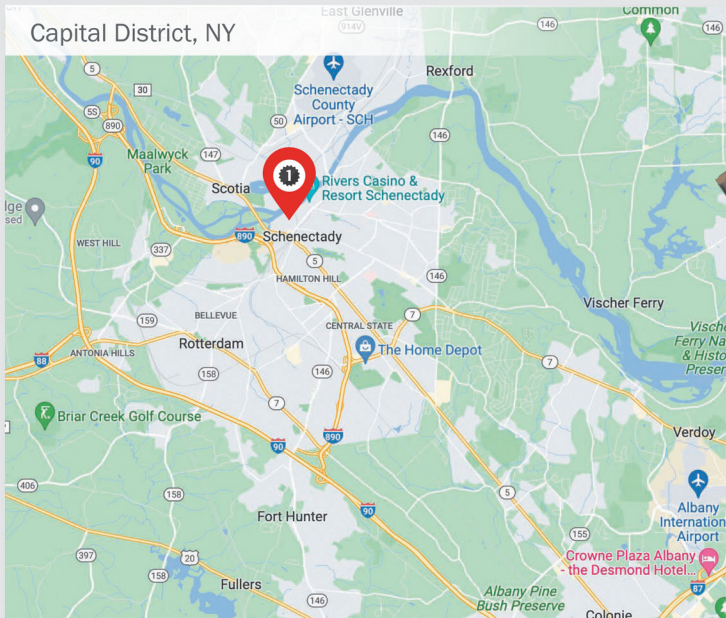
